ness taxable income received by social clubs. This applies to income from nonmembers or the general public less allowable expenses directly connected with the production of the income. Based on information provided, the unrelated business taxable income of the Outrigger Canoe Club for the year ended December 31, 1972, does not result in an income tax liability.

The State of Hawaii exempts non-profit social clubs from income tax.

In conclusion, I would like to say that the splendid financial results of operations for the year 1972 are clearly attributable to our Club Manager, Mr. Norman Riede, and the excellent staff who assist him. He is certainly to be commended for his continuing high level of performance.
