## *No Tips After April 15*

Effective April 15th the by-law of the Outrigger Canoe Club regarding the giving of tips will be enforced. At the last meeting of the Board of Directors our new Manager, Mr. Magill, presented a plan to eliminate tipping. It is based on an incentive plan whereby the employees of the dining room are to receive a percentage of the income in lieu of tipping. It is hoped that the plan will work out, that all employees and members will abide by the rule. It is believed that there will be no favoritism by employees and that service to all will improve.

## *Reduced Rates for Former Members*

The announcement previously made regarding the reduced rate of re-entrance fee for former members is still in effect; however, the board having amended the ruling as follows: "Any former member, including regular, associate, student and junior member who has resigned in good standing may be allowed to rejoin the club as a REGULAR member if they make application in regular form for membership prior to June 30, 1948, and by accompanying such application with \$100.00 initiation fee, plus the Federal Tax," which is at present 20%.

## *May Day-Lei Day-40th Birthday*

May Day, May 1, 1948, is Lei Day in Hawaii. It also marks the Fortieth Anniversary of the Outrigger Canoe Club. It will be celebrated by a DINNER DANCE and ENTERTAINMENT. At this party our new manager will be introduced formally to the membership. A top flight orchestra never heard before at the OCC has been engaged and many surprises have been planned for the occasion. The party will be informal and you are advised to make your reservations early.

## *Locker Room Improvements Started*

The locker room improvements voted for by the membership at the annual meeting have already been started. Extensions of the Men's and Women's locker rooms are being made of hollow tile and will give added capacity of 100 lockers. In addition to this, the covering for the sun deck will also be completed and it is the belief at this time that all improvements can be made without drawing from the Building Fund.

## *Outrigger Canoe Club to Welcome "S. S. Lurline"*

The Junior Chamber of Commerce Old Timers are preparing a celebration for the new luxury liner, the S.S. LURLINE, which will arrive in Honolulu on April 21 at 10:00 A.M. Elaborate preparations are being made and the Outrigger Canoe Club has been asked to take part in helping entertain tourists, officials and others who will arrive on that date. The Board has appointed "Yabo" Taylor as a liaison between the club and the JCCOT's to report back as to ways and means. He and Duke Kahana-moku have agreed to furnish a double hull canoe, twelve regular outriggers with crews and our sailing canoe. "Toots" Minneville will sail our new sailing canoe and this regatta will meet the "Lurline" off Diamond Head at about 8:00 A.M. Yachts and speed boats from boat clubs will join and accompany the ship to Pier 7 where at 10:00 A.M. ceremonies including presentation of an 80-foot lei will be held.
