Former Members, Good News

The Board of Directors has just made a ruling in favor of former members who desire to be reinstated in the Club membership. Any former REGULAR MEMBER, who at the date of his resignation was in good standing, may apply for reinstatement on or before June 30, 1948 by paying a fee of \$100.00 and the 20% Federal Tax thereon. If you know any former members who desire membership at this special rate inform them of this action. After June 30, the initiation fee for former members will return to the \$300.00 plus tax.

Additions Proposed

At the annual meeting in February the membership will be asked to vote on a proposition to transfer \$20,000.00 from the building fund for the purpose of making additions in locker rooms, lockers and equipment. It is the judgment of your Directors that this is a needed improve-

ment, but approval must be granted by the membership for the transfer of these funds.
