

R. Q. Smith, who in business life is president of Pacific Chemical & Fertilizer Co. and chairman of the board of the Pacific Guano Co., a PC&F subsidiary in California, has left on a two to three-month business trip.

Martin Anderson, vice president of the club and partner in the law firm of Anderson, Wrenn & Jenks, also has gone to the mainland and expects to

be gone for a month.

This leaves Ward Russell, club secretary, as the ranking officer in charge. Ward is executive assistant to the president of Hawaiian Telephone Co. and well-known Republican Party figure. By the time the *Forecast* is out, he probably will have announced his candidacy for the Territorial House.

BURTON HOLMES

Burton Holmes, "father of the movie travelogue" and one of the founding fathers of the Outrigger, died on July 22, 1958, at Hollywood

at the age of 88.

Mr. Holmes, who urged creation of the club in March of 1908 a month before it was organized, first visited Waikiki in 1898 and made the first movies of Outrigger canoeing and surfing. Ten years later on March 3, he returned aboard the Siberia and urged a canoeing sports club at Waikiki. He was one of the Outrigger's founding fathers and his passing leaves very few associated with the beginnings of the club.

The lean, bearded lecturer died during his sleep at his Hollywood home, which was once occupied by the matinee idol Francis X. Bushman. Mr. Holmes had been in retirement since 1950 and in failing health

for months.





OUTRIGGER PADDLERS WIN TITULAR CANOE REGATTA

LIHUE, Kauai — The Outrigger Canoe Club of Honolulu, coached by George Downing, scored 36 points to capture the 1958 Territorial canoe racing championship at Nawiliwili Harbor.

An estimated 2,000 persons braved high winds and rain to take in the 10-event program which honored John D. Kaupiko, Sr., veteran Hui Nalu coach and canoe racing enthusiast.


The OCC paddlers placed first in four events and also finished in second place four times. Two other OCC crews finished in third place in their respective events.

Waikiki Surf, which took the men's senior six two-mile blue ribbon event, was second in the team standings with 24 points. Kai Oni followed with 18 and Kai Opua of Kona, Hawaii, was third with 8. Following were Kaual and Lanikai with 7 each, Healani 6, Hui Nalu 3 and Hui Kalia 1.

Waikiki's winning crew in the twomile race was made up of Dutchy Kino, Moses Perkins, Conrad Canha, Rodney Botelho, Blackie Makaena and Blue Makua. The winning time wan 15:02.3.

Outrigger's victory gave Downing's club its fourth straight canoe championship this year.

All times turned in established records for the course. This marked the first time Kauai has held the Territorial championships.





A SALUTE TO JOHN D.

More than 50 years on and still going strong, "Old Man" John D. Kaupiko was saluted in OCC member Margie Stone's "Miracle Mile" column recently. It is reprinted here courtesy of the Honolulu Star-Bulletin.

The Old Man, they call him. Old Man John D. (for David) Kaupiko.

They call him that because he's one of the genuine 14 carat old-timers on the beach, and not because he's old. He's been part of the Waikiki scene for half a century.

Right now he's very busy, particularly when the sun starts edging over toward the Waianae area.

That's the hour for canoe practice, and John D. in his orange straw cap is over on the Ala Wai honing his Hui Nalu boys for the Oahu championship tomorrow.

And then his crews will point for the big one, the Territorial championship races at Nawiliwili, Kauai, August 2. This year it's named the John D. Kaupiko Territorial Championships.

The Hawaiian Canoe Racing Association is paying honor to a man who has done the full measure and then some for Hawaii's kingly sport.

For more than 20 years John D. has been coach and skipper for Hui Nalu, a club with no clubhouse but a venerable history.

Many of the canoe coaches throughout the Territory today first learned to assume the "ready-all" under his tutelage.

As one ex-paddler put it, "I think you could say he's a sort of symbol of outrigger canoe racing in Hawaii. You know those kids of his think he's wonderful. They all call him Daddy."

"Well," says John D., as he intently watches his 13 and unders take a fast quarter mile down the canal,

"this paddling sure keeps them out of mischief."

"We give them a real stiff workout every afternoon. Then they get home at night and boom, they hit the sack. They're too tired to go out.

"Sometimes they get a little lazy. Then we tie a tire on the bow like a lei. You've really got to pull when

you're dragging that along."

John D. has almost 100 boys in training on the canal. They pay just \$1 for the season's racing, earn their own expenses for the big trip to Kauai.

Even as a great-grandfather the Old Man looks as trim and fit as when he was swimming in Mainland competition, 1911 and 1913, with a Hui Nalu teammate by name of Duke Kahanamoku.

"This," he smiles, gesturing at the youngsters sprawled along the bank waiting their turn in the battered practice canoe, "is what keeps me up."

When racing season's pau, Hui Nalu becomes dormant. Today the Club of the Ocean Wave has, besides John D., only two other tangible assets.

One is its famous "We Love You, Hui Nalu" song, an almost guaranteed throat-lumper if you've ever heard the alumni on the beach roaring it out in full voice.


And the other is its sole racing canoe, White Horse. It's the same canoe John D. learned to paddle in back in 1911.

Hui Nalu was formed in 1908, primarily as a swimming club.

"We'd meet at the old Manoa bath house (now gone) and we'd paddle against those big six-foot Hawaiian fellows from Moanalua and Kakaako," John D. recalls.

"If we won we'd get some pineapples, or maybe a chicken or a pig for a prize. That's how racing started."

For decades Hui Nalu and the neighboring Outrigger, formed the same year, kept the sport alive be-

FORETASTE By Rusty Thomas

If you are ever in the mood to 'talk food' at the Outrigger, see Traylor Mercer. Traylor is one of our most avid exponents on the subject of cuisine and furthermore, he 'knows' of what he speaks. He is a member of the Honolulu Wine and Food Society, the local chapter of the London Society.

His interesting hobby has resulted in a collection of over 700 recipes from all over the world which he is now compiling in cook book form, to be published under the title of 'Food Cum Laude.'

A sample of the dishes include:

SAUTEED PORK CHOPS

Saute pork chops and remove to serving dish. Pour off all fat from pan except 1 tablespoon. Add 1 tablespoon clarified butter. In mixed fat, cook 2 tablespoons finely chopped onion until soft and golden. Add 1/3 cup white wine and 1 tablespoon vinegar. Cook wine until reduced to 3/4 original quantity. Add 1 cup tomato puree and 1 tablespoon beef extract. Continue cooking sauce slowly for 10 to 15 minutes. Correct the seasoning with salt and add 1 teaspoon prepared mustard, 4 or 5 slices sour pickle and 1 tablespoon chopped parsley. Swirl in 1 tablespoon butter, moving pan with circular motion. As soon as butter melts, return chops to pan and heat sauce until it reaches boiling point but do not let it boil. Arrange chops on serving dish and pour sauce over them.

CANOE STEERSMAN?

Your Canoe Committee is trying to reconcile records and recollection to arrive at a correct and current list of qualified canoe steersmen. This is particularly important because of new surfing regulations by the Territory, and because of possible liability which may accrue to the Club through the use of its canoes.

All who consider themselves qualified as steersmen are requested to submit their names, together with the extent of their qualifications to the Club secretary. Information should include the size of canoe and the size of surf (e.g. "blowhole." "canoe surf," etc.) in which steersmen consider that they would have full control of the canoe. Names submitted will be carefully reviewed for certification.

Existing regulations for use of Club canoes are under crutiny to assure that they meet current operating conditions. Upon confirmation these rules will be published. Also, consideration is being given to certifying steersmen in two classes, "Junior" and "Senior," with specific limits as to use of Club equipment in the two categories. Further information on this, and on means by which new steersmen may become qualified will be published in later Forecasts.

VOLLEYBALL RULES

EQUIPMENT AND FACILITIES

Courts

size. The playing surface (courts) shall be 60 feet long by 30 feet wide, including outer edge of lines. The height shall be 20 or more feet and free from any and all obtsructions.

Visible lines. All lines and markings shall be well defined in one clearly visible color.

Boundary lines. The courts shall be bounded by lines 2 inches wide, which shall be at least 6 feet from walls or obstructions. The lines on the short sides of the courts are "end lines," the long sides, "side lines."

Genter line. A line 2 inches wide shall be drawn across the center of the playing surface, separating the two courts.

Service areas. To mark the service areas, 2 lines 6 inches by 2 inches shall be drawn 2 inches back of each end line and each to be as a continuation of each side line, so as to permit service from anywhere between them and back of the end lines. The service areas shall be a minimum of 6 feet in depth back of the end lines and between the side lines. In the event the playing area does not provide space for such a depth, then the serving area shall extend into the court to whatever distance is necessary to provide such a minimum service area.

Spiking lines for back line players. A 2-inch line shall be drawn across each court from side line to side line, the center of which shall be 7½ feet from and parallel to the middle of the center line.

Size and construction. The net shall be 3 feet wide over all and 32 feet in length when stretched. It shall be made of 4 inch square mesh of black or dark brown No. 30 thread, and be bound, top, end and bottom, with ½ inch manilla rope. A double thickness of white canvas 2 inches wide, shall be sewed to the top and ends of the net. Through the top canvas shall be run a ¼ inch performed galvanized aircraft cable (7 x 19) with an ultimate strength of 7000 pounds.

Vertical tape markers. A 2-inch vertical marker tape shall be fastened over the entire width of each side of the net at each end to be directly above and vertical to the side lines.

Height and installation. The net shall be tightly stretched by four corners between uprights which are at least 3 feet entirely outside the courts, and shall cross the courts above the center line. The cable shall be drawn by the use of a tightening device so as to permit as little sag as possible, and the top shall be level and measure at the center of the courts 8 feet to the floor and at the side lines as close to 8 feet as possible. The design of the supporting guys or stands shall be adequate to withstand a working stress of 2000 lbs. in the net cable. The bottom of the net shall be drawn taut by ropes anchoring the lower corners to the side upright. From the top ends it should be braced to a support by 2 cables approximately 45 degrees to the line of the net so as not to interfere with the referee's vision and his ability to keep his head over the net.

Ball

Specifications. The ball shall be spherical and have a rubber bladder with a 12 piece laceless leather case or a rubber case; be not less than 26 inches or more than 27 inches in circumference, and weigh not less than 9 or more than 10 ounces. The leather case ball shall have air pressure of not less than 7 or more than 8 pounds and

the rubber case ball not less than 5 or more than 7 pounds pressure. The use of a balanced ball is recommended.

Scoring and Timing Devices

Kind and location. There shall be, as far as possible, a combination score board and timing device, so located that it may be observed by all spectators, players, substitutes, coaches, managers and officials. If no such device is available there shall be manual scoring devices on each side of the court and an electric or manual timing device to time the game.

OFFICIALS AND THEIR DUTIES

All Officials

Kind. The officials shall be a referee, umpire, scorer, timekeeper and two or four linesmen.

Buzzers and whistles. Officials of a game may use sound instruments having the same tone but a different tone from those used in the game on the adjacent courts.

Decisions concerning facts. Decisions by the officials concerning facts are final and not subject to protest.

Official's mistake. When an official sounds his whistle by mistake and this causes a player to stop playing, the referee shall direct a play-over.

Referee

Position of referee. The referee shall station himself on a platform at one end of the net in a position that will give him an equally clear view of both courts and so that his head is at least two feet and not more than three feet above top of net. (Illustrated in diagram of net and referee's platform)

Power to overrule. The referee shall be the superior official of the game and shall have the power to overrule decisions of other officials when, in his opinion, they have made errors.

Decide play and penalties. The referee shall decide when the ball is in play, when it is dead, when a point has been made, when a side is out when there is a double foul and when



other penalties should be assessed according to the play, fouls and errors. He shall not announce "game point."

Matters not in rules. The referee shall have the power to make decisions on any matters or questions not specifically covered in the rules.

Rule interpretation protest. The referee shall make not of the facts concerning a rule interpretation protest and shall notify the scorer to make official note of the score, courts, server, players and relative positions at the time of the protested play and the game shall proceed.

Time-out request. While the ball is dead, the playing captain or coach may make a request for time-out to the referee or umpire.

Substitution request. While the ball is dead, the playing captain or coach may make a request for substitution to the referee or umpire.

Asking for information. While the ball is dead, the playing captain, coach or manager may ask the referee or umpire for information pertinent to the game.
