





#### DIRECTORS

A digest of the minutes of the meetings of your board of directors.

J. Ward Russell, a director, has been appointed an alternate member of the finance committee.

Ken Pratt has been named chairman of the canoe committee and has been authorized to sell or dispose of old outrigger canoes on the beach. Duke made arrangements to move them to a spot at Ala Wai harbor near the library in order to clear the beach for the July 4th races. The Navy had been interested in buying them but then decided not to. Ken's committee is investigating whether some of the canoes can't be salvaged for further use by the club.

Jake Tudor and Charles Hee were instructed to confer and submit recommendations for improving the accounts receivable situation on the club's books.

Term members are being notified that (1) they will not be required to pay the \$2.50 building fund assessment if they don't wish to do so; (2) if they refuse to pay the assessment and still wish to belong to the club at the time their term membership expires, they have to come in as new members, paying the initiation fee in force at that time; and (3) if they pay the assessment they are entitled to continue as regular members at the expiration of their term membership without payment of any additional initiation fee, but subject to the monthly dues in effect at that time.

Directors are investigating rates for a beach service liability insurance policy. They also are investigating how to protect the club in connection with a claim for workmen's compensation re-cently made by Earl King—"including, if advisable, a determination of the status for workmen's compensation purposes, of beach services personnel."

Members of the beach service have been advised to prepare a financial bid for presentation to the directors on setting up a separate operation of the beach services.


In 1908 the Outrigger and the Uluniu Women's Swimming Club jointly paid \$5 annual lease rental for 25 acres at Waikiki, including their present locations. Now John Avent's International Building Co. is paying Waikiki Development Co. \$25,000 a year for five years just to reserve a 50-year lease on the 65,000 square feet remaining.

In 1963, International will pay Waikiki Development a lease rental of \$150,000 a year for the first 17 years of the lease with a reopening in 1980. At that time a new annual rental cannot exceed \$300,000 for the remain-

ing 30 years of the lease.

#### **OPEN LETTER**

to the president, directors, and members:

I have just received the June Forecast and read with interest the progress of the Club plans concerning a new site. Feeling the welfare of the Club is the responsibility of the membership, may I, in absentia so to speak, propose the following thoughts to be considered even though delayed.

A. The proposed new Elk's Club site presents many expensive and difficult problems that no doubt can be solved; however, it is not too late to commence exploration of purchasing or long-term leasing, of the lower three levels including beach and ground facilities of whatever the agent or Trousdale interests may construct.

B. The architectural needs of the new Outrigger Canoe Club could be an integral part of, and designed in conjunction with, the new construction. Whoever builds, Outrigger Canoe Club or new lessee, will of necessity be forced to utmost utilization of a tremendously valuable small land area, by building a multi-storied edifice.

C. I strongly urge we participate as intelligently as possible in this concept which is not only changing the Waikiki Beach area, but the entire Honolulu Community.

D. The disposal, further leasing, and utilization of the Elk's Club area would be a secondary problem.

I sincerely hope these thoughts may be of some benefit.

#### AVENT

John V. Avent, president of International Building, told local newspapermen last month that the "door is open" for the Outrigger and Fred Kingman (Arcade Shops) to work something out with his group so that he can get possession of their present property before their leases expire in 1963.

He outlined his development 'thinking" for the Outrigger Club and Arcade Shops property, which International Building will acquire in 1963 under a sublease from Murchison-Trousdale's Waikiki Development Co. The investment cost will be "not less than \$10 million."

He indicated that neither an apartment-hotel nor a luxury cooperative apartment building is definitely decided upon, but an International Beach Club is planned. Completion would around Christmas, 1964.

Members of the Outrigger who wish to remain at the present location (including Kamaaina Hui members by name) will be given "preferential treatment" on initiation fees if they join the club, Bill Cox, agent for

Avent, told the press.

The beach club is the only required improvement in the lease agreement between Avent and Murchison-Trousdale. The club will provide a certain number of "courtesy memberships" to guests of the proposed Hawaiian Queen Hotel in back of International Market Place. A similar arrangement may be worked out with Matson Hotels.

Avent and his associates indicated they would like to provide beach services from the Moana-SurfRider to the Royal Hawaiian, using "in so far as possible the present beach boys," Cox said.

"It is not our intention to cut anyone out of a job," he said.

Local membership in the club will be "selective without being restrictive," he added.

Avent said his associates in the project include eight Californians and 10

islanders; he declined to identify the local people but said the California and Island groups each owned half of International Building. M. B. Carson and John Eagle are officers of the firm.

5 pounds top sirloin, sliced thin
Sauce
2 bottles Lea and Perrin

# Lalapalooza of a Luau



#### RACING ROUNDUP

Coach Downing's canoe racing squads swept last month's paddle racing events, taking the July 4th Walter Macfarlane Memorial, Sarah Park Memorial, and Oahu championship races.

Here is a summary of the races, courtesy of The Advertiser's sports

Outrigger Canoe Club paddlers took eight first places, one second and one fourth for a total of 44 points in winning the 1958 *Oahu* championship canoe races at Keehi Lagoon.

Second place went to Waikiki Surf Club with 19 points. Kai Oni followed with 16, Healani 12, Hui Kalia 8, Lanikai 5 and Holomua and Hui Nalu

tied with 3 points each.

The other first place winners in the 10-event program went to Hui Kalia which turned in a record-breaking time of 4:06 in the boys novice half mile race. Waikiki Surf's women senior crew finished first in the final event of the day.

Outrigger turned in a time of 17:-47.0 in winning the men senior twomile blue ribbon event of the day. George Downing's OCC paddlers hold the record for this eent with a time of 17 minutes flat.

The races were directed by the Hawaiian Canoe Racing Association. The 1958 championship honored Victor S. K. Houston, former delegate to Congress and a veteran canoe racing figure. Paul Jones was race committee chairman.

Outrigger Canoe Club won the annual Walter J. *Macfarlane* Memorial Canoe Regatta of Waikiki by scoring 35½ points to 30 for the Waikiki Surf Club.

However, the blue ribbon men's senior six two-mile race was won by the WSC canoe in one of the closest finishes ever witnessed at Waikiki.

Waikiki Surf Club, Outrigger and Kai Oni waged a sensational battle all the way. The WSC paddlers, Dutchy Kino, Moses Perkins, Jammer Kekai, R. Botelho, Blackie Makaena and Blue Makua pulled to a "photo-finish" victory, with Outrigger and Kai Oni crossing the finish line in a dead heat for second place. The time was 16:33.5.

Kai Oni was third in the team scoring with 19½ points, followed by Healani with 11, Hui Kalia with five and Hui Nalu with four.

Waikiki Surf Club was disqualified in the women's senior six half-mile when its canoe bumped Healani's at the quarter-mile turn. Healani won in 4:58.9.

Outrigger captured the women's junior six, the freshman six, women novice, boys 17 and under and boys 13

#### **VOLLEYBALL RULES**

#### I. Membership

a. For the purpose of these rules associate members shall be referred to as junior members. From June 15 to September 15, any junior member who holds a full time job and establishes proof of same to the Volleyball Committee shall have the same privileges accorded a senior member.

b. Guests and Pan American Members: Registered guests of members and Pan American members may use the courts only when such play will not interfere with games of senior or junior members of the club. A Pan American member or a guest may, however, play at any time with an eligible challenger.

lenger.

#### II. Courts

- a. Mauka—This court is set aside for senior members' doubles games. A Senior member doubles team shall have the right to interrupt and take the place of any team of junior members who are playing at any time. A senior member doubles team shall also have the right to interrupt any "big game" being played on this court. A junior member may play with a senior member who is an eligible challenger on this court.
- b. Makai Senior members shall have no preference on this court. Any two teams with three or more members, regardless of membership classification, may take precedence over any doubles team waiting to play during the following times: After 4 p.m. on weekdays, after 12 noon on Saturday and all day Sunday. Any team whose turn it is to play shall have the right to choose either the full or the three-quarters court for the next game.
- c. Small Court—This court is for the general use of all members for singles, doubles or large groups. Large games and doubles games shall take precedence over single games.

1. Members desiring to play on any court will be required to place their names on the winners' board assigned to that court and may have their names on no more than one winners' board at any one time. Members violating this rule will forfeit their winners on the Senior court.

2. No Members shall place the name of another member on any winners' board if the other member is not on

the club premises at the time.

3. The winners' board will govern the order of play only when the court is in use. When the court is empty, regardless of the number of names on the winners' board, anyone qualified may start a game. Then the first name on the winners' board will be the next member to play.

4. The relative position of winners on any board cannot be changed and no one can give their winners' position

to another member.

5. Players who have been eliminated by virtue of losing a game or by winning three consecutive games will not be eligible to play the following game. One game must elapse before either player will be permitted to return to the court.

- 6. Players who have placed their names on the senior winners' board and are awaiting their turn, may play warm-up games on the makai court as long as the makai court is not in use. However, should other members desire to play on the makai court the player or players whose names are on the senior winners' board must immediately give way to the newly arrived players or forfeit their winners on the Senior Court. This is important in fairness to all.
- 7. There will be a time limit of two (2) minutes between games. Not more than two (2) minutes shall elapse between the end of one game and the start of the next. Those failing to comply will automatically lose their winners.




Care of Equipment


