

1951 ANNUAL MEETING

The Annual meeting of the Club was held at 5:00 p.m. the afternoon of February 23, 1951. Meeting was called to order by President Wilford Godbold who then read his Annual Report.

Following this report other officers made their reports for the year. All of these reports are printed in this issue of the Forecast.

Mr. Leslie Hicks explained the necessity of increasing the Building Fund from \$150,000.00 to \$250,000.00 and following his statement a motion was duly made, seconded and unanimously carried to that effect.

The reports of the various officers showed great gains in the Club financially, as to membership and in activities. These reports also reflect fine management and direction by the Directors and Officers. Members present in a vote of hanks acknowledged the excellent work of the management for the year.

On the report of election of Directors all incumbents were re-elected and one new member was elected. He is H. B. Danford of whom we hope to have a short biographical sketch in the April

Following the meeting the members present partook of Anzai's famous punch and canapes. The meeting was very satisfactory to all attending, the only suggestion as to improvement of the Club being that more parties be given during the following year.

In this issue, page 2, are given the names of the new officers and committee appointments for the year 1951-52.

REPORT OF PRESIDENT FOR 1950

It is again my pleasure to report, in behalf of your Board of Directors, on a year of progress for our Club.

The Club membership has increased on an overall basis from 1,807 at the end of the year 1949 to 1,877 on December 31, 1950. The largest increase has been in the category of Senior members. The number of Senior members has increased from 752 in 1949 to 827 in 1950. A total increase of 75 Senior members. Junior member-

ship has dropped from 237 to 180. A total decrease in Junior memberships of 57. The other categories of membership have, by and large, shown slight infreases.

The net worth of the Club as of December 31, 1950 was \$338,897.78 compared to \$301,544.44 for the same date in 1949 or an increase in the amount of \$37,353.34. Incidentally, only \$10,000.00 remains to be paid on our note to the bank for the loan in connection with the new improvements to the Club. Our Treasurer, "Yabo" Taylor, will present a more comprehensive financial report.

(Treasurer's Report shows \$15,000.00. \$5,000.00 was paid to bank after report was made.)

The Building Fund with securities carried at cost has snow-balled to \$153,404.35 during the period covered by this report. The balance for the previous year was

\$142,373.08. Les Hicks will report to you on the various investments held in the Building Fund portfolio and on the necessity for a raised ceiling on this fund.

The recent large scale renovations to the Club have, after a year of operation, proved themselves to be more than worth the expenditures involved. A year of gracious dining in the dignity of our new dining-room has no doubt caused a number of us to forget the noise and clatter and harsh glaring lighting of the old. Our cocktail lounge has been described by many as the most attractive they have ever seen. It is indicated that the operations of the Club would have run into the red for the year 1950 except for these improvements. These new facilities have in addition to providing added comfort and pleasure to the membership and greatly needed additional revenue have

also been the incentive which has caused such a substantial increase in the Senior membership.

The activities of the Club throughout the past year have been multiple and varied, running the gauntlet in the athletic field from "clowning" volleyball games through challenge matches for steak dinners to highly trained and competently coached crews and teams representing the Club in inter-club competition and in the scope of social affairs from impromptu gatherings and parties to formal dinner-dances. Some of the highlights for the year included birthday dinners for the "Duke" and "Dad" Center at which crowds of friends paid their respects and had rooting-tooting good times. Buster Crabbe, former Olympic Champion and life member of the Club was welcomed back by the old-timers. Arthur Godfrey was entertained and took Club members Duke, Splash Lyons and Chick Daniels back to New York for a series of TV shows. The dances given by the Club were happy experiences and in my opinion the activities planned for the membership in the entertainment field should be increased in number and in variety.

A number of distinguished Clubs have been added to the list of organizations with which our Club has reciprocal arrangements. It is indeed a pleasure when away from home to find a welcome-mat out and the name "Outrigger Canoe Club" known and respected.

The members who have contributed so much of their time and effort on the various Club committees are so numerous that I will not even attempt to single them out individually but extend to all of them, together with the members of the Board of Directors, Ted Magill and the Club employees my sincere appreciation.

TREASURER'S REPORT

The Annual Report of our Auditors, Young, Lamberton and Pearson, which I present covers the fiscal period ended June 30, 1950. On their recommendation and principally for tax purposes we continue to keep our accounts on a fiscal year basis.

This report is quite voluminous and I will not attempt to read it here but copies are on file and available for inspection at the office of the Manager or at my office in the Bishop National Bank.

As considerable time has passed since this report was made I have prepared and submit for your information a comparative Balance Sheet as at January 31, 1951 and the same date in the previous year.

It is obvious from a perusal of these figures that the Club is in excellent financial condition and continues to forge ahead.

Our resources are stated conservatively. Fixed Assets are being written off over the period of our lease and adequate reserves have been set up for other contingencies. Securities held in the Building Fund are carried at cost although the present market value is considerably higher.

With conditions as they are at present it is difficult to look ahead with any degree of certainty but, barring unforseen circumstances, I am confident the Club will continue to grow and prosper.

HOUSE AND GROUNDS

During the year 1950-51 no major improvements were made as it was felt that the extraordinary re-building accomplished in 1949 had cost about \$65,000.00 and until that debt was lowered we should go slowly.

The Committee called attention to your Directors of some needed improvements, several major and some minor, and were directed to make the minor

ones within certain costs.

Some of these were new shower heads in men's and women's showers, improvement in the cocktail lounge bar, new outdoor shower at entrance to men's locker room, painting throughout locker rooms, repairs on ceilings, installing new urinals, raising the Ewa fence higher to protect Uluniu Club from volleyball, lights on the Terrace steps, parking attendant's shelter, and several other minor

improvements.

The major improvements are: solving the problem of more room and facilities in women's locker rooms, repairs to the roof of this wing and storage space and carpenter shop erection. These problems all tie in together and estimates are now being made to solve these problems in one of several ways. We hope that soon the Committee may be able to report and make suggestions to the Directors so that these problems can be solved. The proposed plans will give the Senior women more space, more privacy and other improved facilities.



HORIZONTAL GOLF CLUB

The world-famous Horizontal Athletic Club now has a hardy though youthful competitor. It is known as the Horizontal Golf Club, but it is different than the HAC as its members are more vertical than horizontal.

Five of the younger set of the Outrigger Canoe Club conceived the idea of a golf group and proceeded to organize in June, 1949. As membership in golf clubs was considered too high this group formed, to play on various courses as a team or teams, changing courses each month. The original members were Jack Ackerman, Jim Beardmore, Bill Beers, Bill Bennett, Jack Cross, James Dwight, Bill Harton, Dick Muirhead, Jim Muirhead, Ed Sultan, George Tibbetts, Gordon Tilley, Alec Williams, Herbert Wilson, Robert Bennett, Spud Pearce, Barry Pritchard, Russell Greer, Don Lord, Ramsay Sandelin, Sam J. C. Todd, and Tom Abel. The membership has grown to about sixty of whom about fifty are active as the others are either in colleges on the mainland or in the Armed Services.

The club plays monthly tournaments such as Aces and Christmas and Thanksgiving Turkey Tournaments. Meetings are held annually in August to elect officers, amend by-laws and conduct other business. The club will apply for membership in the Hawaiian Golf Association in order to be eligible for other activities. Quarterly parties are held for members and guests.

HORIZONTAL ATHLETIC CLUB

This club is well known but a few words may be timely to bring its history to date. It was organized by a group of elder members who believe that there are too many clubs. So they started another.

It is unique in many ways. Horizontal athletes are not athletes. There are no by-laws, constitution or rules. There are no dues. There are no elections. The organizer, Ernie Stenberg, appointed himself Chief Prostrate and appointed a Treasurer. Officers remain in office as long as they wish and name their successors. The Chief Prostrate makes all rules and as there are no dues he may fine any member for breaking any rules he makes. Funds so collected are used only for entertainment.

There are no objectives except to rest. Members while on the beach must be horizontal, prone or prostrate. They must not arise for anything except to leave the beach. Meetings, when held, are at the call of the Chief Prostrate and nothing of a serious nature is discussed. Membership is by selection only, not application; and such selectees must have qualified by a long series of observation by the membership. Initiation fee is the entertainment of active members with as many Planters Punches as they wish to imbibe. The activities of members are contemplative or speculative only.

Chief Prostrates have been Ernie Stenberg, Herman Rohrig, Col. George Unmacht, K. C. Leebrick, and Howry Warner.


FROM GRASS SHACK TO PRESENT CLUB
