

INITIATION FEE REDUCED TEMPORARILY TO FORMER MEMBERS

The Board of Directors earlier this year made a special reduction of the initiation fee to former members of \$100.00 plus tax. Many old timers took advantage of this offer, which closed as of June 30, 1948. However, the Admissions Committee have had many requests from former members who were not advised of this special rate, and several applications are on file.

The Board, after careful consideration, has again opened the Club to applications from former members who may, if they were in good standing at the time of their resignation from the Club, apply for Senior membership on the regular application form accompanied by a check of \$120.00 for initiation fee and tax. Such applications MUST be presented before December 31st, 1948, after which date this offer will be withdrawn.

MEMBERSHIP TRANSFER RULINGS CLARIFIED

The Admissions Committee feeling that there were several inequities and some confusing rulings on transfer of members from one class to another and other rules on Admissions made a number of recommendations for changes. After careful study, the Board of Directors have passed the following rules.

- 1. Junior, Associate and Service members who have been continuously members for two or more years, may, upon becoming eligible, be advanced to their next appropriate classification without the payment of an additional initiation fee.
- 2. Associate memberships be now limited to students only, over eighteen and under twenty-one years of age, and to the spouse of Regular, Term or Life members. The provision regarding amount of income be abolished.
- 3. All Non-Resident and Island members who have been continuously members for two or more years may become Regular members upon payment of a transfer fee of \$100.00 plus tax.
- 4. All applications for Non-Resident memberships be interviewed and processed by the General Manager subject to final approval of the Committee on Admissions and the Board of Directors and cards issued to them shall plainly so indicate.
- Junior memberships be increased to 300 and applications considered whether or not the parents are members of the Club.
- 6. Junior members be not allowed the privilege of having Guests on Saturdays, Sundays, Holidays and during the summer months except, when in the judgment of the General Manager, exceptions are warranted.


