# The President Comments . . .

## O. C. C. PARKING LOT

I believe that it is apropos in order to have a complete understanding and kokuia between the club members and its elected officers and directors for the membership to be informed as to the whys and wherefores of the operation of the club. To this end I have attempted to discuss an item of the club's operations in each of these monthly Forecasts. A misunderstanding appears to exist in the minds of a portion of the membership as to how the parking lot operation fits in with the overall club set up. Our club has no lease on the parking lot area, but has the right to operate the same pursuant to a month to month rental agreement with the Hotels' Division of the Matson Navigation Company. The Matson officials have declined to grant a lease on the premises as no final decision has been made by the company as to its use. Recently your Board of Directors was notified of an increase in the rental for the area to \$200 per month. It will be recalled that the area was an eye sore and became mud flats during rainy periods and during dry periods was a dust bowl which was the source of much dust and dirt which blew into the surrounding premises. When the club officers were notified of increase in rental, negotiations were entered into with the Matson officials to have the area paved and adequately lined for parking. One proposal presented to the Board at the time of notification of the rental increase was that the additional cost of maintaining this area be made available through general increase in the club dues, however, this was rejected as your directors felt that it was improper to assess the cost of operating this area against the whole membership whereas only a portion of the membership made use of the parking privileges. Therefore a bulletin was put up in the club lobby requesting all members who desired the use of the area to signify their willingness to be charged at a monthly rate for parking privileges not to exceed \$2.50 per month

and in the event that a sufficient number agreed to pay for this privilege that the individual charge would be proportionately reduced, the desire of the Board of Directors being to make the parking lot a self-supporting unit. Some 126 members signified their willingness to become supporting members. In the past year the cost of operation of the parking lot has amounted to \$600 per month which expense is segregated as follows:

The average income from the area has been \$652 per month, therefore the plan has worked out on as near a break even basis as possible.

It is apparent from the above that parking privileges do not automatically accrue as a result of club membership. In addition to those members who have agreed to support the parking lot on the monthly pay plan other members are allowed the use of the lot at the rate of 25 cents for the first two hours of parking and 10 cents for each additional hour. However occasional parkers are not allowed the use of the lot on Saturday afternoons and on Territorial holidays, as on these days the lot is overly congested as a result of the presence of a large proportion of its supporting members.

It is suggested that for those who desire use of the lot without restriction there is still an opportunity to sign up for monthly parking at the presently existing rate of \$2 per month.

# UNDER KALAKAUA AVENUE IN A CANOE

*(Alexander Tulloch, familiarly known as the Admiral, while born in Colorado is a true ka-maaina. He was brought to the Islands by his family and settled in the big island. His father was variously a Lima, a sugar planter and a Kona coffee grower. Alec is a member of the first graduating class of the old University of Hawaii, is employed at Pearl Harbor and was present on December 7, 1941. He is a Legionnaire and was a delegate at the historic convention in Paris. He is one of the early members of the Outrigger Canoe Club where he spent many happy days as a boy and a young man. His story following, we think is most interesting.)*

Waikiki in the early days of the Outrigger Canoe Club was far different to what it is today. The beach stretched from Diamond Head to Fort De Russy as it does now, but without the cement walls, thus allowing the sea to hold and develop the beach rather than tear it down. Kalakaua Avenue was where it is, but, there were no electric signs, hot dog stands and the like. It was a dirt road and immediately in front of the Club a stream cut the avenue and over this stream was a culvert bridge. The stream ran through the Club grounds and it was the fresh water shower bath we often took after a dip in the ocean. Across the avenue extending ewa to McCully Road was a swampy area, muddy and smelly. Here Chinese farmers had raked up the rich silty earth into mounds or miniature islands and here they grew bananas and raised ducks. Between these little islands were a series of duck boards for the ducks to walk on and it was indeed a laughable sight to see the ducks waddle up these walks to their nests and to see the Chinese farmers wending their way through their farms, two baskets slung on the end of a pole over their shoulders, out collecting duck eggs for the market.

In those days as now there was a great interest in surfing and plain paddling and many a youth went exploring up

the coast and beaches, out to sea and even as I am about to relate under Kalakaua Avenue. Old timers will remember Palolo stream, bridged by a culvert a few rods on the town side of the Moana Hotel.

One day a group of us OCC members headed by A. H. Myhre and myself decided on an exploring trip up the Palolo stream. We headed up stream through the club grounds and reached the culvert. It was apparent that the canoe could not be paddled through as the height from water to the supports would allow a good-sized duck head room. After a huddle with Myhre we decided to fill the canoe with water, everyone go overboard and push the canoe through under the culvert. This was done and on the other side the canoe was bailed out and all again aboard and paddling for Ainahau. This region extended from the front of the Moana Hotel and well up toward Kaimuki. No doubt the area was named Aina for land and hau for the hau trees which grew so abundantly there. In fact there were places on the stream where we paddled in a tunnel formed by the entwined limbs and branches of these trees. Here was the place where we found the amahs for outrigger canoes with but a few minutes of hunting.

After the paddle through the hau forest we emerged into the area of banana patches, rice fields and flower gardens. Up stream a way we came to a large barn-like structure. Here a Chinese farmer lived who was amazed to see a canoe load of haoles and Hawaiians emerge where usually he only saw flocks of white ducks swimming peacefully. Though no doubt he thought us piratical in our intentions, he greeted us cordially and presented us the fruit of his farm, a basket of duck eggs and several large hands of delicious bananas. Perhaps this was a peace offering, although in those days

everyone really acted with true Hawaiian hospitality or should I say Pake hospitality.

The trip had taken us a little ewa of the Stevenson banyan, then up toward Kapahulu, probably somewhere about where the fair grounds now stand and then in a general direction toward St. Louis Heights. The day was spent paddling along, then getting out and exploring the country and suddenly we realized that the sun was getting low and that we must end this most interesting journey. The paddle back was done much faster than the pull upstream and so back we went with the fruits of our trip. At the culvert we carried our eggs and bananas across but again sunk the canoe and pushed it under the avenue and into the club grounds. I may add that to my knowledge this was the first such trip made and that we probably could have paddled quite far up into Palolo Valley had we started earlier or not have visited and explored along the way. Thus ended a pleasant day, one of the many I have enjoyed at Waikiki and its environs.

## A NOTE ON HIGH COSTS

A couple of weeks ago I was dining at the club with Judge LeBaron and noticed that the price of my favorite lunch-entree had been increased.

Confronted with this direct attack on my pocketbook, I stopped by the manager's office to inquire the reason and found out some things about increased food costs of which I was generally aware, but the extent of which amazed me.

For instance I found that from a low point on March 15 the average increase to July 15 had been 37 percent with no reasonable assurance that the ceiling has been reached. Naturally, under the circumstances, I could readily understand the necessity for an increase in menu prices which, however, has been only about 10 percent. The manager feels that except for a slight adjustment here or there it should not be necessary to make any further increases unless wholesale prices continue to advance. I hope they have reached the top.

The following memorandum recently written by the manager to the chef is self explanatory:

## PITY YOUR MEMBERSHIP COMMITTEE

Your Membership Committee and particularly its chairman, Dr. Irving Blom give up many hours of their time for duties required of them. Every applicant for membership must be interviewed. Every application must be checked carefully as to a number of important facts. You as a member sponsoring an applicant or seconding such application, too, have an important and responsible duty.

No application should be signed by you unless you know the applicant well and are willing to be used as a reference. To each sponsor or seconder goes a questionnaire which must be returned to the Committee properly filled out and signed. If you receive such a questionnaire and do not return it, the person for whom you signed an application is either denied membership or his application may be delayed for months. This is neither fair to him or to the club.

Only senior members in good standing may sponsor or second a membership application, and in no event may a member of the Board of Directors or the Membership Committee act as a sponsor or as a seconder.

When you act as a sponsor you are guaranteeing that person's character and his actions. You guarantee that the applicant is the sort of a person you would gladly welcome into your home, whom you would associate with and whom you can truthfully recommend to all other members. So, when you sign an application don't just do it to be a good fellow or do it lightly. Once in, an objectionable person is rather difficult to unload.

Some time ago it was announced that the Club could not at present accept any applications for Junior membership with the expectation that they could be acted on at an early date. The condition has not improved to date and there is a long waiting list on hand with prospects rather dim for accepting any Juniors soon.

# Hui Nalus Win Macfarlane Memorial Canoe Races

Coach John D. Kaupiko's Hui Nalus won the Walter Macfarlane Memorial Canoe races Monday afternoon off Waikiki beach by outpaddling the Outrigger Canoe club, 37-34, in a thrilling meet.

Honolulu Police Department was third with 14 points. Others who followed in order were Outrigger Beach Service club, 5; McCabe, Hamilton and Renny, 2, and Waikiki Surf club, 1.

In the blue ribbon event of the afternoon, 4½ mile race, senior men, the Outrigger Canoe club maintained its winning streak of six in as many years by negotiating the distance in 34 minutes 10.1 seconds.

Hui Nalu's "Malolo" led until the end of the first lap, but was swamped at this point to be overhauled by the O.C.C.'s "Leilani," which led by a comfortable margin the remainder of the distance.

Waikiki Surf club's "Hanakeoki" hit the finish line before "Malolo," but was relegated to third spot owing to disqualification. Members of the winning crew were Tommy O'Brien, Bob Bush, Don Tobin, Jim Pflueger, Ken Chaney and Allan (Turkey) Love.

Outrigger Canoe club's "Kakina" came in second in the four man junior men's one turn race, but was scratched by the judges for bumping into Hui Nalu's entry on the outside turn.

Honolulu police department's "Leilani" was accorded second place. Hui Nalu's "Malolo" was first, the time being 8 minutes 3.4 seconds.

In the final event of the afternoon, the two canoe relay race, which proved to be most exciting, the Hui Nalu crew, some 15 lengths behind the Outrigger team, outpaddled its rivals on the final turn and crossed the finish line several lengths ahead.

In a special "mint julip" event for the visiting midshipmen, the Princeton crew hit the finish line first with a sudden, unexpected capsizing. Dartmouth Indians and the Yale Bulldogs finished second and third, respectively.

Judges of the meet were Herb Case, Vic Kahn and Babe Carter. Timers were Cecil Benny, Bob Corbaley, Buddy Ackerman and Barbara Corbaley. Carlos Rivas was the announcer.

Results follow:


