

## THE PRESIDENT COMMENTS

An increasing number of senior members have been complaining about the juniors taking over the Club and "getting in their hair." This has gone to the extent that several of the senior members are strongly advocating a closing out of all junior memberships. These members apparently fail to realize the place this Club holds as a community project. One of the prime purposes of the Club is the athletic development of the youth of the community It is true that the Club is probably a far cry from the original organization created for the sole purpose of canoeing, surf-riding and other related activities. However, we oldtimers who developed with the Club, know through our own experience that our Club fills a needed gap for a large segment of the youth of this Island which could not in any other way be filled. Therefore, it is essential that the junior and senior membership work together so that both classes of membership may obtain the most benefits possible from the use of the Club. Without question, a number of the juniors fail to realize the privileges being extended to them at the financial expense of the senior membership and their relative responsibilities in connection therewith.

As a step forward in working out this problem, the Club manager has been asked to organize Disciplinary Committees composed of junior girls and junior boys in order that they may work out (Continued on Page 6)



## OUTRIGGER CANOE CLUB FORTIETH ANNIVERSARY

Just forty years ago a group of young men in Honolulu planned and created a club at Waikiki Beach which later became known as the Outrigger Canoe Club. One of our very good friends, Mr. Charles Frazer, donated to the club documents, copies of which are printed below. They are very interesting and we know many of our members will appreciate the information given on the beginnings of the Club:

### Dear Sir:

Honolulu, April 7, 1908

Will you put before your members the project of the Outrigger Canoe and Surfboard Club at Waikiki.

We wish to have a place where surfboarding may be revived and those who live away from the waterfront may keep their surfboards.

The Club will own a certain number of canoes, while members will also have the privilege of keeping theirs under the broad lanai, of the club house.

It is probable that land for a Hau tree lana house will be secured at Waikiki on nominal rental. Many of the most prominent gentlemen in the city have already applied for membership in the Club. It has been suggested that those who join with privileges of entertaining or giving visitors cards to strangers pay annual dues of \$10.00 while young boys and actual surfers without privileges of extending courtesies of Club to friends and visitors, pay \$5.00 per annum. The main object of the Club being to give an added and permanent attraction to Hawaii and make Waikiki always the Home of the Surfer, with perhaps an annual Surfboard and Outrigger Canoe Carnival which will do much to spread abroad the attractions of Hawaii, the only islands in the world where men and boys ride upright upon the crests of the waves.

It was the intention of the founder of the Outrigger Canoe Club, A. H. Ford, that the peoples of the mauka lands would have a place to come and enjoy the beach at Waikiki and to keep alive the art of canoeing, surfboard riding, swimming and any other water sports.

(It started as an amatuer club with many of the prominent citizens and business houses donating money and gifts in its early life.)

During the life of this Club there have been many championship teams. It has sponsored men and women swimming teams that are the finest in the world an many of its members went to all parts o, the world. The Club has encouraged water polo teams, both men and women divers, basketball, soccer, American football, track, volleyball, Hawaiian canoe sailing and body surfing.

Starting out from grass shacks, this Club took part in many of Hawaii's parades, carnivals, water pageants and city functions. Notables from all over the world have been entertained on its grounds. Originally from the youth of the community, it evolved into a family club, passing along to an outstanding athletic club and one of the best social clubs of today.

From present indications it will again become one of the outstanding athletic clubs in this community.


## Juniors to Organize
