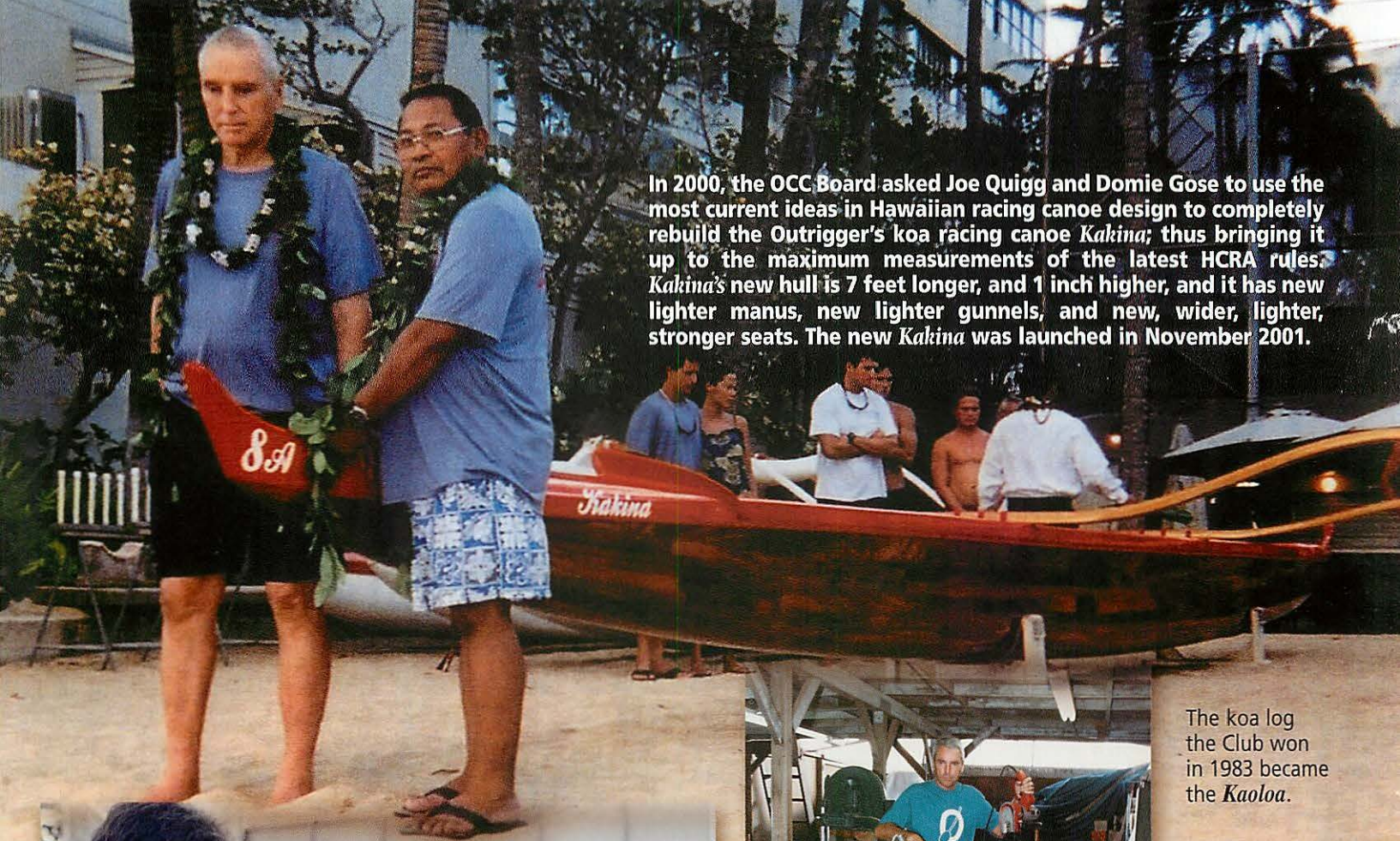

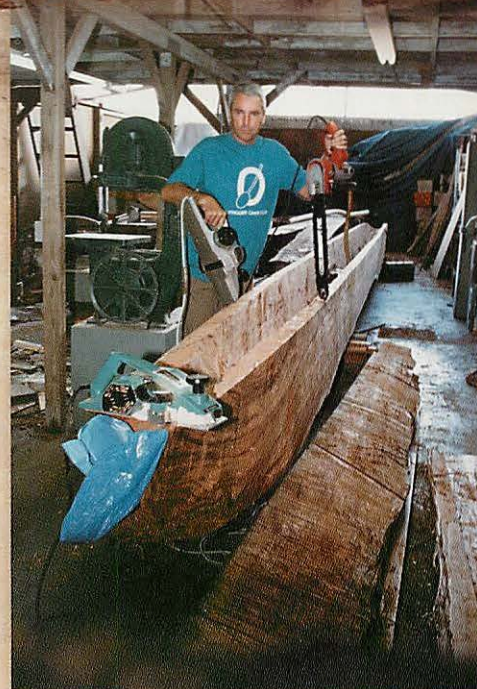

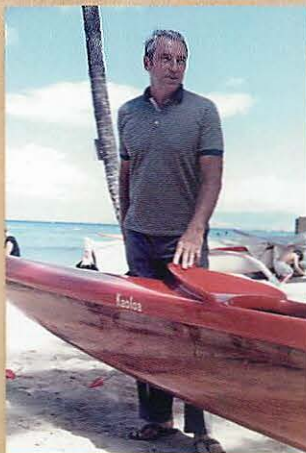
In 2000, the OCC Board asked Joe Quigg and Domie Gose to use the most current ideas in Hawaiian racing canoe design to completely rebuild the Outrigger's koa racing canoe *Kakina*; thus bringing it up to the maximum measurements of the latest HCRA rules. *Kakina's* new hull is 7 feet longer, and 1 inch higher, and it has new lighter manus, new lighter gunnels, and new, wider, lighter, stronger seats. The new *Kakina* was launched in November 2001.

JOE QUIGG SELECTED TO WINGED "O"

At the Outrigger Canoe Club annual meeting in February 2005, Joe Quigg was one of two members elected to the distinguished Winged "O" for his dedication to the Club's athletic program. Quigg has given his talents, prowess, time and loyalty to the Outrigger's water sports programs in keeping with the principles set forth by the Winged "O".

Joe has been a member of the OCC for 52 years. He has devoted his life to developing fast, light, efficient water sports equipment that has changed construction, shapes, and riding styles around the world, including surfboards, race-winning paddleboards, one-man canoes, catamarans, and Hawaiian racing canoes.

He has used his skills to help members of the Outrigger Canoe Club excel in their water sports competitions. It is for his painstaking endeavors to produce excellent equipment for the Club that Joe has received this prestigious award.

In the 1970s, Outrigger member Cline Mann asked Quigg to design and build a paddleboard that would help revive paddleboard racing. Quigg designed a 12-foot board. This length has endured and 12-foot boards are still used today in races throughout the islands, as well as internationally.

When the Tahitians came to Hawaii to compete in the Molokai Hoe Canoe Race in the 1970s, they brought with them their long, light Tahitian canoes. The Tahitian boats were considerably swifter than the Hawaiian canoes.

The Hawaiian Canoe Racing Association (HCRA) recognized that if they wanted outsiders to compete on an equal basis, they would have to revamp their rules.

In 1981, Outrigger Canoe Club's racing chairman Don Mailer asked Quigg for some sketches of a six-man canoe that would incorporate the most extreme limits of the newest HCRA rules for canoe design.

Quigg's design sketches prompted the Outrigger Board of Directors to have him make two, 12-foot canoe models, which were to be tested in the towing tanks at the Steven's Institute of Technology in Hoboken, NY. Jeff Kissel, Walter Guild and Joe Quigg took the two models to New York where they were towed and tested in the Institute's tanks.

After the tests at Stevens, the Outrigger asked Joe to completely remodel their fiberglass canoe *Mana Ula*, up to the maximum limits of the new HCRA rules. In the newly-remodeled *Mana Ula*, the same Outrigger crew that had just come in a distant fourth place in the Molokai race came in a full mile ahead of the next boat in the Lanikai race.

In 1983, the Outrigger Board of Directors

commissioned Quigg to remodel the Club's Koa canoe, *Leilani*. He added three feet to the *Leilani's* length, narrowed the canoe by two inches, constructed a new front manu, and installed new, lighter seats.

In August 1983, paddling the newly-remodeled *Leilani*, Outrigger paddlers won a Koa log for having accrued the highest points in the Oahu HCRA season. Also in the *Leilani*, in the 1984 Molokai Hoe, Outrigger's number one men's crew set a new record finishing time of 5 hours, 18 minutes and 29 seconds.

In 1983, the Fiberglass Shop began production of a new fiberglass Quigg canoe design, quite close to the new HCRA rule, though a little shorter and wider.

This fiberglass design played a significant role in the growth of canoe paddling. The first boat was christened the *Kai'o'ino*. The production model was labeled the Hawaiian Class Racer.

The Hawaiian Class Racer became the standard fiberglass canoe class for distance races, and clubs from around the world purchased them. Crews came to Hawaii to compete in the distance races, often borrowing a Hawaiian Class Racer, with the knowledge that the boat gave them an equal chance of winning.

Paddling the Hawaiian Class Racers, Outrigger senior men won the Molokai Hoe races in 1986 and 1987, and in 1988 they set a new record. In 1992, Outrigger's women came in first paddling the Hawaiian Class Racer *Iwalani*, beating the four time winners from California's Offshore Canoe Club, and bringing the women's Molokai Hoe trophy back home.

In these three Quigg designs, the *Mana Ula*, the *Leilani*, and the Hawaiian Class Racer, OCC paddlers won an all-time number of gold medals and regattas.

In January 1985, the Outrigger Board of Directors commissioned Joe to design and build a canoe from the Koa log the Club had won in 1983. Quigg built the *Kaoloa*, and the new canoe was launched in July 1986.

In *Kaoloa's* first season, Outrigger teams paddled and won the State Championship Canoe Regatta in Hilo. In the 1990 Molokai Hoe, paddling the *Kaoloa*, Outrigger's senior men finished first overall, even beating the livelier fiberglass canoes.

Joe Quigg feels he has been extremely fortunate to have had so many outstanding paddlers who were so eager to paddle his designs. Joe credits the Outrigger athletes for bringing such glory to his efforts. He is very grateful for receiving the Winged "O" award.

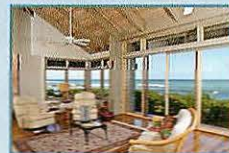

Keiki Carnival Saturday, June 18



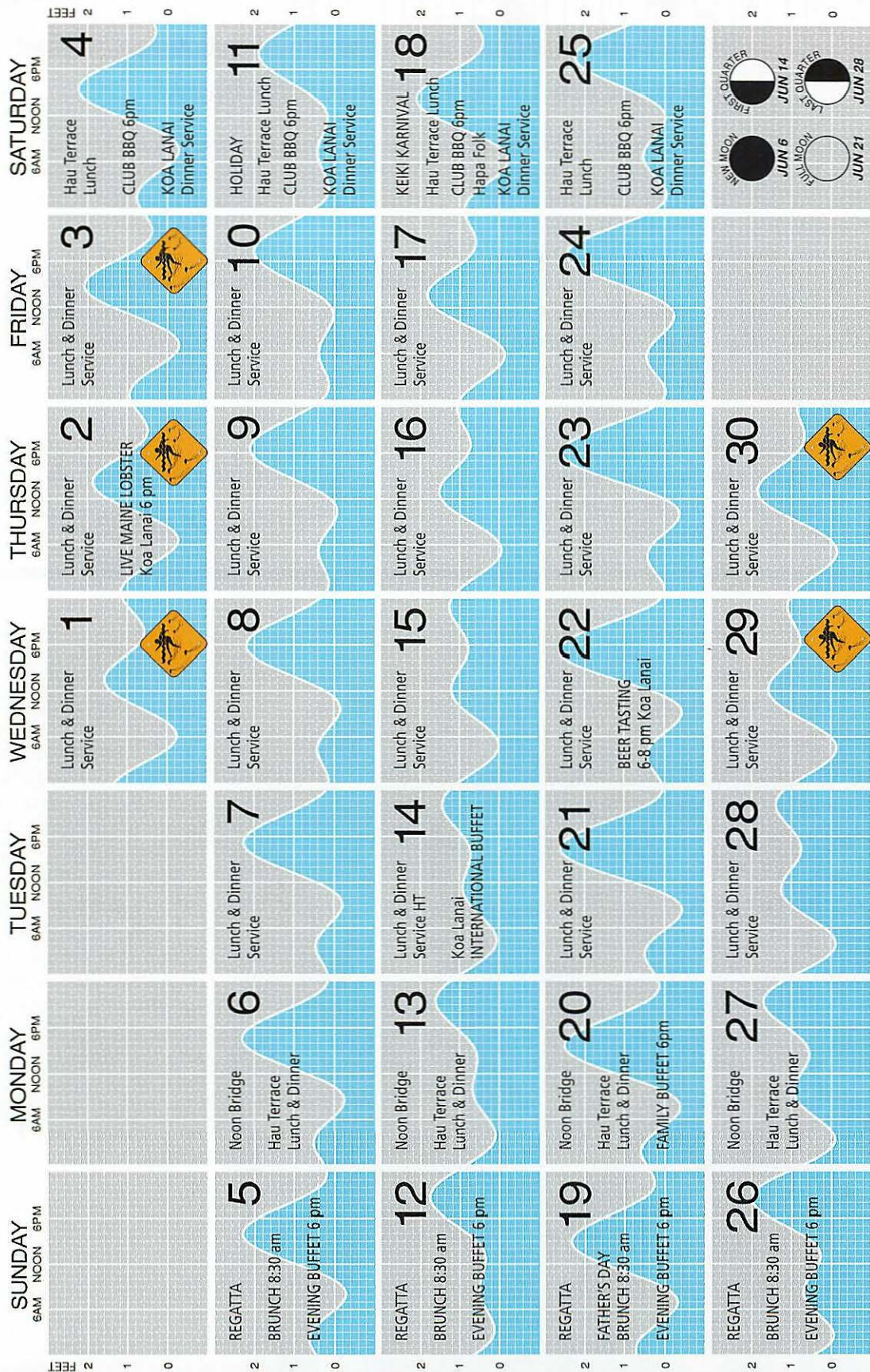

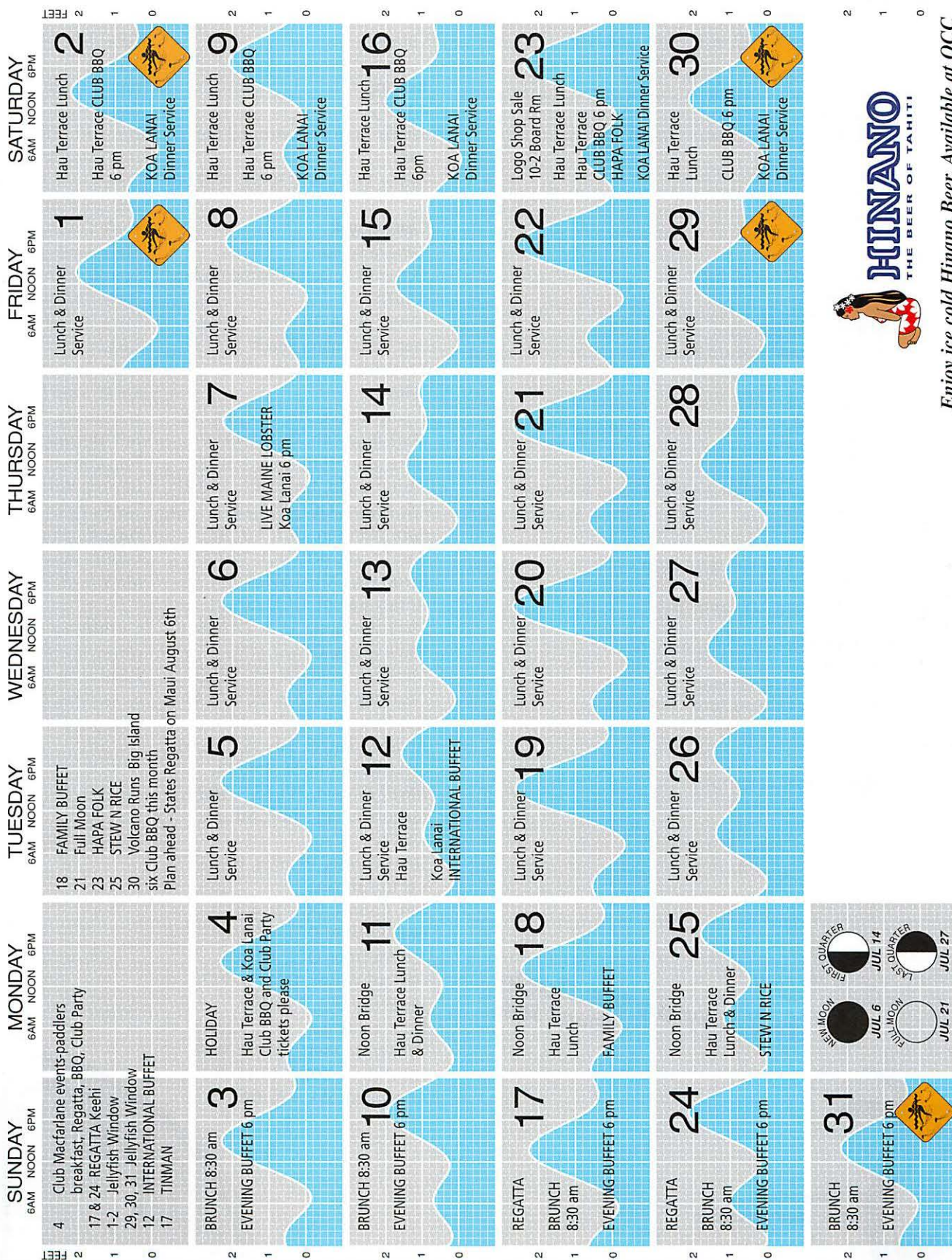

'Riggers Do Basic Handgun Training on Molokai

After a day of live-fire training on the range, everyone enjoys the beauty and comfort of the ranch. In late January, a group of Outrigger members flew to Molokai, not to paddle but to do some shooting at Kimo Austin's ranch.

Jimmy Austin, Jenifer Bossert, Byron Ho, Anthony Hunt, Mike Kane, Sean Monahan, Mike Nakano, and Karel Tresnak Jr. had approached Chris Kincaid to teach them the fundamentals of using a handgun for self defense.

Kincaid, and childhood friend, Joe Golonka, a certified National Rifle Association instructor, agreed to organize a three-day seminar in proper firearms handling skills for home defense, self defense, and certification. The seminar included a day of lectures and discussions covering safety and legal issues, as well as taking a written NRA test.

Both Kincaid and Golonka have extensive training in handling shotguns, rifles, and handguns, and have traveled to training facilities across the country to acquire skills. Both have expert rankings and are certified in different weapon systems.

The participants learned that using a handgun for protection and defense is not like the movies where every shot you take is a hit, no blood gets on you, there are no post-psychological issues, and you go to bed at night a hero.

The instructors stressed that becoming competent takes training, and more importantly, there are many moral, ethical, criminal, and civil issues involved.

The group then set up a range in an open field on the mauka side of the property, and endured the Molokai heat for two days of live-fire training. Kincaid and Golonka ran the participants through a series of drills and tactical scenarios culminating in a skills test for speed and accuracy on the last day.

Everyone passed the test and everyone got certified, but the highest points were scored by Nakano, who was officially dubbed "Top Gun" for his achievement.

The entire weekend was not just devoted to firearms training. Some got up early to hunt, while others simply enjoyed the rugged beauty and serenity of Molokai. But the experience taught all the participants the value in the proper use of handling a firearm, and everyone expressed an interest in continued training.

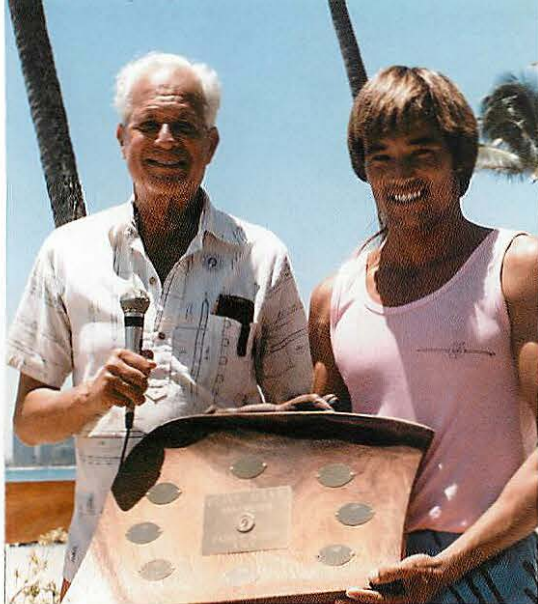

JOHN CLINE MANN & the Kapua Channel

The Cline Mann Memorial Paddleboard Race is scheduled for Saturday, July 9 from the Makai Pier to the Outrigger Canoe Club. Many may wonder who John Cline Mann was.

Oldtimers know, but younger members, Nonresidents, and our Junior 'Riggers probably do not. His picture is in the Ka Mo'i Lounge, and it would be real easy to dismiss this as some old timer who drank Budweiser. Well he was, and he did, but there is more to what he represents for Outrigger that is memorable.

Born January 11, 1923, he died September 16, 1996, at the age of 73. He was a Life Member of the Club, a member of the Winged "O", instrumental in starting the paddleboard race that was later named for him, a former member of the Board of Directors, and one time President of the Club.

Cline was responsible for reviving paddleboard racing in Hawaii. He instigated the design for the 12-foot paddleboard that is most often used in today's paddleboard races, and as chairman of the Paddleboard Committee, scheduled and directed three paddleboard races each year: the Summer Surf Race in June, the 5K in August, and the Winter 10K each December.

He never missed a race. He set the turn buoys early in the morning, so he could be on the beach by check in time to lend his encouragement to the participants. He hand drew a map of the course which he clearly described before the race started. He insisted on a photograph before the start of the race, with the boards on their tails pointing toward the sky. Then, with megaphone in hand, he started the race.

At the end of the course, he stood in the water, welcoming each paddle boarder back onto the beach, signaling to the timers each participant's official finish. After giving out awards to the winners, he joined them on the Terrace to talk story and enjoy a "cool one" with his friends.

In the early years, the race participants were mostly Outrigger members and lifeguards. Today, it is not unusual for more than 100 people to enter. In addition to the three paddleboard races that Outrigger sponsors, Cline's influence has been felt and there are other paddleboard races around the island.

At his death, monetary donations to the Outrigger Duke Kahanamoku Foundation provided for a fund designated for water sports. His sister, nieces and nephews are still members of the Club. His father was also a former President of the Club.

Cline was an engineer and a surveyor, and what he knew about our present OCC Club site is probably not equaled by any other member previously or subsequently. The information that follows was taken from an Oral History Cline gave in 1982 to the Historical Committee.

Did you know the Channel in front of the Club out towards the wind sock has a name? Read on.

Cline joined the OCC in 1946. Active in many committees, he was Board Secretary and chair of the 1962 Planning Committee, responsible for entering into a 99-year lease with the Elks Club that got us to the Kapua Channel, site of our present "new" Club.

This committee was instructed to get the OCC moved out of the Waikiki old Club and into the new Club site in time for the 1963 Christmas party.

The Club is situated on the land of Kapua which is a large sand dune extending on the north from the Kaimana Hotel, on the south to Coconut Avenue, and to the limestone cliffs where the old heiau is, at the La Pietra boundary at the end of Kapiolani Park.

All of this sand is below a foot and a half layer of dirt, and OCC ended up with 11,000 cubic yards of beautiful beach sand from the excavation of the property at Kapua.

When it rains heavily, water pools in Kapiolani Park. This is due to an old water course that opened up the reef and the lagoon. This is currently known as the Sans Souci lagoon and channel. On ancient maps this was called the Kapua Entrance.

When fresh water exits you have a channel because coral cannot grow in fresh water. Cline knew this would give us a good beach and easy access to the open ocean.

At 2909 Kalakaua Avenue, every single tree except the Monkeypod tree on the left hand side of the entry driveway was removed. On April 1, 1963, the Club was a one tree site. And, of course, they held a party first, so members could come and park on the cleared site under a tent, have refreshments, see the surf and canoes in the Kapua Channel and have a good idea what would be there at Christmas.

In a timetable which could never happen in current time, a building and fully landscaped yard was created in less than a year.

The conventional way of planting a coconut tree is to put in a 3 to 4 foot sprouted coconut in the ground and wait 25 years. In order to make our Club looked lived in, they brought in tall coconuts, 80 of them, creating a Clubhouse in the middle of a coconut grove.

Hau trees were transplanted in "slip" form from a member's home on Round Top Drive. These were called "Cline's Folly" because it took them five months to get any leaves. They created the Hau Terrace as we now know it.

It seemed like building and landscaping and decorating all occurred simultaneously instead of sequentially. The furniture came in September both from San Francisco and the Orient, on two freighters that arrived in Honolulu a day apart. The contractor was instructed to bring everything to the partially completed Club Dining Room, and assemble everything on site.

The Kitchen was in, the Bar was substantially complete, and the Christmas party was on, drinks and pupu at the new Club for Christmas. On New Year's Eve 1963, the old Club had fireworks and everybody said aloha to the Waikiki site. The first week of January 1964 the Club officially moved from one site to the other and the Club site we are now on was open to the members.

Thanks to Cline Mann.

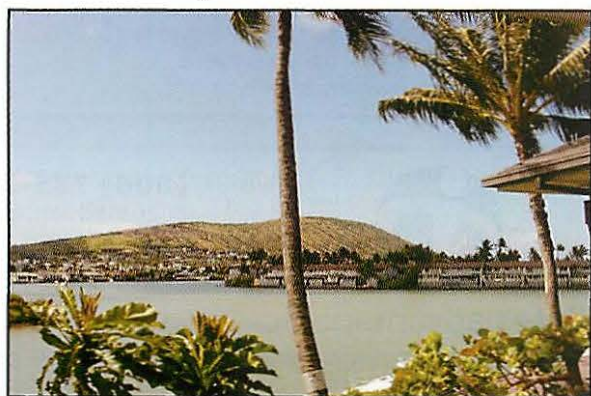

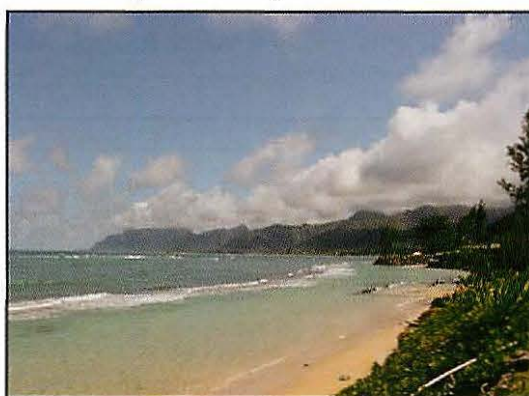

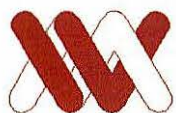

Backward Glances

51 Years Ago 1954

Samuel M. Fuller, President

Early this month the surf addicts were treated to exceptional surfing. Only the most expert surfers dared the First Break which was reported by some to be from 40 to 50 feet high.

Kamehameha Day races at Pokai Bay, Waianae, were marred by heavy surf that resulted in several swampings and fouls. The event was a clean sweep for the Waikiki Surf Club with 39 team points; Hui Nalu, 26; Hui Kalia, 12; Outrigger, 7; Healani and Kai Oni—a newcomer to the racing scene—at 5; Koolaupoko, 2; and Lanikai, another newcomer, at 1.

"Scoop" Tsuzuki, OCC photographer who took the Makaha surfing pictures featured on the *Star Bulletin's* front page, received an honorable mention award from *Look* magazine for the best sports photos of 1953.

The award was for meeting the "highest standards of pictorial journalism" "Scoop" took the pictures with a Graflex from the edge of the coral reef at Makaha where surfers braved 23-foot waves.

Herbert M. Dowsett of Lanikai invited a group of old time sports followers to the re-launching of the famed and historic canoe the *A*. The canoe, 39 feet 9 inches in length, was claimed to have been the most perfectly built and fastest racing canoe in Hawaii, and was owed and raced by Prince Kuhio Kalaniana'ole. *A* is an Hawaiian word meaning "the great black bird with white feathers"; also, "jawbone." For many years the *A* lay in OCC's canoe shed and was removed in 1931 to the Bishop Museum where it was displayed until May 1952.

Mr. Dowsett made a deal with the Museum to replace the *A* with a canoe in good condition. After two months of arduous labor by Dowsett and a cabinet maker, Kiyoshi Tsumura, the canoe was restored to its original beauty.

The launching was made by the young members of the Lanikai Association. Several races were held with oldtimers manning the *A* and Lanikai Club members manning another great canoe of Mr. Dowsett's, the *Manu Keokeo*. Oldtimers who raced in the *A* were Zen Groves and Toots Minville, stroke; Dad Center, Francis Bowers, Knute Cottrell, Gay Harris, Wilbur McCraw, Lex Brodie, Ernest Cooke; and Edric Cooke, steering.

38 Years Ago 1967

Thomas M. Arnott, President

The Junior Athletic Summer Program started with Dave Pierson as our program director. Assisting Dave were Butch Hemmings, Mark Buck and Thomas Holmes.

New athletic facilities were installed to prove athletic prowess. A rope for climbing was placed in the corner of the volleyball court, and a basketball backboard was mounted on the backside of the volleyball bleachers to improve members' shooting skills.

OCC did well in the Kamehameha Day Races considering we entered six of 12 scheduled events. The Boys 14 broke the existing record with a time of 1:55.2 in the quarter-mile event. The Boys 16 broke another record by bringing the *Leilani* over the finish line in 4:57.6 in the half mile event.

The weather almost got the event just as it did last year, but not quite. The action was great and just about everyone got into the act one way or another.

31 Years Ago

1974 Peter A. Balding, President

The Club's women swimmers were honored in a trophy case display of photos, medals and awards for aquatic events dating back to the 1920's.

OCC members were asked to help the Club expand the record of its past and present history by donating old and new photos of canoe races, volleyball, special Club events, distinguished members and guests. Donors were given signed receipts, and other gifts were catalogued and safely stored. Photos will be displayed at appropriate times.

Charlie "Iron Man" Martin and several other Club parents have bridged the generation gap that typifies the father-and-son/daughter tradition of the Outrigger. Charlie's four kids are on many of our younger canoe crews and like Dad, they are all inclined toward steering. They are son, Chad Martin, and daughters, Charlie, Allison and Leslie Martin. So the paddling tradition is alive and well at OCC.

The 1974 canoe racing season got underway on June 2 hosted by the Makaha Canoe Club. Like most season openers, technical errors plagued many of our new crews and some of the seasoned ones as well.

The women's sophomore crew was OCC's only first place winner; a strong team with veteran paddlers and steered by Heidi Hemmings. Because of newly formed age group paddling for women, paddlers who had previously paddled in higher ranked races were allowed to come back down in classification.

The Makaha Regatta winner with 78 points was the Healani Canoe Club which won 12 out of 20 events. Lanikai was second with 51; followed by Hui Nalu, 31; Outrigger, 24; Waikiki Surf Club, 19; Makaha, 17; and Leeward Kai, 2.

OCC's 1974 Surfing Championships, a two-day event, were held in three to four foot surf in front of the Club. Meet Co-Chairmen John McMahon and Bruce Ames directed the smooth-running contest in which more than 100 Club surfers participated.

A new event was the Tandem won by Fred Hemmings and Leslie Keith. Also included was an event last run in 1910; Canoe Surfing for three people two men and one woman. Ten different teams participated and winning first place was Fred Hemmings, steersman; with Eduardo Arena, a member of Club Waikiki, Lima, Peru, and OCC paddler Eva Segovia.

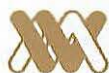

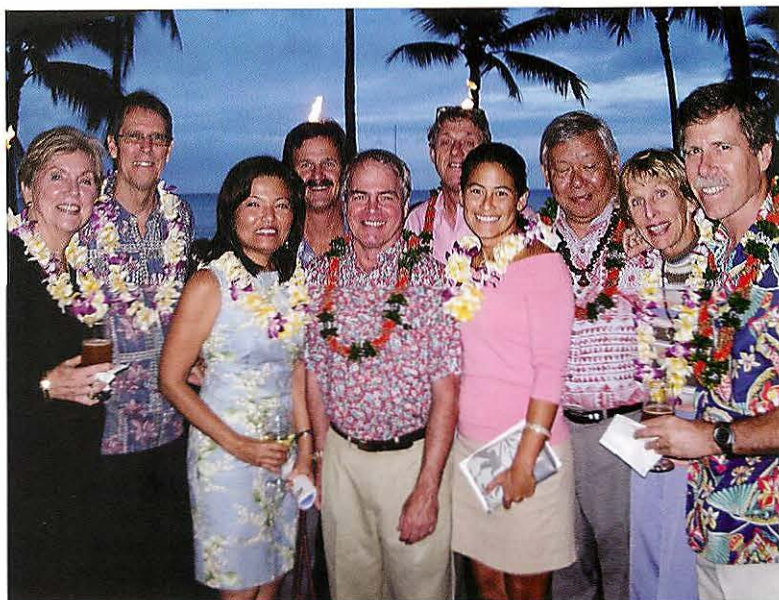
Some lucky attendees went home with some very special treasures from the live and silent auction. Fray Heath bought a beautiful, classic Kamaka ukulele!

Standing Committees

The Board approved the following additions and the Finance Committee roster for the 2005-2006 committee year: Building & Grounds: Kathy Merrill; Entertainment: Hilary Lambert; Finance: Bradley Tothorow, Chair; Joanie Shibuya, Gregg Robertson, Hal Henderson, Peter Ehrman, Michael Hicks, J. Gordon Beaton, Matthew Haley, Kalani Schrader; House: Joey Cabell, Ray Robinson; Public Relations: Jeff Davis.

A& M Report

The Membership Count was 4,799 as of March 31, 2005.

Secretary's Report

Six members were suspended for 15 days due to their account being delinquent for a third time in a twelve month period.

Nonresident Membership

The Board approved a committee recommendation to allow minors (10 thru 17 years of age) to apply for Nonresident membership.

Fitness Center Enclosure

The Board approved a recommendation not to pursue enclosure of the Fitness Center at this time. However, the issue may be revisited at a later date.

Reciprocal Privileges

The Board approved the motion to suspend reciprocal club privileges of any Outrigger Canoe Club member that violates another club's house rules. Mr. Comstock will draft the language to be used in the Board policy.

President's Portraits

The Board approved the Historical Committee's proposal to reduce the size of the Club President's portraits currently hanging in the Board Room to accommodate future portraits. The Historical Committee presented two options and the Board will allow the

committee to choose between the two. As there is no budget for this project, Mr. Comstock will submit costs for inclusion in next year's budget.

Articles for General Press

In light of the Club's upcoming centennial anniversary, articles about the Club's strong athletic tradition/history might be of interest to the general public. Discussion followed. It was decided that as long as the objective/intent is clear and the articles are reviewed before submission for publication by both the Public Relations and Executive Committees, the committee can proceed.

ODKF

The ODKF fundraiser on April 7 was well attended (about 150 – 200) and enjoyed by all who attended. The event raised about \$45,000. Mr. Bryan asked for clarification about ODKF's "ads" in the Club's magazine. Space is allotted, at no charge to ODKF, if there is space available.

Manager's Report

Overall, March was a good month financially. Sales in the Koa Lanai, Hau Terrace and Ka Moi Lounge were all over budget. This was in spite of poor weather over Spring Break which explains the shortfall in the Snack Shop. Cost issues continue to concern. New menus have or will be in place by mid-May and this should alleviate this issue. Beverage prices will be raised before the onset of summer. Monthly menus in the Koa Lanai aid in keeping costs in line. A new menu will be in place in the Snack Shop prior to the summer season. Labor costs continue to be a focus of management.

Locker room work has been completed. We have just received the final design of the Snack Shop beam and cosmetic details. We are waiting to hear if the welding company can fabricate and install the beam prior to Memorial Day; or, we will wait until September to install. The ramp from the Lobby to the dining areas will be installed after the busy summer season.

A permit for the wave deflector is being sought from the City on the premise that this minor project does not require State shoreline certification. Mr. Comstock indicated that we will need to settle the certification issue before any major projects may be undertaken in the future.
