



OCC's Executive Sous Chef Arnaud Jager thrilled members at his quarterly cooking class on April 19 as he showed them how to prepare Crab Cakes with Aioli and Petit Pot de Creme.

As usual, Arnaud made it look easy and members came away confident that they could create the dishes at home. Here are the recipes if you'd like to try.

As you can tell from the happy faces, everything tasted as good as it looked.

### Crab Cakes

#### Crab cake ingredients:

1 cup finely chopped red onion

1/2 cup finely chopped celery

1/2 cup seeded and finely chopped red bell pepper

1/2 cup seeded and finely chopped green bell pepper Salt

Cayenne pepper

1 Tbsp. chopped garlic

1 lb. lump crab meat

1/4 cup chopped green onion

1 Tbsp. chopped ginger

1 tsp. chopped lime leaf

2 Tbsp. chopped parsley

1/2 cup mayonnaise

1 Tbsp. Dijon mustard

3/4 cup panko (Japanese bread crumbs)

## Crab cake coating:

All purpose flour

2 eggs mix with 2 Tbsp. water

Panko

In a large bowl, combine all the crab cake ingredients and mix well. Divide the mixture into 10 equal portions and from them into 1 inches thick patties. Place some flour in a plate. Mix the eggs with the water. Place the panko on a plate.

Heat the oil in a large sauté pan over a medium-high heat. Dredge the cakes first in flour, tapping off the excess, then in the egg wash, letting the excess drip off. Dredge the cakes in panko, coating them evenly. Gently lay the cakes in the oil & fry until lightly golden brown, about 4 minutes.

Drain the cakes on a paper towels

#### Aioli:

2 egg volks


4 cloves garlic, chopped

3-5 tsp. lemon juice

1 cup olive oil

Place the egg yolks, garlic and 3 tsp lemon juice in a food processor & mix until light and creamy. Add the oil very slowly. Season and add the remaining lemon juice and a little water if necessary.





# PETITS POTS DE CREME

3-1/2 cups milk

1 vanilla bean

6 egg yolks

2 eggs

3/4 cup superfine sugar

Preheat the oven to 300 degrees. Put the milk in a saucepan. Split the vanilla bean in two, scrape out the seeds and add the bean and seeds to the milk. Bring milk just to a boil.

Mix together the egg yolks, egg and sugar. Pour the milk over the egg mixture and mix well. Skim off the surface to remove any foam.

Ladle the mixture into four ramekin and place in a roasting pan. Pour enough hot water into the pan to come halfway up the sides of the

Bake for 30 minutes or until the custards are firm to the touch. Allow the ramekins to cool on a wire rack, then refrigerate until ready to serve

For chocolate pots, add 1 Tbsp of cocoa and 1/3 cup melted dark chocolate instead of the vanilla bean

For coffee pots, add 1 tbsp of instant coffee.





# Stew-Rice Night Monday, June 9 OCC's Cobey Black - A "Massie Case" Authority

A Honolulu editorial writer said of the Massie Case, in 1932, that it "has plagued Hawaii as no other event in the history of these Islands . . . has brought in its wake one terrible event after another . . . sowed the seeds of hate and distrust . . . threatened the very foundations of government with destruction by the wave of prejudice and passion that has been aroused among people thousands of miles away who do not understand our problems but still hold our fate in their hands.

"It will plague us from now until the end of time unless the complete truth is unfolded and justice is done."

Did the complete truth emerge? Was justice done?

Journalist-author Cobey Black, in *Hawaii* Scandal (Island Heritage, 2002), chronicles the actual events of Hawaii's most shameful and far-reaching case. Her sources included

government documents, trial transcripts, Territorial records, medical and police reports, diaries, contemporary magazine and newspaper articles, letters, and personal interviews.

Her connection to the case began as a child in Washington, D.C. and continued decades later when she moved to Honolulu. Amazingly, facts about the case continue to unfold. Her presentation will allow for a question and answer session.

#### **Fitness Center**

Chair Phil Whitney, OCC staff Rod Ussing and their committee members reviewed usage of the facility during the past two years. The average number of "sign-ins" per day has increased approximately 60% and the number of visits per month by members has increased to over 2,000. Members using the Fitness Center are encouraged to sign-in so the new facility can be designed to accommodate the actual demand.

**Beach & Water Safety** 

Chair Rick Hobson, OCC staff Don Isaacs and their committee members introduced Sunday morning outrigger canoe rides for members and guests in April. This new program provides certified steersman to accompany members not enrolled in the paddling program to experience the essence of the Outrigger Canoe Club. Members interested in this activity should contact Director of Beach Services, Don Isaacs or the Beach Attendant on duty for additional information.

**Coaching Handbooks** 

The Board of Directors approved a Coaching Handbook for our athletic programs. This handbook provides guidelines adopted from the Positive Coaching Alliance. The general intent of the handbook is to improve the

athletic experiences of our members by improving the quality of our coaching. Copies of this handbook are available in the Executive Office.

**Canoe Racing** 

Chair Courtney Seto and committee members have re-organized the paddling program for this season. Regatta Head Coach Anthony Hunt and Youth Head Coach Keoni Kino conducted a pre-season coaches meeting and provided a letter to the parents of all registered junior paddlers.

The purpose of the Parent Letter was to explain the mission and goals of the youth paddling program and to define the protocol for resolving concerns about their child's paddling experiences during the season. Volunteers from the committee refurbished the training canoes for the season in an attempt to reduce maintenance costs. The *Iwalani* has been sold to another canoe club.

OC-1/Kayak

Chair Susan Brown and Walter Guild have been working with General Manager Rick Lee to improve the availability of surfboard and boat lockers for members that are actively using their watercraft. Walter has been conducting thrice-weekly morning training sessions for one-man paddlers since December. These session support members who are new to one-man training as well as the elite paddlers preparing for the crossing of the Kaiwi Channel during the World Championships.

# Cline Mann Koʻolaupoko Paddleboard Race, June 28

The Outrigger Canoe Club will host the 2003 Cline Mann Ko'olaupoko Paddleboard Race Saturday, June 28. Attracting Hawaii's best ocean paddlers, this annual event consists of a spectacular 17-mile open-ocean paddleboard race from Makai Pier in Waimanalo to the Outrigger Canoe Club in Waikiki.

The race is held in commemoration of the late Cline Mann, one of Outrigger's most distinguished and beloved members who was an invaluable supporter of Hawaiian ocean sports.

As Hawaii's only "Lighthouse to Lighthouse" race, this challenging course serves as a fantastic warm up for the prestigious Quiksilver Edition Molokai to Oahu World Championship paddleboard race scheduled for July 27.

# **OCC Members Dominate the Kanaka Ikaika Series**

Congratulations to OCC members for an outstanding performance in the 2003 Kanaka Ikaika OC-1 and Surfski season. Approximately 25 OCC members entered each race with the largest turnout for the Hawaii Kai races which ended in our own backvard.

Karel Tresnak Jr. dominated the OC-1 long course division, winning six out of seven races going into the state championships, pushed by OCC member Mike Judd who often finished a close second.

In the regular season Surfski division, Steve Kelly won all but one race that he entered, finishing behind OCC members Mike Beyers, Sean Monahan and Tom Allen. Paula Crabb continued to be a strong challenger in the women's OC-1 long course division, and Mary Smolenski was a standout in the Surfski division.

On the OC-2, Kisi Haine and Ann Marie Mizuno proved a duo to contend with, winning all races entered. In the short course Surfski division, Allan Dowsett finished the regular season undefeated, while Novice B OC-1 paddler Will Estes battled for a top three finish each race.

Howling winds and a substantial south swell made for epic conditions in the State Championship Race. In keeping with tradition, OCC paddlers dominated both the long (23 miles from Makai Pier to Sand Island) and short course (15 miles from Hawaii Kai to Sand Island).

Karel Tresnak Jr. and Mike Judd took first and second in the OC-1 long course division; also placing in the top ten were Mark Rigg, sixth and Walter Guild, ninth. Rounding out the top 20 were Tapa Worthington, Jimmy Austin, Bill Pratt, Ian Forrester, and Eric Levora.

OCC Surfski paddlers swept the long course division with Sean Monahan, Mike Beyer, Steve Kelly and Tim Twigg-Smith placing first, second, fourth and fifth, respectively. Sue Brown and Mary Smolenski finished first and third for the women.

Todd Bradley, Marc Haine, Tom Conner and Paki Vaughan battled in the short course, finishing a close second, third, fourth and sixth overall. Also in the OC-1 division, Gaylord Wilcox and Tay Perry finished first and third in their age division. Paula Crabb won the women's OC-1 short course and Allan Dowsett remained undefeated in the Surfski short course.



# **A Tradition of Excellence**

The article entitled, Filling the Emotional Tank, in the April issue of this magazine, introduced the topic of the "athletic culture" at the Outrigger Canoe Club. The Positive Coaching Alliance emphasizes the importance of defining the team culture because it clarifies "the way things are done in our athletic program."

The Board of Directors reinforced this philosophy in March when they requested a mission statement from each of our athletic programs. A clear mission statement reminds our members about the purpose of our athletic programs.

In its Roadmap to Excellence, the Positive Coaching Alliance emphasizes the importance of a mission statement for the following reasons:

· Defines core values of the organization.

· Guides in solving problems that are difficult or ambiguous.

Encourages focused communication between coaches, athletes and parents.

• Creates a system of accountability for all members of the organization.

The purpose of the Athletic Committee as defined by our Charter is to "promote athletic [water] sports and activities in all their forms and branches, the cultivation of social intercourse among its members, and the advancement of learning of arts and sciences."

The Board of Directors further defined the mission of the athletic programs to "promote sports history, traditions, and skills as well as maintain competitive training programs for members in all age groups." This statement precipitated a

discussion among our members regarding the meaning of "competitive training" programs as it relates to "our tradition of excellence."

The essence of the debate on this issue was distilled down to two opposing viewpoints; participation verses competition. The consensus among the members of the Athletic Committee and the Board of Directors was:

• to emphasize the *participation* of the maximum number of Club members for team sports events held on the island of Oahu and

 to emphasize the competitiveness of elite teams/crews in major state, national or international events.

The mandate for the Athletic Committee is to create and maintain an organization of volunteers that remain committed to the mission of our athletic programs. Therefore, our primary focus at this time is to improve the quality of our youth sports programs because these young athletes will provide the pool for our elite teams/crews in the future.

The athletic programs that support youth teams/crews will be focusing on the following PCA recommended areas:

• Coach recruitment - Individuals that support the positive coaching philosophy will be actively recruited as youth coaches.

• Coach development - Enthusiastic volunteers will be supported with coaching workshops and technique clinics.

 Recognition - Coaches and athletes that perpetuate the athletic culture will be acknowledged on an annual basis.

Parent expectations - Youth coaches will communicate with parents via
meetings and letters to explain the goals of the athletic program, define the criteria for team/crew selection, outline a process for conflict resolution and
remind parents about the philosophy of "double-goal" coaching.

The PCA also introduced the concept of "culture keepers" during our Coaching Workshop last November. A culture keeper can be anyone in the organization that reminds a coach, athlete or parent about "the way we do things at Outrigger" whenever inappropriate behavior makes it necessary.

The Outrigger Canoe Club also has a unique group of "culture keepers" for our athletic programs. The members of the Winged "O" have been selected for their outstanding performance in athletic competition and for their service to the Club on committees, and as officers and as coaches for a period of at least 10 years.

This auspicious group of men and women, along with their teammates and coaches and the generous support of our membership, created our *tradition of excellence* in athletics.

Andrea Mead Lawrence, the first U.S. alpine skier to win two gold medals in a single Olympics said, "Competition can be a very intense experience and a very rewarding one, or it can be enormously destructive. External pressure, whether it's exerted by a coach, a school, a [sports] club, or a country, is what can make it a negative thing.

When they use you to satisfy their need to succeed, when they impose their value system on you, then competition isn't personally rewarding anymore.... You're either a winner or a loser.... There's no way in my mind that you can divide humanity into those two categories.

Members of the Outrigger Canoe Club can take pride in our athletic culture and the pervading philosophy that promotes mastery of the sport over winning at all costs. This summer, when you are dining on the Hau Terrace, sometimes long after the sun has set, watch our paddlers carry our canoes up from the beach and set them carefully onto the sand, then listen as they join hands and softly say, "Outrigger."

This ritual is conducted after every practice and before every competition. It is intended to honor those athletes that came before us and to remind us that we are responsible for perpetuating the tradition of excellence that makes us, "Outrigger."

# **Living Treasures**

The Outrigger Canoe Club is rich with a diversity of members, each one having a special story of their own. Not all members are participants in the daily athletic activities of the club and may just go unnoticed as they sit alone quietly in a corner reading a book or having lunch.

It's easy to keep the lines of separation that so easily can define us. I challenge you to walk a different path, share the sunset on the Terrace with a complete stranger, and enjoy what all of the members have to offer. Therefore, I'd like to share with you one of the many Outrigger Canoe

Club's Living Treasures.

Jean Erdman is one of the foremost choreographers of the 20th century. She had also been an innovator and ground-breaker in her work as a dancer and director. She left Hawaii in her senior year for boarding school in Massachusetts then went on to Sarah Lawrence College where she majored in dance. That is where she met Martha Graham and eventually joined her company.

As a contemporary dancer she wanted to create and dance her own works and eventually decided to leave Graham's company four and a half years later. Miss Erdman and her late husband Joseph Campbell (American

writer on mythology and comparative religion) spent most of their summers in Woodstock where she created some of her early works including "Transformation of Medusa" and "Hamadryad".

In 1955 she made a solo world tour, the first by an American dancer. In 1962 she developed a revolutionary theater piece combining elements from all performing arts, an approach that was to become known as "total theatre". This piece, "The Coach with the Six Insides", first won the Vernon Rice and Obie awards and then toured the US, Europe, Canada, and Japan.

In 1972 she and husband founded the Theater of the Open Eye directing numerous total theater works. She has been artist-in-residence at arts festivals in Vancouver, Tokyo, Los Angeles, San Francisco and Boulder, Colorado.

She has choreographed Satre's "The Flies", Giraudoux's "The Enchanted", the Repertory Theatre of Lincoln Center production of "Yerma" at the Vivian Beaumont Theatre, and the New York Shakespeare Festival production of "Two Gentlemen of Verona" in Central Park and later on Broadway, for which she received the Drama Desk award and a Tony nomination for outstanding choreography.

# **Keeping Track of Box Jellyfish Invasions**

The box jellyfish (Carybdea alata) invasion is unique to Hawaii. Hawaii is the only place in the world where the box jellyfish have a fixed scheduled appearance on our leeward beaches. True fact.

Native to the islands, or it may have been brought here accidentally, it was first noted in 1906. Nobody paid much attention to them until the late 1980's when we seem to have them showing up repeatedly, and in masses.

Lifeguards and swimmers noted that they were appearing nine or 10 days regularly after the full moon. Supposedly they gather together on this lunar cycle to spawn. Why here and no place else? A mystery.

The stings hurt, but are not usually fatal, and the symptoms of nausea,

dizziness, and skin irritation vary among individuals.

The best medicine is avoidance, which is why we print the jellyfish window in the calendar. You should avoid early morning swims or paddles during those three days, because they seem to be "thicker" in the morning than in the afternoon.

Treatment is vinegar which will inactivate the stinging cells on the skin. Meat tenderizer, which works for the Portuguese man-o-war stings, does not work with box jellyfish stings. And, with both types of stings, urine does not work.

Depending upon your reaction, and experience, either ice or heat may help. When in doubt, or if really suffering, call 911 and get some help right away.

Keeping track of the jellyfish window can help you better plan or enjoy the Club's water sport activities.





# **Backward Glances**

#### 45 Years Ago 1958 Ronald O. Smith, President

The Board of Directors announced effective June 1 Senior and Term members were to be assessed \$2.50 per month or the purpose of paying for the new building and facilities at the Elks Club site.

Outrigger won the Kamehameha Day Regatta held June 12 at Keehi Lagoon. Out of 10 events, OCC entered seven and garnered 26 points against second place Kai Oni's 23 points and Waikiki Surf's 21 points.

OCC's Mountain ball team placed third in the final standings of the City Businessmen's League's 1958 season following the round robin championship series. Champion was the R. M. Towill squad with nine wins and no defeats; Belt, Collins & Associates, second, 6-3; OCC, third, 5-4. OCC was lead by player-coach Bill "Whiskey" Barnhart.

Top Club batters were Bob Clarke, .500; Jim Hutchinson, .425; Tom Fink, .392; Clarence Philpotts, .364; and Dick Cleveland, .347.

Volleyball is once again on the upswing at OCC. The new volleyball committee schedule headed by Chairman Mark Auerbach was geared to both male and female aspirants from age nine to 90. Other committee members were Tommy Haine, representing the senior men; Gail Lange, senior women; Marilyn Haine, junior women; and Gil Halpern and Bill Danford, junior men.

In a junior 15 and under volleyball tournament, Bill Danford and Mike Buck emerged as winners in a closely fought match with Nat Norfleet and Terry Ledford. Mike Lemes and Keoki King placed third. The junior 18 and under tournament was won by Bill Danford and Gil Halpern; second place went to Paul MacLaughlin and John Marshall; and third place went to Butch Hemmings and Nick Beck.

The novelty volleyball "Throw Tournament" brought a touch of nostalgia to club oldtimers who recalled the days before the AAU rules crackdown that did away with the proverbial "sticky fingers" in tournament play.

The modernized version of the game won the tournament for Tom Haine and Bill Baird who combined AAU rules with the tricky throw shots of yore to edge "Gloves" Casey and "Manicure" Cook. Pete Balding and Ron Sorrell came in third

But with the approach of the cocktail hour, members and their guests began arriving for the Anniversary Luau until more than 500 were finally seated. A rousing evening followed with great kau kau and entertainment by Gabby and his gifted group.

A new item was added to the Hau Terrace Menu. Light steak dinners were offered every Saturday and on any Monday holidays during the summer months. Tariff is \$3.65 per person.

The annual Club Surfing Championships were scheduled for the Kamehameha Day weekend, but unsatisfactory surfing conditions postponed some of the events. Some events that were held in 2-3-foot surf at Tonggs and Old Mans were the minnows, women's and semi-finals of the boys 12-14.

OCC volleyballers competed in the Far Western Championships. Outrigger reached the semi-finals but lost to the Balboa Bay Club the previous year's AAU runner up by scores of 10-15 and 8-15. OCC finished third in the tournament by beating the Olympic Club of San Francisco 15-11 and 15-9.

The ladies had their day at the Club. The annual fashion show was a sellout. It was presented by Carol & Mary and many of the stylist outfits were modeled by Club members.

# 4th of July Memories of Walter Macfarlane

It will soon be the 4th of July again, and time for the Walter J. Macfarlane Regatta. Who was Walter Mac and why was the race named after him?

OCC member and philanthropist Muriel Macfarlane Flanders, who died in January 2003, gave the Club her impressions of her brother, Walter Macfarlane, and stories of their life together in an Oral History.

Muriel's three children are Alice Guild, Mary Philpotts McGrath, and Judith Flanders, all OCC members. Many of her grandchildren are also OCC members, and continue the 4th of July traditions honoring their Uncle and Great Uncle, Walter Macfarlane, who never married and had no children.

Muriel used to attend the awards ceremony after the race, and was a major donor to the Outrigger Duke Kahanamoku Foundation.

The Macfarlanes came to Hawaii from Scotland, via New Zealand in the 1840's. Walter Macfarlane's mother was Alice Kamokila Campbell of the James Campbell family. Walter and his siblings grew up in Honolulu, spending the summers sailing, swimming and surfing. Walter was also known for his horseback

riding and polo playing.

One time OCC President, Walter Macfarlane is credited with "saving" the Outrigger Canoe Club from financial problems in the 1940's. Memberships were down, WW II was eminent, and there were lease problems. Through the sale of Life Memberships and solicitation, he kept the Club afloat. According to his sister, it was probably his greatest and happiest achievement.

When Walter Mac went to Mexico in 1943 he contacted typhoid, and returned to the San Francisco area for medical care. During the war medical supplies were scarce and he unfortunately died on June 4th. It was decided to name the next month's OCC canoe regatta in his memory.

His sister says"...when I see those kids out there in the sunshine, the beautiful water, beautiful waves, and everybody so happy and clean and salty...it's just the most beautiful memorial imaginable...he would have loved it."

The Macfarlane Regatta is the oldest annual canoe race in Hawaii.

Many of the Regatta trophies come from the Macfarlane descendants:

- the koa and sterling wave trophy to the overall winner
- the koa racing canoe given to the Boys 18 (made by Walter Guild)
- · a sterling silver bowl for the senior women's race
- 2 milo wood bowls from the women's 35 masters and 45 masters

Board Briefs is taken from the minutes of the Board of Directors meeting on March 27, 2003. The Executive Committee meeting on February 13, 2003 was canceled.


