# Outrigger Canoe Club's Contributions to World Peace

On September 11, 2001, the United States experienced a national tragedy with the terrorist attacks on the New York World Trade Center, the Pentagon in Washington, D.C., and the United Flight 93 crash in a Pennsylvania field, in a manner previously unknown. The number of people killed or injured was more than in the attack on Pearl Harbor and to everyone's horror they were civilians of many nationalities and military personnel.

Immediately, Hawaii became isolated due to commercial air travel being suspended for two and a half days with only military flights authorized. When the airports reopened it was for commercial travel only. General aviation did not resume for a number of weeks thereafter.

All of the airport terminals and other important facilities in the Islands became fortresses with the activation of the Hawaii National Guard immediately following the attacks. Only commercial maritime activities continued but with greater surveillance and control.

Within days of this most recent tragedy and the designation of "Operation Noble Eagle/Enduring Freedom," several members of the Club were called to active duty into the armed services with assignments for up to a year or more. Their civilian jobs were "put on ice" and guaranteed upon their deactivation and return to civilian life.

In the past century the Outrigger Canoe Club has contributed its share of manpower and materiel with regard to the various conflicts endured. World War-I listed more than 100 OCC members in service from 4/6/1917 to 11/11/1918. It was the Great War to end all wars.

By far, World War-II (12/7/41-12/31/46) was the most demanding with hundreds of members serving in the various armed forces in Hawaii and abroad. The Clubhouse and grounds

were used to the utmost by active duty OCC and Service members who joined when they arrived in Hawaii.

In addition, members were subject to martial law, civil law being suspended, requiring blackout nightly, ID cards, vaccinations, civil defense training, censorship of news and mail, gas and food rationing, and the mandatory carrying of gas masks until late 1943.

The voluminous use of the facilities by service members during the war paid off the Club debt incurred prior to the war. It was said that the Club had the best "food and booze" in town, better than the officer's clubs.

Korea (6/25/50-1/31/55), Vietnam (2/28/61-5/7/75), Desert Shield/Storm (12/20/89-1/30/90), the Iraq north & south no-fly zones, Bosnia and Kosovo, and now "Operation Noble Eagle/Enduring Freedom," were conflicts that required OCC members to serve but in lesser numbers.

One must ponder the extensive U. S. global commitment with a number of sites that personnel of our armed forces are committed not as warriors, but as peace keepers, a task previously unknown.

To our active duty members we wish God speed and a quick resolution to a conflict that is so different than in past national confrontations. A terrorist is an individual who fights in a cowardly unconventional manner without uniform dress or device showing country of origin. It's a conflict that knows no end.

To the OCC member veterans we express a big mahalo for commitment to duty to our country in war, peacetime and into the future. We also celebrate Thanksgiving Day, on which all of us should be very willing participants in remembrance.

In commemoration of Veterans Day, you'll find some vignettes about the Club and its members in previous wars.

## A Look Back at Wartime OCC

### World War I

*Reprinted from the OCC Forecast of May 1, 1956*

Sons of the OCC fought and died during the First World War. Daughters of the Club did their full share of winning the war. Lives, bodies, work hours and dollars they contributed loyally. Uncle Sam entered the struggle to end all wars, Japanese warships patrolled Pacific waters in sight of the beach at Waikiki. German ships were interned. Through it all the OCC expressed hospitality lavishly. Members fought and played, but kept the pledge that surfing and other aquatic sports would always be at Waikiki.

The First World War fighting came to an end on Armistice Day, 1918. Hawaii, Waikiki and the Outrigger Canoe Club had done a noble American part in the 19 war months. No hostile shell fell on Hawaii and Sunday, December 7, 1941 was not even a bad dream on Armistice Day of 1918.

### Outrigger Club to Have Service Flag

The members of the Women's Auxiliary of the Outrigger Club are now at work on the service flag to be presented by the Pan-Pacific Union to the Club on April 6, the anniversary of America's entrance into the world war.

So far more than a hundred names have been gathered of Outrigger Club members who are in the service of Uncle Sam, and it is desired that the wives, mothers, sisters or sweethearts stitch the names of their relatives on the respective stars of the flag. During an alarm, persons in the Club or on the premises are requested to seek shelter in the main building. Leave the dining room immediately. The canoe flag on the beach building will be lowered to notify members in the water to come ashore.

## World War II

*Reprint of OCC Forecast Article of December 1951*

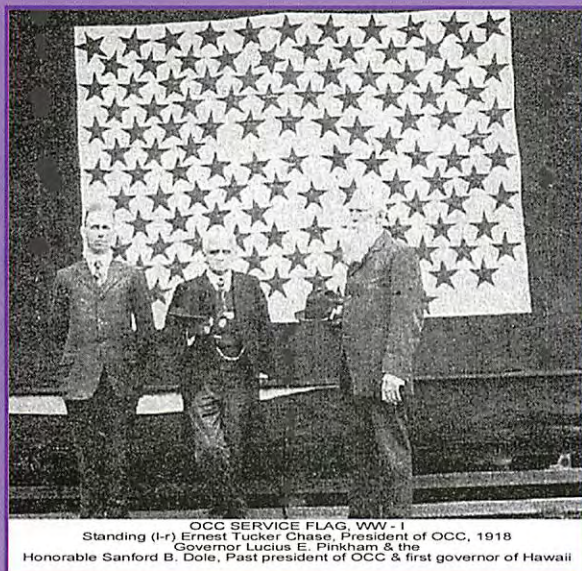
Ten years ago on a bright, sunny Sunday morning, December 7, 1941 Honolulu was awakened by the explosion of bombs, anti-aircraft fire and the radio voice announcing, "This is the real thing." It was our fellow member Webley Edwards announcing the sneak attack by the air force of the Imperial Japanese Navy on Pearl Harbor, Kaneohe Naval Air Station, Hickam Field and other military installations and civilian objectives.

For a short few hours all was chaos civil and military personnel caught unawares and unprepared lacked coordinated leadership. But soon order prevailed and in a matter of hours, Hawaii was under Military Government (Martial Law). Defense organizations were at work and the Civilian Defense planned in advance on paper fell into organized pattern and Hawaii dug in to defend and protect itself.

The military, hard at work re-organizing its forces, planning for the future found a lack of recreational facilities for its personnel and soon began to take over favored spots for recreation for its forces. However, the Outrigger Canoe Club long before this happened opened its doors to the Armed Forces and by invitation invited the men in uniform to be our welcome guests.

Thousands of enlisted and commissioned men of all branches availed themselves of the opportunity and the Club was the Mecca for them in

Waikiki. Sandwiches and refreshments were served through the cooperation of the Red Cross until the military had adequate recreational spots of their own.

The Royal Hawaiian Hotel, our neighbor, was taken over and all during the war it was a favored haven for the war weary submarine officers and crews. However, the Club opened its membership to commissioned officers, eliminating any entrance fee and enjoyed the membership of hundreds of them all during the war.

Letters of commendation were received from Admirals Nimitz, Halsey and others as well as General Richardson and other Commanding Generals. The close association of our Club with the Armed Forces has been maintained throughout these years and we hope it ever will. We number many fine members of the Club within the Armed Forces and many retired officers and enlisted men on our roster.

Should war ever strike again the Club will be found ready and willing to do its share toward the recreation and morale of our Armed Forces personnel.

*(Editor's Note: Prior to WW-II, the Club was deeply in debt preparing to build the new clubhouse that opened in 1941. In 1939-40 the Board solicited and issued bonds to the membership and corporations to mature in 5 to 10-years. Due to the military membership and the dues and income received, the bonds were retired by the middle of the war in late 1943.)*

## Korea Bronze Star

*Reprinted from OCC Forecast of April 1, 1953*

Lt. William W. Monohan Jr., OCC member and a U. S. Marine officer, received a Bronze Star medal for heroic service and courage in Korea. The citation read: "Lt. Monohan displayed exceptional courage and initiative when the unit was engaged in close combat the raiding party sustained severe casualties. Without regard to his personal safety, with the aid of another Marine he carried three of his men out of effective range."

He was wounded but returned again to rescue another man, then administered first aid and re-organized his unit.

## Vietnam Bronze Star

*Reprinted from OCC Forecast of February, 1969*

Lt. jg Robert Timothy Guard, U.S. Navy Reserve, was presented with a Bronze Star medal for heroic achievement while engaged in armed conflict against North Vietnamese and Viet Cong community aggressors in the Republic of Viet Nam on October 28, 1968. As Officer in Charge of Patrol Craft Fast 103, Lt. Guard participated in a hazardous raid into an enemy held river during Operation SEA LORDS. The enemy position was targeted and damaged.

He was cited for his devotion to duty, courage under fire, and exemplary leadership which significantly contributed to the success of the mission.

# MILITARY HONOR ROLL

Clubs around the world honor their member veterans in various ways.

In March of 1918 the Women's Auxiliary of the Outrigger Canoe Club created a service flag with over one hundred stars containing the name of an Outrigger member in the service to his country in World War I. Unfortunately, the service flag has not survived through the years, but a photo of it does.

Again, after World War II in 1945 the Outrigger Canoe Club created an Honor Roll by way of a small koa surfboard listing 21 individuals killed in action. The information on the surfboard is lacking for which armed service the individual served in. Clarification is invited.

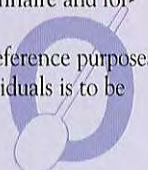
A questionnaire has been created and is provided to establish an expanded Club Military Honor Roll. Information may be obtained from the veteran's honorable discharge certificate or form DD-214. The attached questionnaire may be copied and is to be completed by:

- A Club member who was or is on active duty (180 days minimum) while a member of the Club.
- A spouse, relative or close friend who knew of a Club member on active duty, as stated above.

If anyone knows of additional individuals, please make a copy of the questionnaire and forward to the individual for completion and submission.

The questionnaires will become a permanent record and will be bound for reference purposes in the Outrigger Canoe Club Historical Committee archives. A listing of individuals is to be included in the OCC Centennial Book.

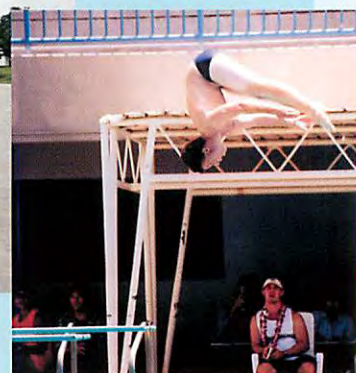
Celebrating a Sweet 16 birthday at the OCC were Emily Jones, Sarah DeMello (the birthday girl) and Kim Craigie.

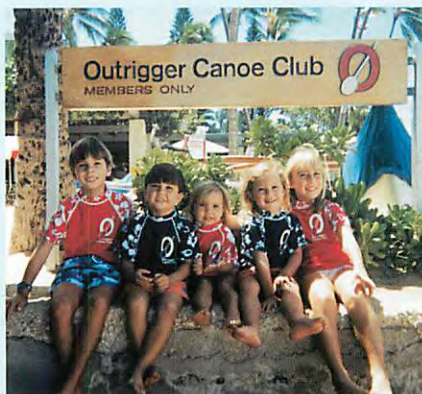

# OUTRIGGER CANOE CLUB - THE 2nd CENTURY

The Board of Directors has approved the design concept developed by the Master Plan Adhoc Committee and Architect Ted Garduque and authorized them to proceed to the next phase, which includes the preparation of more detailed schematic design drawings and obtaining contractor proposals.

The committee has dubbed the new plan OCC 2 C short for *Outrigger Canoe Club the Second Century*. To make sure that every member who is interested has a chance to see and understand what OCC 2 C is all about and to make comments and suggestions, the committee is planning a visual and narrative presentation followed by a forum for questions and answers.

Meetings will be scheduled for standing committees, athletic committees, and all members. Notices will be posted around the Club and on our website, [www.outriggercanoeclub.com](http://www.outriggercanoeclub.com). The Master Plan Adhoc Committee also plans to have a special section of the website devoted to OCC 2 C.

At the OCC 2 C meetings, members will see a culmination of work that began back in 1998 when the Building & Grounds Committee recognized the need for an integrated, comprehensive approach to overall facility space planning and recommended to the Board that a long-term facility master plan be developed.

Due to the large number of pending renovation projects, the continuing need for repair and replacement of electrical and mechanical equipment, the aging of our facility, and the growth of our membership and staff, it was quite evident that the "piecemeal" approach that had worked in the past was no longer acceptable.

The Master Plan Adhoc Committee and the architect, with help from specialized consultants, have considered a number of factors including the age and condition of our building, its interior space and grounds, and the preservation of the architectural design and ambiance created by the original Planning Committee and Architect Val Ossipoff. Always keeping in mind the overall purpose and mission of the Club, the committee has given special attention to member preferences and also to the needs expressed by our management and staff.

Throughout the process affordability has been a top priority. The end result the committee seeks is a facility that will serve members well for the next fifty years and not require a special assessment or financing, or any dues increase beyond what would normally be expected to support the day-to-day operation of the Club over the years.

After much study and discussion, the committee identified 12 features that the plan must address:

- Consolidation and redesign of administrative office space to ensure greater efficiency and improve member service.
- Redesign and configuration of mechanical and electrical systems to achieve long term cost savings, energy efficiency and safety.
- Redesign and increase the size of "back of the house" support space including areas for mechanical and electrical equipment, food and beverage storage and office space.
- Redesign of the employee lounge/dining and locker rooms to better allocate space and provide a more pleasant environment.
- Improved handicap accessibility
- A "facelift" for the lobby and redesign to include a reception area dedicated to receiving members and guests and improved display areas.
- Transformation of the Board Room to a multi-function room that will continue to serve for Board and other meetings, and also enhance member amenities and generate revenue.

- Construction of a new fitness center to replace the temporary facility and fulfill the most frequently requested space improvement recorded on member surveys.
- Additional parking stalls
- Redesign of the Logo Shop to provide storage and improve service and revenues by providing space to better see and try on merchandise.
- Improved beach and water sports equipment storage
- Improved Snack Bar appearance and service areas.

Since it began its work, the Master Plan Adhoc Committee has considered five plans. The committee is convinced OCC 2 C addresses all these criteria better than any of the other plans. It can be built within an affordable price range, accomplished within current zoning and design district requirements, and completed with limited disruption to Club activities. OCC 2 C will provide approximately 7,500 square feet of additional area and 15,800 square feet of renovated area, recover needed parking stalls, leave the volleyball courts intact, and the overall look of the Club virtually unchanged.

OCC 2 C literally allows Outrigger members to "have our cake and eat it too." We will retain all the lovely casual, understated ambiance Val Ossipoff created, but the Club will look fresh and invigorated, provide additional athletic and social amenities for members, and have back-up facilities that will enable us to operate efficiently for many years to come.

Because of the lead time required for publication, the Master Plan Adhoc Committee does not have drawings that can be reproduced as of the date this magazine goes to press. They will be on view at the OCC 2 C meetings and subsequently published. Meanwhile, just to give you an overview of the major elements of OCC 2 C:

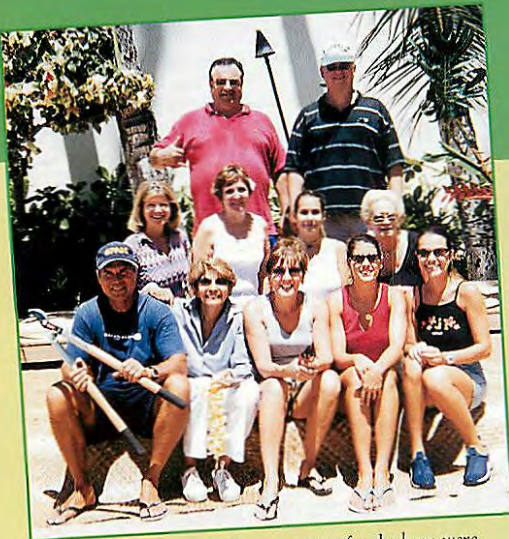
- The existing bar will be demolished.
- A basement will be excavated under the existing bar and connected to the existing basement to create approximately 4,200 square feet of additional space in the basement.
- The bar will be rebuilt with a second level above it, which will create approximately 3,300 square feet of additional space for a fitness center.
- All administrative functions, membership services, and "back of the house" functions will be consolidated in the new and renovated basement area.
- In the lobby, a new 400 square foot Logo Shop will be discretely positioned off to one side. No merchandise or store displays will be visible from the lobby, but once inside the shop, members will enjoy a much more "shopper friendly" environment. An area will also be created in the lobby to showcase the Club's history and traditions.
- The Board Room will be relocated to the area of the current employee dining room and the employee dining room will be redesigned and relocated.

The Master Plan Adhoc Committee is eager to talk with all members about OCC 2 C. Please come to one of the meetings and see for yourself. 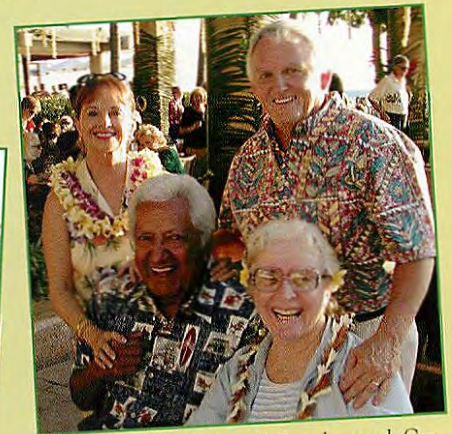

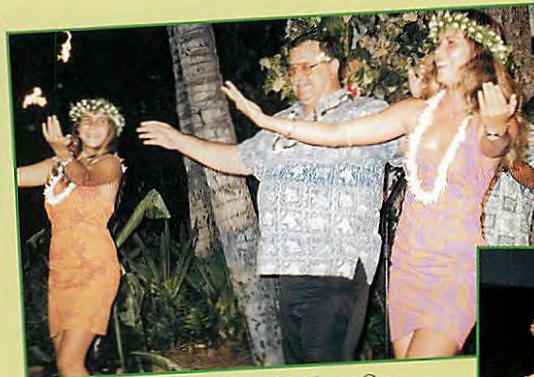

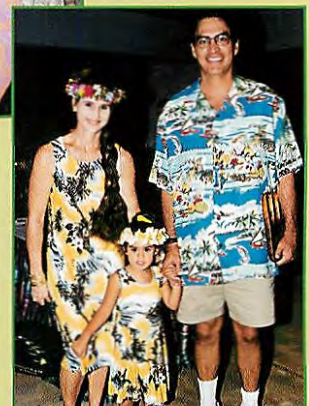

Paddlers got inspired and got going on the long distance canoe racing season once the regatta season ended in Hilo.

On August 18, the men made an impressive distance season debut by winning the Open, Masters 35 and Masters 45 divisions in the 24-mile Duke Kahanamoku Long Distance Race. The Masters 35 crew finished an impressive sixth out of the forty-four crews entered.

A week later the women of Outrigger picked up where the men left off and stunned all comers in the Dad Center Race from Kailua to the Club.

Thirty-five crews finished the 24-mile course. Sticking to a tight inside line, the crew came so close to the rocks that "we were picking opihi," quipped steersman Kisi Haine.

It has always been a big thing with Outrigger crews to win the races the Club sponsors. But what made this win particularly exhilarating was the quality of the competition. Second place finisher Kai Opua of Kailua-Kona is the two-time defending Na Wahine O Ke Kai Molokai champion. Na Wahine Team Eyecatcher, which is comprised of elite paddlers from Maui, Kauai and Oahu, finished third though it was the first time this year that the crew paddled together.

On August 31, Outrigger sent three women's crews and five men's crews to Kona for the Queen Liliuokalani Long Distance Races. More than 120 crews participated in each of the men's and women's events in the 18-mile race from Kona Bay to Honaunau and back to Kona Bay. Crews in the open division raced iron, meaning six paddlers start and finish the 18-mile course without escort or relief paddlers. Masters division crews had nine paddlers and were allowed to make ocean changes with relief paddlers in an escort boat.

In the women's events, Outrigger's first open crew finished a solid fourth overall; the second open crew won second place in the koa division; and the Masters 35s won their division.

Outrigger's first men's crew also finished fourth overall, while the second open crew won the koa division. The Masters 35s continued their winning streak while the Masters 45s took third place honors in their respective divisions.

On the following weekend of September 7, Outrigger sent its top women's and men's crews to Catalina Island to challenge international competition. Conditions were uncommonly sunny, clear and warm. Both crews finished third.

On the same weekend, the women's second crew participated in the E Lau Hoe race to Pokai Bay. Usually, this race is 31-miles of flat conditions and hard paddling, but for the first half of the race, there

were favorable wind and ocean conditions. Racing against first crews from other canoe clubs with novice paddlers Debbie Pinto and Wendy Wichman, the crew finished a respectable eighth overall. Pokai Bay is the last tune-up race before the Na Wahine O Ke Kai which was held on September 29.

It used to be called the Skippy Race. Now it is called the Henry Ayau Men's International Canoe Race. Really, it should be called the "Bruddah Henry Lovefest" because on September 15, that's what it was.

Fifty-one men's crews honored the memory of Henry, an expert waterman and longtime paddler for the Club, who passed away May 8, by participating in

the 32-mile race from Maunaloa Bay to the Ko Olina Marina.

The event began with the blessing of Outrigger's new canoe — the Henry Keawe Ayau. Then Henry blessed the event with favorable winds, current, and ocean swells to surf. Outrigger placed third in 3:38:43 paddling in the new fiberglass canoe.

Coach Kala Judd said, "The boat was flawless; it really helped us. It turned out to be a real emotional and spiritual race for us."

The Masters 35 and Master 45 crews also fared well placing second and third in their respective divisions. For the men, this was the last race before the October 13 Hinano Moloka'i Hoe.

The numerous athletic programs supported by the membership had a very active and successful summer.

The Volleyball Subcommittee, co-chaired by **Peter Ehrman** and **Peter Balding Jr.**, sent highly competitive teams to the U.S. Junior Olympics in Louisville, KY this summer. The Boys 14s won first place and the Boys 16s won third place.

The Canoe Racing Subcommittee, co-chaired by **Bret Chuckovich** and **Jen Thayer**, had one of the more successful regatta seasons in recent memory. Our crews, under the leadership of Head Coach **Michael Mason**, won four regattas including the Macfarlane Memorial Regatta and the OHCRA Championship. This was the second consecutive and the 14th OHCRA Championship for Outrigger. The season culminated with a third place at the HCRA Championship at Hilo Harbor on August 3.

**Aka Hemmings** conducted a series of Canoe Steering Clinics for youth and novice paddlers again this summer. The Surfing Subcommittee, chaired by **Terri Needels**, sent the Surf Team to all 10 HASA competitions on Oahu. Members also participated in several other surfing competitions including; China Uemura's 6th Annual Ripcurl Girls Wahine Classic at Kuhio Beach, Steinlager Longboard Series Aston No Ka Oi at Lahaina Harbor and the Town & Country Mini Grom at Kuhio Beach. Members of the OCC Surf Team reached the finals in every competition held on Oahu. The OCC Summer Surf Competition was also a successful event.

Free Surfing Clinics for Youth and Adults were provided again this summer by **Terri Needels**, **Kisi Haine** and friends. A review of the principles of surfing, wave etiquette, and water safety were followed by surfing at Tongg's. Kisi worked hard to help everyone catch a wave. The OCC Surf Camp was a fun-filled, intensive week of group surfing lessons taught by professional surfers from the Hans Hedemann Surf School.

The Paddleboard Subcommittee, chaired by **Eric Rhodes**, hosted the annual Cline Mann Paddleboard Race in June. Outrigger members won the team events. Members competing in major paddleboard competitions will receive nominal financial support from the Subcommittee budget.

The Swimming Subcommittee, co-chaired by **Peggy Danford** and **Chris Moore**, hosted the annual Outrigger Invitational Swim in July and co-hosted the Biathlon with the Running Subcommittee. The committee is also preparing for the Castle Swim on December 1.

The Running Subcommittee, co-chaired by **Tommy Damon** and **Katy Bourne**, was active as usual. The 5th Annual Outrigger Biathlon held on June 22 was a resounding success. The 3rd Annual Keiki Fun Run was held in Kapiolani Park on the same day for 81 children.

The OC-1/Kayak Subcommittee co-chaired by **John Goody** and **Bret Chuckovich** has supported the individual efforts of members competing in the major canoe and surfski competitions. Planning is currently underway for the annual Tri-Ocean Race in December.

The Athletic Committee has integrated the Outrigger Web site into the athletic programs in an effort to improve organization and communication. The paddling program was used to create a template for other athletic programs. The Outrigger Web site now features current athletic information on the Bulletin Board, Paddling/Sports News, an Athletic Events Calendar and Members in the Media Web pages.

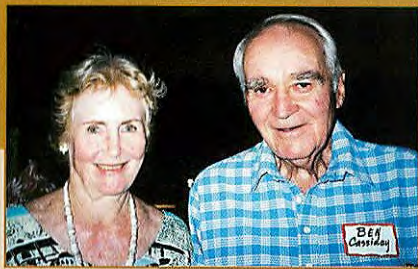

# 31st Annual Hana Relays

Hawaii's second longest running footrace of any kind (the Maui Marathon is reportedly our state's oldest event), and unequivocally the most enduring and enjoyable relay race, fielded a record turnout of 105 teams finishing, the largest number ever entered. Saturday, September 14, our three OCC teams started the 52-mile run from Kahului Airport to Hana in East Maui, finishing in very respectable times.

No clouds at Haleakala, cool NE breeze, and a gradual cloud cover on the Hana Highway. This was the weather at the 5:30 a.m. start. Gradually the trades perked up to add a crispy feel to the Hana Highway.

Teams of five to six members,

The OCC Mixed Madness finished in 6:05:38 (pace 7:02). They placed fourth of 53 teams in the Mixed Division and 10th overall. Team members were Scott LaRue, Bob Egbert (13th leg), Dave Stackhouse, Tom Damon, and Katy Bourne.

Running with the OCC Mixed Plate that finished in 6:37:01 (pace 7:39) were Matt Kresser, Terri Needels, Uli Frowein, Gino Morez 13th leg, Stefan Reinke, JoAnne Klinke. They placed 12th of 53

teams in the Mixed Division and were 29th overall.

The OCC Masters of the Universe finished in 6:37:25 (pace 7:40). They placed fifth of six teams in the Men's Masters and 30th overall. The team was Don Eovino, Rich Turbin, Joe Teipel, Bob Dewitz, Twain Newhart (13th leg as usual), Henry Richmond.

You will need to ask these runners what 13th leg means, as well as ask the Masters of the Universe about that 24 second loss to the Mixed Plate.

When the teams arrived in Hana, there was a little bit of OCC waiting for them. Grant and Beth Senner, Hana residents, had set up a tent, complete with OCC towels as banners, chairs, coolers with the usual, and lots of ice. Grant's Mom, aka Tent Mom, Gerry DeBenedetti, brought teri chicken and artisan bread, which was called "real food." Judging from the bags of chips left behind by the OCC runners, they weren't kidding, they were in need of real food.


Those of you who have finished anything, know what a thrill it is to find someone waiting, who says, "come over here." We have a tent, we have cool things to drink, we have a place for you. There is no finer example of the reason we

belong to this great Club, wherever you go, even 52 miles out on the Hana Highway, we are waiting for you and you have a place to go.

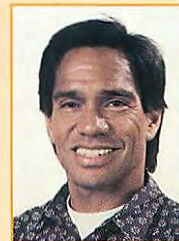

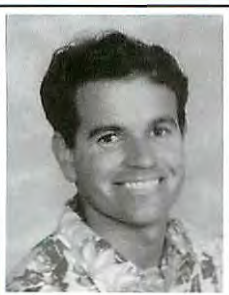

# Board Briefs

Board Briefs is taken from the minutes of the Board of Directors meeting on August 29, 2002. The Executive Committee meeting on August 15, 2002 was canceled.

## Treasurer/Finance Report

There was a general discussion about members visiting the Club with guests and whether or not guests are covered under our liability insurance. The General Manager indicated that as long as guests are with a member they would be covered by the Club's insurance.

## VP Operations Report

The Duke Kahanamoku Stamp Celebration was a success. ODKF thanked the Outrigger Board for their support and for hosting the sponsor breakfast last month. The Board approved a flyer insert for members about how to buy the Duke T-shirts that were sold at the event.

## Secretary's Report

Six members were suspended for 15 days for being delinquent for the third time in a twelve-month period. Three members were terminated due to their accounts being delinquent four times during a twelve month period.

## General Manager's Report

Net income from operations of \$824 for July, is \$18,124 better than budget. . . A construction worker dropped a window from an apartment at the Colony Surf. The window crashed in the alley next to the Snack Shop at 6 p.m. in the evening. Luckily, the Snack Shop was closed and the alley was empty. . . The Board complimented Sharna Engle and Rodney Ussing on their CPR abilities and efficiency with the Defibrillator when helping a man who collapsed on the beach.

## Admissions & Membership Report

The membership count was 4,582 as of July 31, 2002.

## Building & Grounds Report

The Board approved a carved wooden sign like the one on the Koa Lanai be placed on the back wall in the newly renamed Ka Mo'i Lounge.

## House Report

At the request of the Board, the House Committee reviewed the mini charge. After much discussion, the House Committee recommends that no change be made to the mini charge. . . Discussion arose about menu pricing. The General Manager said he has been holding to a policy of keeping prices constant throughout the year. This is difficult when there are increases in the cost of food, particularly fresh and frozen fish. Several Board members suggested that the fresh fish could be listed on the menu at "market price." It was also noted that thought could be given to sometimes offering fish other than mahimahi and opakapaka as the "fresh catch".

## Long Range Planning Report

The Board approved a Permanent Elks Adhoc Committee with the following members: Peter Nottage, Permanent Chair; Keith Steiner, Bob Dewitz and J.D. Watumull. There would also be two others to be appointed by the President. Currently they are William Swope and Larry Johnson. The two members appointed by the President could be replaced by future Presidents. The Permanent Chair could be replaced only by a 2/3 vote by the Board of Directors. The Permanent Chair appoints and removes the members. The Committee will report to the Board of Directors for oversight and approval of actions.

## Athletic Report

The Board approved use of the Paddling Committee "Special Fund" to purchase 11 racing paddles. . . The Board approved the purchase of a \$12,900 foam core Mirage canoe to use in the Molokai Race. They propose to purchase the canoe with money from their "Special Fund". The issue of reimbursement will be considered at the 2003 budget meetings. . . The Board approved \$13,460 to send seven crews to Kona, \$16,950 for two crews to Catalina, \$9,990 for the women's Molokai and \$13,650 for the men's Molokai. . . The Board approved \$228 be transferred from the Paddleboard Committee to the Keiki Paddleboard Clinic. . . The Board approved funds for the Hana Relay totaling \$4,496. . . The Board asked the Club Captain to contact the athletic committee chairs and remind them that continuing funding of their activities is contingent upon their submitting stories and results of events to the *Outrigger* magazine. . The Board requests that the Club Captain organize the requests from each athletic committee and submit them in one report that could be placed in the Board binders in advance of the meeting.
