# Club Bar Renamed Ka Mo'i

In an informal ceremony on August 9, the Outrigger Canoe Club Bar and Lounge was renamed the Ka Mo'i Lounge in honor of the restored koa canoe, Ka Mo'i, which now hangs from the ceiling of the Lounge.

This outrigger canoe is reputed to have been built by James Takeo Yamasaki and Kyuhei Takimoto in Kailua, Kona, circa 1931. It was finished by James "Box" Kaya, an employee of the Outrigger Canoe Club in 1933. The original log was from the North Kona forests on Hualalai.

Though its original builders probably intended it as a large fishing canoe, it did not serve as such. From the time of its arrival and completion in Waikiki, the Ka Mo'i was a surfing canoe and sometimes a racing canoe.

When the canoe was finished it was placed in service on the beach fronting the original Outrigger Canoe Club. It served the tourist industry and Club members from that time until the Club moved in 1964. It was used in attempts to revive the sport of canoe sailing in the late 1940s.

The Ka Mo'i was used by a beach boy crew in the Molokai to Oahu race in 1954. It was then placed on display at the Ulu Mau Village at Ala Moana Park from 1966 through 1977 when the village was closed.

At that time, it came back to the Outrigger sadly in need of restoration. In 1978, a group including Bob Fisher, Timmy Wong, Charlie Martin, Bill Cook, Mike Mason, Walter Guild, Wayne Faulkner and others worked on the canoe. Their work consisted of patching the leaks and refinishing the canoe so that it could be displayed at the Walter J. Macfarlane Regatta on July 4, 1978.

The canoe was paddled to the race site and back that day. That was the last known time the Ka Mo'i was paddled until its recent blessing. After this event, the canoe remained stored on Outrigger Canoe Club premises until 1982.

To our knowledge, the canoe was placed on a lease to a restaurant in Poipu on Kauai in 1982. It is rumored that it was used as a salad bar until the restaurant was destroyed by Hurricane Iwa. It survived this calamity and was worked on by members of the Hanalei Canoe Club and prepared for exhibition in the Princeville Hotel where it remained until 1992, when that hotel was destroyed by Hurricane Iniki.

The canoe again survived and was taken to the nearby Hanalei Bay Resort where it was hung from the lounge ceiling.

In November 1998, at the request of the OCC Historical Committee, Tay Perry and OCC General Manager John Rader, went to Kauai to locate the Ka Mo'i and to determine how we were

to arrange for its return home.

On January 17, 1999, a party consisting of Tay Perry, Kawika Grant and Allan Dowsett went to Kauai to retrieve the Ka Mo'i. With the help of the Hanalei Canoe Club, we were able to deliver the canoe to the dock.

The restoration work on the Ka Mo'i did not commence until August 2000.

The condition of the canoe was far worse than originally estimated. A complete and total overhaul was begun and lasted for one and one half years. Work was completed on the canoe itself at the end of January 2002.

The work involved stripping the former finish, removing all of the metal fastenings, rebuilding the stern, patching the cracks, termite damage and dry rot. The existing fir and plywood manu were discarded and new ones fashioned from a koa log. The ama and iako are new with the wood being gathered from the Maunawili forest by Club members.

The principal members of the restoration crew in the order of time participated were Tay Perry, Kawika Grant and Allan Dowsett who contributed over 85% of the total hours worked. Also participating were Norman Ho, Jay Dowsett, Mike Mason, Clarence Au, Cale Holman, Norm Dunmire and Bret Chuckovich.

In all, a total of 1,155 man hours were contributed to this project. All of the labor was volunteer.

Donors of materials were George Norcross of Epoxy Sales of Hawaii and Ted Wilson of Fiberglass Hawaii, Inc. The Friends of Hokule'a and Hawaii Loa provided space, electricity, equipment, moral support and lunch for the project.

Ka Mo'i was launched again in a simple Hawaiian ceremony conducted by Kawaika Kapahulehua at the Sans Souci Beach on February 25, 2002. This launching party included mostly the workers, close friends, and those associated with its history.

Upon launching, it was paddled out to sea and then back in to the Club for its homecoming blessing which was conducted by the Rev. Thomas Van Culin, following the OCC Annual Meeting.

There is a lot of history of the Ka Mo'i that is not known to any one person. This canoe has had an intimate relationship with the Outrigger Canoe Club, belonging to it for more than 70 years.

Many members have their own experience and history with this canoe. There are many thousands of people who have had thrilling surf rides in it who will never forget their experience.

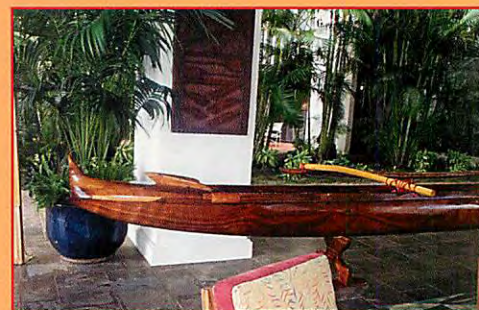

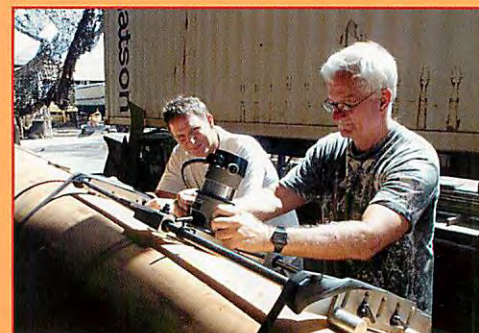
The Ka Mo'i hangs proudly in the newly renamed Ka Mo'i Lounge.

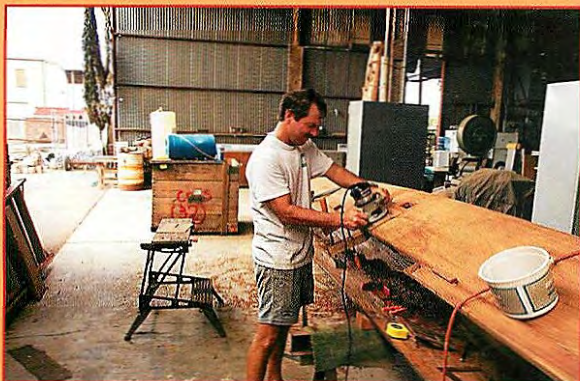
The Ka Mo'i was displayed in the lobby of the Hanalei Bay Resort until reclaimed by OCC.

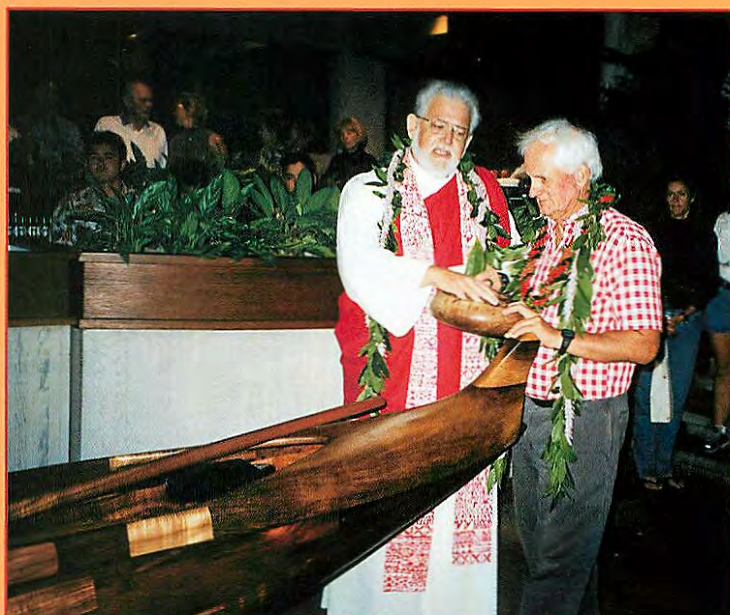

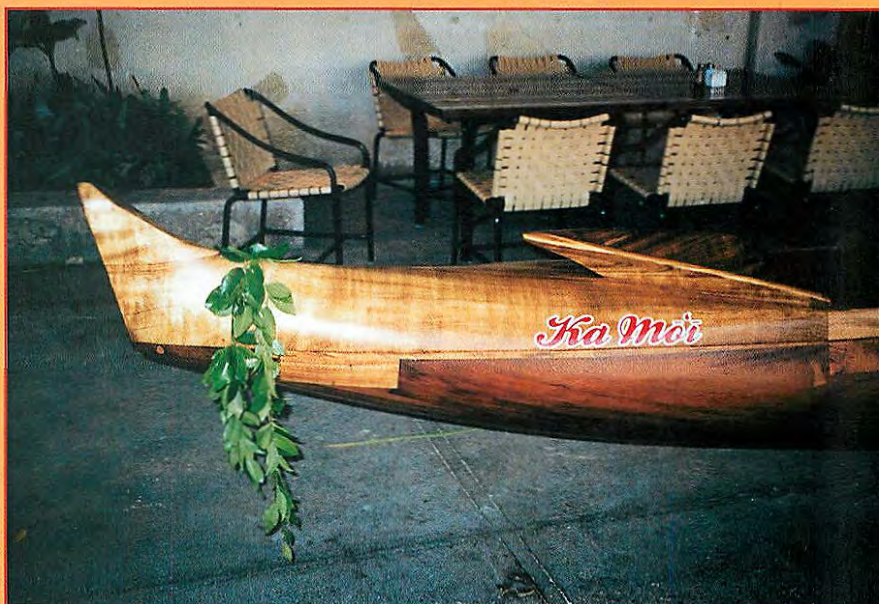

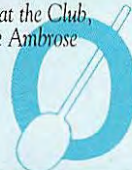

# Next Stew Rice Night, November 4 The Dillinghams & Kapiolani Park

*A Slide Show/ Lecture by Jack Gillmar*

It may be a month away, but it's not a day too soon to make reservations. This is not one to dawdle over, and never mind that "The Dillinghams" and "Stew-Rice" seem grossly incompatible.

What's relevant here is that the Dillinghams of La Pietra were an illustrious, intriguing family; Kapiolani Park has a little known but rich history; there were connections between Park and family; and there could hardly be a more perfect person to pull it all together than Jack Gillmar, who generously accepted the OCC Historical Committee's invitation to be guest presenter at the Committee's next Stew-Rice Night—November 4th.

Gillmar is president of the Kapiolani Park Preservation Society, which is publishing a book—Kapiolani Park A History, by Robert Weyneth in November. Further, he is a history teacher of 30 years at La Pietra/Hawaii School for Girls and has a long-standing interest in La Pietra, architecturally and historically.

As a kamaaina who grew up in this area, he has a wealth of wonderful stories about it. In fact, his family is part of the lore of the place and Outrigger's history, too. One of his kin, a Dr. Scudder, minister of Central Union Church, was a charter member of Outrigger, 1908.

Somewhat later, Jack's mother, Ruth Scudder, was one of Outrigger's outstanding swimmers and therein lies a most interesting story. If he doesn't mention it in the Dillingham/Kapiolani Park talk, ask him about it. You'll be amazed.

While not a current member, Jack, too, was once an Outrigger athlete, a paddler, during his Punahou years but resigned when he went off to college at the University of Pennsylvania, where he earned a bachelor of

arts degree in American civilization. His interest in American history is highly appropriate, as he descends from a notable American Colonial family.

Many of his family members later distinguished themselves as patriots in the Revolutionary War. Jack is a direct descendant of Dr. and Colonel Nathaniel Scudder, who represented the state of New Jersey at the Continental Congress and in 1781 became the only member of Congress to be killed in action during the Revolution.

Back to Jack after UPenn, he earned a master of arts degree in education at Harvard, where he also studied design, before returning to Honolulu to teach and to pursue community service interests. He is chairman of the Parker School Trust (Waimea, Hawaii) and president of the Friendship Garden (Kaneohe). He is married to landscape architect Janet Gillmar, and they have two children.

As a Stew-Rice Night presentation, "The Dillinghams and Kapiolani Park" offers a wealth of possibilities for a delightfully relaxed and informative evening.

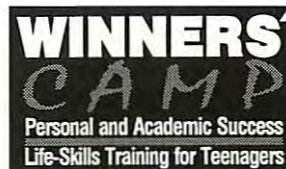

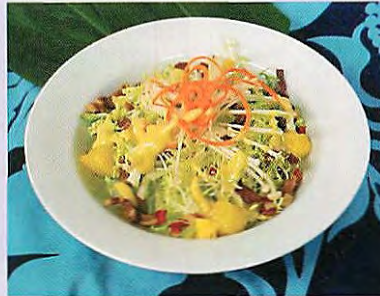

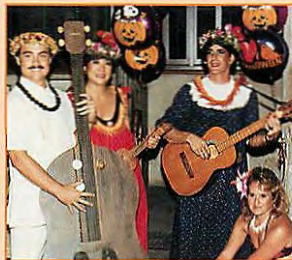

# Backward Glances

## 40 Years Ago 1962

J. Ward Russell, President

At this point in time, the general design and theme for the new Club premises have been established. The second phase of the beach development is under way by Hawaiian Dredging and Construction. This phase includes the removal of coral deposits from the Sans Souci Beach, construction of a groin, additional dredging to increase the area of the swimming basin, and shaping and compacting of the coral base for a future beach. Borings at the site disclosed excellent material available for beach use.

With a caller in fine voice, a square dance party was held at the Club. Members showed up in dude and fancy dress western garb, and dined on chuck-style beef with all the trimmings.

The Japan National Championship baseball team was hosted to lunch at OCC.

## 30 Years Ago 1972

The Outrigger reported that Club member Harry Huffaker became the first swimmer in history to swim from Oahu to Molokai on September 14, 1972. The 26-mile swim from Makapuu to a spot near Ilio Point was sponsored by the Club and completed in 16 hours, 15 minutes.

Many of the moorings fronting the Club have not been maintained. A reminder was published to say that neither the OCC nor its employees

are responsible for the mooring system. "Take a look please, and remember: the boat you save may be your own."

It was reported that the Club's summer free canoe ride was carried out every Sunday during June, July and August. Each Sunday, some 50 members were taken out in Club canoes. An estimated 500 people rode the summer waves.

At the Club's Annual Awards Banquet in August, the top athletic award, the Winged "O" was awarded to Bill Baird and to Karl Heyer III. Baird, a member since 1944, was a paddler and member of the All American volleyball team. Heyer, a member since 1945, participated in Hobie Cat regattas and served as Club Captain for two years.

## 20 Years Ago 1982

The 1982 Athletic Awards ceremony was held on August 20. Bob Fisher was awarded the honor of receiving the Winged "O". More than any other individual, he is deemed responsible for the good relationships between the Outrigger and those who make up the leadership of the canoe racing association.

Na Wahine O Ala Wai: Wahine from different clubs paddled together at their first annual regatta for all master women's crews from seven OHCRA clubs. Fred Hemmings Jr. was racing chairman for the afternoon. "Right On" Fred is known to have described the women's masters as "a bunch of ladies who really know what paddling is all about."

## 10 Years Ago 1992

On July 5 at Kapiolani Park, what was billed as the Inaugural Legends Reunion took place. Five OCC members took part in the old Bar and Restaurant Baseball League. Levi Stanley served as umpire while Henry Ayau, Colin Chock, Jim Gaddis and Bill Kilcoyne played.

Shades of gray and white dominated what was left on the tops of heads; bellies protruded, and eyelids sagged. An ambulance was supposed to be stationed nearby. When the game started, everyone thought of themselves as 20 years younger until they reached first base. Even the youngest player in the game, 40-year-old Gaddis, needed 54-year-old Samoan Chief Fia Moe to pinch-run for him every time he got a hit.

The Club has just completed renovations of both the Executive and Business offices. These included new furniture and rearrangement of work stations.

# How Our Favorite Surfing Spots Got Their Names

On July 29, John R. Kukeakalani Clark was the featured speaker at the Historical Committee's popular Stew and Rice night. Clark, Honolulu's deputy fire chief, former lifeguard and water authority, spoke about coastal sites near the Club, and their mo'olelo.

Among the stories he told, were the histories of the surfing spots in front of the Club that are popular with members of all ages, and how they got their names. He also shared stories told to him by Hawaii's avid watermen.

For those who couldn't attend, we'll share his tales. All of these, and more, can be found in his book, *Hawaii Places: Names, Shores, Beaches and Surf Sites*, which is published by the University of Hawaii Press.

## Old Man's

This site was first surfed regularly by Albert "Oscar" Teller (1909-1995). He came to Hawaii in 1932 and learned to surf in Waikiki. A body builder, with an excellent physique, the beach boys immediately named him Oscar after the statuette given out for the Academy Awards in Hollywood, and that was the name he used for the rest of his life.

In 1958, Teller moved into a cottage behind the Sans Souci condominium, and started surfing Old Man's. During the early 1960s, Ralph Sallee and Floyd Bendickson, two younger friends who surfed with him, began calling the site Old Man's and the name stuck.

Teller surfed here regularly until 1984 when he finally stopped surfing at the age of 75. His ashes were scattered at Old Man's in 1995.

## Tonggs

This popular site was named for Ruddy Tongg, an island businessman, who had a Diamond Head beach front home from 1946 to 1961. His sons Michael and Ronnie were avid surfers, and their home was the focal point for the neighborhood surfing community.

## Castles

Castles was named for the home of Samuel Northrup Castle who arrived in Hawaii with the eighth company of missionaries in 1837. He left the mission in 1851, and with Amos Cooke founded Castle & Cooke Company.

The Castle Family's three-story beach front home, Kainalu, was a prominent landmark in Waikiki and the landmark for the take off at Castle's. It was razed in 1958 for the construction of the Elks Club. Castles is the south shore's most famous big wave surf site. The second reef site does not break unless wave heights are 10-feet or greater.

In 1930, Duke Kahanamoku caught a now legendary wave here and rode it standing all the way to Waikiki Beach. This spot is also known as Kalehuawehe.

## Mo'olelo

In Mr. Clark's book, former OCC beach captain and big wave surfer George Downing shared the following stories about Castles.

Castles was also called Blue Birds and Steamer Lane by some. However, these were not actually Castles. Blue Birds is to the west of Castles, outside of Techniques, and it forms only on a special swell, a more westerly swell. That's the spot that the Duke named Papa Nui.

When Duke made his famous ride from Castles to Canoes, he was riding a 16-foot long skegless redwood board. To make that ride, the angle of his slide would have been important, especially to get from Castles past Cunha's. That in between section is Techniques, and it's a difficult section to get through. You had to have good technique to make it, especially on the old boards.

Steamer Lane was a term that was used to describe Waikiki when it was breaking at its biggest, as in, "We have a Steamer Lane swell" today." It happened when the lineup put you so far offshore that you were in the shipping lanes used by the former interisland steamers. But it wasn't one specific site.

In the years that followed Duke's ride, there was talk among other surfers, if he really did it or not if anyone could actually ride a wave from Castles to Canoes. This bothered Downing, and he wanted to prove to himself that the Duke could have done it.

"In the early 1950s, I was out at Castle's on a big day, but using a smaller board, a 10-foot balsa/redwood with a skeg," Downing told Clark. "I made the ride three times from Castles to Canoes. In fact, I ended up past Canoes, inside of Populars, and there's no doubt in my mind that I could have made the Halekulani Hotel. But out of respect for the Duke's ride, I never went ashore. The Duke was something special, and I tried to be respectful of his image and what he did.

"I proved to myself that it could be done, and that if the Duke said he did it, he did it. The smaller board took a lot of maneuvering, compared to Duke's 16-foot board, which had a lot of

glide, and the paddle back out between waves took at least 45 minutes. During the rides I remember thinking, 'alright, I'm still going', and at the end of each ride, I was always amazed that I had ridden so far.

"Castles on a big day is a massive wave. The current is strong, and it's so hard to line up that lots of waves come through unriden. You drift quickly and really have to watch your markers. The big sets usually clean everyone out.

"To make that ride to Canoes, takes a special wave, the more from the south, the better, and it is probably one of the longest waves in the world on one wave. The ride takes you from end of the Bay to the other. From Castles it's the same wave, one long swell, and you go through section after section. Each section has a peak, and you have to turn down into the peak and then accelerate forward. All of the riding is done outside of the regular spots, like Publics, and Cuhnas."

June 1995 is the last time Downing surfed at Castles, and the swell then lasted three days. "I had a pair of binoculars and from the beach I counted over 500 people in the water from Castles to Populars. This is what makes Waikiki so unique so many sites in one bay, in one place. When we get a gigantic swell, the wave train breaks outside and regenerates itself inside in many different spots. These are the waves that produce lots of good memories that live in your mind forever."





# Castle Swim Set for December 1

The 29th annual Castle Swim will be held the Sunday after Thanksgiving, December 1. Registration is on the Hau Terrace at 8 a.m.

The swim is named for an old swim, also called the Castle Swim, which was open to the public and began in the 1920's. Harold Castle's home was on the site of the present Elks Club, and he provided the trophies for the swim which started at his home and finished on Waikiki Beach, where the Outrigger Canoe Club was formerly located.

Twenty nine years ago Fred Hemmings proposed that we revive the Castle Swim, make it an OCC members only event, and race from the former finish to the former start. There were seven people entered in 1973, and after the race they all sat on the Hau Terrace for refreshments and decided how to arrange the age groups so they could each get a trophy out of the deal.

Those pioneers were Bruce Ames (1st, overall), Dale Hope, Roger Cundall, Gerry DeBenedetti, Karl Heyer III, Cline Mann, and Fred Hemmings.

The next year we discovered a problem: we didn't have a Swim Committee. Can you imagine? So Gerry DeBenedetti became the chair of the first Swim Committee, and subsequent chairs have been Ian Emberson, Pam Zak, Arnold Lum, Chrissy Lambert Rhodes, Chris Worrall and Peggy Danford. (If we forgot someone, speak up so we can correct our historial record)

Awards are given for every five years in age groups, from junior to as old as our competitors. Swimmers are advised to have an escort, who may be on a paddleboard, one person canoe or kayak, or even swimming beside you. A tip for you first time swimmers: your escort should set the course for you, and you follow their heel, or back, or bubbles.

There is no entry fee. So, making it as free and easy as possible, you do your part and save the date, and start practicing. You have 60 days to shape up.

Sign up at the Front Desk to join us for the swim and brunch to follow. Brunch is complimentary for you and your escort. Maybe you'd like to escort a fellow member, also sign up and show up that day. Look for more details on the tunnel bulletin board.

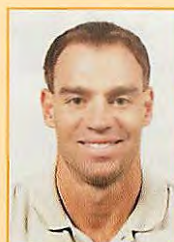

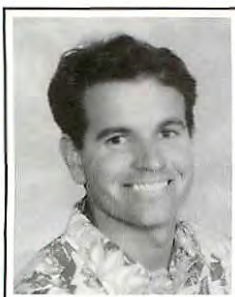

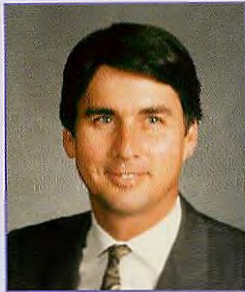

# Board Briefs

**Treasurer/Finance:** When the 2002 budget was developed an additional loss of \$256,700 was projected due to the September 11, 2001 terrorist attack. It was agreed that the additional loss would be considered a one-time charge, which would be subsidized by initiation fees transferred from the Capital Improvement Fund to Operations. The subsidy allocated for the first half of 2002 was \$114,679, roughly half the expected loss of \$256,700. . . The Club is doing very well compared to budget. As of June 30, 2002 we were \$134,495 better than budget in Food & Beverage, Logo Shop, dues and insurance and essentially required no subsidy. There was, however, an unbudgeted expense of \$47,783 to remove concrete pilings. Initiation fees were transferred to Operations to cover that cost. The excess of budgeted subsidy remaining in the Capital Improvement Fund as of June 30, 2002 was \$66,897.

**Building Fund:** Formerly all initiation fees were placed in the Building Fund. About a year ago the Board approved placing all newly received initiation fees in the Capital Improvement Fund. No new funds were placed in the Building Fund during the period June 30, 2001 to June 30, 2002. The Building Fund balance as of June 30, 2002 was \$12,671,602, which is a loss of \$935,634 or 6.9% compared to the June 30, 2001 balance. The report compared the Building Fund's loss of 6.9% with the Dow Jones loss of 12% and the S & P loss of 19%.

**Vice President of Activities Report:** The all day Master Plan Charette was very successful. After reviewing the strengths and weaknesses of the previous proposals, the Committee voted to examine in more detail a concept to be referred to as SK-5. Preliminary studies show that it will meet future Club requirements and fall within all zoning regulations. The key points addressed

in SK-5 are: consolidation of the Administrative Offices, Fitness Center, a New Logo Shop, Back of the House Storage; Board Room; Member Courtesy Lounge; Beach Service Area; Snack Shop; Employee Lounge; and Parking. The architect will prepare a vertical dimension, special relations sketches. The full committee will meet to review and fine tune these plans.

**Master Plan Marketing Subcommittee Report:** The newly formed Master Plan Marketing Subcommittee consists of Sue Tetmeyer, Chair; Bob Dewitz, Barbara Stehouwer, and Joyce Timpson. Their goal is to achieve widespread member and employee support of the Master Plan. Their initial strategy is to share the Master Plan concept with all standing committees and interested athletic committees, to get their input (within a specific framework the subcommittee will define and communicate) and their endorsement.

**Secretary's Report:** One member was suspended for being delinquent for the third time in a 12-month period.

**General Manager's Report:** Net income from operations for June was \$32,766.

**Admissions & Membership Report:** The membership count was 4,569 as of June 30, 2002.

**Building & Grounds Report:** The Board discussed the hanging kayak storage. The members on the waiting list are not interested in placing their kayaks in the hanging kayak storage system. The issue was sent back to the committee for their recommendation on whether the hanging kayak storage should be eliminated. . . The Board approved the Building & Grounds Committee to have design/drawings for a wave deflector completed by Sea Engineering. The estimated cost is \$2,200.

**House Report:** Mr. Rader presented the

plans for a new bar in the Koa Lanai to the House Committee and said he expects to have it built in January 2003. Mr. Rader was authorized to proceed as planned. . . a half off food special recommended by the House Committee will begin on Tuesday, September 3, 2002. On Tuesday nights only on the Koa Lanai all food will be half price if you make reservations (or walk in and are seated) between 8:00 p.m. and 9:00 p.m. All beverages will remain at regular price. The House Committee is hoping this special pricing will attract members to the Koa Lanai.

**Athletic Report:** \$25,524 was approved for the State Championships in Hilo. . . The Board approved \$2,200 line item transfer for a puffy koa ama for the *Kakina*. . . The Board approved George Wessberg as Club Captain for the balance of 2002. . . The Board approved \$4,700 for compensation for the 2002 Regatta Coaches. . . The results of the Volleyball Nationals: two 18 year old teams participated. The team competing in the elite division placed 13th. The team that competed in the club division placed 9th; the 16 year old team came in third place; the 14 year old team came in first place; the 12 year old team came in fourth place; the 10 year old team came in sixth place. . . The Club is having difficulty getting insurance coverage for non-members who are participating in Club events. . . A&M reviewed the records of members who joined as Juniors (Parent Nonmember) and participated in the Junior Volleyball Program. They found very few are dropping out of the Club. Therefore, the recommendation is to continue the current admissions policy.

**Entertainment Report:** The Board approved Taina Thompson as a new member on the Committee.
