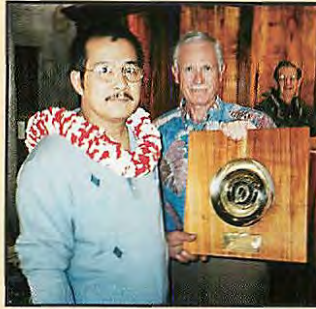

More than 100 members gathered at the OCC on February 25 for the Annual Meeting of the Outrigger Canoe Club.

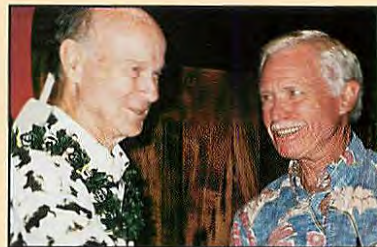
President Hal Henderson presided over the meeting which included the introduction of newly elected members of the Board of Directors, committee reports, the introduction of the Employee of the Year, the awarding of Life Membership to John Goss, the announcement that Marc Haine had been elected to the Winged "O" and the blessing of the newly renovated koa canoe Ka Mo'i.

President's Report

At about 6 a.m. on September 11, John Rader called me and, amongst, other things, we discussed the possibility of closing the Club for the day in light of what had happened that morning. After talking to two other Directors we decided not to. We felt that many members might want to be with friends for comfort or to work off frustration and anger in or on the water, working out, or just enjoying the Club and the beach. This has been the essence and spirit of the Outrigger for almost a century and I'm sure this will continue to be so.

Your Club is in sound financial condition. In spite of the drop in business as a result of 9/11, we managed to do just a little better than break even in the food and beverage operations for the year and overall came in slightly worse than the small loss that we budgeted.

Looked at over a five year span, however, we have been slightly in the black after setting aside funds for capital replacements. Our goal has been to provide the best services possible to the membership while keeping costs in line and essentially trying to run a break even operation over time.

A substantial increase in the minimum wage and other rising costs forced us to increase dues by 5%, effective February 1 this year. However, over the last five years, dues have increased an average of only 1.4% per year compared to the preceding five year period in which they increased over 7% per year. I'm sure that future Boards will continue to keep dues increases to the minimum consistent with the quality of the facility and operations.

During the year, we completed the membership survey which has provided valuable insight into areas where we need improvement and which is being used to expand and improve operations. Thanks again to all of you who responded.

Work on the Master Plan continued. The survey indicated that across all membership categories there is a desire for a better fitness facility. This is one of the driving forces behind the Master Plan and perhaps the most difficult to deal with.

Height limitations, other zoning requirements and our own desire to maintain the architectural integrity of this beautiful facility are being studied very carefully to determine what is practical and feasible. Progress was made in this area this year and the work is on-going. I know that the new Board will have it as a major priority.

We also completed a comprehensive analysis of the Capital Improvement Fund and the so-called Building Fund to re-assess their purpose and adequacy. The first of these is funded by setting aside cash from

operations, primarily depreciation, and from initiation fees.

The purpose of this fund is to accumulate the necessary money to replace capital items that will wear out over time, such as tables and chairs, kitchen equipment, air conditioning equipment and also to fund Master Plan improvements.

The Building Fund as most of you know, is there to fund either the purchase of this property or to help offset the rent increase which will occur in late 2006. We determined that, taken together, the total of the two funds will be adequate for their stated purposes.

Which leads me to my next point—our neighbor and landlord. No further progress was made, in fact, nothing was attempted this past year. As Peter Nottage reported last year this is like pushing on a string. Unless and until they want to have a serious discussion we are only negotiating against ourselves. That time is coming and I do believe that we can make a very persuasive case that it would be in their best long-term interests to sell us this property.

Finally, as many of you may know, the Department of Land and Natural Resources received an anonymous complaint about the piles located in the water out front. When they were installed we apparently obtained an Army Corps of Engineers permit but not one from the State. Now that this has been brought to their attention the bureaucracy has no option but to deal with it. They have asked us either to remove the piles or obtain a permit and then enter into a lease for the area they occupy.

Ricky Grigg has confirmed our unscientific observations that the piles do little if any good in keeping the sand on our beach since the prevailing current moves from Diamond Head towards Waikiki. Since the cost of removal is significantly less than that of obtaining a permit and paying lease rent to the State of Hawaii for the next 50 plus years, we are now in the process of negotiating a contract for the removal of the piles.

On a personal note, It has been a great privilege to have served on the Board for the past six years and I am sure that the others in my class of 1996, Liz Perry, Joyce Timpson and Karl Heyer IV will agree. It's been a lot of work but also a lot of fun.

For me particularly it has been a great honor to have served as your President for this last year. I would like to thank all my fellow Board members, Committee Chairs and committee members and all the staff, particularly John, Gordon, Don, Chef Manfred and Terry for all your advice and support throughout the year. Thank you all and ALOHA.

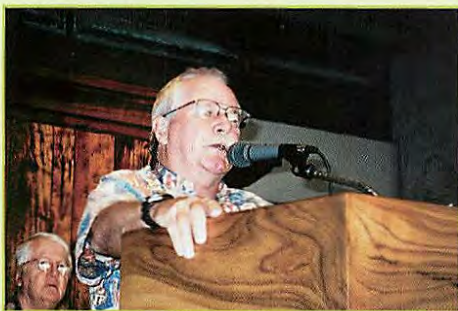

Ballots were mailed to the 1,810 members eligible to vote. These include Regular, Intermediate, Senior and Life members. A total of 942 ballots were received. Of these 22 were invalid because the envelope was unsigned or the voter was delinquent in Club accounts or the ballot was unmarked. This left 920 valid ballots compared with 888 in last year's election.

Secretary's Report



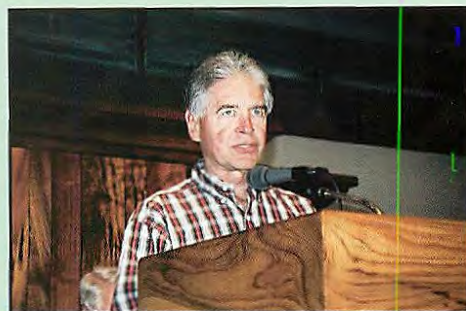

Treasurer's Report

2001 was a tough year for your Club. It got off to a slow start, but a strong summer pushed the Club back ahead of budget. Then came September 11 and I do not have to explain to all of you how devastating this tragic event was not only for the nation but for our Club as well.

The Club finished the year with an operating loss of \$98,800 which is \$23,600 worse than the \$75,200 loss that was budgeted.

There were \$543,400 in initiation fees collected which were added to the Capital Improvement Fund.

At year end, members' equity was approximately \$19 million of which \$12.9 million was in the building fund and \$6.1 million in the Operating Fund. \$1,843,000 of the operating fund balance has been set aside in the Capital Improvement Fund for future capital improvements.

The Club's food and beverage operations met the goal of breaking even with the mini-charge, and strong sales in December enabled the Logo Shop to reach its budget.

The Club spent \$622,300 on capital improvements and another \$387,400 on repairs and maintenance.

We are of course an athletic club and as such our athletic expenditures were \$215,900 which is 2.9% of operating revenues.

A small part of capital expenditures, but one with positive implications for the Club's paddling program, was the redesign of the Kakina, one of the Club's oldest koa canoes. With the design and wood working skills of Joe Quigg, and the craftsmanship of Dome Gose, the Kakina is now a state of the art koa racing canoe and will serve the needs of the Club's paddling program for years to come.

Another koa canoe with a long history with the Club, the Ka Moi, was refurbished through the guidance of Tay Perry and with the assistance of other Club members. The Ka Moi will be blessed after this meeting. At a later date the Ka Moi will be hung in the bar.

The Budget Committee faced a challenge in developing the 2002 Budget. As a result of September 11, Reciprocal and Guest usage was projected to decline, member usage was expected to decline and there were significant increases in the cost of insurance projected.

Due to the uncertainties surrounding the magnitude and duration of these changes, the Budget Committee decided that instead of making drastic staffing cuts and changes in hours of operations, they would take a wait and see approach using a portion of the initiation fee revenue to subsidize the possible projected operating loss.

To minimize the amount of initiation fee revenue needed to subsidize the projected operating loss, the operating budget for 2002 was cut wherever possible as long as it did not have a significant negative impact on the services provided to members. Capital expenditures were also prioritized with many items not related to safety deferred until a future date. The variations in sales levels as a result of September 11 will be evaluated quarterly.

Admissions & Membership Report

Our membership is at 4,530, 60 percent of that is resident members and 40 percent of that is Nonresident members.

This year's committee processed and interviewed 170 new members. We meet with sponsors and candidates at a rate of 15 per meeting. This was an exceptional year in that we interviewed the best of the best candidates and were all accepted.

We are always looking for ways to improve our system and make the A&M process equitable for all candi-

dates. This year's adhoc committee updated several policies that will assist the committee and speed up our system.

Athletic Report

The Club enjoyed a banner year in all of the sports in which it competed. Crews and teams sponsored by the Club honored themselves in the highest levels of national and international competition. In addition, and some say more importantly, the athletic programs supported by the Club reached farther into the membership than ever before allow-

ing many more Outrigger members to enjoy the honor of representing the Club.

In canoe racing, the Club won the Oahu Championships in July which was an accomplishment that paddlers from 12 through 60 plus were able to enjoy together. The Club then banded together to take third place in a hard fought State Championship on Kauai. In all, over 200 members, including a record number of juniors, paddled in the Regatta season.

In the long distance paddling season, more paddlers participated in the program than ever before. The Club supported junior members taking part in the distance races which has not been done in the past. The Club also sent a deserving men's novice crew to Molokai after that crew had gone nearly undefeated during the Regatta season. Men's and Women's crews also placed high in the prestigious Catalina and Molokai races.

In volleyball, the adult teams once again dominated local competition and placed high in national competition. Junior member participation was at an all time high with one of the boy's teams taking a bronze medal at the junior national tournament.

Two of our members, Stein Metzger and Kevin Wong, products of the Outrigger volleyball program, are ranked in the top five on the international beach volleyball circuit and have established themselves as serious gold medal contenders in the Athens Olympics in 2004. Stein and Kevin have certainly not forgotten their roots and have given back to the Club by providing their time at beach clinics for our young members.

In addition to paddling and volleyball, the Club supported hundreds of members in one man canoe racing, kayaking, paddle board competitions, surfing, softball, running, swimming and golf. This included support for the elite athletes in their sports as well as members who had met the requisite training requirements.

Credit for the success of the program must go not only to the athletes but also to the volunteer athletic subcommittee chairs and their committee members.

Bill Danford took on the thankless task of serving as the Club Captain for the second year in a row and should be commended. John Rader, Gordon Smith and their staffs provided tremendous support and flexibility in accommodating the athlete's needs and handled those tasks with ease and grace. Finally, my fellow Directors were all very supportive of all athletic programs this past year.

In 2001, we established and budgeted for a paid activities director to oversee the extensive athletic program and to create new programs for the entire membership. We hope to find a qualified candidate sometime this year. We also established spending procedures which will ensure that the Club's financial resources will be best utilized so that the Club can maintain its position as the pre-eminent athletic Club in the nation.

We have a terrific young lady, Sasha MacNaughton, who has taken over as Club Captain for 2002 and will undoubtedly do a fine job. As you can well see, the future is extremely bright for Outrigger athletics.

Bylaw Amendment

Members voted to amend Section 41 of the Club Bylaws as recommended by the Board of Directors to read as follows:

"Absence and Hardship. Each member other than a Nonresident member who has been absent from Oahu for a continuous period of six months or more may petition the Board of Directors for a remission of one-half dues during such period."

The Board of Directors, at its discretion, may grant inactive status to members in, but not limited to, the following situations: financial hardship, illness that prevents use of the Club for an extended period, or absence from Oahu pursuant to military orders or to attend school.

Cinco de Mayo

Cinco de Mayo kicked off the 2001-2002 Entertainment calendar. 213 people participated in the event, which included a Margarita Hut, a Mexican food buffet

on the Hau Terrace and music by a traditional Mariachi band.

Keiki Carnival

Held in June, the Keiki Carnival has come to signify that summer has officially kicked off at the Club. This year's event proved to be the largest Keiki Carnival yet, with over 200 children and adults spending the day enjoying the free crafts and activities. The Carnival was held on the sand area between the Hau Terrace and Snack Bar and included making picture frames out of popsicle sticks (then filling them with a Polaroid picture of themselves), necklace and bracelet stringing, pottery and temporary tattoo application.

Activities included a dunking booth, inflatable bouncing Castle, two clowns performing magic and creating balloon sculptures, and a shaved ice booth. Brown bags lunches were also available for those who wanted a quick and inexpensive meal.

A Night with June Jones

University of Hawaii Football Coach June Jones joined 106 of our members for a stew and rice supper before giving an hour presentation about Achieving Personal Success. This first time Club event was met with much anticipation as it was only the second public speaking engagement Coach Jones had done since his near fatal car accident five months earlier. The event was considered a great success with a suggestion for the future that it be geared towards motivating younger members of the Club personally as well as athletically.

Annual Club Luau

The Annual Club Luau is always a highlight for the membership and in turn, accounts for the majority of time and energy spent by the Entertainment Committee. Although there was a fear that attendance for this year's Luau would be hurt by the events of September 11, 434 members turned out in force to enjoy refreshing beverages from the Mai Tai Bar as well as ono Hawaiian food prepared in the Club's own kitchen.

Music included the Cockett Trio, Hui Aloha and the always popular Ho'okena. Under the supervision of Patti Mowat and Conne Sutherland, decorations transformed the Hau Terrace into a South Pacific garden and were left up for Club members to enjoy the next day as well.

In addition, for the first time the Committee chose to enact a "payment at the time of reservation" system. A couple of members expressed dislike for the system (and therefore were accommodated by management) but in general the new payment system ran smoothly and greatly reduced the no-show factor. And finally, although the intent of the event was to financially break even, it netted an impressive \$2,700.

Princess Kaiulani Fashion Show

The Outrigger membership again supported this holiday tradition with a sell-out crowd. Club members modeled muumuu and holiday attire designed by Princess Kaiulani.

Finance Committee Report

Our committee is responsible for overseeing five major areas: 1) The Building Fund, 2) The Capital Improvement Fund, 3) The Defined Benefit Pension Fund, 4) the Club's property and liability insurance, and 5) the annual audit.

The Building Fund was established to help finance the purchase of the fee simple interest of the land on which this Club is located, or secondarily, to help

fund the expected increase in lease rent at renegotiation in November 2006.

The fund's specific goal is to grow in value to at least \$16 million by the year 2006 by investing in a combination of fixed income and equity investments. I'm happy to report that we are on track to make that goal with a total market value for the fund of \$12,934,800, as of December 31, 2001.

The Capital Improvement Fund was established to have funds available for specific, future capital improvement projects. Fixed income investments comprise 100% of the fund's investments and are invested in bonds with various maturities to match the projected capital needs over the next five years.

As of December 31, 2001, the total market value of the Capital Improvement Fund was \$1,843,200.

The Defined Benefit Pension Fund was established for the benefit of the employees of the Club to provide them with income after retirement. The committee routinely reviews investment performance and the actuarial assumptions of the fund, to make sure they are aligned with the current economic environment. This coming year will give rise to higher pension expense due to the negative impact of lower discount rates and the poor capital markets performance in 2001.

As of December 31, 2001, the total market value of the pension fund was \$4,206,100.

The committee also reviews the Club's property and liability insurance contracts annually, and this past year there were no major changes in contract renewals. This coming year, however, we do expect significant premium increases from the major insurance carriers caused, in part, by the September 11 attacks and heightened terrorists risks.

Finally, PriceWaterhouseCoopers conducted an annual audit of the Club's financial records and will be issuing an unqualified opinion on the Club's financial statements. A copy of the audit report will be available in the General Manager's office for review by any member in mid March.

Historical Report

The Historical Committee, with its diligent working members, has experienced another productive year for the benefit of the Club members. The primary purpose of the committee is to preserve and account for the various items and memorabilia concerning the Club and its activities.

The committee consists of a number of ad hoc committees that are the working backbone that get the various tasks done.

- Current News Clippings—Is tasked with mounting various current news clippings from

the daily newspapers and other contributions concerning the activities of the Club. A clipping service over the years, the cost being underwritten by director Joyce Timpson's company, has been of great assistance in this matter.

- Photos—This ad hoc committee meets frequently throughout the year to catalog and account for the various photographs the Club possesses. The cataloged photo count is numbering 3,000 and growing.

- Oral Histories—Two oral histories were completed during the year. Volume 11 consisting of 29 oral histories was indexed and is presently at the bookbinders for hard cover binding to be completed by April 2002. The number of oral histories completed to date number 60.

- Slide Show/Special Events—Much planning and producing were instrumental in presenting the Stew & Rice Monday evening events of Manu Boyd, a former employee, "History of Hula" in September and member Dale Hope's "The Aloha Shirt" in November.

- Writing Research—The researching of the Club records by the committee contributed to the Backward Glances column in each issue of the *Outrigger* magazine.

- Trophies—A catalog listing exists on all of the Club's trophies and various items that are accounted for elsewhere. The list of trophies and their sporting categories grows each year and now number 253, a gain of 13 trophies in 2001.

- Library—There are a number of tasks that are performed in accounting for the various assets in the archives files, such as collating, binding and general management. The '98-'99-'00' *Outrigger* magazines have been bound in hard cover.

- Lobby Display/Reception—Historical puts on a display each year to explain its function as a standing committee. In March and April 2001 a display was exhibited. In addition, displays advertise the Stew & Rice events.

- Koa Canoe Research—The completion of the restoration of the Ka Mo'i is now fact. Plans for the installation of this renowned koa surfing canoe in the Bar/Lounge is to take place upon the Club's announcement. It is strongly recommended that the Lounge be named the Ka Mo'i Lounge.

- Digital Archiving—Is pending the search for a knowledgeable computer whiz kid.

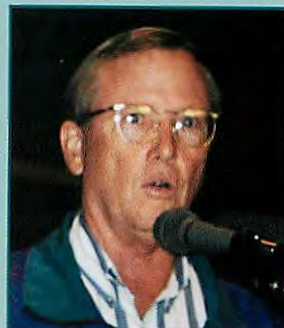
- Centennial Publication—The preparation of the time line and proposed budget for publishing the centennial publication by 2008 has been updated. Presently a meeting of this ad hoc committee is held annually to consider updates, if any. First expenses will be incurred in 2004.

- Archive News—This ad hoc committee is researching the Library of Hawaii newspaper articles concerning the Club's activities. To date, 1908 to 1917, including 1926 have been recovered. The articles are copied, without photos, from microfilm and are transcribed using MS Word to make them readable and ready for scanning. A CD-ROM, along with a printed list of articles is on file. Presently there are 201 articles and counting.

To assist the committee, 22 databases have been created to catalog, list and keep track of the various items of information and physical presence. These lists are kept in the Executive Office for reference by individuals on a "need to know" basis.

I wish to note the passing of our Past President and committee member extra ordinaire J. Ward Russell last July. He was focused on historical matters of the Club right to the end. A case in point was referenced in an article in the January *Outrigger* magazine on the return of the Clark trophy which was awarded to an outstanding girl surfer. In 1910 it was awarded to Josephine Pratt (Paris) and in 1917 to Josephine Hopkins (Garner). It is the first known surfing trophy to a female.

Long Range Planning Committee

Long Range Planning, as the title implies, does not hold schedule sensitive, pressure cooker, kinds of meetings like the social, athletic or finance committees. Nevertheless, we had a interesting and efficient year with productive discussions on many topics.

The President and his board asked us to examine the basis for our membership quotas and guidelines. We made a project of this request and produced a documented system

and procedure for evaluating these 16 categories and for establishing a basis for recommended changes.

This document is on file with the General Manager, our Controller and with Ms. Sue Tetmeyer who heads the membership ad hoc committee. The procedure is available to any individual or committee wishing to either validate or recommend a change to one or more of our membership categories.

Separately the committee spent time discussing our Intermediate membership category which has been in decline for 15 years. We devoted one meeting primarily to this subject and included four guests at the meeting who are members or prospective members for this category. Our recommendations for programs to improve the Intermediate membership have gone to the Board for distribution to other committees.

Other subjects the committee discussed, and sometimes debated, include an IRS statute requiring certain initiation fees to be returned to a member who resigns; handling of returning Nonresident members should these numbers increase dramatically at sometime in the future; and the planning methodology associated with the master plan designs.

Additionally we examined specifics from the member survey taken in April to see how results applied to the projects we had under discussion. And together with John Rader and Dale Armstrong, we considered alternatives for how Long Range Planning should be involved with our facilities maintenance program called Reserve Pro.

Lastly the committee has made recommendations to the board for topics to be considered by Long Range Planning during the coming year.

Building & Grounds Report

The Club has continued to invest in significant repairs and improvements to the property over the past year and I would like to review some of the more significant items with you.

Most recently, a renovation of the Snack Shop area was accomplished to improve the productivity of the work space and the ambiance of the service and seating area.

A new access from the parking garage to the main entryway has been designed and is ready to be constructed.

Repair & refinishing of one of our koa outrigger canoes has been completed.

Other improvements include: concrete surfacing of the canoe storage alleyway and a new awning, replacement of a large portion of roofing and correction of standing water problem, stripping and resealing of parking garage decks, replacement of landscaping adjacent to the Bar area, design and installation of a prototype kayak storage rack to remedy the chronic shortage of

slots and eliminate need to take parking spaces for kayak storage, installation of ventilation system in fitness center, continuing repairs of spalled concrete, installation of a new, stainless steel spiral stairway to the volleyball court, resealing of the main driveway asphalt, removal of water stains and refinishing of the ceiling in the dining area entry corridor, and replacement of deteriorated wooden beams all around the dining area fascia.

In addition to these bigger ticket items, our maintenance staff has continued to make progress on a backlog of more routine items such as: renewal of light fixtures in various areas of the building, repainting and refinishing of outdoor furniture.

This progress could not have been without the efforts and contributions of the committee members who give very generously of their time and talent to guide and oversee this effort. I thank them most sincerely. I would also like to thank our Maintenance staff and our Facility Manager, Terry Girulat for their effort and support.

I would most especially like to thank our General Manager John Rader. During the two years I have been chair of B&G, John has been the person who ultimately has had to execute every one of these projects. He has done an extraordinary job and we are fortunate to have someone with his energy, talent, and commitment.

House Report

A two-part Membership Survey was completed by Market Trends Pacific in March of 2001. The results indicated that overall satisfaction of the club is high. In general, the members suggest the Koa Lanai could offer better value, and the Hau Terrace better service and more variety.

There is strong support for a better Fitness Center, more member canoe and kayak storage, new beach chairs, more seating capacity at the Snack Shop and improved shopping, including website shopping in the Logo Shop.

Useful "tracking questions" were also tabulated. Formal presentations of the survey results were made to the Board of Directors and the House Committee. Copies of the reports were distributed to all of the standing committees.

Management has responded to the survey with a spirit that the survey has empowered them to act decisively because they have been given a clear message of the member's desires.

Your House Committee has worked with management and has begun to show a creditable response to the member's wishes and concerns.

The Koa Lanai menu was revised by management. It reflects lower fresh fish pricing and includes a number of lower priced entrees that encourage families with young children to dine with us. Nightly specials add variety. The Hau Terrace menu has also been revised and there are nightly specials. The Bar features daily specials and the new "Wine Finds" program featuring Lyle Fujioka's wine value recommendations.

The Hau Terrace management team has been supplemented, provided with wireless communication devices to improve their effectiveness and supported with additional "food runners". Training is continually being reviewed.

The membership has responded with higher patronage of the Club food and beverage facilities. Food and beverage sales were up approximately 10 percent prior to September 11. There was a definite impact on sales from our nation's crisis, but we have also recovered nicely.

The free birthday wine was replaced by a free birthday dinner entree beginning in January of 2001. The results were very encouraging. We had been serving about 30 birthday bottles of wine a month under the old program. Five hundred and eighty-six birthday dinners were served in 2001 or 49 per month. (Almost a third of the eligible members celebrated their birthday with us.)

Canoe Paddling at Outrigger Canoe Club
Updated: 16 Feb 02

Tradition -- The Outrigger Canoe Club was founded on Waikiki Beach in 1908 for the purpose of preserving surfing on boards and in canoes. The members of our club held the first annual Walter T. Macfarlane Regatta at Waikiki on July 4th, 1943. It is now the oldest ongoing outrigger canoe racing event in Hawaii.

Mission -- We are committed to providing an outrigger canoe paddling program for members to compete and be successful at the highest level. The emphasis is: to provide a safe, fun environment for members to learn skills and develop knowledge necessary to participate; to instill the values of respect, responsibility and sportsmanship to self, team, club and community; and to support competition and experiences for winning.

Membership -- All paddlers on our crews must be individual members of the Outrigger Canoe Club at the time the season begins even if a parent or sibling is a member. The application process may be initiated by a Regular Member of the Outrigger Canoe Club for individuals ten years of age and older. The membership process must be conducted through the Admission Committee and it usually takes a year or longer for adults and at least six months for children. Children of non-members may be sponsored by a Regular Member for Junior membership.

Registration -- Members desiring to participate on one the paddling crews must register in early March every year. A copy of a valid birth certificate and a recent photograph is required to complete the registration. There are separate registration dates and fees for the regatta and the long distance seasons.

Paddling Season -- The Regatta season begins in early June and ends in early August at the State Championships. The Long Distance season begins in August and ends with the Na Wahine O Ke Kai in late September and the Molokai Hoe in early October.

Chef Shares Recipe for Carrot Bread

Members have been asking for years for the recipe for the Club's famous Carrot Bread, one of the favorite lunchtime menu items. Chef has decided to share it with us, but remember's even though you can make it at home, it tastes better in the Koa Lanai and Hau Terrace when you're watching the waves and enjoying a relaxed lunch.

OCC CARROT BREAD

- 5 large eggs
- 2 cups oil
- 1 Tbsp. Vanilla extract
- 2 ½ cup Granulated sugar
- 4 cups all-purpose flour
- 1 Tbsp. Baking powder
- 1 tsp. Salt
- 1 Tbsp. Cinnamon powder
- 1 Tbsp. Baking soda
- 4 cups peeled & grated carrots (packed)
- 4 oz raisins
- 1 cup chopped walnuts

Method:

Preheat oven to 350 degrees
Sift the sugar, flour, baking powder, salt, cinnamon & baking soda together
Mix eggs, oil & vanilla extract in a mixing bowl till creamy
Add all the sifted ingredients & mix at a low speed until well blended
Last, add carrot, raisins & ½ cup of the chopped walnuts
Pour mixture into a 12x18 greased and floured baking sheet pan & level off
Sprinkle with 1/4 cup chopped walnut & bake at 350 degrees for 35-40 minutes

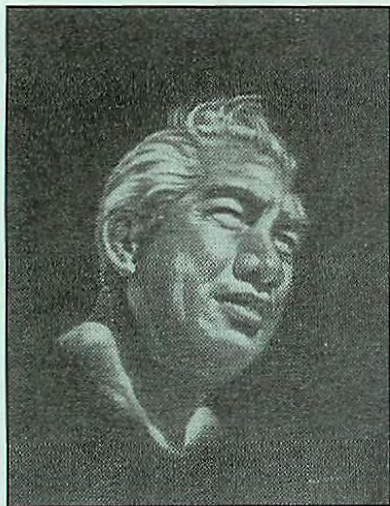

50 Years Ago - 1952

The Polo Season for 1952 began on April 11th. There will be "3 teams competing with each other" and with mainland and foreign teams. "The matches are held under the auspices of the Hawaii Polo and Racing Club."

In the April 1952 *Forecast* Edwin North McClellan writes in one of his outstanding historical articles of the announcement in the *Evening Bulletin* of March 14, 1908 that "Honolulu is to have a Clubhouse at Waikiki Beach for the Surfboarders and those interested in Canoe-Surfing."

"Mr. Stout, manager of the Seaside Hotel, and Proprietor Lishman have, at the request of Alexander Hume Ford, granted the site, and Jack [A.L.C.] Atkinson has promised to promote and organize the Club. Burton Holmes and E.K. Bonine are registered as the first and most enthusiastic non-resident members."

On page 7 of the April 1952 *Forecast* it states that "the Outrigger Club was actually founded on May 1, 1908." The story of the founding of OCC written by Edwin North McClellan continues in the May 1952 *Forecast*.

35 Years Ago - 1967

The Men's volleyball team had successful results at the OCC annual volleyball tournament held at Mid-Pacific Gym. The OCC Red team won 1st place, and the Green team was second. At the Central Y Tournament, Outrigger White took 1st, and Outrigger Red was 2nd.

At the National Championships in Detroit April 29-30, 1967 and at the AAU meets in Detroit the following weekend, OCC will be represented by Colin Chock, Tony Crabb, David Hendrickson, Michael McMahon, Ron Sorrell, Thomas Haine, Mike Holmes, Carl McGown, Dodge Parker, Pete Velasco, John Lowell, coach, and Wallace Young, manager.

30 Years Ago - 1972

Thomas A. Haine, President

At the regular April meeting of Club Directors, Christian Foster Jenkins, one of the few surviving Charter members, was elected to Honorary Membership in the Outrigger Canoe Club. He helped to promote the idea of the Club in 1908 and became one of the Founding members. He was active during the early years.

25 Years Ago - 1977

Robert Alexander Anderson, Jr., President

It was announced in the April, 1977 Outrigger that an amendment to the Club Bylaws, adopted at the annual meeting, has eliminated the classification of Lady Membership because "it discriminates against all other classes of membership in favor of women." Lady members will be transferred to other categories and will pay the regular membership dues of \$30 per month instead of \$22.50.

Board Briefs

Board Briefs is taken from the minutes of the January 31, 2002 meeting of the Board of Directors.

Executive Committee Meeting, January 17, 2002 – The State of Hawaii Department of Land & Natural Resources requested that OCC remove piles that form a groin in the ocean on the Diamond Head side of the Club because a special use permit was not obtained from the State. Later at a hearing before the DLNR Board, it ordered that OCC be fined \$2,000 plus \$220 in costs for not obtaining the permit and that OCC be required to submit an “after the fact” application for a permit.

Later it was determined that even if OCC obtains the permit it still must pay the state lease rent for the land that the piles rest on. Estimates for a 55-year lease range from \$60,000 to \$90,000 based on the fair market value of the adjacent land. It was estimated that it would cost about \$20,000 to complete the special use permit application, although some thought it could be as high as \$30,000.

There are no firm bids on the removal of the piles based on written specifications developed for OCC. However, one company has given a preliminary estimate of around \$80,000 and another has made a soft verbal estimate of around \$40,000.

Ricky Grigg has preliminarily reported that the piles do not significantly help maintain OCC's beach since the primary movement of sand is in the Natatorium direction (west).

Based on a consideration of cost and other considerations, the Board approved removing the concrete pilings. The Building & Grounds Committee will begin the process of obtaining the state's permission to enter its land to remove the piles.

Treasurer's & Finance Report – Based upon last year's projected liability, the Club may have to make an additional contribution to the employee pension plan of around \$500,000. This is due to a combination of the lower discount rate resulting in higher liabilities and a higher service cost, plus the poor performance of the stock market in 2001. The cost of the pension plan was discussed and it was decided to set up a sub-committee to analyze whether the Club should continue the defined benefit pension plan, freeze the pension plan or terminate the pension plan, since the Club also currently offers a defined contribution pension plan (401K) as a benefit to its employees.

Master Plan Update – Club representatives met with the Land Use Permits Division regarding the height limit as related to the volleyball fence. A site visit will be planned at a future time.

Secretary's Report – Three members were suspended for 15 days due to failure to pay their accounts on time.

Admissions & Membership Report – The membership count was 4,530 as of December 31, 2001. . . The A&M committee and the controller were authorized to work out a payment plan for qualified associate spouse members who apply for transfer to regular membership, and who demonstrate sufficient financial need. The payment plan would allow the member to pay the current initiation fee over a period of up to four years, with monthly payments equal to or greater than the amount of Regular monthly dues and, if applicable, a “balloon” payment at the end.

Athletic Report – Funding was approved for five teams to enter the Haili Volleyball Tournament.

Entertainment Report – The Spring Event was canceled.

The person who thinks so highly of Vicky says about her “she tries her hardest, is cooperative and reliable, she works earlier or later if someone is out sick”, and more.
