PRESIDENTS REPORT

With the Hawaii economy still struggling and showing no immediate signs of improvement, the Board of Directors began the 1998 term concerned as to the recession's

impact on our Club and its members. We partnered with management, standing committees, and adhoc committees, to formulate a single and most challenging goal.

We asked for a concerted effort to generate adequate income to cover operations without increases in member dues or food and beverage prices. With a goal of no budget increases, the challenge for the management team was enormous.

A common solution for private clubs with lethargic food and beverage operations is to increase the membership "mini charge". During my six years of service, the OCC Board of Directors has stubbornly refused to take such action.

Instead, a master plan was formulated launching the renovation of the Dining Room and Bar. Five years ago, Adhoc committees were formed within standing committees to provide expertise and assist in initiating corrections within operations.

SERVICE, QUALITY, CREATIVITY, and CONSISTENCY became our credo. Like other complex operations, there were numerous small targets which we hoped, collectively adjusted, would make a difference.

Each year John Rader and his team have taken the most eminent challenges and formulated viable programs for change. Success in operations required a delicate balance between expenses and services. Cut backs in food and beverage inventory, over time, and staffing needed to be aligned and balanced with the marketing push mandating increased sales, quality, variety and service.

As society has become more responsible in its social drinking habits, our beverage operations have shown substantially reduced revenues.

To off set the impact of the Bar's losses, and to respond to the trend for casual dining, management initiated a

very successful second dining operation on the Hau Terrace. Our Chef and staff created a separate menu and served two restaurants from a kitchen badly needing remodeling. This year we funded the long awaited Sous Chef position allowing Chef Manfred to expand his quality, creativity and presentation.

We have in process a professionally administered "space utilization study" which will provide the Club with guidelines for future capital expenditures and a master plan for the physical plant. The kitchen renovation scheduled for 1998 was included in the study to assure its value and longevity, and construction is now scheduled for the Fall of 1999.

Our committee chairs have each described their accomplishments and future projects. They will all be working with our information technology subcommittee in preparing our web site program and long range information technology master plan integrating the requirements of both management and membership.

You received, for the first time, the OCC handbook or roster and the OCC Club calendar. Our monthly magazine continues to dazzle us with increased color, substance, and style. We thank all of our hard working committees and volunteers for their accomplishments in events, communications, decor, wise investment, preserving Club history, selecting new members, athletic accomplishments, and keeping the Club fit and beautiful.

To conclude, I say thank you for six wonderful years. I have learned so much about teamwork and trust. I have watched people grow with recognition of their talent, ability, integrity and loyalty. I have participated with a complex and diverse team of volunteers and staff committed to common goals and allowing for human error in a process of achieving incredible results. I have watched the kind and nurturing leadership of John Rader and his building of a management team. And with the directors and staff, I have seen partnering at its very best. Please join me in applauding the OCC team of the future. They are ready for the next millennium.

Ballots were mailed to the 1,806 members eligible to vote. These include Regular, Intermediate, Senior and Life

members. A disappointing total of 779 ballots were received. Of these 15 were invalid because they were unsigned or the voter was delinquent in Club accounts and 21 ballot envelopes were sealed but empty. There was one spoiled ballot. This left 742 valid ballots compared with 878 in last year's election.

The committee would like to recommend to the Board of Directors that written procedures be developed for the Judges of Election, and that a Bylaw change be made to mail ballots 21 days before the election.

Fel says the Club and the members and his fellow employees are his family. He especially appreciates the loyal friendship of many of our members.



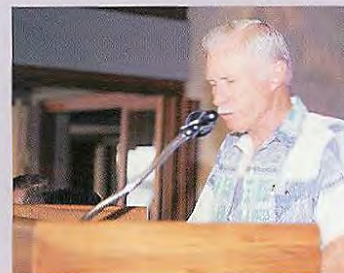

Treasurer's and Finance Reports

Notwithstanding the continued poor economic conditions in Hawaii and the increased competition from new restaurants vying for our members "dining-out" expenditures, your Club had a great year financially. The Food and Beverage operations of the Club, in particular, had an excellent year. Mr. Rader and his staff continued to operate the Club at a high level of performance.

Operating income for 1998 was \$431,000, which I am told is a record, and well ahead of budget. Food and beverage operations were an important contributor to this performance particularly the Koa Lanai and Hau Terrace activities.

The Logo Shop was a strong contributor also. Its profit contribution of \$190,000 was 6.4% ahead of budget. Logo Shop sales of \$517,000 were an all-time high.

Considering the Club's operational success, the Board of Directors saw no need to increase dues in 1999. The budget developed with management and the standing committees for 1999 is a sound but a challenging financial plan. A significant renovation of the kitchen is planned this year.

The Finance Committee had a busy and successful year in its duties of assisting the Board with its oversight and enhancement of significant aspects of the Club's finance and administrative activities.

First I will comment on the Committee's regular activities. Our insurance programs were successfully renewed with improved coverages, the audit of the Club's books and records process went smoothly, and employee retirement plans, Building Fund, and Capital Improvement Fund investments continued to be monitored and fine-tuned.

The Building Fund, which is intended to provide financial support for future ground lease payments or other arrangements, had good returns in 1998 from its portfolio of equity and fixed income securities. As of December 31, 1998 after taking into account capital gains, interest, initiation fee contributions, and income tax liabilities, the Fund had grown to \$11,435,000.

In the way of adhoc activities, the Finance Committee helped implement a new defined contribution employee retirement plan (a 401K), which the Board of Directors approved in lieu of continuing the Club's deferred compensation plan; and it formed a sub-committee to help the Club develop a long-range information technology plan.

The 1998 audited financial statements will be available for members to review in the Controller's office.

As co chairman with Jon Bryan, we are happy to report the Outrigger Canoe Club continues to attract new members in this stagnant economy. For the first time in many years, the waiting time for an interview increased from the previous year, and our total membership count increased by 18, versus dropping by five, as it did last year.

Our total membership count as of January 31, 1999 is an all time high of 4,307, eight members short of our quota. The 1998 calendar year membership count spreadsheet outlines the additions and deductions we experienced in all categories of membership.

A review of this spreadsheet reveals additions in all categories of membership, supporting the Club's ability to attract a wide variety of members. The canoeing and volleyball programs, our exceptional child friendly atmosphere, and our elegant dining opportunities are at the top of every candidate's list of reasons for joining.

Due to the committee's desire to spend quality time with each candidate to ensure we maintain the Club's character, total additions were the lowest in four years. Fortunately, so were membership deductions, resulting in our net gain of 18. This ratio is reviewed every year to ensure we are interviewing enough candidates to maintain our count.

In addition to interviewing and recommending 135 candidates to the Board of Directors for membership, this committee spent a considerable amount of time reviewing and updating all of the associated applications, forms, and questionnaires. The Sponsor Information Packet each member receives when sponsoring a candidate was also updated. This committee was also involved in changes to four Board Policies relating to admissions and membership. A copy of these changes has been included in this report for your review.

Jon Bryan and I would like to thank the committee for providing a well rounded, yet diverse mix of knowledge and tenure to this committee. Together we accomplished our responsibilities with the Club's best interest in mind.

The Entertainment Committee is comprised of 18 hard-working and dedicated individuals.

Here is my review of our successful April 1998-March 1999 committee year:

April 25, 1998: Paniolo Night at the Circle O Ranch featured the award winning film, "Paniolo O Hawaii, Cowboys of the Old West", that was introduced by its producer, Edgy Lee. 350 members and their guests attended this event wearing the best in western attire.

Entertainment included trick roper Eric Roberts and a heart warming ukulele, "talk-story" session with living legend Kindy Sprout and Leabert Lindsey. Not to be out done, our Chef created a mouth watering Western BBQ. (Of financial interest, this event generated a 28% profit of \$3,000.)

June 21, 1998: The Entertainment Committee assisted the Club in preparing for the arrival of the USS Missouri. Red, white and blue was the color of the day and the many flags along the sea wall fronting the Terrace were visible by all.

July 18, 1998: The first Keiki Carnival was attended by 200 children, some with parents who also seemed to be enjoying a second childhood. This event was especially designed for children 2-12 years of age. Crafts, beach games, and the tattoo parlor were kept very busy. The ever popular dunking booth and shave ice station experienced long lines. Budding artists painted ceramic tiles which were fired up and now are hanging on a wall at home. Other art work created by the children is being considered as covers for the keiki menu. The Keiki Carnival's success has assured its being scheduled as an annual event.

July 25, 1998: Cielo at Kahala Mall presented a 'Touch of Heaven' Fashion Show featuring the clothes by award winning

designer, Monica Emelge. It was a well attended luncheon show with Club members as models and background music provided by Jennifer Tricky.

Annual Beach Style Luau. Henry Ayau did it again and Margaret Puder's decorations transformed our Club to reflect the beach-style theme. The Entertainment Committee was there to assist them. On behalf of the Outrigger Canoe Club, mahalo to Joan, her family and Princess Kaiulani.

Finally, the Historical Committee has nominated and the Board of Directors has ratified Anita Brightman and Genie McMahon as the first female Outrigger life members.

Two long-time members of the Historical Committee were voted Life Memberships at the Annual Meeting on February 22. They are Anita Brightman and Eugenia "Genie" McMahon. Both women were honored for their numerous contributions during their combined service on the committee of 36 years.

Anita Brightman

Anita is now 92 years old but still going strong!. A former teacher, school principal and outstanding community leader, she became a member of the Club at age 71 and immediately volunteered and was accepted for committee service. Fortunately for the Club, she was selected by the Historical Committee in 1983. She has been a member ever since.

Her first assignment was on the Library subcommittee. Next, and ongoing, she is on the Clipping subcommittee. The Club has been a subscriber to a clipping service since the early 1970s. Supervision was rather haphazard and when Anita took over in 1983, there was one bound volume of clippings. She assumed the monumental task of overhauling the entire program with the result the Club now has annual volumes dating back to 1978, beautifully bound, cataloged, indexed and secured under lock and key.

A few years ago, she originated the "This and That" scrapbook, the purpose of which was to assemble and publish special recognition given to the Club and its membership including items of historical events. It met with instant success. She is now on her fourth scrapbook.

In 1989, Anita conceived the idea of a Sunshine Committee responsible for sending out get well and sympathy cards to Club members. She is still a member.

She also provides scrapbooks of annual canoe racing and other athletic events. She developed the Historical Committee's original microfilm program. She has also served on various adhoc committees including chairperson of a Fashion Day program, authored articles for the Outrigger magazine and assists whenever and wherever needed!

- Reviewed the 1995 Membership Survey to determine if any changes were made, how effective those changes were, and if any further changes are necessary.

- Reviewed Club demographics to project trends (i.e., membership trends such as declining Intermediates, membership aging, and the significance of Nonresident members)

and provide input to the Club's Master Plan in respect to maximizing the Club's services and facilities.

Initiated focus groups of the Intermediate members to determine their interests and gather feedback on the dues structure (the percentage of Intermediates is declining).

Compared the Club's five-year budget projections with actual year-end figures to determine accuracy of projections.

Completed special projects such as a study on the relocation of the Logo Shop, a review of lease renegotiation issues, and a compilation of marketing ideas for the Club and membership.

Going forward the Long Range Planning Committee will continue to strive toward making the Long Range Plan a "working" plan that integrates all sub-committees' goals with the Club's goals.

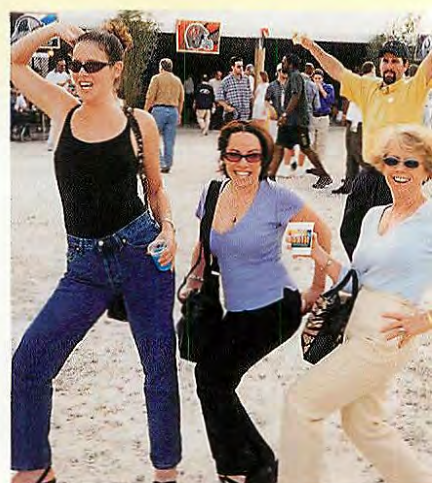

April 26th Stew-Rice Night to Spotlight Two Talented Kamaainas: Irmgard Aluli and Meleanna Meyer

Two wonderfully vibrant, strong, and talented Hawaiian women—representing two different generations—are what OCC's next stew-rice night presentation is all about.

To be specific, the subjects are: first, song writer/musician/matriarch/and role model extraordinaire Irmgard Farden Aluli, known widely and lovingly throughout the state as Auntie Irmgard; and, secondly, her niece, filmmaker/artist/linguist/community volunteer/and OCC member Meleanna Meyer.

How these two fit together for the April 26th stew-rice event is this: Filmmaker Meleanna is going to introduce and show *Puamana*, her acclaimed 47-minute 16-mm documentary film featuring Auntie Irmgard

and her siblings—ten of whom were still living when the film was completed in 1991. Then, they ranged in age from 76 to 92.

"I wanted," says Meleanna, "to record for posterity a bit of my upbringing. Earlier, I had thought everyone was raised with music and dance, family gatherings, and living next door to cousins. As I grew older, I realized this upbringing was truly remarkable.

"The experience was very profound, because it gave me a sense of deep appreciation not only for family, but for traditions and for the perpetuation of na mea Hawai'i—things Hawaiian—music, dance, attitudes, and values.

"I love to present this piece and to talk about how each and every one of us comes from families that have

stories to tell."

Meleanna has completed three film/video projects and will be working on a fourth this summer at the World Indigenous People's conference. *Puamana* was her first. It has been shown in film festivals throughout the United States, New Zealand, Australia, and other places around the world. It was picked as one of the best among Hawai'i International Film Festival entries, 1992.

As for Auntie Irmgard and clan, it's terribly tempting to go on and on about this family of living treasures—but that would be edging into the spotlight of what Mele has planned for you. One tidbit: Auntie Irmgard herself has been invited. If this octogenarian and her group are not out captivating an audience with some of the 300-plus songs she has written,

we may have the opportunity to meet and to thank her personally for the inspiration she is to this community.

In any event, *Puamana*, the film—to be screened April 26th as an OCC Historical Committee presentation introduced by the film's creator, Meleanna Meyer—is sure to be very, very special. We have no reason to doubt that it will attract a turn-away crowd.

Here are additional details you may want to know: No-host cocktails are at 5:30 p.m. OCC's traditional stew-rice buffet begins at 6:00 o'clock. Beginning at 7:00 o'clock, you'll be in Meleanna's hands. She'll take questions from the floor at the end of the film.

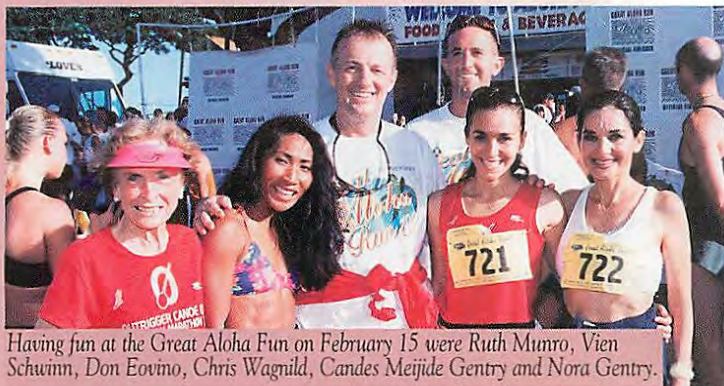

NOTE: Twenty-ninth in a series of Reciprocal Club Reviews, this month features both the Mooloolaba Club, Queensland, Australia and the Pacific Club in Newport Beach, California.

These two clubs are the newest addition to our reciprocal list.

Surf Club at Mooloolaba

The Surf Club at Mooloolaba is already well known among OCC paddlers who have visited down there and participated in races. Their paddlers have also been here and enjoyed our facilities.

The Club is located on the Sunshine Coast and the closest airport would be Brisbane. Surf Club has been in operation for 76 years and is a respected member within the Association of Surf Club Life Saving, Australia. They currently have 300 active members and several thousand social members. The facility has an unsurpassed location on the beach with magnificent views. It sports a relaxed atmosphere in an air-conditioned clubhouse and is a place all of our members would enjoy - but will be especially appealing to our younger athletic members.

Surf Club has a gymnasium and locker rooms for those who wish to work out, and as mentioned above they are also an outrigger canoe racing club.

The Boathouse Restaurant is a family restaurant catering to all ages and is open for lunch and dinner seven days a week. The menu ranges from sandwiches to steaks and fabulous seafood. There is also a great deck which houses the Sunday breakfast buffet and is also a good spot for a glass of wine or beer. There is live entertainment Friday and Saturday nights and Sunday afternoon.

There's even a sports bar area and state of the art poker machines. Even though this is a casual, relaxed spot similar to our Hau Terrace area there is a dress code. Football shorts,

midribs and swimwear are not permitted at any time, and thongs and sandals are not permitted after 6 p.m. Cash is acceptable for payment, and tipping, like all over Australia, is not expected.

Pacific Club

The second club in this review is the Pacific Club located in a beautiful clubhouse in the heart of Newport Beach approximately five minutes from John Wayne Airport. This is a club where the traditional comforts of a fine city club are blended with the energy of contemporary Orange County.

The club was founded in 1981 and is dedicated to serving the business, social and leisure activities of its members in an elegant, comfortable and professional environment.

The club has an expansive athletic facility occupying two floors. They employ exercise physiologists who oversee a complete program of aerobic conditioning. The fitness center houses life cycles, life rowers, cross country ski machines and stairmasters, free weights and lifting systems. Low impact aerobic classes are held as well as nutritional analyses, health assessments, cholesterol testing, weight loss classes and wellness seminars.

Members can also enjoy badminton, outrigger canoes, a skeet and trap shooting club, and softball team. There are private locker rooms for men and women. Men have Jacuzzi, steam rooms and sauna and ladies have saunas, facials, paraffin waxing, and herbal wraps. The club also has a massage therapist on staff.

The club has two dining rooms and 10 private meeting rooms with all the necessary facilities for business meetings such as audio/visual and public address equipment. Breakfast is served Monday to Friday from 7-9 a.m. Lunch is in the main dining room Monday to Friday, 11:30 a.m.-1:30 p.m. and in the Talbot Grill from 11:30 a.m.-3

p.m. Monday to Friday.

Dinner is served Monday-Saturday from 6-9 p.m. in the Talbot Grill, and the bar is open Monday-Friday, 11:00 a.m.-closing and on Saturday 6 p.m. to closing. Special brunches are held on different Sundays.

The club sponsors many special events similar to OCC including gourmet food and wine events and guided tours to the wine country of California and France.

Dress code is business casual, no jeans. The club's kitchen will also provide picnic baskets for special occasions, and even offers unique game services for the wild game hunter. The kitchen will receive member's ducks and other wild fowl and game for picking, butchering, and storing during designated seasons. Services for dressing and freezing game are also available.

There is a parking lot for you to valet or self park. Tipping is allowed; however the club will not cash checks or accept cash. They will bill the host club and there is a service charge of 20% and sales tax of 7.75%. The club is closed on major holidays.

So, whether you're going Down Under or hopping to the West Coast, stop by the OCC office and get your introductory card as both clubs request that you have one.

At this point in time I have covered most of the clubs that we have as reciprocals and all of the new ones that we have accepted in the past couple of years.

The House Committee has expanded reciprocal clubs, especially on an international basis which was the intent, and I have received many good comments about the clubs we've chosen. We have done this so that OCC members would benefit from the new locations, and at the same time chose clubs that we felt would send good business to OCC.

If more clubs are added at a later date then please look forward to more reviews at that time. And as always, if you members have any suggestions for new clubs they are most welcome. Some members have already done this and it is appreciated. Please take all such ideas to John Rader. Mahalo for your support.

On a quarterly basis, the committee will review the portfolio allocations and rebalance the portfolio as necessary to

keep the portfolio within the asset allocation ranges. . . The capital improvement fund will be allowed to utilize money market funds, short-term fixed income mutual funds, short-term fixed income securities and/or individual issues in U.S. Treasury and agency obligations, tax exempt Hawaii municipal bonds with maturities which correspond with the projected project expenditures.

Vice President of Operations—

Jimmy McMahon reported on the trademark application. Edison Brothers Stores, Inc. claims that they own the rights to the mark OUTRIGGER for clothing and related goods. The Board will proceed with the trademark OUTRIGGER CANOE CLUB.

Secretary's Report—

Six members were suspended for 15 days due to failure to pay their accounts on time.

Manager's Report—

The Manager recommends a surfboard policy for members under the age of 15. A consent form must be signed by one of the member's parents. . . The Web site should be up on March 1.

Admissions and Membership Report—

The membership count was 4,305 as of December 31, 1998.

Athletic Report—

The Ka Moi is back from Kauai.

Entertainment Report—

The Swing Event is moving ahead. The Cinco De Mayo event has a chef from Cholos Home style Mexican II Restaurant in Haleiwa cooking.

ODKF ANNOUNCES FIRST QUARTER GRANTS

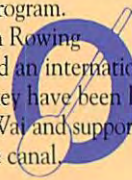
ODKF recently awarded \$3,000 in athletic grants to four previous grantees of the Foundation.

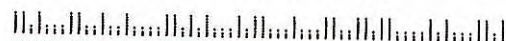
