Defending champion Off Shore won the 41 mile race in 6:00:37, followed by Kailua in 6:07:28 and Outrigger in 6:08.47. A total of 47 crews competed in the relatively calm seas.

Second Open Crew Finishes 8th Overall

The 1994 Bankoh Na Wahine O Ke Kai will be remembered by those who participated in many different ways and for different reasons. But one thing that will be unforgettable to many, is how the Outrigger Canoe Club fielded a second crew that finished in eighth place overall and was the fourth Hawaii crew to finish in a field of 47 canoes that included all-star teams from around the world. Their finishing time was 6:29:28.

The crew paddled the Iwalani and consisted of Pam Clifford, Possie Dudgeon, Carolyn Hall, Debbie Ing, Jennifer Lowe, Vanessa Lowe, Missy Mowat, Norma Santiago, Mary Smolenski and Jennifer Thayer.

This crew included five members for whom this would be their first crossing of the Kaiwi Channel. For three members this was their first year of paddling and for two members of the crew, this was their first long distance race.

If this wasn't enough lack of experience for you, the steersperson

(Vanessa Lowe) is included in the first channel crossing, and first year paddling category. In fact, Vanessa had never been to Molokai before.

At the start, the crew of the Iwalani battled with the other canoes to reach Laau Point and the first change as quickly as possible. Once past Laau Point and into the Kaiwi Channel, the women never looked back.

With canoes and escort boats creating nothing but chaos in front of them, they put the hammer down and started challenging and then passing one canoe at a time. This included steering into and around a group of three canoes that never knew what hit them.

At the three hour mark, the crew had moved into position at the tail end of the front pack. With the leaders in sight, the realization of what they were accomplishing started to hit home. In any club other than the Outrigger, this crew would be the first crew and they were in first crew territory and still challenging.

Locked into a battle with Lokahi and Lanakila of California, the crew pushed the Iwalani north of the pack in

an effort to get to the water of Maunalua Bay and the changing tide first.

As they approached Portlock, they had distanced themselves from Lokahi and Lanakila. It was at this point that Vanessa knew that the "Force" was with her and the crew responded with their natural surfing ability.

As the Iwalani approached Black Point, the race to the finish was on. As the crew passed Diamond Head they were attacked by a "sneaker" wave that broke completely over them. While we watched in amazement, the crew emerged from this wall of water, still paddling as if they did it just to cool off.

Lanakila managed to slip ahead in the calm waters of Waikiki but it didn't really matter. The women of the Iwalani knew that they would finish in the Top 10 before the race started and they proved it.

The OCC can stand proud in the achievements that all of the women in the long distance program helped to accomplish. A special thanks to Coach Steve Scott and all the support crews. ☺

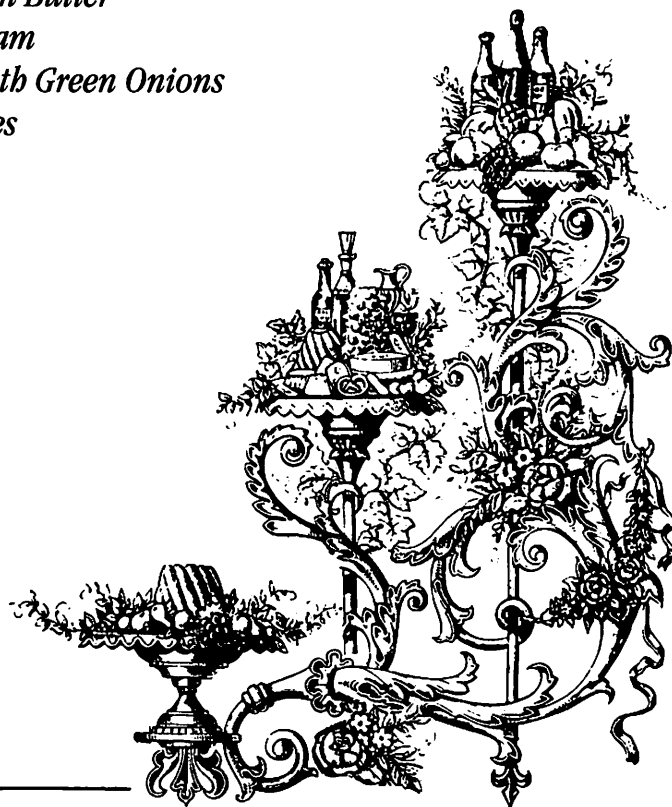

Long hours and personal sacrifice were rewarded by new friends and fantastic fun times. We wanted to win our division but 1994 was not our year. However, with a starting crew of Crabb, Jenkins, Downing, Bourne, Finney and Black, we were well ahead of OCC's second open crew and 10th overall at Laau Point."

tougher and the participants younger and stronger."

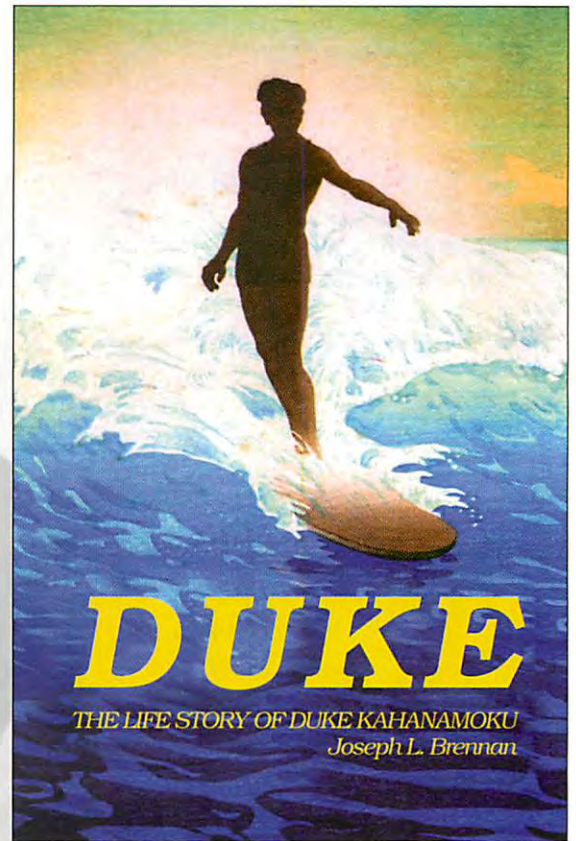

Outstanding OCC Male/Female Athlete of the Year

A new Club trophy, The Outstanding Male/Female Athlete of the Year, will be awarded next summer. During the next 10 months, members of the Club's Athletic Committee will be searching and watching for candidates that may be outstanding enough to be nominated for this new annual prestigious Club award.

The award is a co-project of Ron Sorrell and the family of the late John

Barry Pritchard. The award is in memory of Barry, a Club member for four decades. The trophy took 11 months to complete. Kawika Grant aided in the design and construction of the trophy.

The criteria for winning the trophy is being developed and suggestions are welcomed by the Athletic Committee.

Barry grew up at the old Club. Like all his peers during the 40s and 50s, he was an all-around athlete. He surfed, played volleyball and bodysurfed all over the Territory. Barry was "one of

the boys" and was quick with a smile and a wink for the wahines of Waikiki Beach. He also earned his wings on the Hau Terrace.

In the early 60s, Barry was diagnosed with Parkinson's Disease. Barry was a boxer during his days in the Navy and he put on his gloves and fought the disease for three decades. He gave it his all, always seeking the advantage to use his KO punch and rid himself of this shaky problem. But on May 1, 1993, Barry took a right cross to the lungs with pneumonia, and with the Parkinson's, went down for the count—a fighter to the end.



Outrigger Bids Farewell to Tom "Daddy" Haine

If Duke Kahanamoku is Hawaii's legendary king of surfing, then Tom "Daddy" Haine is undoubtedly Hawaii's king of the volleyball courts.

On September 14, family and friends gathered at the Outrigger to "Celebrate the Life and Spirit of Tommy Haine" who was the Club's secretary at the time of his death from a heart attack on September 10.

Tom had served the Club twice as president, in 1972 and 1987. He was on the Board of Directors for a total of 15 years beginning in 1968. He served as Club vice-president three times (1970, 1971 and 1986), secretary in 1994, treasurer in 1969, 1984 and 1985, and Coordinating Director of Athletics (1968) and Long Range Planning (1973, 1988, 1989 and 1993).

In addition, he served on the Canoe Surfing Committee in 1985 and on the Long Range Planning Committee in 1984 and 1990.

Although his business skills helped keep the Club running smoothly, it was on the volleyball court that he may have made his greatest contribution as both a player and unofficial coach to many of the Club's young volleyball players.

Tom started playing volleyball at the old Club in 1950. He was state doubles champion 12 times, most recently in 1968, 1970 and 1971 with Paul MacLaughlin. He was also Club doubles champion many times, most recently with Jon Stanley in 1974.

He captained the 1968 U.S. Olympic Team which had the distinction of being the first U.S. Olympic team to beat the Soviets in international competition. He received a silver medal in 1963 and a gold medal in 1967 in the Pan American Games.

Playing for the OCC, he was named an All-American 35 times, including both open and senior divisions. He was also named Golden Masters Player of the Year in 1982 and received the USVBA All-Time Great Player award in 1990. In 1991, he was inducted into the Volleyball Hall of Fame in Holyoke, Massachusetts.

Tom was one of the group of

original Club athletes elected to the Outrigger's Winged "O" in 1968.

In addition to volleyball, he also paddled for Outrigger. In 1952 he was a member of the winning state championship Junior Men's crew.

A memorial service was held at the Club on September 14. A flotilla of canoes, kayaks and surfboards helped scatter his ashes near Old Man's, his favorite surfing spot while the Hawaii National Guard flew overhead, a rainbow appeared, iwa birds hovered over the canoes and turtles swam through the leis.

Following the service, more than 100 friends gathered on the volleyball courts for a tournament in honor of "Daddy" as he was known to many.

Donations in his name may be made to the Outrigger Duke Kahanamoku Foundation, c/o the Outrigger Canoe Club.

"We will always be thankful for the support and confidence Tommy gave to all of us," said OCC president Walter Guild. "We will miss Tommy deeply. His impact on the OCC has been too great for us to ever forget him." 🌀

Catalina Race



All of us have watched geese heading south for the winter flying in a "V" formation. You might be interested in knowing what science has discovered about why they fly that way. It has been learned that as each bird flaps its wings it creates an up-lift for the bird following. By flying in a "V" formation, the whole flock adds at least 71% greater flying range than if each bird flew on its own. Whenever a goose falls out of formation, it suddenly feels the drag and resistance of trying to go it alone, and quickly gets back into formation to take advantage of the lifting power of the bird immediately in front. When the lead goose gets tired, it rotates back in the wing and another flies point. The geese honk from behind so as to encourage those up in front to keep up their speed. (What kind of a honker are you?) Finally, when a goose gets sick, or it is wounded by gunshot and falls out, two geese fall out of formation and follow it down to help and defend and protect it. They stay with the goose until it is either able to fly or until it is dead; and then they launch out on their own or with another formation to catch up with their group, total support to the finish!!!

Board Briefs is taken from the minutes of the Board of Directors meeting on August 25, 1994 and the Executive Committee meeting on September 15, 1994.

Dining Room Report—The projected cost for the Dining Room is \$634,916, Hau Terrace \$43,273, exterior lighting \$100,629 and landscaping \$28,005. A contingency fee of \$80,100 was added. . . The project is on schedule.

Manager's Report—The job description for the Club House Manager was approved. . . The Club's insurance representative will appear at the October meeting of the House Committee to review the Club's policies. . . The Board approved the membership contribution for the annual employee Christmas gift.

Athletic Report—Approval was given to purchase a treadmill for the Fitness Center.

Building & Grounds Report—Approval was given to adding one additional beach stair for the amount of

\$6,404.

House Report—There will be a discount of 20% in the Logo Shop from November 15 through December 15. . . Six water saver shower heads were purchased and installed in the men's and women's locker rooms. . . Motivational training sessions will be held for employees while the Dining room renovation is taking place.

Public Relations Report—Athletic teams that are funded by the Club are responsible for submitting information to the PR Committee for publication in the Outrigger magazine.

Barry Pritchard Trophy—Ron Sorrell has donated a trophy to the Club in memory of Barry Pritchard. The trophy was made with the balance of \$6,000 left in the Pritchard fund. The trophy was referred to the Athletic Committee for recommendations.

Mini Charge—There will be no deletion or deferral of mini charges during the renovation of the Dining Room. ☐

Outrigger House Rules

The Club Bylaws empower the Board of Directors to regulate the affairs of the Club, set policies and establish rules of conduct on Club premises. Bylaws also assign responsibility for enforcement of established rules to the Club management.

The rules and regulations are posted on the Club bulletin boards and other conspicuous places. Some significant House Rules are:

Identification Cards

Each member's eligible child age 10 and older, dependent or family member (other than spouse) or guest using the Club more than twice in any one calendar month must have his or her own appropriate membership card and be billed accordingly.

Club employees, by direction of the Board of Directors, are instructed to ask to see the membership card of anyone using the Club facilities if the person is not known, and to report violations to the General Manager.

Please do not feel offended if you, or a guest, are challenged by a receptionist, beach attendant, server, parking or locker room attendant or any other authorized Club employee, as the intent is to protect the Club from illegal use.

To protect our privileges and private Club status, members are obligated to report to the management any persons believed to be using the Club illegally.

Guests

Any member in good standing may bring guests to the Club provided they are not persona non grata. No guest shall use the Club more than two days in any one month. This limitation does not apply to spouses of members or ladies and gentlemen accompanying single men or women members, respectively.

Members are responsible for determining their guests' eligibility. Guests are required to remain in the company of the host member as long as the guest remains on Club premises. ☐
