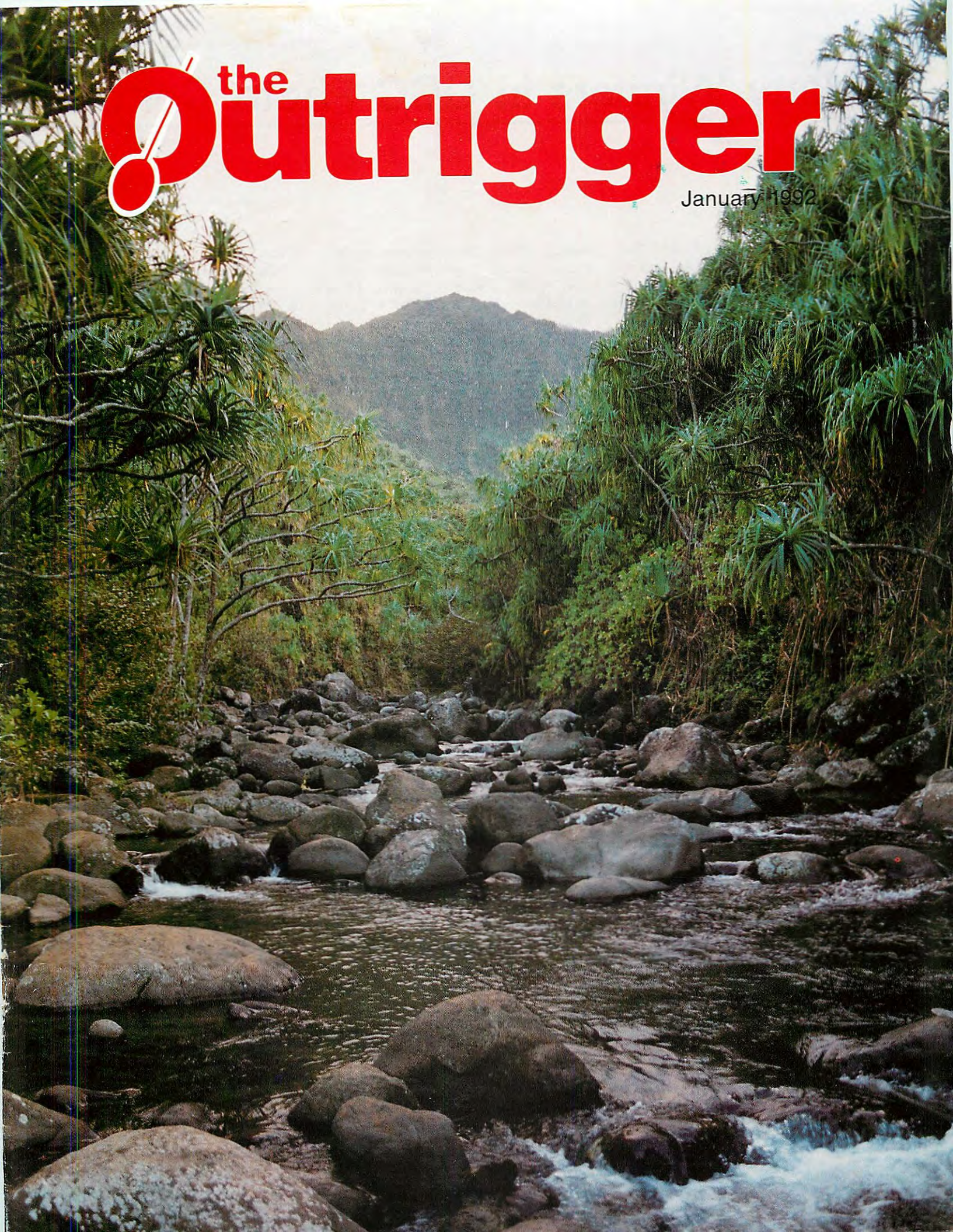

Many Winners in OCC Photo Contest

As author and photographer of *The Hawaiian Calabash*, Irving Jenkins and Hugo deVries, are not strangers at working together. They brought this teamwork to the challenge of judging the 100 entrants in the 9th annual Outrigger Photo Contest.

While certain categories were very popular, such as Nature, Places and People, the judges especially liked the strength of the entries in the Black and White category.

On the other hand, humor and Outrigger Canoe Club categories were poorly represented. The judges were "shocked and dismayed" at the lack of entrants in the OCC category, as the Club facilities, functions, activities, location and members are all great photo opportunities.

So folks, next year, we'll expect great things in this category.

In fact, for those of you who are clicking those shutters now for next year's contest, we'll probably adjust those categories a bit.

We are considering (based on the

judge's advice) OCC (includes sports, people, places), People (includes adventure, sports, portraits), Scenics, Flora and Fauna, Abstracts and Still Life and Black and White.

What did the judges consider? Jenkins and deVries made a distinction between the "lucky shot," one that gives the impression of being a good picture arrived at by accident, and the considered shot, one with a sense of thought being brought to the composition, light, and technical aspects.

As a measure of whether the photographer understood the focus of their entry, the judges considered the appropriateness of the category selected.

Several pictures, for instance, might have done quite well in humor, but were not outstanding in the nature section. One truly outstanding shot was entered in people, but nature and place were the compelling features.

Pictures that did not conform to the format were considered more critically. More than anything else, however, the judges said, Hey Kids. Focus. Focus.

Focus.

The Public Relations Committee chose the cover picture without knowing the judges' choices. After long and serious debate, Mark Sandvold's stream was the committee choice.

The committee was thrilled to see that the vast majority of the entrants were first-timers. Encouraging new photographers is certainly a primary goal of the Outrigger Photo Contest. Hope to see you all back next year.

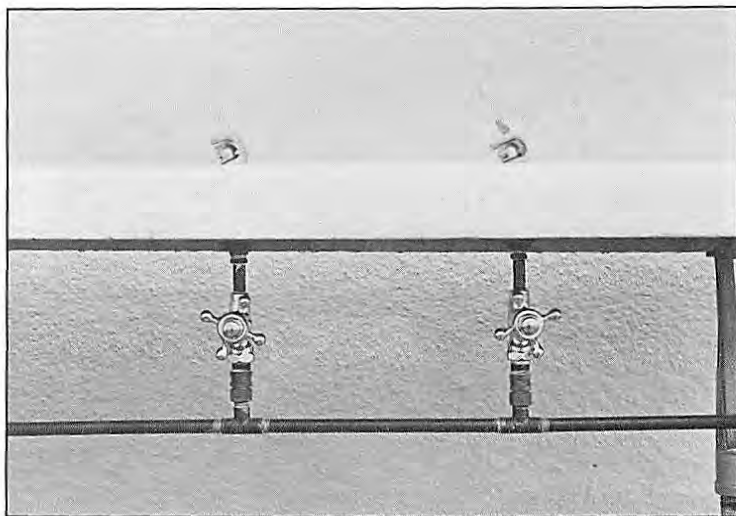

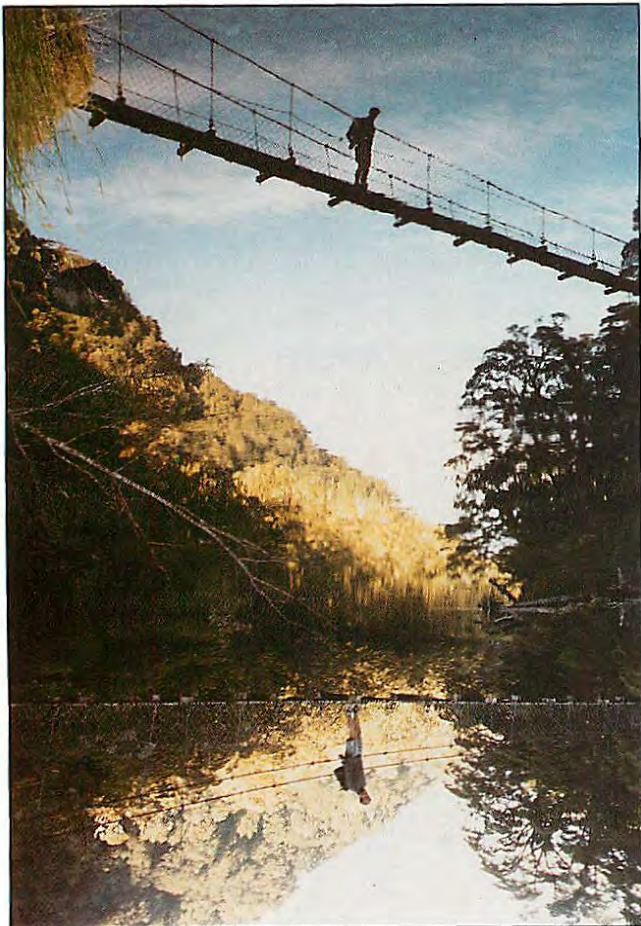

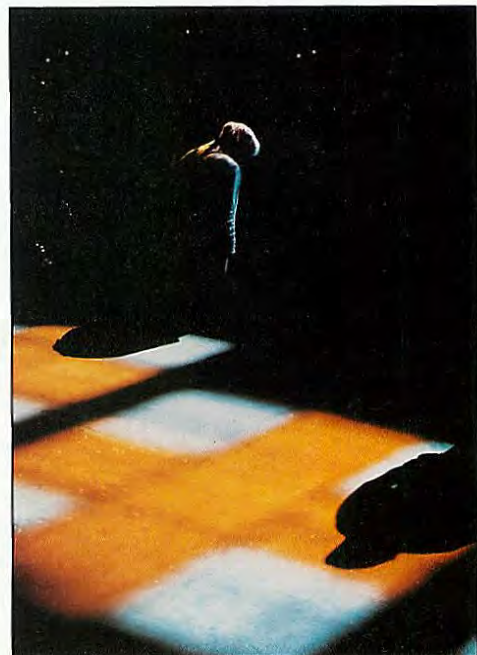

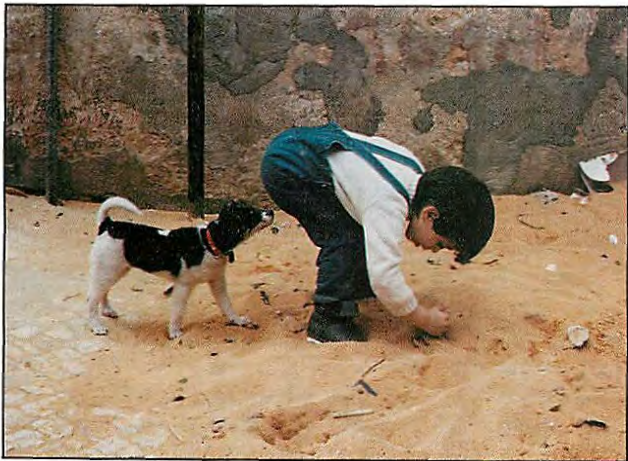

AROUND THE CLUB

Our Board of Directors has found it necessary to approve an increase of 20% to the current dues structure for Regular, Senior and Nonresident members, and 15% for all other classes of membership.

This action was taken reluctantly and only after an exhaustive study of alternatives.

The increase, effective January 1, 1992, is necessary to maintain sound fiscal management within the general Club operation. The last increase to our dues structure was January 1989.

In 1992, we are projecting general Club expenses of \$2,191,800. This is an increase of \$130,400 (6.3%) over 1991.

These expenses are made up of insurance, lease rent, administrative costs, maintenance, utilities, athletic expenditures, the Outrigger magazine and depreciation.

At our current dues structure, we would have generated dues income of \$1,889,000 for 1992, generating a general Club deficit of \$302,800, a 16% dues deficiency.

The Budget Committee was faced with the choice of making up the general Club deficit by either a dues increase or increased profit objectives within our operation department (Dining Room, Bar, Snack Shop, Beach Shop, Beach Services and Locker Rooms).

After a thorough analysis of all costs relative to our general Club operations, and an in-depth review of the expenses associated with our six operating departments, the Budget Committee felt it more prudent to recover forecasted general Club deficits through a dues increase rather than increasing our price structure within our operating departments, which would have placed an inordinate share of general Club expense on those members who already support the Club through their use of our operating departments.

Recovering the forecasted general Club deficit through Club operations was not considered a viable option for another reason as well.

Our operating departments will be facing additional costs in 1992. We

have projected a 4% inflationary increase for all costs in 1992. We will also be facing additional costs with the new employee compensation plan which will increase labor costs by as much as 6%.

Therefore, the Budget Committee recommended, and the Board approved, the dues increase.

Locker Fees Increased

Also included in the Budget Committee's recommendations to the Board was an increase for locker fees which was approved and will become effective on January 1, 1992. The increases range from between 50-cents and \$3.00 per locker per month, depending on size and type of locker.

In addition to dues, Senior, Regular and Intermediate members who do not spend more than the above mini charge amount on food and beverage in the Dining Room and/or Hau Terrace each quarter, will be assessed the difference between what they spent on food and beverage in the Dining Room and/or Hau Terrace, and the mini charge.

In computing the mini charge, only the base charge (excluding taxes and gratuity) will be considered.

To ease the administrative problems of having all the members' mini charges expire on the same date, we have divided the membership into three sections based on last name. The members' quarter will end for mini-charge purposes as follows according to their last name:

A-G January, April, July, October
H-O February, May, August, November
P-Z March, June, September, December

Other Changes

We will also be enacting a number of subtle changes within our operating department. The goal is for us to become more cost efficient and maintain our Club quality.

- Our food service at lunch which currently starts at 11:30 a.m., will be moved back to 12 noon.
- Lunch will no longer be served in the Main Dining Room on Saturday. We will continue to offer our full menu for lunch on Saturday on the Hau Terrace and the Bar Lanai. This will make available our Dining Room for private parties on Saturday afternoons.
- The Club Bar will close at 11 p.m. on Sunday, Tuesday, Wednesday and Thursday; 12 midnight on Friday and Saturday; and 10 p.m. on Monday.
- We will be reworking our menus in an effort to eliminate slow moving and labor intensive items, and also adding moderately priced entrees.
- **There will be no, I repeat no, price increases on food or beverage in 1992.**

All of the before mentioned steps are being taken with the ultimate goal of becoming as efficient as we can be, and at the same time, providing the membership with a quality Club that is second to none.

We have a facility that is well maintained, a staff that is well trained and eager to please, and a dues and price structure which affords our members full value for their dollar.

The Board of Directors and management appreciate your understanding and confidence in the Club's sound economic future. ☺

Board Approves Dues Increase, Mini Charge

Because your past and present Boards of Directors have acted with vision, and in a fiscally responsible manner, your Club's finances are sound. However, your Board has determined that a dues increase is now necessary.

The increase in member's equity this year will approximate \$800,000, but most of the increase is due to initiation fees and interest earned on the Building Fund.

As most of you know, initiation fees are set aside in a Building Fund for various reasons, the most important of which is possible purchase of a permanent site for the Club. Our lease rent is to be renegotiated on November 15, 2006 and it expires November 15, 2055.

We do not use initiation fees and interest to offset operating losses or to make up dues shortfall which has been the practice with many clubs.

In addition to the Building Fund, a separate reserve account for capital improvements exists to maintain existing facilities. The Club is faced with very significant maintenance requirements during the next five years and the reserves set aside for that purpose may not be sufficient for the task.

Therefore, we must operate at a better than a break-even point, which did not happen in 1991. In fact, the forecasted net operating loss is \$61,600.

The Club has not raised the dues for three years. One of the primary reasons for not raising the dues earlier, which would have achieved a break even point, was that merely raising dues tends to reduce the incentive to really analyze the options available to decrease costs and/or increase revenues in other ways.

Operating at a loss has put the pressure on everyone to figure out alternate ways of doing what we are doing. If we DO NOTHING differently in 1992, the forecasted net operation loss would be \$408,700. That gets your attention doesn't it?

Fortunately, there are many things we can do. Your Board studied at least 18 subjects and decided to implement seven of the most significant over a period of time.

The budget forecast, including these assumptions, is for a net operating fund increase of \$79,000.

The two items of greatest financial impact to the members are:

- A 20% increase in dues for Regular, Senior and Nonresidents and an increase of 15% for all other classifications to cover the next two years; and
- A charge for maintaining the availability of the Dining Room and Hau Terrace for those members who choose not to purchase food or liquor in those areas or whose purchases average less than \$25 per month.

The accompanying article describes in greater detail the effect of this policy on each classification.

Why?

Because in the past three months, 11.6% of the Regular members spent zero dollars and 31.3% spent less than \$25 per month.

The Dining Room areas are provided for the use of all members. Each member must share the cost of supporting the dining areas. You have a choice to

share by use or non use. We sincerely hope you will choose the former.

We have implemented changes to improve services to the membership. A computerized dining ordering and billing system was activated. Training classes have been increased to improve staff and employee skills.

Staffing on the Hau Terrace has been increased and the menu was revised to allow the kitchen and service staff to increase the speed of service.

The study of other improvements is continuing.

No food price increases were proposed for the 1992 budget. In fact, we expect to gradually introduce a menu selection containing dishes priced below present levels.

On December 1, masters swimmer Ian Emberson squeaked ahead of second place finisher Mike Miller by eight seconds, to win the 18th annual Castle Swim for OCC members only.

This is not the closest finish we've ever had in our 18 year history, but it was still very close with Ian finishing in :32:16 and Mike in :32:24.

First woman to finish in her first Castle Swim was Hilary Lambert in a great time of :34:32. This also placed her third overall, not bad when your competition is Ian and Mike.

There was some good natured grumbling that the course was "longer" than usual, but some finishing times are consistent with previous years.

The field of entrants stays pretty stable, which means some of these veteran

swimmers might be slowing down, but who can say? Every year, the course monitors do their best, but with moving water, and changing currents, and fluctuating tides, it's safe to say the course is never the same.

This year, with threats of jellyfish and worse yet, sharks, we did pretty well to get 30 entrants, regardless of age.

Some of our masters swimmers have quite a showing. Record holders are George Crandlemire, 13 swims; Ian, 14; Jake Updegrove, 16; and Gerry DeBenedetti, the only person to swim in all 18.

Swim conditions were good. Overcast cloud cover and a ton of rain the day before swept away on Sunday morning to put the sun directly in the swimmers eyes. Lots of funny racoon-eye sunburns and rosy noses.

Until we headed into the Outrigger channel, there were no waves to speak of, but some current, which is probably why those tired masters thought the course was longer; for them, it was.

BOARD BRIEFS

Board Briefs is taken from the minutes of the Board of Directors meeting on November 21 and the Executive Committee meeting on November 14, 1991.

Vice President of Operations Report: A meeting was held with Hau Terrace management and Comptroller to re-evaluate the computer system. Steps are being taken to simplify the menu, experiment with processing the checks and to have the software checked.

Manager's Report: Four projects are in progress with an approved funding of \$63,170. The beach access is under review to see if a less massive structure can accomplish the task. The preliminary testing on the volleyball court waterproofing project is complete and bid documents are being drafted. . . There was a net loss of \$24,730 from food and beverage operations in October, which is \$20,730 below budget. Sales in November are continuing to be approximately 10% below last year's levels. . . The Employees Christmas Party was held at the Hyatt Regency on December 9. . . The Hawaii Employees Council is reviewing the Employees Manual prior to printing.

1992 Budget: The Board approved the 1992 Budget which included the following:

- 6% pay increase for employees, except waitstaff who are scheduled for a 24.7% increase effective April 1, 1992 due to State minimum wage increase.
- 4% inflationary increase in other costs.
- Expanded Fitness Center Hours to remain in effect for the full year.
- 20% dues increase for Regular, Senior and Nonresident members; 15% increase for all other classifications (see Manager's Column for details).
- \$75 per quarter mini charge for Regular members; \$37.50 per quarter for Senior and Intermediate members.
- 33% increase in locker fees.
- Move the start of lunch from 11:30 a.m. to 12 noon.
- Close the Dining Room for lunch on Saturdays.
- Close the Bar at 11 p.m. Sunday through Thursday, except for the night before a holiday.
- Simplify menus, eliminating slow moving and labor intensive items.
- No increase in food or bar prices.

The Board complimented the Club Captain Bill Bright for his outstanding job the past two years in setting up pro-

mal policy and keeping the athletic program within budget guidelines.

Athletic Committee Report: \$150 was authorized for reimbursing entry fees for an earlier Softball tournament. . . The Board affirmed its policy that all participants in Club events must have their own membership, including spouses. . . Greg Moss was approved as chairman of the Paddleboard Committee succeeding Mark Sandvold.

Treasurer's Report: For the period ending October 31, 1991, there was a net operating loss of \$31,191. . . Initiation fees collected were \$11,800 and building fund income was \$19,722. The year-to-date increase in member's equity is \$803,564.

Building & Grounds Report: The plan for renovation of the Executive Office was referred back to the Building & Grounds Committee. . . The beach stairs and a possible problem of exhaust fumes in the Fitness Center are being reviewed. . . Repair items will be defined for Volleyball Court project. The major emphasis will be on lighting, which will be coordinated with landscaping projects.

House Report: The Board approved a deferred compensation plan for qualified employees with the Club matching an employee's contribution up to 2% of eligible payroll.

Entertainment Report: The committee recommends holding another Karaoke Night since the last one was so successful. . . The Board approved a dinner meeting for the committee.

Public Relations Report: A sub-committee has been formed to handle the Lobby Display Case. . . The Board approved a dinner meeting for the committee.

Historical Report: The Board approved \$265 to transfer the 16mm film of the 1966 Molokai to Oahu Canoe Race to video cassette. . . The Board approved a dinner meeting for the committee.

Admissions & Membership Report: The membership count is 4,210 as of October 31. . . The Board referred the issue of processing applicants in the Intermediate and Associate classifications where parents are members, to the Membership Adhoc Committee.

New Business: The President asked for recommendations from the Board for the Nominating Committee.
