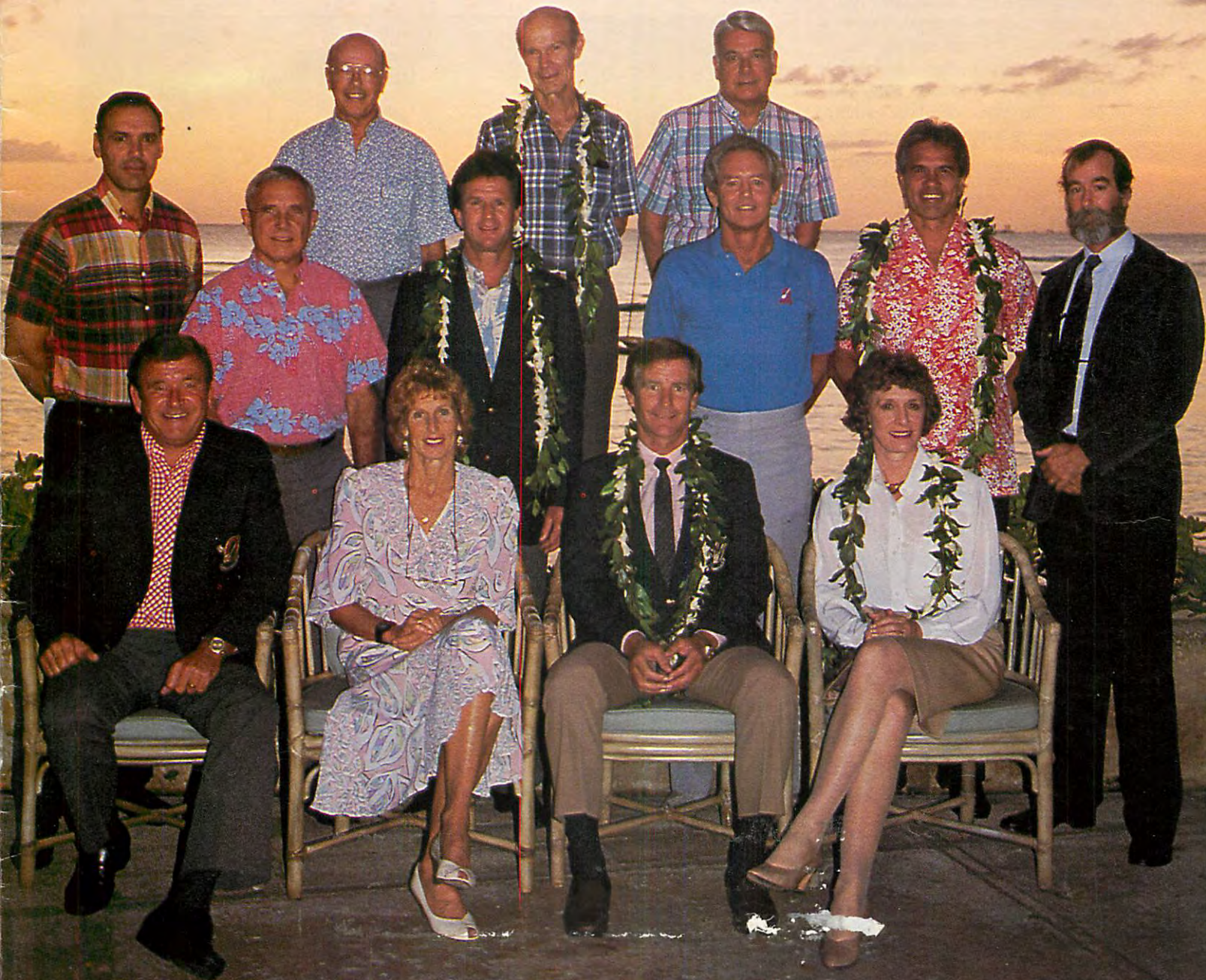

Annual Meeting of the Club

Treasurer's Report

The auditors have completed their examination of the Club's financial statements, except for their determination of the Club's pension costs. They are awaiting information from Aetna so they can determine our pension expense under the new accounting standards for reporting and disclosing pension information.

The Club has paid all amounts

necessary to fund the Club's pension plan under current law and the determination of the reportable pension expense will not cost or save the Club any money. My comments on the 1987 financial statements are subject to the auditors' determination of the Club's pension expense.

Total revenues from all sources for 1987 were \$4,855,000; however, for the first time in over 10 years, the Club's operating revenues declined from the previous year.

Revenues in all areas except the locker room were down from the 1986 levels. This decline in revenues, coupled with an increase in operating costs, resulted in a net operating income of \$18,700 which was \$154,700 lower than the 1986 net operating income.

The operating profit of \$18,700, together with initiation fees of \$170,000 and building fund net investment income of \$70,000 resulted in a net income of \$258,700 for 1987. This represents a 5% increase in members' equity which was \$5,355,300 as of December 31, 1987.

The Club spent \$1,433,200 on capital improvements during 1987 which included the addition to the parking structures, the second phase of the kitchen renovation, the renovation of the dining room and bar area, a new exhaust fan for the men's locker room and the renovation of the surfboard and kayak storage area. The Club spent an additional \$166,900 to repair and maintain the Club's building and equipment.



Athletic expenditures were \$115,700, or 2.6% of operating revenues and dues.

The Club's funds managed by Atalanta/Sosnoff Management Corporation were adversely affected by the decline in the stock market and provided a return of only 5% during 1987.

The Finance Committee, which monitors the performance of the investment manager, will reevaluate performance after the first quarter of 1988, and will make recommendations to the Board of Directors at that time on any changes in the manager.

As of December 31, 1987 the Club had cash and investments (at market value) of \$1,893,500 of which \$174,300 is in the Club's operating fund and \$1,719,200 in the Club's building fund. ☺

The Judges of Election Committee met on Sunday, February 28 in accordance with Section 9 of the Club's Bylaws and determined that the following nominees were duly elected to the Board of Directors for the two year term 1988-90:

The Committee would like to congratulate the members who were elected and would also like to commend those members who were nominated but were not elected.

A total of 1,069 ballots were cast. Of these, 37 were invalid because they were unsigned, the voter was delinquent in Club accounts, or they voted for more than six nominees. This left 1,032 valid ballots as compared with 1,067 in last year's election.

Ballots were mailed to 1,861 members entitled to vote. These include Regular, Intermediate, Senior, Life and Honorary members.

Club members who served with distinction on the Judges of Election Committee this year were Jack Brown, Richard Ferguson, Roy Kesner, Robbie Ostrem, Jim Schulte and Tom Vesey. ☺

Bylaw Amendments Pass

The proposed amendments to Sections 8, 9, 24, 27 and 29 of the Bylaws of the Outrigger Canoe Club were passed by unanimous vote.

The second and third sentences of Section 8 were amended to read:

"The Nominating Committee shall, not less than seven weeks prior to the Annual Meeting of Club, designate and post on the Club bulletin board the names of the candidates nominated for election by the Nominating Committee. Additional candidates for election may be nominated by a petition signed by 35 voting members and delivered to the Club, addressed to the Secretary thereof, not later than five weeks prior to the Annual Meeting."

Pertinent portions of Section 9 were

amended to read:

"The election shall be conducted by the Committee of Judges of Election appointed by the Board of Directors who shall, not less than three weeks before the date of the closing of the ballot, prepare the official ballot containing the list of all candidates designated by the Nominating Committee, and by members of the Club as provided in the Bylaws."

Section 24 was amended to read:

A Nominating Committee composed of not less than five voting members, appointed at least ten weeks before each election of directors, shall nominate persons for election to the Board of Directors."

The pertinent portion of Section 27

was amended to read:

"Associate. Spouses of Senior, Regular, Life, Intermediate members and/or persons 18 thru 25 years of age who are not married and who are: 1) Full-time students attending an accredited school or college; 2) On active military duty in a noncommissioned status during such periods of duty."

The first sentence of Section 29 was amended to read:

"Only Senior, Regular, Life and Intermediate members shall have the right to vote and the right to be represented at any meeting of the club by written proxy filed with the Secretary of the Club, or the secretary of the meeting at which such right is desired."

Admissions & Membership Committee

The Admissions and Membership Committee met on the first and third Wednesday evenings of the month throughout the year to interview sponsors and candidates for membership. Our recommendations were forwarded to the Board of Directors for final action.

Along with interviewing and investigating applicants for membership, the committee also made some procedural changes. The changes were necessitated to better evaluate the potential members.

The committee interviewed both sponsors of the candidate to get a more complete picture of the person and his

or her contribution to the Club. When a sponsor lacked knowledge about a candidate, the committee even interviewed the referenced people listed on the application.

Of real concern to the committee is the number of sponsoring members who do not know their candidate well enough to answer specific personal or business questions about the potential new member.

Remember, the committee in almost all cases must rely on the sponsors to present a complete picture of the applicant. The committee would like to know why the person would make a good member. Even non-sponsoring members who know new candidates are encouraged to comment to the committee about these people, either positively or negatively.

As much as we would like to know the good aspects of candidates, we would also like to know why they may not fit in with the existing membership.

If you are sponsoring someone for membership, you should be prepared to present that person in an informative, positive manner. The committee depends on the sponsors to provide them with reasoning as to why the candidate would make a good member

and how that person would contribute to the Club.

The future of our Club still lies in our youth. Interviewing the junior member applicants, whether it's those whose parents are members or those whose parents are not, is especially rewarding.

It is important that these prospective members understand the goals of the Club should be in common with their own and that they have the responsibility to work towards those goals.

As of December 31, 1987 the number of new members in the categories admitted or reinstated by the committee during the year were:

No new nonresident members were admitted. The existing quota is filled.

The total Outrigger Canoe Club membership as of December 31, 1987 was 3,974, just 24 more than the same date a year earlier. Of the total, 1,358 people are nonresident members. Interestingly, 80% of these members started out as resident members. ♪

He was especially observant of the garage construction, noting several errors and following them through until corrected.

Lou Fulton as co-chairman was especially helpful in our many projects by providing renderings and drawings. He spent many hours completing various jobs.

I would like to express our appreciation to the House Committee for their coordinated efforts in helping us to achieve maximum project efficiency.

Of significance is a 24-month Landscape, Lighting and Maintenance Budget that was recently completed by a B&G subcommittee chaired by Kim Thompson. This proposed budget, to be passed to the new B&G Committee, totals \$101,700.

The purpose of the budget was to recover those projects or programs that have fallen by the wayside for one reason or another, and to reenter them into the budget, if in fact, they have merit.

We felt this would provide the new B&G Committee with "what has happened in the past", thereby saving them a great deal of time and lost motion. We hope this proposed budget will be helpful.

We have written several articles for the Outrigger, made recommendations to assist the physically challenged, conducted studies on how best to launch canoes, how to hoist and stow additional canoes and kayaks and how to improve the weight room. 🚣

Athletic Committee

Outrigger Canoe Club has continued to uphold its reputation of excellence in the area of athletics. Accomplishments from all 17 committees in both individual and team sports were great.

We have the talent here, from the young, Kai Mowat, 11-years-old, placing first in the Ironkids Triathlon, to the old, Hank Lass, 61-years-old, crossing the Molokai Channel to place third in the Masters Division of the Molokai Hoe.

We've got Junior 'Riggers competing at Olympic Festival and national tournaments, along with their own local high school events.

"Too Hot To Stop" was the motto of the canoe racing program in 1987. This was another winning season with a 7-1 record during the regatta season, including the Oahu and State Championships.

The men won the international Molokai Hoe title again, with the masters winning their division and placing ninth overall, and the senior masters placing third in their division and 16th overall.

The women took second in the Na Wahine O Ke Kai race, just 4 1/2 minutes behind first.

Volleyball showed a strong representation in the open (7th place), masters (4th place), golden masters (4th place) and juniors (5th place) in the national championships.

Water polo held an open ocean tour-



namment in front of the Club which was a great success.

Three paddleboard races were held, with record setting performances in the two ocean races. Diane Stowell won her age group in the Waikiki Rough-water Swim. Marshall Rosa was first Hawaii finisher in the Molokai kayak race, and Walter Guild was first in the open division in the Mauna Kea 200 motorcycle race.

We also have members on the mainland training for the Olympic trials in kayaking and canoe racing--Traci Phillips, Kevin Olds, Mark Sandvold and Gib Bintliff.

Success and winning is not only dependent upon the athletic talent we have here at the Club, but the support and backup of others involved with the Club. I would like to give special recognition to all of those who have supported the program. 🚣

House Committee

Committee members were asked to make an inspection of specific areas of the Club and to report the conditions observed each meeting. In addition, several subcommittees were formed, each concerned with specific operational aspects of the Club.

Highlights of the year include:

Attention was drawn to speeding and unsafe vehicle operating practices in the parking garage through articles in the *Outrigger* magazine.

There was a major refurbishment of the Ladies Locker Room. Special kudos must be given to Gerry DeBenedetti for her outstanding work in defining the problems and her persistence in assuring their accomplishment.

Concern over the loss of business resulting from the garage addition prompted the committee to seek a small increase in selected food prices in June, to compensate for the anticipated loss of patronage from resident members. This recommendation was not, however, accepted by the Board.

The committee strongly recommended the establishment of a maintenance supervisor position to assist the Manager in the care of the facility. The Board decision was to study the matter further using graduate students from UH. The Committee still feels the position is essential to the proper operation of the Club.

The Wine Committee recommended, and the Board approved, the use of a bottled House Wine with an OCC label. The Club is indebted to Dick Hager for this very successful innovation.

An extensive study was made in cooperation with the B&G Committee of the available storage space, both on-site and offsite, with the objective of meeting all the storage needs of the Club.

The committee recommended that significant price reductions be made on excess and/or old inventory in the Beach Shop to reduce inventory. This action was approved by the Board. The Board concurred with the committee recommendation that merchandise in the Beach Shop be responsive to the



basic needs of an athletic club. No gift items should be carried.

The Board approved a committee recommendation to issue new parking decals in January, 1988. The location of the decals was moved to the lower left section of the windshield.

The Board expressed the desire to redo the President's plaque in the Lobby. After some preliminary study, the committee was informed that the plaque would be studied in conjunction with redoing the entrance. The matter was referred to the B&G Committee.

A study was made of the effect of affiliated clubs and nonresident members on the tax position of the Club. This work was spearheaded by Al Vivas. The committee recommended to the Board that in order to maintain revenue from nonresident B and C within the 15% limitation, an attempt be made to increase the percentage of usage by active members by putting a minimum of \$75 per quarter into effect. As of this writing, Board action has not been taken.

A special study was made proposing appointments for the Duke Room. The proposal was not approved pending clearer definition of the purpose of the room.

Plans were initiated for a mini gym in the Ladies Locker Room.

The use of the TV in the Bar came under considerable discussion. Since Club rules restrict its use to athletic events, means to control the operation were examined. In the final analysis, no action was taken to change the TV or the rules.

On recommendation of the committee, control was improved and locker fees were raised slightly to provide incentive for those who do not use the lockers to give them up in order to obtain more equitable utilization.

The committee examined the need for, and assignment of, non-smoking areas in the Dining Room. It was decided to continue the current policy of discouraging smoking but not to designate any specific non-smoking areas. Administration of these non-smoking areas by Club personnel was considered to present too large a problem.

There are several items of uncompleted business which should be continued by the House Committee this coming year. They include:

- A study of the need for ramps for the handicapped.
- Completion of action on the storage space study.
- Assure that the study examining the need for a maintenance supervisor does not falter.
- Follow through on the Board action to the affiliated clubs and nonresident member situation, as it relates to the tax position of the Club.
- Complete the study of the use and appointments for the Duke Room.
- Monitor sales of the new *Outrigger* poster. If they are not moving, develop a program to enhance sales.
- House Committee recommended the bronzed head of the Duke be placed in the center of the trophy case with an appropriate plaque. Monitor the Board action. (Subsequent measurements have shown that the head will not fit in the trophy case. Editor) 🗨️

Garage Committee

Two years ago, the Board of Directors formed an ad hoc committee to investigate the feasibility and cost of adding two half levels of parking to the existing garage structure.

After almost a year of study, it was established that it was feasible and a budget was submitted to the Board. Once the budget was approved, a timetable was established which called for the project to start after Labor Day 1987 with substantial completion before Christmas.



This tight schedule caused some of the prospective contractors to refuse to bid. Of the remaining bidders, Teval was selected as the lowest bidder who could meet our schedule.

I am happy to report that the project was completed on time, within the budget and with a minimum of disruption to the Club operation.

There are only two items that remain to be done: shielding of some of the lights so that they do not annoy our neighbors, and the installation of the top deck light standards, which have not yet been delivered.

This project was more than just an addition of 57 parking stalls. At the same time as the new construction, the existing structure which we discovered was badly deteriorated, was repaired and brought up to current safety standards.

Had this project not been done, within a few years we would have been faced with a repair bill of more than half of what we spent on this project just to keep the old structure serviceable without the addition of any

new parking stalls.

I would like to give my thanks to Teval Construction, Ossipoff, Snyder & Roland, and the Club management for all of their cooperation and assis-

tance in this project.

I thank you Club members for your patience and support of the Dining Room during this time of inconvenience. ☺

Long Range Planning

During 1987, the committee conducted meetings with the House, Building & Grounds and combined athletic committees to test reactions of those committees to the report and recommendations of the 1986 committee.

Membership

Last year's committee produced a study which related membership categories to revenue producing Club facilities. The committee wrote a computer program which facilitates the "what if" analysis of various membership mix and dues raising alternatives.

Club comptroller Gordon Smith modified the program to run on the Club's microcomputer.

Continuity

The committee will establish a committee manual containing the papers produced by the committee. This committee inherited the work of previous committees and has attempted to build upon those efforts.

It is intended that the hard work of successive committee members can be passed on for reference and this will assist in providing for the desired con-

tinuity of committee effort.

Recommendations

The Club Bylaws should be amended to establish a Long Range Standing Committee.

A Long Range Plan should be established by a process involving input from the standing committees. The plan would be produced over a two year period and become a document which is ratified by the membership, reviewed annually and changed as circumstances warrant.

A professional, physical Master Plan for the Club should be commissioned at some point in this process of producing the long range plan. This Master Plan would serve the purpose of facilitating the implementation of the desired physical changes in the context of how each change effects the existing and future Club structure.

A professional should be employed to establish a computer based Facilities Management Program for the Club. This could be a part of the Master Plan, but would actually inventory all equipment, utilities and physical components of the Club premises and age each for repair, replacement, painting or refurbishing.

This inventory would include a budget for accomplishing each individual appropriate action. Committees would review and update the inventory and projections as a part of their annual duties.

A professional consultant should be employed to review and recommend management structure or organization chart for the management of the Club.

A professional consultant should be hired to establish a management training program for all service employees. ☺



Public Relations Committee

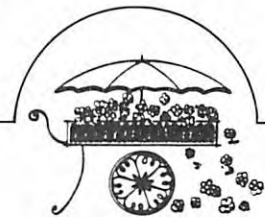

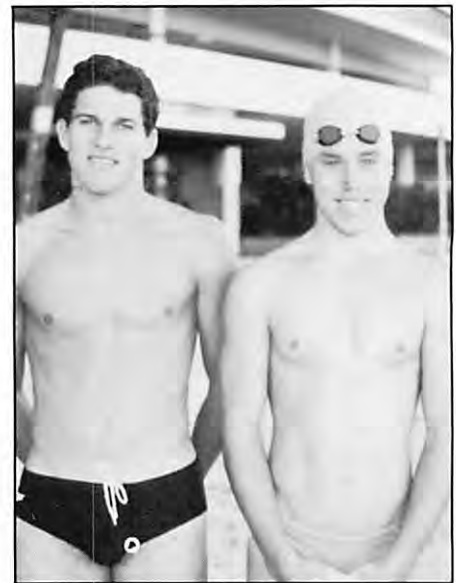

BOARD BRIEFS

Treasurer's Report: The financial statement for the period ending January 31: net income year to date was \$5,895 which is \$14,159 below budget and \$22,298 below 1987 . . . Member's equity is \$5,355,973 and represents a year to date increase of \$698 or .01%.

Secretary's Report: Four members were suspended for a 15-day period for failure to pay their accounts on time.

Fashion Show

Informal modeling of clothing from Casual Aire will be held at the Club on April 29, during a luncheon fashion show.

Modeling will begin at 12:30 p.m.

The regular luncheon menu will be served. Reservations are requested.

Manager's Report: The parking structure addition, with a budget of \$1,399,764, and expenditures of \$1,343,147, has two outstanding commitments remaining in the amount of \$13,000 and \$2,080. The total project cost will be \$1,358,147, which is \$41,617, under budget by 3%. . . The Manager stated a change in the Food and Beverage statement. The operating results in the Snack Shop have been separated from the Dining Room. The Dining Room operations for January resulted in cost of sales of 36.8%, producing a gain of \$2,684, significantly ahead of the previous period. The Snack Shop suffered a loss of \$2,084. Cost of sales appeared at a high 54.6%. Combined Food and Beverage for January generated a net gain of \$1,100 or .5% as compared to the \$7,723 net gain produced in the previous period. . . The Board approved \$6,800 for tile work in the Weight Room. Plans will be reviewed by both the Building and Grounds and House Committees.

Membership: The membership count of 3,971 as of January 31 was accepted.

Building and Grounds: The Board approved the landscape, lighting and maintenance concept as a capital improvement with a budget ceiling of \$34,720. Building and Grounds will request funding as projects arise. \$5,000 was approved for landscaping of the entry circle with appropriate lighting. The five coconut trees and

philodendron currently there, will remain.

House: The Board approved a birthday wine program to Regular, Intermediate, Senior and Life members, effective March 1, on a one-year trial basis. Members will be notified by letter and offered dinner in the Main Dining Room, effective only during their birthday month.

Athletics: The Haili Volleyball Tournament was approved for 40 participants. . . One special membership was granted for women's volleyball, effective through June. . . There was a proposal for an Athletic Director which will be referred to next year's Coordinating Director and for discussion at March's Board meeting. . . Chairpersons were approved for surfing, slow-pitch and canoe surfing committees.

Long Range Planning: Guidelines and recommendations will be mailed to each Board member.

Public Relations: Reciprocal clubs will not be allowed to advertise in the Outrigger magazine.

Historical Report: A draft was submitted to help in determining Life membership based on a scale of points. This could be used as a tool for future reference.

New Business: The President extended his appreciation to each Board member for their contributions and accomplishments throughout the year.

Board Briefs are based on the Board of Director's meeting on February 25.
