New Parking Decks Dedicated

Amid maile, soft Hawaiian music and delicious pupus, more than 100 Outrigger members gathered for the blessing of the Club's two new parking decks during special ceremonies on January 16.

The new decks provide 59 new parking stalls in the Outrigger parking garage, bringing the number of available spaces to 220.

Club Vice-President Peter Balding presided over the dedication ceremonies, thanking Club members for their "patience and understanding during the extremely difficult months while construction was taking place."

"I want to thank all of you who continued to support the Club during the construction. We did our best to help by providing valet parking, but we know it was not always convenient to wait for your car.

"We hope you will use the Club

often and take advantage of our increased parking facilities. With the new spaces, we should be able to accommodate even the large weekend crowds."

Balding also thanked Gene Long, chairman of the Ad Hoc Garage Committee, and his committee members Richard Ferguson and Kim Thompson.

He also expressed the Club's appreciation to Treasurer Dan Williamson; John Goss, Coordinating Director for the Building & Grounds Committee, and Manager Ray Ludwig for the

many long hours they worked on the project.

The blessing was given by the Rev. William Kaina, pastor of Kawaiahao Church, who asked God's blessing on the entire parking structure and thanked God for making the decks strong and the foundation capable of supporting everything.

Ossipoff Snyder & Rowland were the architects for the project. The Teval Corporation was the contractor.

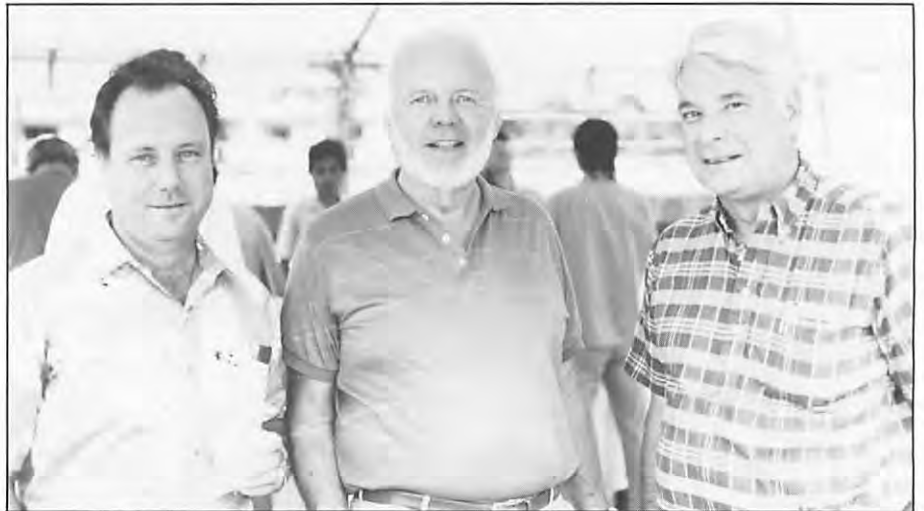

3rd Annual Winter Ocean Kayak Race

More than 80 kayakers paddled in the 3rd Annual Winter Ocean Kayak Race, sponsored by the Outrigger Canoe Club on January 23 and conducted by the Kayak Committee. The race started at Maunalua Bay and finished at Sans Souci.

Olympic hopeful Mike Harbold completed the 9-mile course in 1:06:10 to capture overall honors. OCC veteran Marshall Rosa, the defending champion, paddled with Harbold the entire way, finishing second in 1:06:15.

This was the largest field ever assembled for the race. Among the participants were 19 Outrigger members, many of whom were competing in their first kayak race.

Marc Haine won the Novice C division in his first outing, in a time of 1:17:18.

With surf breaking across the channel entrance, the finish was an exciting one for spectators at the Club.

Club vice-president Mark Buck

presided over the awards ceremony on the OCC beach after the race. He was assisted by Kala Judd, Kayak Committee chairman. 🏆

On September 4, 1987, OCC members Fred Chuckovich, Ricky Grigg, Joe Teipel, our fearless leader Fred Fong and myself and professional photographer Bernie Baker met with 10 others at Honolulu International Airport with our quivers of surfboards to begin a week of surfing on a tiny island on the barrier reef in Fiji.

Little did we know we were to embark on seven days of the best surfing and fishing ever.

Upon arrival at Nandi Airport, we boarded three small motor boats and began a 20-minute ride to Tavarua Island, a 30-acre island off the coast of Fiji.

Nearing the island, the 6-8 foot perfect lefts began to show themselves. We landed on the island and were greeted by the previous week's group as they prepared to leave. They looked horrible; they had been bounced and dragged across the reef and looked like they had been through a war.

The sight made us a little less anxious, nevertheless, we set out to challenge the reef's fury. The term, "perfect left's" took on a new meaning. This was better than we had ever dreamed and was not that treacherous if you were careful.

The next morning, we took a five minute boat ride to Cloud Breaks, where it was 10-12 feet. After five hours of surfing, it was back to camp for breakfast followed by some papio fishing and diving. The evening surfing session was held right in front of camp, which wasn't bad with 300-yard

long 3-6 foot tubular lefts.

The rest of the week was unbelievably repetitive, and after seven days of seven hours a day of surfing, we were ready to go home. The trip will be long remembered thanks to all the new friends we made, and recorded, thanks to the time our photographer Bernie Baker spent in the water.

We plan to make this an annual program. If you're an adventurous surfer, this trip is for you. 🤿

Another First for OCC – Club Poster

The first of what may well become a series of Outrigger Canoe Club posters has just been released and is available for sale in the Beach Shop.

Sponsored jointly by the Board of Directors and the Outrigger Duke Kahanamoku Foundation, the poster is more accurately described as a work of art in the form of a limited edition lithograph.

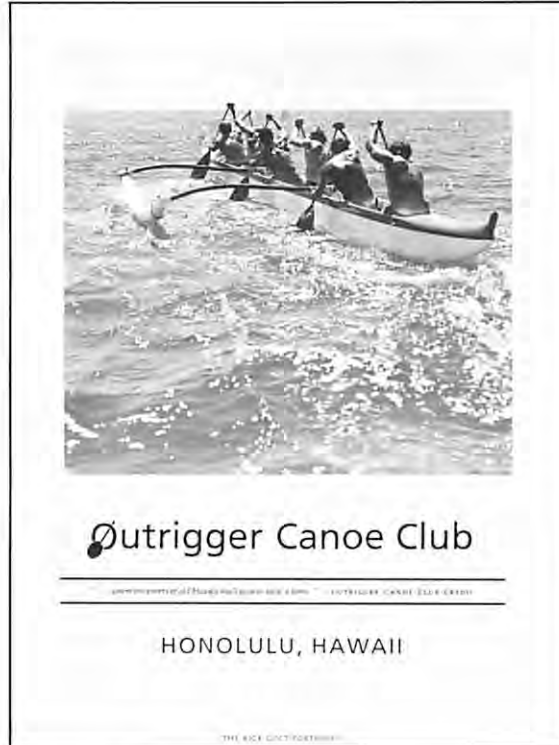
The poster was created by longtime Club member, Rick Golt, famous for his "green flash" photo which hangs in the Club bar. Twenty years ago, he opened Honolulu's first photographic art gallery and began a series of corporate and private commissions that literally spanned the globe.

After many years of study with world-renowned photographers Ansel Adams and Minor White, Rick was the first photographer to have a one-man show at the Contemporary Arts Center and then at the Honolulu Academy of Arts.

With major commissions from Australia to Saudi Arabia, he soon found his name on a number of books, including, "Hawaiian Reflections," "Hawaii Hawaii," "Wakaya Island," "The Hawaii Garden" and "Eternal Saudi Arabia." Today, Rick's murals and prints hang in the halls of government, and in corporate and private collections throughout the world.

During the last four years, Rick has turned a major effort to personally reproducing his work in a museum-quality edition of fine lithographs. A unique production team was assembled including designer Stephen Harvard, who created the classic look of the Ansel Adams posters and books, and Meriden-Stinehour Press, the renowned printers for the Metropolitan Museum, and Museum of Modern Art in New York.

As Rick said when he presented the idea of an Outrigger poster to the Board of Directors, "I was sitting out there at Old Man's in a canoe waiting



for a wave . . . and I realized how few experiences in life allow man to become so intimate a part of nature. I knew I had to create a poster for the Club that could somehow portray this experience.

"I knew that if the image was to become the timeless, sculptural statement I wanted, it had to remain separate from any specific identity or personality."

Choosing to shoot on what turned out to be a perfect day, Rick assembled a team of master paddlers with nearly

150 years of paddling experience and a Hawaiian class racing canoe, appropriately named the Leahi.

Working in waters off the Club, Rick wanted an image where you could find a feeling of understanding, a feeling of appreciation for the ocean, the canoe and the energy, and yet remain abstract and universal.

Although he shot many scenes, Rick knew the moment he got the perfect image. A small cloud formation appeared on the horizon, known to Hawaiians as kai opua, and the light seemed to form a spotlight shining directly on the canoe and its men of the Outrigger paddling into the future.

"I hope I have accomplished a visual statement about the canoe and the sea, and what our Club Credo is all about. Above all, I hope it is a poster of which we can all be proud for many years to come."

All of us involved with the Club and the Outrigger Duke Kahanamoku Foundation, join Rick in hoping that you will feel as excited about this image of the Outrigger as we do. A portion of the proceeds from the poster will directly benefit the athletic community through the ODKF.

The posters are on sale in the Beach Shop, each separately enclosed in an attractive red mailing tube. Signed lithographs are available for \$35 each, unsigned ones for \$25.

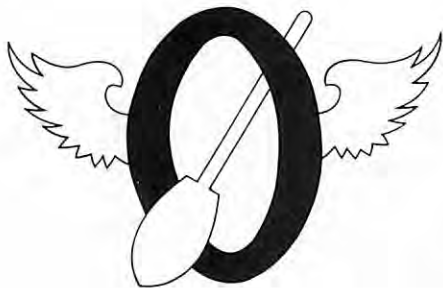

Help Save Huanchaco, Sacred Beach of Chan Chan

Historians and archaeologists agree that members of pre-Inca civilizations which evolved along the coast of Northern Peru were riding waves on their agile fishing/wave-riding reed sea horses more than 3,000 years ago.

These one-man totora reed craft, while originally designed for the purpose of fishing, were redesigned over time to perform the task of getting in and out through Northern Peru's constant surf.

Thus, the totora sea horse portrayed in ceramics and the walls of Chan Chan, were clearly designed by ancient craftsmen with the purpose of improving their handling in the surf and as such, were clearly the precursors of modern day wave-riding vehicles.

Today, Huanchaco the sacred beach of Chan Chan (largest clay citadel in the world dating back over 2000 years) and possibly the most ancient site where wave-riding has been documented, is being threatened by progress.

A project to build a marina precisely at the best part of this excellent point wave is under study. The project would not only change this beach forever, but it would most likely alter coastal currents affecting the customs of local fishermen who still use their reed sea horses to journey in and out of the surf like their ancestors did thousands of years ago.

The Peruvian Surfing Association has been unable to muster the political pressure to put an end to this unnecessary and destructive project.

As a last ditch effort, we are spon-

soring the 1st Annual Chan Chan Ocean Festival at Huanchaco Beach, Peru, May 2-7.

The event will have two purposes. First, to prove to local politicians and residents the important historic value in keeping the beach and surf in its natural state.

Second, to serve as a showcase for the many sports that have developed in and around the surf.

There will be individual and team competition in Open Surfing, Men Long Board (40+ years, 9-foot single-fin board), Wave Ski, Women's Open Body Board, Kayaking/Surf Skis, Totora Sea Horse Wave Riding, and Paddling and Swim-Run events.

Teams will have five members, including one woman body boarder, one long boarder and one judge.

You can help us save Huanchaco by competing in the festival, attending as a spectator or becoming a sponsor.

Sport Doping Problems

The Chief Medical Officer of the U.S. Olympic Committee, Dr. Robert O. Voy, told a recent (October, 1987) assembly of International Sports Federations that doping is the most serious problem facing sports since the days of the Roman gladiators. His talk is reported in the December "Olympian".

Dr. Voy, the Director of Sports Medicine and Sports Science, said, "you would think that we have progressed in preventing sport from being this destructive. We spend millions of dollars in sports medicine and science research to find protective equipment to prevent injury."

Dr. Voy cites several examples of athletes who have died as a result of ingestion or injection of performance improving drugs. One of the most incredible was that of a West German heptathlete, Birgit Dressel, age 26, who died after three days of unbearable pain.

Each day for a year, she had swallowed a total of nine capsules and pills, including medications doctors usually give to treat aging diseases such as arteriosclerosis, swelling of the legs, allergies, inflammation of the intestines, arterial cramps and dropsy.

Dressel had become a world class contender, rising from 33rd to 6th place in world rankings. She had increased her shoulder muscle mass and from a distance, she resembled a man.

The pills were given to her by her doctor, considered one of the "gurus" of German sports doctors.

In addition to the pills from her doctor, she also took "Stromba," an anabolic steroid she obtained from another doctor. Over the past year she had taken over 400 injections of some 40 different substances including some harmless ones such as bee pollen.

On the day she first complained of pain, her doctor (he is called "Mr. Syringe") injected her backside numerous times with "Meydop," a mixture of "standardized macromolecules of fresh cells from animal brain and placenta."

The cause of Dressels death was listed as "acute allergic reaction, an oversensitivity and breakdown of her body's resistance to the hundreds of medicines to which she had subjected her body over the past year."

Dr. Voy says that athletes, who use these drugs as a short cut to success, and unethical physicians, have gone too far in having athletes be the "best that chemistry can buy," resulting in the development of chemical robots risking injury and death.

To keep this spreading problem from getting completely out of hand, Dr. Voy recommends institution of a massive worldwide education program, increasing the number of drug tests, testing during the training period, obtaining an international cooperative agreement on testing, establishment of approved standards of selection and testing, implementation of consistent penalties and adoption of a standard banned substances list.

Dr. Voy makes it clear that the

world has a long way to go in both education and control of sport doping.

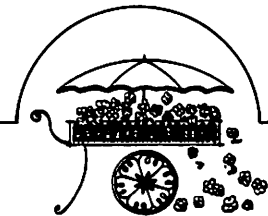

BOARD BRIEFS

By Diane Stowell

Treasurer's Report: The Treasurer reported on the financial statement for the period ending December 31, 1987. Net income year to date was \$18,674 which is \$39,208 below budget and \$154,746 below 1986 . . . Members equity is \$5,355,275 and represents a year-to-date increase of \$258,731 or 5.1%.

Delinquent List: Six members were suspended for 15 days due to failure to pay their accounts on time. One member had his membership terminated for being four times delinquent in a 12-month period.

Manager's Report: The Manager reported that as of January 22, 1988 seven projects reached completion. The projects received Board funding in

the amount of \$154,584 and were completed at a cost of \$156,156 which is \$1,572 over budget. Six projects reflected on the report were completed within or under budget. The dining room and lounge renovation project came in \$3,285 over budget. This was due to fiber sealing of the upholstery on the 60 lounge chairs and 125 dining room chairs. . . Board approved funding for the five projects that have not reached completion is at \$1,450,464 of which \$1,286,571 has been paid out, leaving a balance of committed funds of \$162,321. . . Year to date Food and Beverage sales generated was \$2,439,342.58 and produced a net gain of \$55,736.66 or 2.3% as compared to \$117,869.01 in the previous period. . . The Manager predicts that there will be an increase in competition for qualified people at all levels and requested an Ad Hoc Committee be appointed to study our entire wage structure. . . The Building & Grounds Committee will be involved in the beach erosion problem. The Board approved raising the stipend for the employee of the year and employee of the month. . . The Board approved the installation of ceiling drop lens in the Men's, Boy's and Girl's locker rooms for \$592.80.

Membership Report: The membership count of 3,974 as of December 31, 1988 was accepted. The Admissions and Membership Committee will come back with recommendations for a letter to Nonresidents regarding non-transferable memberships to surviving spouses. . . Approval was given to discontinue the required one year wait from date of application for the Associate and Intermediate category. . . Associate spouses will be required to sign a letter stating in the event of a divorce action within one year from the date of the granting of an Associate membership, they will not be afforded transfer privileges and will be required to apply for regular membership.

Building & Grounds: Approval was given to proceed with the expansion of the Weight Room, without hiring an ar-

chitect, in the present location using 4 parking stalls and done in-house. The cost will be submitted by the Manager.

A sketch was presented on the surfboard area and paving of that area at a later date. The Board approved the concept and after reviewing the two projects, the decision was made to put the two items on hold and include them in capital expenditures for 1989.

House Report: The Committee felt that safety is an area of concern and should be investigated as well as the fire and smoke alarms within the Club.

Athletics: The Running Committee budget was approved . . . Also the Golden Masters request to have two guest member participants during the week of the Haili and National tournaments.

The senior masters crew has been approved to participate in the Prince Kuhio Day long distance race on Kauai on March 26. . . Two exercise machines have been approved for purchase not to exceed \$1,300. . . The chairpersons for Bicycling, Motorcycling, Running, Tennis, Waterpolo and Weight Room were approved.

Entertainment: Three Scoops of Aloha were approved for the entertainment for the Athletic Awards Banquet.

Historical Report: The Life Membership Report prepared by Mr. Thomas was accepted. One member will be announced at the annual meeting for Life Membership.

Special Projects: There was a good turnout for the blessing of the parking addition.

New Business: The Board discussed and reviewed the Persona Non Grata list . . . Eight members were placed on illness status for one year and two members on financial hardship status.

Old Business: The Board approved the purchase of a frame for the Golt poster for display purposes. The posters, upon arrival, will be sold in the Beach Shop. . . Admission's Committee had money approved for their committee to have a dinner meeting.

Board Briefs is based on the January 29 Board meeting. ☺

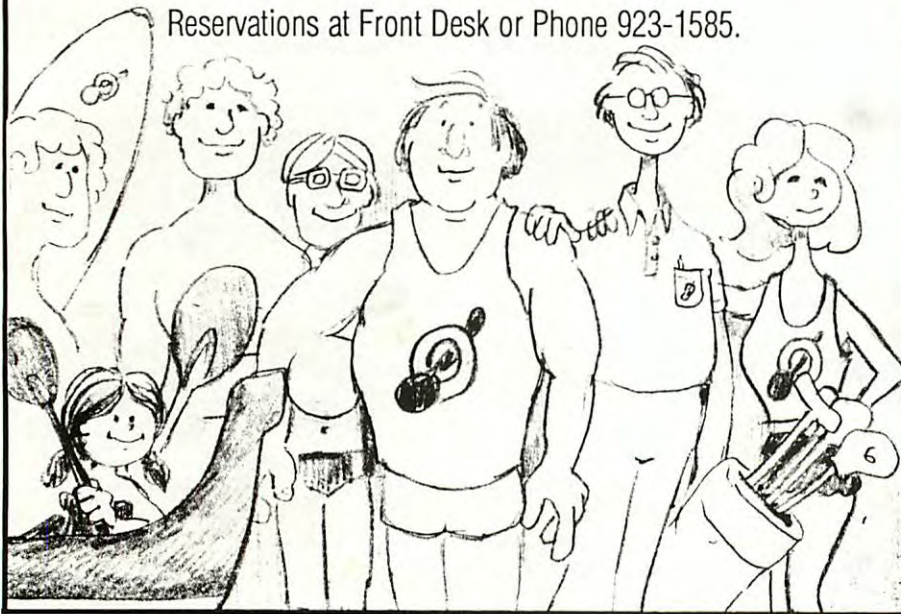
