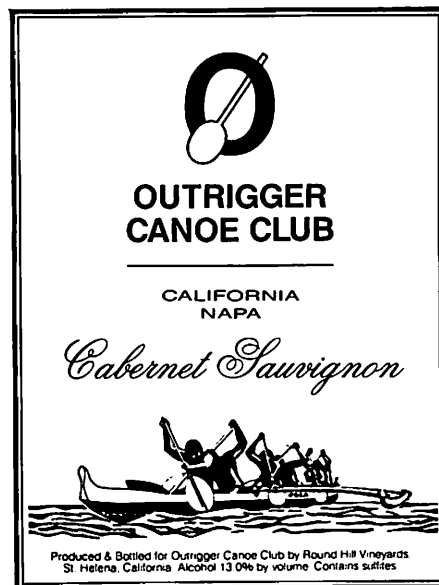
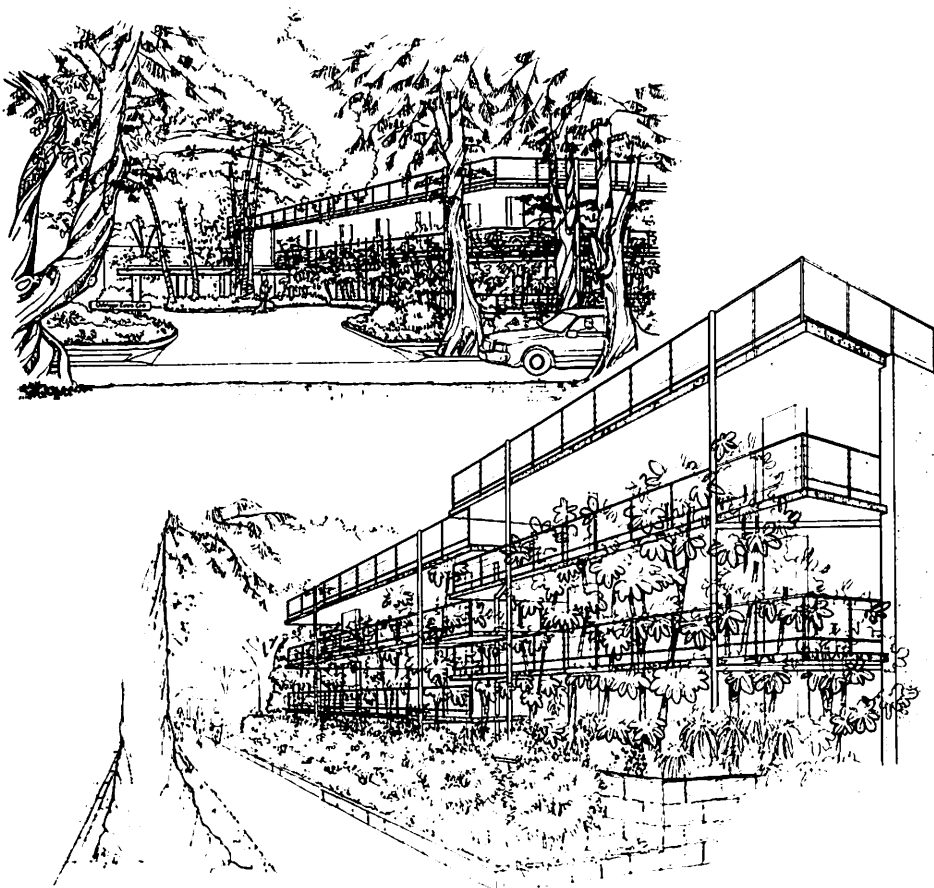
Valet Parking

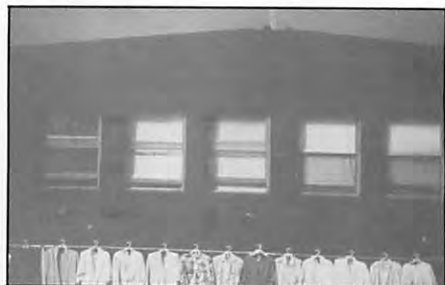

member of the Golf Committee.

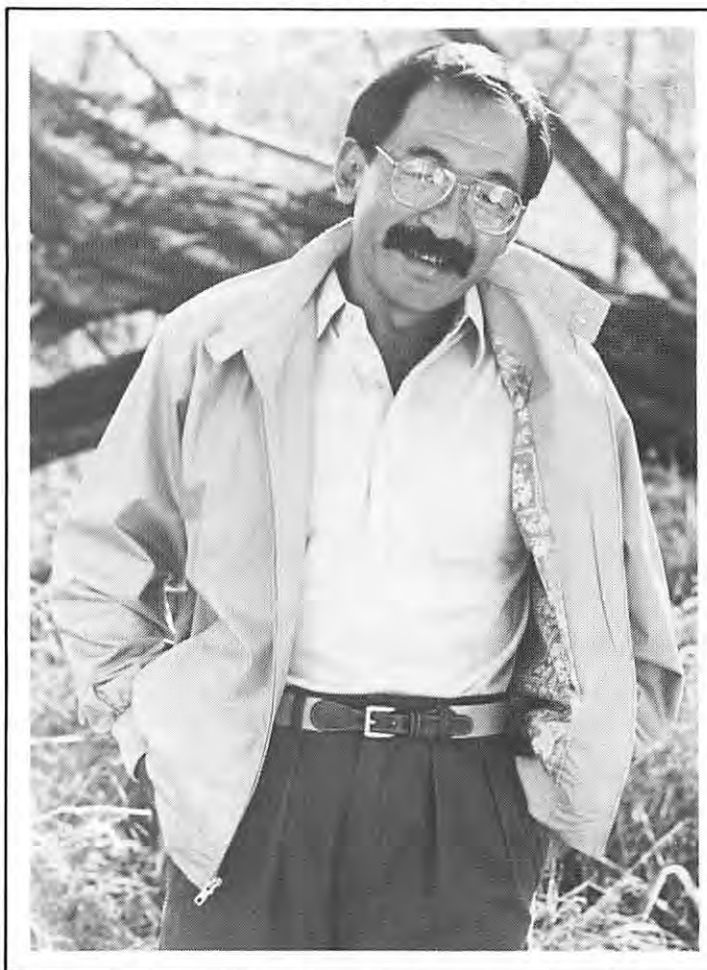
Golf Chairman Jim Hammons acted as master of ceremonies for the highly successful evening which also featured a great prime rib dinner.

Winged "O": Tom Arnott

Winged "O" Awarded January 15, 1968

When he was 17 years old and a football star and 440-man at Roosevelt High School, Tom Arnott became a member of the Outrigger Canoe Club. Forty-nine years have passed, but Tom's participation, loyalty and devotion to the OCC have not diminished.

His athletic achievements during the 40s were awesome. Being a member of the unbeaten six-man crew of 1943-49, which was coached by the immortal Duke Kahanamoku, was one of his proudest achievements as an athlete.

He teamed up with Sargent Kahanamoku in 1947 to win the Club volleyball doubles championship and was untouchable in combination with Jimmy Pflueger in 1942-45 doubles paddling competition.

Later, crewing for Duke, he and Duke were winners in the Lipton Cup S Boat class races. Tom also crewed on the Outrigger-hosted Kamalii in three Transpac races.

In the mid-sixties he helped with the Molokai Hoe, manning the pick-up boat.

Throughout his athletic career, Tom

was an unselfish team player. He carried that same spirit into his participation in other activities and duties in the Club.

After serving on almost every Club committee, Tom rose to the Club presidency in 1966 and served in that capacity for two years. He had pre-

viously served as Club Captain (at both the old and new Club), treasurer and vice-president. In the business world, he is Pacific Division General Manager for the Carnation Company.

No one in our Club is more deserving of the Winged "O" honor than Tom Arnott--a tried and true sportsman. ☺

Food and Beverage Prices to Rise

Toward the end of 1987, several budget sessions were held to discuss and develop a systematic plan for meeting expenses during the coming year. Included in the budget process was an in-depth analysis of the Club's food and beverage operations.

Number of meals served, average check per meal, total dollars generated per meal period, number of staff hours utilized per meal period, operating overhead, variable cost, fixed cost and food and beverage cost percentages were all scrutinized in detail.

The Budget Committee felt that the Club's food operation should continue

to operate at as close to breakeven as possible and the beverage operation should have a profit objective of 15% of sales.

In order to achieve these goals and continue to maintain our high standard of food and service, the Budget Committee recommended to the Board of Directors an increase to our price structure as follows: food 10%, beverage 5%. The Board of Directors concurred and the increase will go into effect in January, 1988.

We regret that this adjustment has become necessary, but it has been five years since our menu prices were last in-

creased. Much thought has been given to keeping the augmented costs as modest as possible, without sacrificing quality or curtailing our high standards of service.

Concurrently, Chef Teruya is in the process of developing an exciting new menu and we urge you to order and enjoy some of these innovative specialties. We will be most interested in hearing your comments.

We have worked hard to build and maintain high quality levels within our food and beverage operation and I am sure the membership is well aware of the high value received for dollars spent in our Club Dining Room.

In summary, we felt that adjusting menu prices to cover increased operating costs was preferable to cutting corners on the quality of our food and service. ☺

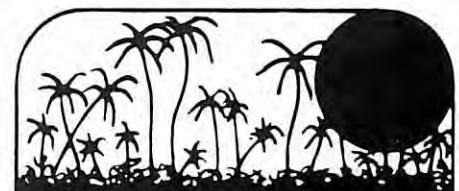

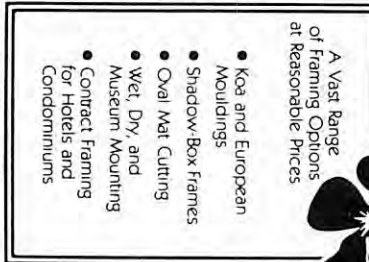

New Club Locker Policies and Procedures

At the recommendation of the House Committee, the Board of Directors recently adopted new policies and procedures on the assignment and use of Club lockers. All members are asked to review the rules and abide by the changes.

Availability & Eligibility

Lockers are available in Senior Men, Senior Women, Junior Boys and Junior Girls locker rooms for permanent assignment or day use. The Club Manager will maintain a list of locker numbers and current rental occupant.

Those eligible for permanent lockers assignment are all classes of membership (except Nonresident) who are in good standing and residents of Oahu.

Assignment & Priority

Club management will maintain wait-

ing lists of eligible members who want lockers. Lockers will be offered in turn to the next person, regardless of their permanent membership classification. Lists will be maintained for Oahu residents only.

Locker Preference

When available, a locker will be offered to the next name on the list. If the person does not choose that particular locker, their name will be returned to first on the list, and the locker will be offered, in turn, to the next waiting person until someone selects the available locker.

If you wish to take the locker temporarily, but prefer another locker size, you may have the available locker and your name will be maintained first on the waiting list for a locker of your preference.

When changing from Junior (under 18) to senior status (over 18), you may temporarily retain your junior locker until a senior locker is available. However, you must put your name on the senior locker waiting list. If the senior locker that becomes available is not your preference, you must take it in order to leave the junior locker room. Your name will be retained on top of the senior waiting list for a locker of your preference.

Nonresident Members

Nonresident-A members with a locker at the time of the adoption of these policies will be allowed to retain their locker.

There is no nonresident waiting list. Your name will not be put on a waiting list until you become an Oahu resident. Nonresident-B & C members may use only day lockers.

Change in Membership Status

Once you have obtained a locker, it is yours to use, regardless of your change in membership status from Associate, Regular or Nonresident-A, as long as you use it within the year and respond to non-usage correspondence described under the section on retention of lockers. If you were a resident and become a Nonresident-A you may wish to give up your locker or share with someone.

If your membership is terminated for delinquency or other reasons, your locker may be retained in your name for 90 days (three months), giving you the opportunity for reinstatement.

If you are reinstated within 90 days, you will have your locker. After 90 days, your locker will be emptied and released to another on the waiting list. If you are later reinstated, you will have to place your name on the bottom of the waiting list. You will not have a preferred waiting status.

Retention of Lockers

Use of a locker is a privilege. Non-use of a locker can be grounds for revocation of that privilege.

On January 1 of each year, a letter shall be placed in each locker inquiring

if the rental occupant still wants to retain that locker and if so, to return the letter of intent to the locker attendant.

On April 30 (after four months), all lockers will be opened and those rental occupants with the intent letter still inside will receive a letter from the manager requesting release of the locker due to non-usage, or a statement in writing of the occupant's wish to retain the locker.

Those who have not responded to the Manager's letter by June 30 (after two months), will have the contents of their locker removed and disposed of and locker fees will be deleted from their Club bill.

This locker is now available for the next person on the waiting list.

Locker Name/Occupant

The occupant of the locker will be indicated on the locker list and will be the person billed for the locker. You may have only one locker.

A spouse holding a "Special Guest Card" may have a locker. It will be billed to the permanent sponsoring member's account.

The names of other Club members using your locker on a shared basis must be supplied in writing to the attendant or the key to the locker will not be released to those members. The person assigned the locker will receive the bill for the locker.

Sharing is encouraged but by personal arrangement. If there are problems with the other members sharing your locker, you are responsible for your locker and must handle those problems.

Day Lockers

Day lockers are available from the attendants for one day use for any classification of membership and guests. A signed Club charge slip will be made for the applicable fee. This locker must be cleared by the end of the day.

Fees

All fees are established by the Board of Directors and will be posted as appropriate.

Care of Lockers

You are responsible for the interior care of your locker. Do not store food, perishables or wet items in your locker.

Laundry Services

If you wish towels or athletic clothing to be laundered, sew or write your

locker number on the item. It will be washed and returned to your locker by the attendant.

Both an alphabet letter indicating which locker room, and your locker number, must be used. Example, M201, W111, G16, B2.

Use of locker laundry service is at your own risk. The Club is not responsible for lost or damaged personal items.

Liability

The Club assumes no responsibility or liability for personal valuables or other belongings stored in lockers or left in the locker rooms.

Violations

Members abusing their locker, storing offensive material, delinquent in paying bills or not responding to locker usage notices could lose the privilege of having a locker.

Complaints

The locker room attendants are available to assist you in enjoying the Club. Any complaints are to be submitted in a suitable manner.

Those complaints about the condition

of your locker or the locker room facility should be made in writing to management.

Amendment of These Operating Procedures

Changes in these procedures can be made upon recommendation to the House Committee for approval by the Board of Directors.

Recommendations are always welcome. Make them in writing to the Club General Manager and/or the House Committee. ☺

BOARD BRIEFS

Treasurer's Report: Net income for the month of October was \$25,968 which is \$5,203 less than budget and \$11,159 better than October, 1986 . . . Members'

equity represents a year to date increase of \$278,098 or 5.5%.

Delinquent List: Two members had their membership's suspended for 15 days for failure to pay accounts on time.

1988 Budget: The Board reviewed the proposed 1988 budgets. Next year, an invitation will be extended to the Coordinating Director for Athletics and Club Captain to sit with the Budget Committee. The budget was approved to include an increase in locker fees as recommended by the House Committee.

Manager's Report: The Manager reported as of November 16, total Board approved appropriations for capital improvement projects is \$1,590,348. Total expenses are \$1,102,649, which leaves a balance of \$486,699 of committed funds. . . The Board was informed that there is a delay in the ventilation system of the Ladies Locker Room. . . Approval was given for additional funds for the base of the TV. . . The parking structure is running ahead of schedule, but will be receiving light poles for the upper level in February. However, temporary wooden poles may be considered. . . Food and Beverage departments are currently running a deficit of \$8,249 as compared to \$23,687 or 1.6% for the previous period. . . The Manager has resumed monthly staff meetings.

Membership Report: The membership count of 3,969 as of October 31, 1987 was accepted.

House Report: The data system in the business office is being evaluated. . . The suggestion box from the locker rooms will be relocated and will be

noted in the Outrigger magazine. . . Approval was given for a locker fee increase, effective January 1, 1988. . . A dinner meeting was also approved for the House Committee to be held in February.

Athletics: The Board discussed establishing a policy for loaning of equipment. A fee will be charged for loaning fiberglass boats with the funds going to Club operations.

Entertainment: A wonderful turnout for the Halloween Party was reported. Approval was given for the blessing of the parking structure addition to include music, champagne punch and light pupus on January 16, 1988.

Public Relations: Approval was given for the committee to have a dinner meeting in December.

Historical Report: Approval was given for the committee to have a dinner meeting in December. . . Publicity will be forthcoming to encourage the return of original pictures such as the Dad Center photo.

Correspondence: A recommendation was submitted to obtain a life-sized head of the Duke sculpted in plaster. It was suggested that the sculpture be cast in bronze. This will be investigated before making any decisions.

New Business: Bill Brooks will be chairing the Nominating Committee.

The location of the Beach Shop and beach storage will be referred to the House Committee for consideration.

Board Briefs are based on the minutes of the Board's November 19, 1987 meeting. ☺
