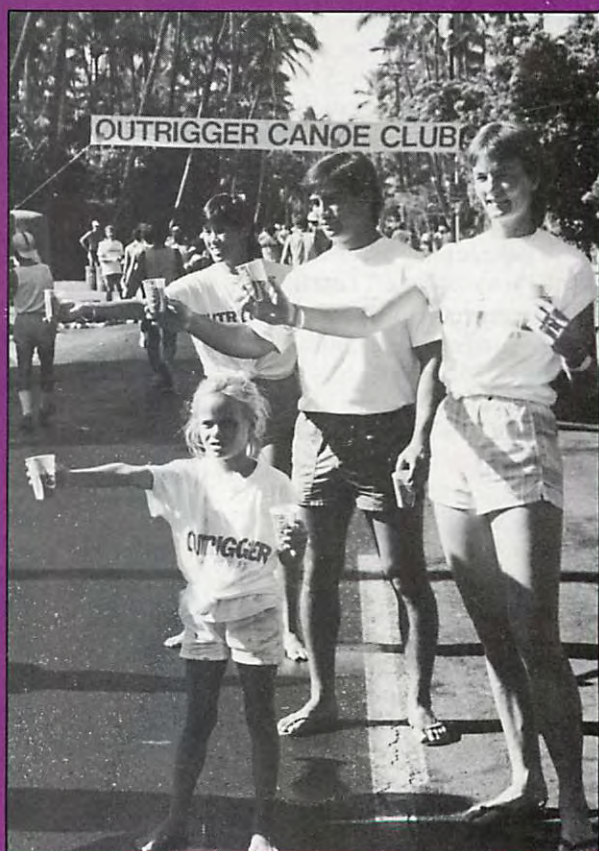

# Marathon '85

## A Winner

More than 100 loyal Outrigger members arrived before dawn to set up the Club's annual Marathon Aid Station on Kahala Avenue, while at the other end of town more than 30 hardy Outrigger runners gathered on Rudy Choy's Aikane catamaran at Aloha Tower to await the start of the 13th annual Honolulu Marathon.

When the day was over, the applause was loud for all those who ran and helped.

Our runners appreciated the last minute encouragement and coffee provided by Choy and Club supporters at the start of the race.

Cline Mann and his team of Gen. Don Schmuck, Bill Cook, Brad Martin, Nick Black, Jimmy Dean, Reed Minuth and Ralph Mintz, arrived in the wee hours to begin the setup of the Aid Station on Kahala Avenue. By 5:30 a.m. they had been joined by more than 100 OCC volunteers who passed out ice cold sponges, "wata" and cokes, as well as lots of encouragement to the runners as they passed.

The Club banner hung across Kahala Avenue and brought many "Thanks, Outrigger" comments from runners. Aid Station volunteers were outfitted in OCC Marathon '85 T-shirts.

The Aid Station was located at Mile 8 on the way out and Mile 23 on the return.

Those Outrigger runners who wore the Club's white singlets with red OCC emblazoned on the chest, were easy to spot, photograph and cheer on. All Club members are encouraged to wear Club shirts when running in the future.

At Kapiolani Park, Robin Smith, Running Committee chairman, and her crew offered refreshments and massages to finishers, as well as congratulations and cheers.

Three cheers for all of those who helped make Marathon '85 a memorable experience for all.

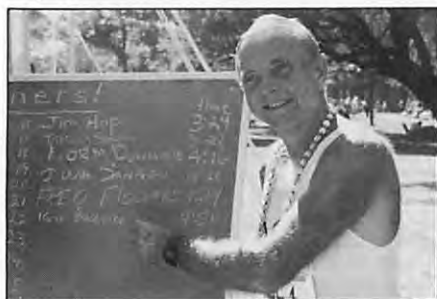

## Ocean Triathlon

Patterned after Ocean Ironman Surf events in South Africa and Australia, the 3rd annual OCC Ocean Triathlon will be held on Saturday, March 8.

The trio of events will be a one-mile swim, two-mile paddleboard race and four-mile kayak race, to be performed consecutively. Each member of a three-person relay team will perform only one of the events. Contestants must provide their own kayaks and paddleboards.

The Triathlon is open to all. The entry fee is \$10. Entry forms will be available at the Front Desk. Registration is the morning of the Triathlon from 7:15 to 7:45 a.m. The first event will begin at 8 a.m. on Sans Souci Beach.

Sandwiches and refreshments will be served at the beach following the Triathlon, and awards for first, second and third places, men and women, will be given by Hawaiian Style T-Shirts, Downing Hawaii and Outrigger Canoe

Club.

This year, there will be a cash prize of \$100 for the first finisher in the Open Division (Ironman) and \$150 to the first finishers in the relay race.

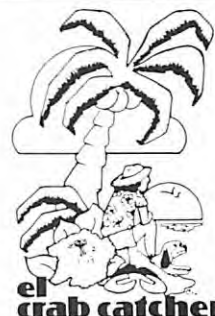

The Paddle Board Committee, chaired by Karl Heyer IV, and members Cline Mann and Robby Mist, put on the race.

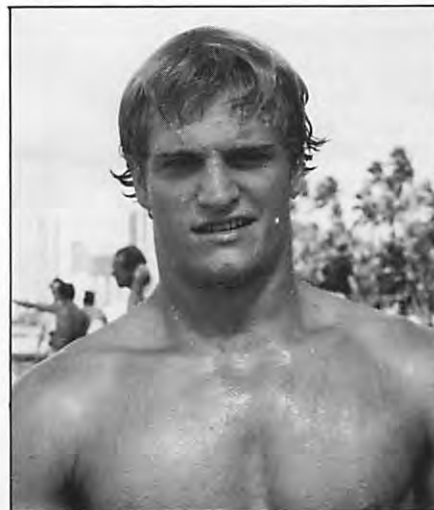

The race is being renamed the Outrigger Duke Kahanamoku 10K Paddle Board Race next year.

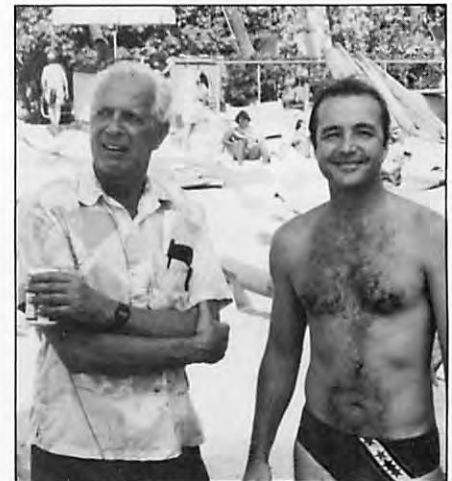

# Board Briefs

By Gerri Pedesky

**Treasurer's Report:** Members Equity year-to-date had an increase of \$782,564, or 21%. Total Members' Equity as of said date was \$4,515,628. Board commended the 1985 Budget Committee for the fantastic job they did in preparing this past year's budget; it was right on target. . . . 8 members were suspended for 15 days for being delinquent three times in a 12-month period. One member received automatic termination for being four times delinquent.

**Manager's Summary:** November was a fairly good month for the Food Department. Year-to-date net bottom line had a gain of \$13,085 or .8%. Beverage Dept. year-to-date had a net gain of \$52,225. Both departments combined had a net gain of \$65,311 or 3.1%. . . . Manager reported four emergency lights have been purchased and have been installed.

**Admissions and Membership:** Membership count as of November 30,

1985 was 3,873. The Board reviewed the A & M Committee's recommendations with the following actions: Approved a quota of 1,305 (90% of the 1,450 Regular quota) for Nonresident-A memberships. Approved in concept the Nonresident-D category. Approved the changing of the previously-approved Nonresident Affidavit so that 6 months reads 26 weeks.

**Building & Grounds:** One back section of the top parking level railing will be installed with pre-woven netting. This is part of an ongoing search for the best appearing and most functional safety measure to prevent individuals from slipping between railings. . . . Upon Committee's recommendation to hire a professional service to provide specs and supervision for re-roofing, it was the Board's decision to wait to see if there are any more leaks since the roof drains have been made functional before attempting re-roofing. If work is needed, specs would be obtained from members and only those areas needing re-roofing would be done. . . . The Board gave the go ahead with building the hollow-tile wall up to the edge of "A" dining room then installing an anodized aluminum fence from said edge to seawall. Appropriate landscaping and lighting would be executed on the dining room side of the wall.

**House Report:** Board approved the Committee's following recommendations: Kayak paddles may be stored in the men's locker room ventilating room only in designated areas, at the owner's risk and no other personal items may be stored in that area. As a health measure Club has discontinued providing razors to both locker rooms.

**Athletic/Winged "O":** Board approved sale of two "Malia" mold canoes, one to a Kauai canoe club and one to the University of Hawaii. Both canoes had been in service since 1978 and would be sold at a very good price (\$2000 each). Said monies would go against the purchase of two new "Hawaiian Racer" mold canoes during the regatta season. This is in accordance with the overall plan to upgrade the Club's canoe fleet.

**Entertainment Report:** Board wishes to thank the Committee for the wonderful Christmas decorations and especially Mrs. Barbara Sharp, Gay Austin, May Balding, Phil Sharp, Jim Stackhouse, Mitzie Lee and Sue Oliver for their hard work in installing the decorations.

**Public Relations:** Board approved the Committee's recommendation to appoint Marilyn Kali as the Editor of "The Outrigger". . . . Advertising in "The Outrigger" is to be kept at the 80/20 ratio.

**New Business:** The following members were approved to serve on the 1986 Judges of Election Committee: Willard Asdahl, Robert Costa, Les Gamble, William Kea, Gene Long, Pat Olds, Ward Russell, Tom Vesey. . . . The following members were approved to serve on the 1986 Nominating Committee: John Beaumont, Bill Cook, Mike Holmes, Ward Russell.

**Outrigger Foundation:** Board approved language of Statement of Purpose (to be in next issue). Fund balance is \$106,073.

## Locker Survey

# Elections at OCC Fixed?

Of course not! But . . . now that we have your attention . . . PLEASE read on. If you are one of the approximately 1850 voting members of our Club (all Regular, Intermediate, Senior and Life members in good standing) we encourage you to exercise your most valuable Club privilege by voting in the upcoming elections and attending the annual meeting to receive the results.

When your vote is received at the Club, there are several steps followed by the Judges of Election:

- Envelopes are removed from the large ballot box. If there is not an outside SIGNED envelope, i.e. if there is only a ballot envelope, it will be thrown away. Only by having an outside signed envelope can the Judges of Election know your vote is legal and comes from a qualified,

voting member.

- Signatures on the outer signed envelope are then checked to be sure members are not delinquent. Delinquency will invalidate the ballot.
- After the above, the outer envelope is discarded and the inner ballot envelope is placed in the true ballot box, then removed from this box for the actual counting. Even at this step there are invalidations, as many people do not carefully count how many votes they may cast and "over vote," thus causing the entire ballot to be cancelled.

In last year's election, of the 1,048 ballots cast, 95 were invalidated for one of the above reasons. In the final results only 50 votes separated the last 3 finishers from those elected and in one

case one vote meant the difference of being elected or not.

When you receive your 1986 ballot, please vote, vote carefully and return your ballot immediately. Your vote counts!
