The Ko'olaupoko Cline Mann 2012 race on July 7 was arguably the roughest, biggest water I've seen on race day. We were all prepared to be hating life with a South swell at 3 feet 14 seconds combined with a backing up tide coming at us.

Lucky for all of us, the raging ENE wind (19-23 mph) that had been building all week combined with an ENE swell at 8 feet 8 seconds to push us along and make the course actually really fun once we got around Makapuu corner.

All in all, it was an amazing day on the water. Clark Abbey gave a pule and told stories about Cline Mann, and how he had revived the traditional sport of paddleboarding, with a ceremonial Budweiser before we headed out. We were all feeling pretty proud to be paddleboarders.

I remembered my first time ever paddling the Ko'olaupoko, Makapuu to Kaimana course (with Clark Abbey and Greg Quinn). I remember watching Greg and Clark surf their Malolo paddleboards down what I thought were giant waves and thinking "aaaaahhh... I'm scared! This is so cool!"

This race, I saw a similar vision, watching my good friend Marc Rocheleau teetering on the top of some large swells along Sandy Beach in the middle of all the chaos, however, dolphins surfed with me along Hanauma Bay. I also caught a nice wave in at the finish.

Brian Rocheleau won the men's field for the first time (Yeah Brian! - happy 1 year old present from son Eli, who's birth kept Brian from racing last year!). Keoni Watson was the runner up. Most impressive to me, however, were the women. We had five women (most ever!) do the solo long course. Up and coming super star Leanne was right behind me, and Joanna Bilancieri finished third on a stock board. Joan Fukumoto and Kiyomi Shepherd rounded out the women's field.

The short course, from Hawaii Kai to the Club, consisted of three races, a prone paddleboard race, a stand-up paddleboard race and a relay for juniors.

OCC President Marc Haine was the first finisher in the prone race and Scott Gamble repeated in the stand up division. First to finish in the relay were Hunter Pflueger and Nat Yee.

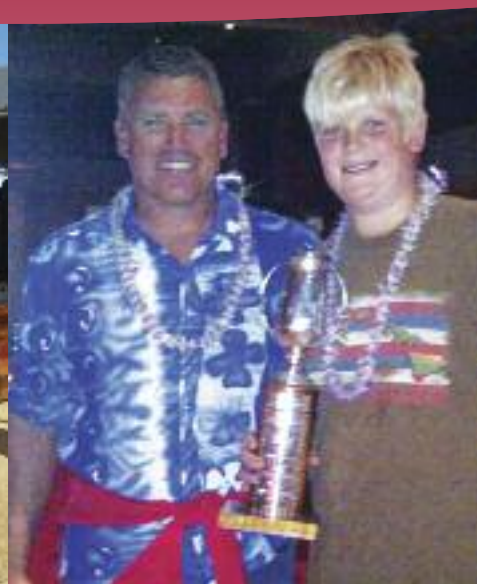

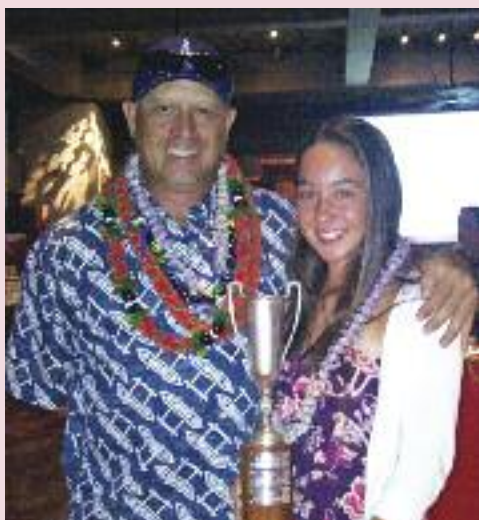
## Girls 15 Undefeated in Regatta Season

The 2012 canoe racing regatta season is in the books, following the Hawaiian Canoe Racing Association State Championships on August 4 at Keehi Lagoon.

Outrigger's Girls 15 completed a perfect season by winning all eight of their regattas. The Boys 18 and the Men 65 had near perfect records winning seven of their races.

Outrigger scored 242 points in the HCRA regatta to finish fifth overall in the AAAA division, behind Lanikai and Kailua which tied with 330 points, Hawaiian Canoe Club 325 and Kai Opua with 301.

Winning state titles were the Girls 15, Boys 18 and Women 55.

Outrigger wound up the OHCRA season with three second place finishes in the Pa`aina, Macfarlane and Lee-

ward Kai regattas, third place finishes in the Kamehameha and Waimanalo regattas, and fourth places in the Kaupiko and OHCRA regattas.

Youth Coach Mike Lum's Junior 'Riggers had a really good year, and he predicts they will work hard in the off-season and come back next year stronger than ever.

Coaches Steve Scott and Shelly Oates-Wilding are rebuilding their open crews and looking forward to the distance season which continues in September. The Na Wahine O Ke Kai Molokai race for women will be held on September 23, while the men will wind up the distance season with the Molokai Hoe on October 7.

They encourage paddlers to continue practice in their one-mans during the off season so they'll be ready in 2013.

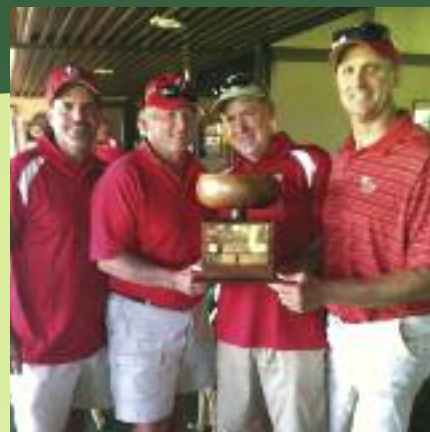

## Ka Mo'i Boathouse Bar Renovation

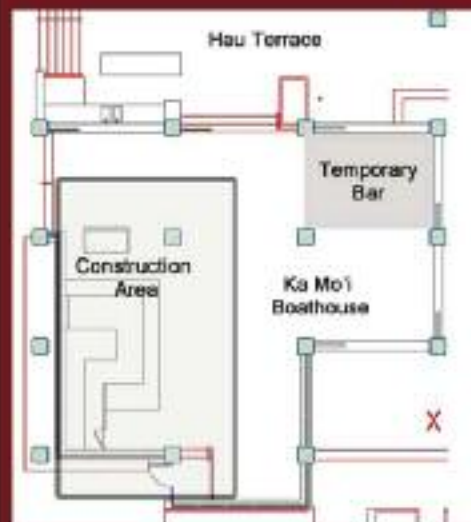
The *Ka Mo'i Boathouse* bar will be undergoing renovation in September to upgrade the "back of the bar" area.

# Backward Glances

## September 1996 - 16 Years Ago Tim Guard, President

The September OCC magazine reported OCC paddlers piling up wins at the John D. Kaupiko Regatta on July 14 at Marine Base Hawaii, Kaneohe Bay, and the Oahu Hawaiian Canoe Racing Association (OHCRA) Championship July 21 at Keehi Lagoon. Winning 12 events in the Kaupiko, OCC scored 91 points to Hui Nalu's 66 and Lanikai's 56 for the Oahu Championship. Winning 13 events in the OHCRA Championships, OCC again scored 91 points followed by Kailua with 69 and Hui Nalu, 67.

The magazine reported on Fred Hemmings' Third Annual Maunawili Trail Run sending OCC runners through The Flume in the Tunnel on June 23. Fred traced out a trail through the old part of Maunawili and exiting in Waimanalo.

The ditch trail, said to have been built by engineers in

the early 1900s, was a man-made marvel, a state-maintained irrigation ditch through the mountain to bring water from Nuuanu Pali into Waimanalo.

The trails Fred found were not well traveled and his map proved accurate. Fred named landmarks after nicknames he and surfing pals used for surfing spots. Thus on the map the open area known as Utilities cited a clearing of utility wires.

The trail straddled Olomana ridge between Olomana and Waimanalo, creeping along with one foot on each side. The water tunnel was four feet high where stooped-over runners entered, plunging ahead into the darkness while hearing scary tales of a resident dragon, leeches, and screaming wombats.

Flashlights were on. For the last 100 yards the tunnel opened up to a six foot ceiling where runners could stand erect. At the end of the day Fred began working on a new map for next year.

# BOARD BRIEFS

Board Briefs is taken from the minutes of the Board of Directors meeting on July 26, 2012.

**Membership Count:** The Membership Count was 4,783 as of June 30, 2012. The Board approved Athletic budget line item transfers for the Canoe Racing Committee. . . Anthony Hunt, Mary Balding, Rick Humphreys, and Nedra Manson were approved to serve on the Volleyball subcommittee for the remainder of the committee year.

**Finance Committee:** The Board approved the following recommendations from the Finance Committee: investment consulting fees for UBS to be paid via a reduction to plan assets for both the 401k and pension plans and adding corporate bonds as an acceptable fixed income investment.

**Historical Committee:** The Board approved Dave Rochlen to serve on the Historical Committee.

**Budget Committee:** The Board approved the following to serve on the 2013 Budget Committee: Jeff Dinsmore, chair; Marc Haine, Jon Whittington, Brad Totherow, Steve Gilley, Diana Allen, David Buck, Liz Perry, Fred Noa, Eric Crispin, Mike Ako, Joyce Nobriga.

**Kalanianaʻole Property:** The Board approved moving forward on an offer to purchase the Kalanianaʻole property. There is currently an Intent to Purchase agreement, but a contract has not yet been signed. Steve Torkildson will be asked to draft an informational letter to the membership regarding the purchase agreement.

**Financial Statement:** Ending Net Operating Fund Income for the month was \$70,855. This high positive

variance will normalize as athletic expenses are submitted. YTD \$317,750 in initiation fees have been collected and deposited in the Operating Fund. There was a combined Food & Beverage net income, with the mini-charge, of \$36,149.

**F&B Director:** Jason Pohlman will be leaving the Club on September 15 to pursue a new job opportunity in the restaurant business. Jason is well regarded by staff, members, and the Board and we wish him well.

**Wave Deflector:** This project is no longer viable and should be taken off the 2013 budget.

**Front Desk Renovation:** A new countertop surface is being looked at for the Front Desk. The cabinetry is being fabricated in house.

**Building & Grounds:** Bar renovation starts in September and should take 30 days. A temporary bar will be erected on the Ewa/makai corner of the Boathouse to service membership. . . Fred Noa reported that the Elks Club is also considering an Energy Savings project. He suggested an informal dialog with the Elks Club by the Board, possibly an ad hoc committee. This will be discussed at the Board retreat. . . Outside Historical Clock is still being repaired. . . Step-up in basement was removed and replaced with a concrete ramp to eliminate a possible tripping hazard.

**Athletics:** Jared Watumull will be stepping down as Club Captain at the end of the season. A search is underway for a new CC.

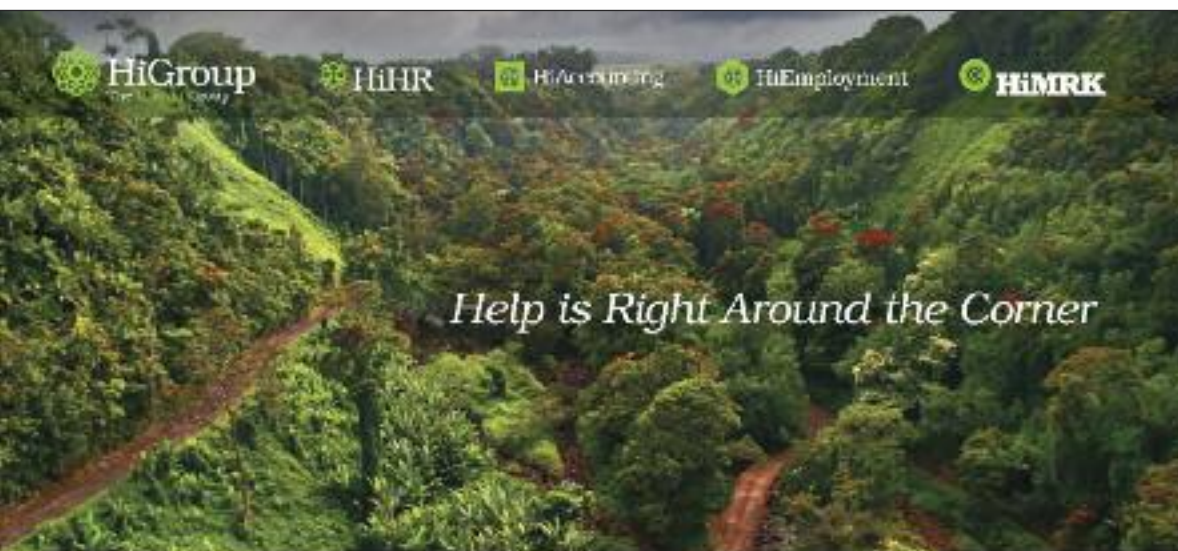
