Austin Wins Kaiwi Channel Solo Race

(Editor's Note: Jimmy Austin won the Kaiwi Channel Solo OC-1 Race on April 15, 2012 setting a new course record of 3 hours and 31 minutes, beating out Karel Tresnak Jr. who finished second in 3:32:45.)

The Steinlager Kaiwi Channel Solo is regarded as the World Championship for single person outrigger canoe paddling. It is the title that watermen covet most. The solo race begins at Kaluakoi on the western end of Molokai, crosses the Kaiwi Channel, considered one of the roughest ocean channels in the world, and finishes in Hawaii Kai. Since its inception in 1993, there have only been six winners: Pat Erwin, Steve Cole, Mark Rigg, Karel Tresnak Jr., Kai Bartlet, and Danny Ching.

The level of competition in the past few years has become quite tough and in turn requires huge sacrifices to be fast. Training regiments consist of workouts six days a week, both morning and afternoon. Time is spent paddling, doing cardio, lifting in the gym, stretching and getting bodywork done (i.e. chiropractor/ massage).

To be competitive there are many things that come into play; experience is one of the biggest. Paddlers don't just come out here for the first time, step off the plane, and win the race. To win, it takes many crossings through the channel.

The winning recipe for everyone is different; for me, it's important to figure out what nutrition works, what course works, and how to push myself mentally through those painful moments when my body is telling me to quit.

On top of that, you never know what the conditions are going to be. The past few years have been upwind, downwind, and even flat. With such a variety of scenarios, you have to train for all three conditions and be prepared for whatever Kaiwi is going to throw at you that day.

I never knew what training at a high level was until John Puakea told me, "here's a program why don't you see how well you can do." I had recently lost my dream job with Aloha Airlines and the ocean was my way of getting my mind off of the situation. I put a wholehearted

effort into the training, and with my family's support I went all in.

In 2009 I finished third and was absolutely shocked; that year the course was upwind and I was not expecting such a good outcome. In 2010, I finished second even with an unfortunate mishap during the race (I flipped my boat). In 2011 I finished third again and thought to myself that I missed my opportunity in 2010 and thought I may never be able to win this race.

This year, on the day of the race I thought I had a chance of winning, but knew it wouldn't be easy. I would be up against Pat Dolan (a top waterman who had been training as an Olympic hopeful and who has done more training than me), Karel Tresnak Jr. (seven time solo OC-1 World Champion), and Danny Ching (2010 OC-1 world champion and the guy who had always edged me out over the past three years).

In the solo it's all about being patient, trying to maintain hull speed, conserve whatever energy you have and wait for an opportunity to present itself. If and when that happens you go all out to seize that chance at victory. For me that opportunity didn't come until the three-hour mark. I fought through everything you could imagine and then some.

Just when I thought I had the race won, Karel pulls up on a wave next to me inside Hawaii Kai and says "Hi, I'm back!" I knew at this point this was it. This is where all my training, sacrifice, and drive came in to play. I put my head down and gave it everything I had.

As I crossed the finish line I was in tears. It was so surreal. I had trained so hard and dreamt so much of that moment but for some reason there was always doubt of whether I was capable. My lifelong dream of being a world champion had come true. It still hasn't completely sunk in, but I thank God everyday for what He has blessed me with and look forward to what the future has to offer.

It just goes to show you that if you're willing to put in all the effort, your dreams can come true.

"Nepal is a country rich in Buddhist and Hindu culture and traditions, a woven tapestry of colors, sounds and tastes. However, we all came to appreciate how lucky we are to live in a country where the electricity is always on, you can drink water out of the tap and your garbage gets picked up.

"In Nepal, you are greeted with "Namaste", which is like our word "Aloha", which means "hello", "goodbye" and "I care for you". It was a nice way to see how our two cultures are connected."

Brett Thomas sent along the photo of Duke Kahanamoku and Jack LaLanne. Jack's wife Elaine related to Brett that Jack was a big admirer of Duke. Jack, who passed away in 2011, was widely known as the "Godfather of Fitness."

Both men were iconic waterman. Kahanamoku as an Olympic swimmer and surfer, and LaLanne, whose feats included: Paddling solo in 1958 at age 44, the approximate 30 mile channel between the Farallon Islands and San Francisco. LaLanne paddled the channel on a 12 foot paddleboard made by Jack O'Neil. He also, for his 70th birthday, swam handcuffed and shackled while pulling 70 rowboats across the Long Beach Harbor for one mile.

Brett and his father visited Jack and Elaine at their home in San Luis Obispo, California about a month before he passed away. Still working out and fit, he was very excited to pass on this photo and asked that I present it to the Outrigger Canoe Club. He had fond memories of his time spent at the Club over the years. His son, John, lives on the Big Island of Hawaii shaping surf and paddleboards

2012 Pilot Athletic Membership Program

In an effort to make the Outrigger Canoe Club more competitive with other canoe racing programs, the Board of Directors approved a pilot program for a new athletic membership for 2012 at its Board meeting on April 26.

"The OCC Board of Directors has been concerned about the competitiveness of our paddling teams over the last decade," stated President Marc Haine. "The increase in the number of OHCRA regatta events has changed the number of paddlers necessary for any club to successfully compete in individual regattas, the overall OHCRA and State championship, and long distance races."

Per our Bylaws, Outrigger must find paddlers within its own membership, he pointed out, while other clubs have the ability to recruit paddlers from anywhere on the island.

"It takes a minimum of 350 paddlers evenly spread throughout the 44 OHCRA regatta races to compete and win regattas," said Club Captain Jen Bossert. "We haven't been able to fill all of the events, every week, for a number of years."

"We often have an overage of paddlers in a particular age group, but then not enough to fill a boat in other events. We do our best to move people around but due to race rules we aren't always able to get enough bodies in the boat in each event," Bossert added.

"Our goal will always be to put regular Club members in boats first," she added, "but the new athletic member-

ships will allow us to recruit paddlers to fill the empty seats."

The Canoe Racing Committee and Club Captain requested that the Board consider special athletic memberships for outstanding paddlers who could make a contribution to our Club. After several months of discussion, the Board approved the new athletic membership for the 2012 Regatta and Distance seasons.

Outrigger has offered athletic memberships in the past, most recently in the 1980s. The program was stopped when we could fill all the boats with regular members. However, since then, new regatta events have been added that have stretched our membership's ability to fill seats in a canoe.

The Athletic Membership falls under the Special membership classification as defined in Club Bylaws Section 30.

A maximum of 40 athletic memberships will be available for the 2012 paddling season, Haine said.

Guidelines for the program have been set up. They include the same application process that all applicants follow including obtaining two sponsors, a 30-day posting, an interview with the Admissions & Membership Committee, subsequent approval by the Board, and if approved, paying appropriate age-based category monthly dues. Applicants will be allowed to practice while posted, as current BOD policies permit.

The athletic membership shall be for a set period of

time, which shall generally include the practice period leading up to a season through the end of the season and any subsequent award events related to the season.

Behavior unbecoming of a Club member shall not be tolerated. In general, the athletic member shall be held to a higher standard of personal conduct: loss of membership, not reprimand.

Potential athletic membership candidates should be directed to the Club Captain and/or Canoe Racing Committee Chair. Candidates will need to go through the admissions process outlined above. There will not be an initiation fee. Athletic members will pay the existing Club dues, including sports fees for the sport season; however, will not pay the mini-charge.

Athletic members will have family guest privileges, but no family signing privileges. Family may only use Club facilities in the company of the athletic member. Athletic members may not grant guest memberships but may bring a guest to the Club twice a month (normal rule).

The new athletic membership is good for paddling regatta and distance seasons only. AM's may use the Fitness Center.

In 1909, just a year after its founding, the Outrigger Canoe Club entered a canoe in the popular barge races in Honolulu Harbor. This helped to rejuvenate the sport of outrigger canoe paddling when a total of five canoes competed.

Of course the most exciting events of the day were barge races between the Healan and Myrtle boat clubs, but for the first time, the two famous clubs entered canoes as well as barges, and Prince Kuhio brought a crew of Hawaiians from Kona to paddle his famed koa canoe, A. The A won the race.

70 Years Ago

President: Walter J. Macfarlane

World War II, with its curfew, blackout, and barbed wire circling the beach, really restricted activities at the Outrigger. But not long after the Battle of Midway in June, 1942, the curfew was moved from sundown to 10 p.m.

Social events at the Club expanded and dinner dances, ending at 9:30 p.m. were popular on weekends. Weekday dinners drew large crowds. In his oral history, Bill Barnhart recalls the long lines of people waiting to be seated.

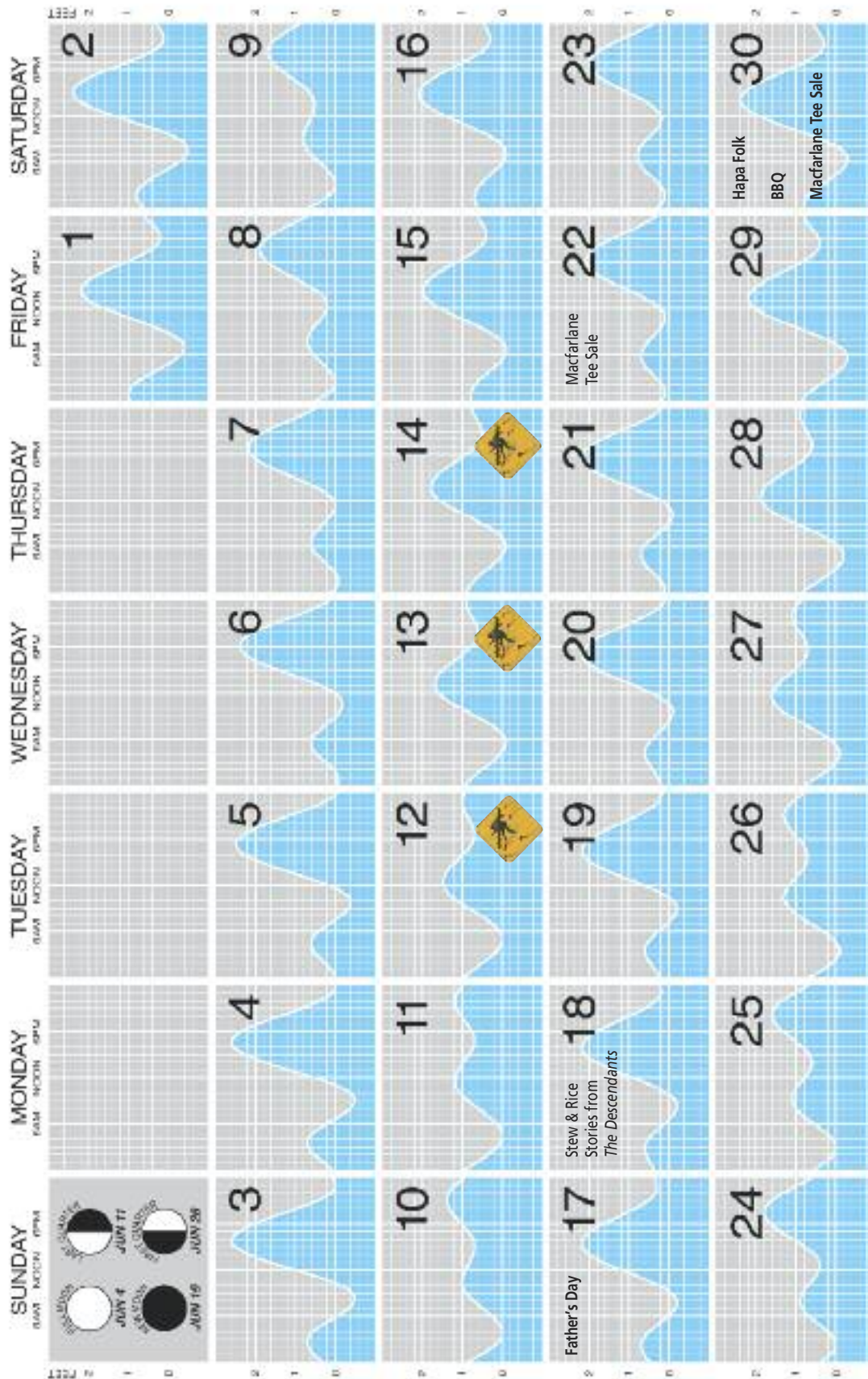

Financial Statement: Ending Net Operating Fund Income for the month was -\$21,684. There was a combined Food & Beverage net loss, with the mini-charge, of -\$22,492. Year to date, nonmember income (parties of 9 or more, sponsored by a member, with payment for the function paid by an entity other than the sponsoring member) was \$62,761. Year to date, non-member income is at 15.4% compared to 13.6%

Executive Chef: The General Manager is pleased with the performance of the new Executive Chef, Doug Lum, and is working with him in analyzing food costs and lowering this number.

Buildings & Grounds: The Bar renovation project is estimated to cost \$250K. Further study is being done on the benefits and return on investment (energy, sales etc.). The warranty on the volleyball courts waterproofing expired in 2009. The Front Desk reception area is being considered for renovation.

Athletics: The Board approved \$5,000 for Koa wood to repair the canoes.

Entertainment: The Board approved \$1,500 for expenditures for the Club Day event on May 27.

Public Relations: The PR Committee is forming a sub-committee to handle the Lobby Display Case. Peter Brown and Laura Williams will be working on future displays.

Historical: The Historical committee is discussing the opportunity to house the Club's old Board of Directors minutes in the State Archives under climate controlled conditions. The Board requested a more detailed recommendation from the Historical committee.

Fitness Center: A suggestion from member Robert Harrison to name the Fitness Center was denied.
