# Secret Trail to Makapuu Pools and Pele's Chair

The Makapuu adventure hike on March 18 was planned months in advance because of the inaccessibility of the area at high tide. The path was around the bottom of Pele's Chair and along a secret path on the rugged coastline only the fishermen use and most people don't casually find.

The day was determined based on low tide charts and was a little more vigorous than previous ones. On most of this route the path was along a rocky shoreline with no trail, and some spots along this section ended up being dangerous in spite of the low tide. High surf was a surprise no one expected.



Although the tide was low, the waves picked up considerably and about two thirds into the hike, one had the choice of turning back, or forging ahead. Some turned back but most decided to move ahead.

The waves crashing against the lava created a spray that sometimes was 20 feet high, and went up the side of the trail. If you didn't time it quite right, you could be hit with an incredibly strong spray that could knock you off your balance and force you to cling to the lava rocks. The lava was made of 'Aa 'Aa, and was quite sharp, causing several scratched hands and legs.

The experience was probably the hiking adventure of a lifetime, as the scenery was the most dramatic we had seen because of the waves. We did learn that hiking is a risk, and proper clothing is important and some hikes are more difficult than others. We will post the challenges as we know them, but Mother Nature has a way of doing her own accounting!

Our group consisted of OCC members Katy Bourne, hike leader; Gerry DeBenedetti, Blake Johnson, and several other intrepid adventuresome souls.

Stay tuned for Adventure hikes each month. The location will be posted in the tunnel or on the OCC website.

# OCC Specialty Drinks

## The Club's Tradition of Mixology

Witnessing the green flash of a sunset over the horizon is one of the most memorable moments we experience at the Club. Several years ago in celebration of the green flash as seen from the Ka Moi Boathouse, a couple of members endeavored to create a drink to mirror the color (and feeling!) of the event.

It took three bartenders, two members, and a great many initial iterations of the drink, but eventually the "Green Flash" was born. Kawika Grant, one of the original inventors of the specialty cocktail, recalls "To make the perfect Green Flash it took the bartenders' eyes to recreate the reddish orange colors, and our taste buds to determine an instant classic."

The unique drink, which "contains a flash of Midori at the bottom" quickly gained popularity among members and guests alike and has joined the Club's line-up of specialty cocktails.

Many of the other specialty cocktails at the Club (some popular for more than 50 years!) are named after members who loved to order them. The Rab or Alice (Guild), and the Fowler are just a few.

All of these drinks are refreshingly blended and as Grant says "great coolers on a hot Hawaiian night."

There are some specialty drinks from the old Club location that cer-

tain members like Grant are working to make popular again. Try ordering a Pimm's Cup or a Ramos Fizz the next time you belly up to the bar or sit down to enjoy the sunset.

Both those drinks were big sellers at the old Club. The old timers still order them but the new generation of members isn't familiar with them. Too bad, because both are great drinks, Grant says.

Pimm's cup is an English drink that a London pub owner made famous in the 1850s and it's still going strong. It is the traditional drink at Wimbledon just like the mint julep is for the Kentucky Derby, Grant added. It is a sloe gin-based drink, blended with a secret mix of herbs and fruit juices. It is sold in bottles just like gin or whiskey. The Pimm's is mixed with ginger ale and garnished with a cucumber slice or spear.

The drink is traditionally served in a pewter mug or tankard which unfortunately are so pilfer able that the supply of them brought from the old Club have all been ripped off. They're served now in a tall glass.

The Ramos Fizz, originally popular in the 1920's, strangely contains an egg white!

The Fowler is the invention of Donny Fowler. It consists of vodka, orange and grapefruit juice, and passion fruit syrup. Like the Henry

and the Rab, it can be served on the rocks or blended. The blended version is by far the more popular. No garnish is used.

OCC classics like the Henry (named for its inventor Henry Ayau) or non-alcoholic Henrietta, are a favorite of one and all. The OCC Bloody Mary contains a precise mixture guaranteed to kick you back into gear. The OCC Mai Tai, built with special homemade syrup, is the perfect cocktail to enjoy with friends over pupu.

The Anzai's Banzai appears only at the OCC Christmas Party, but I hear its effects last until the New Year. Anzai, a long-time OCC bartender, kept handwritten recipes including that for the Banzai, in a small, black three-ring binder. While the whereabouts of this binder are currently unknown, the Anzai's Banzai recipe lives on in the minds of a few who carry the torch.

Whether you order up a classic or try something new, with or without alcohol, the Club's specialty drinks and extraordinary bartenders offer something for everyone.

Enjoy responsibly and `okole maluna!

If you're wondering what goes into these traditional Club favorites, our bartenders have shared the following recipes:



### Green Flash

1/2 oz. Lilikoi Syrup  
1 oz. Absolut Citron  
1/2 oz. Midori  
2 oz. Cranberry Juice  
1/2 oz. Sweet & Sour  
Lime Wheel  
*Build in a martini glass.  
Garnish with a lime wheel.*



### Rab Guild

1 1/4 oz. Vodka  
1 oz. Sweet & Sour  
1 oz. Simple Syrup  
Fresh Mint Leaves  
*Blend and serve in a double old fashioned glass. Garnish with mint sprig. For an Alice omit the Vodka.*



### Lilikoi Margarita

1 1/4 oz. Tequila  
3/4 oz. Triple Sec  
2 oz. Sweet & Sour  
1 oz. Lilikoi Syrup  
*Blend and serve in a double old fashioned glass with a salted rim. Garnish with a lime wheel.*



### Henry

1 1/4 oz. Vodka  
1 oz. Orange Juice  
1 oz. Passion Juice  
1 oz. Grenadine Syrup  
*Blend and serve in a double old fashioned glass.  
Garnish with an orchid. For a Henrietta omit the Vodka.*



### OCC Mai Tai

1 1/4 oz. Light Rum  
1 oz. Dark Rum  
1/2 oz. Orange Curacao  
1/2 oz. Simple Syrup  
1 oz. Lime Juice  
1 oz. Orgeat Syrup  
*Build in a double old fashioned glass.  
Garnish with pineapple and a spiked cherry.*

### Chinese Margarita

1 oz. Tequila  
1/2 oz. Triple Sec  
2 oz. Li Hing Syrup  
1 oz. Sweet & Sour  
Li Hing Powder  
*Blend and serve in a double old fashioned glass with a salted rim. Garnish with a lime wheel.*
