#### **NEW SITE PLANS**

Pursuant to the recent board decision to design a club facility without residence apartments at a cost within the financial capabilities of the club, the planning committee has met twice within the last two weeks with the architects for the purpose of revising the program and establishing a new time table. The desires of the membership, as determined by the recent survey, are expressed in the new program. The club shall have the qualities of openness, informality and gracious Hawaiian living and there shall be provision for considerable green belt areas. The accent of the club shall be on the ocean front. Every attempt will be made to provide parking for a minimum of 200 cars. Outdoor athletic facilities will be provided on the roof of the parking structure; however, as decided by the board, a swimming pool shall not be included in the plans.

The new time table is as follows:

September 30, 1962 Completion of preliminary drawings and authorization by the membership to proceed;

January 31, 1963 Completion of working drawings; February 28, 1963 Commencement of construction; and October 30, 1963 Completion of construction.

In order that the foregoing timetable be observed, the committee shall meet weekly with the architects and report its progress monthly to the board and the membership.
