The President's Letter

THE NEW LOOK

As announced in the last issue of the FORECAST, it has been decided by your Board of Directors to change the format of future issues. This is the first issue of the new FORECAST.

One reason for the change is that we found many of our members evidently did not have time to read all the articles contained in the previous sixteen page issue. For example, in almost every issue this year we have had an article covering progress with respect to the plans for our new club. Yet on numerous occasions your president and other directors have been approached by members who complained that they were not being kept up to date as to "what was going on with the new club." It is hoped that this issue of the FORECAST will be read in its entirety. Let me assure you that your Board of Directors wants to do everything possible to make the FORECAST informative and yet at the same time keep it as brief and readable as possible. ON THE NEW CLUB

Speaking of plans for the new club, you should by now have received a comprehensive report prepared by Cline Mann, Chairman of the Planning Committee on what has happened during the past year. As a member of the Steering Committee, I can honestly say that Chairman Cline and the other members of the committee have worked long and diligently with our architects to provide the best club possible for our members at the new site. Schematic drawings of the proposed facility are now on exhibit at the club and it is hoped that as many members as possible will take the opportunity to examine these plans. MEMBERSHIP MEETING

At the last meeting of your Board of Directors on December 21, it was decided to hold a general membership meeting to present the plans for the new club and to obtain comments regarding the development of our new site. In order to accommodate as many members as possible, this meeting will be held at the Princess Kaiulani meeting house. Tentatively, this meeting has been scheduled for Thursday, January 25. An official notice will be sent to you as soon as plans for the meeting are finalized.

WELCOME, ARTHUR JARL

You have probably read the article which appeared in our local newspapers announcing the change in the club's management to be effective on January 1, 1962. Arthur Jarl will replace genial Jake Tudor who has been with us for over three and a half years. Mr. Jarl, as many of you may know, was manager at the Oahu Country Club from 1950 to 1956. Leaving the Country Club for the hotel business, he took over as manager of the new Waikikian Hotel when it opened in 1957. Deciding he wanted to return to the Mainland, he joined the swank Bel Air Country Club in Los Angeles as manager during 1958-59. Again new fields beckoned and he went to work for the Presbyterian Church developing their retirement housing projects in La Jolla and other sections of California. Early in 1961 local financier Chinn Ho contracted for Mr. Jarl's services to do research on retirement housing projects in Hawaii and also to advise him on management problems in connection with the Ilikai development. Your Board of Directors feels the club is very fortunate to obtain Mr. Jarl's services at this particular time. It is anticipated that his knowledge and experience will be of considerable value to us in the development of our new club facilities.

Their service has been outstanding and their work these past two years in connection with our future plans has been invaluable. While they cannot sit on the board next year, it is strongly recommended that whoever the next president may be, he utilize the outstanding abilities and valuable experience of these two members.
