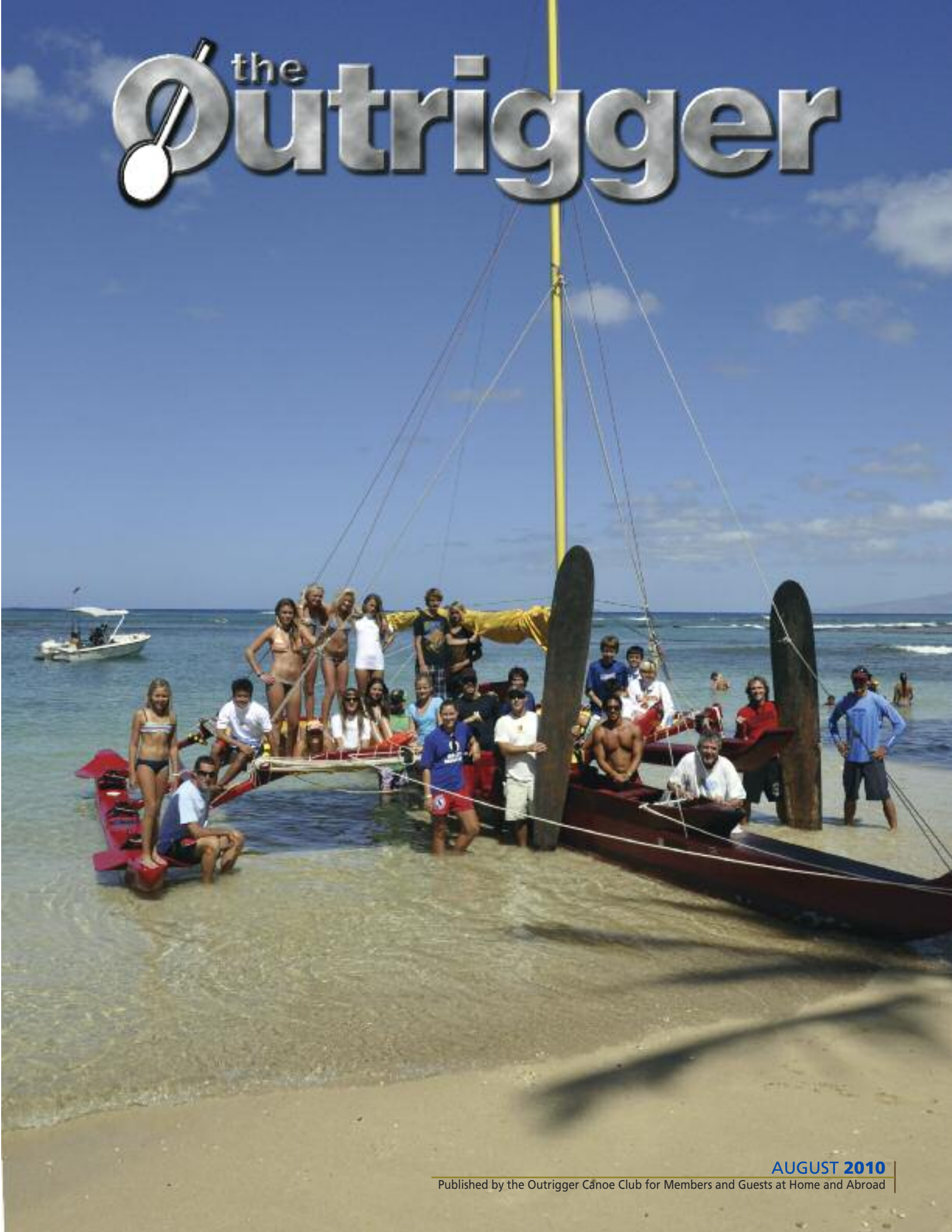

# Celebrating the 4th of July Outrigger Style

On July 4, 1910, less than two years after its founding, Outrigger Canoe Club held a party at its beach site in Waikiki, the first of many Independence Day sporting events which over the years have become the celebrated Walter J. Macfarlane Regatta, Hawaii's oldest annual canoe race.

Back in 1910 there were very few organized canoe racing clubs, let alone an Oahu or island-wide canoe racing organization, so OCC was pretty much limited to its own various crews racing against each other. To expand the number of events preceding the evening hoolaulea, a surfing contest was added to the agenda, and the crews of three naval vessels in port Honolulu at the time were invited to compete against each other in the canoe racing segment of the program. All three ships accepted the challenge: two U.S. Navy cruisers and a Belgian naval training ship. As reported next day in the *Pacific Commercial Advertiser*:

"The boys of the Belgian training ship L'Avenir navigated their outrigger canoe over the course and crossed the finish line winners yesterday afternoon, while the men from the United States cruisers *Cleveland* and *Chattanooga* allowed their crafts to swamp in the surf.... The men were all new at the game, but they made a great showing with the surf running high."

Fast-forward to July 4, 2010. The Canoe Racing Committee decided to celebrate the 100th anniversary of that first OCC 4th of July canoe race by inviting military crews to participate once again. This time, in honor of all our service men and women on this most special of days, crews composed of active duty personnel were invited from all five military services: Army, Navy, Air Force, Marines and Coast Guard.

Five OH CRA clubs 'adopted' these crews for the day: Outrigger, Hui Nalu, Lanikai, Kailua and Honolulu-Pearl, provided them canoes and paddles, gave them some quick coaching, and cheered them on as they pounded out through the surf, rounded the quarter-mile flags and headed for home in the last event of the day.

As in that first race 100 years ago, there were two huli, the Army and the Coast Guard went belly-up in the surf! The remaining three crews, however, cruised to the finish line in a virtual dead heat, with the Navy emerging victorious by a nose, followed closely by the Marines and the Air Force.

Outrigger hosted Marine Corps paddlers, and they were excited! They even made red team shirts to match Outrigger's colors. Though they finished second they were so thrilled to have caught some waves that it didn't matter. As a salute to these valiant men and women in uniform, Outrigger later hosted all five crews at the Club's post-race party.

Like the first race in 1910, there were memories made in the 2010 version of the Macfarlane as Lanikai edged Outrigger out for the regatta title.

For starters, we won a lot of races (and then some) - from the youth races to the senior masters. We won the prestigious Senior Men's race, watching Outrigger and Lanikai coming into the one mile inside turn manu-to-manu on the same wave, then witnessing Lanikai bury their flag and Outrigger go on to win the race with Karel Jr. catching a fantastic wave almost all the way in from the last turn.

The Senior Women's race came down to the wire with Outrigger, Kailua and Lanikai finishing together, all on the same wave, after paddling out through the waves and back in, and Outrigger placing second by a just a fraction of a second.

We celebrated unexpected wins from crews that haven't won all season and watched canoe after canoe battle the waves out and some fall off the waves on the way in. The Mixed 55s race was exciting, with five clubs catching the same wave in, and then suddenly one after another, three of them fell off the wave, lost control, rammed into the canoe next to them and huli-ed. Outrigger's crew was on the end and finished the race victorious! (It was even better because Malia Kamisugi steered them, which was perfect because the season is dedicated to Keanuenu Rochlen, one of the greatest wave steerswomen of them all.)

In the Women's Junior race, Billy Lawson steered his mom Laurie's crew to a huge victory! They were so far ahead that some of the other clubs hadn't even finished after they came on shore and ran up through the victory tunnel. Wow!

Kim Darling and Diane Esecson, who accepted the challenge to coordinate the 68th anniversary of the original Waikiki regatta, did an exceptional job, remaining 'cool, calm and collected,' throughout the day.

They created some great special events that we hope become a tradition. We started the morning with a Special 'Ohana race, where each club could enter two adults and three youth paddlers from the same family to compete. Mark Sandvold, who paddled in the race with his daughter Kiana (plus Karl Heyer IV and his son Karl V, and Will Gacutan and his daughter Malia), shared that this was a very special day for him. Not only did they win, but he was able to share this winning experience with his daughter - priceless.

And that's what the whole regatta is about... not so much winning or losing. So much comes down to your lane, the waves, and some luck, but at the end of the day, it's really about creating memories and stories that you can share for a lifetime, and celebrating the Fourth of July with good friends and family.

# Reciprocal Club *Review*

## Review #53 Features The Rainier Club, Seattle, Washington

Nestled in the heart of downtown Seattle on the corner of Fourth Avenue and Marion Street sits The Rainier Club. Founded in 1888 and named after British Admiral Peter Rainier, it was first housed in a 22 room Victorian mansion owned by James McNaught, which the original members, dubbed by the press as the "Dudes of The Rainier Club" rented for \$100 per month. At that time Washington did not recognize private clubs.

In June 1889 a great fire ravaged the city but the McNaught Mansion was spared and later became a hub for reconstruction efforts. In 1893 the Club relocated to the Seattle Theater and in 1899 when private clubs were recognized they reincorporated.

Eventually needing larger quarters, architects were hired to build what is now the current clubhouse which opened in September 1904 and with no expense spared including telephones in every room. In December 1986 the club was officially recognized as a historical landmark.

The entire fifth floor is devoted to the Health Club, which has a wide range of equipment including Cybex, free weights, Concept 11 Rowing, treadmills, lifecycles, Stairmasters, etc. The locker room includes standard amenities plus a dry sauna and laundry service. There's also personal training, yoga, massage, and nutritional counseling. The Health Club is open from 5 a.m.-9 p.m. Monday through Friday, and 6 a.m.-9 p.m. Saturday and Sunday.

The club has a business center with three private computer rooms with high speed internet, one quick-service laptop e-mail section, personal computers with LCD flat screens, and copy, scanning, printing and faxing services. The entire club is Wi-Fi accessible.

The club also has overnight accommodations in six suites. The suites offer room service during regular dining hours, continental breakfast on weekends, 24 hour concierge service, hair dryers, daily housekeeping, and daily newspaper. Overnight guests have complimentary use of the Health Club and Business Center facilities. Rates as of March were \$225/night for two people.

The Heritage Room on the third floor is open for breakfast, lunch and dinner Monday to Friday and features a private wine cellar with a vast array of Pacific Northwest wines as well as those from all over the world. Sixteen private dining rooms are also available. More relaxed dining can be found in the Fireside Lounge open from 11 a.m.-10 p.m. A lunch buffet is served from 11:45 a.m.-2 p.m. Monday to Friday.

A service charge of 20% is added to all food and beverage services, and guests are requested to pay for their dining with a credit card. Dress code is business casual in the dining room and all areas of the club except the Health Club. No denim, athletic shoes, or shorts are allowed unless going directly to the Health Club or an overnight suite.

The club has its own parking lot for a charge of \$13 per meal period and valet parking is available during regular meal hours. It's also \$13 for overnight accommodation parking.

Credit cards may be used for payment and the club requests that Letters of Introduction be e-mailed or faxes in advance.

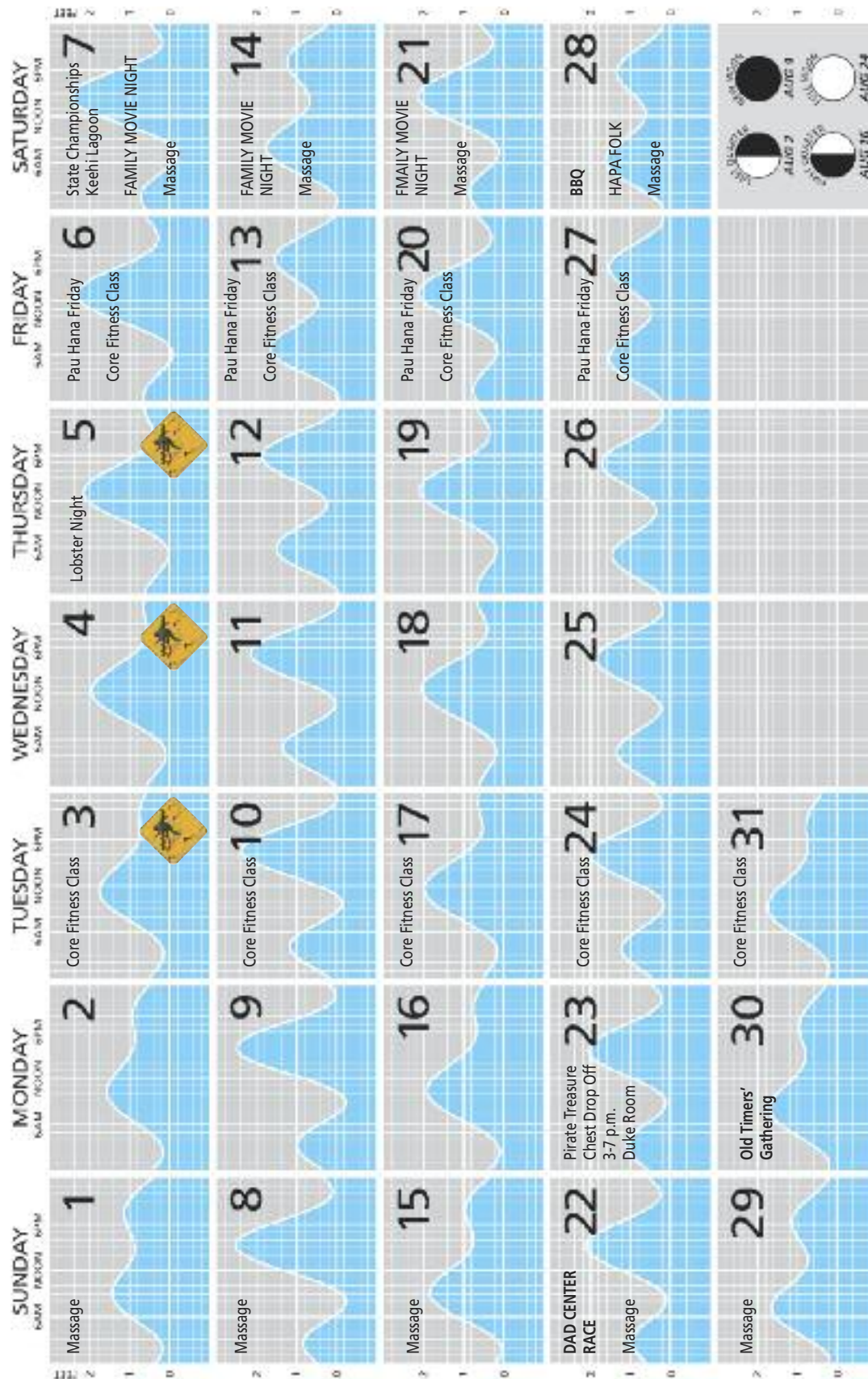

# Backward Glances

## 90 Years Ago 1920

### Peter Warren Dease, President

In 1920, two years after the death of owner James B. Castle, the Elks Club purchased the estate, one of the finest homes in Honolulu, from his widow for \$155,000.

## 55 Years Ago 1955

### Samuel M. Fuller

At the annual meeting on February 25, Leslie Hicks made a strong plea to purchase part of the Elks Club property as a sound business investment, whether or not the Outrigger relocated there. The following month, a vote authorized the Board to offer \$450,000 to purchase 77,000 square feet of Elks Club property. The offer was rejected and a counter offer of \$500,000 was made. Outrigger upped its offer, pending membership approval, only to have it countered with \$600,000.

Realizing the rapidly increasing value of the land, the Elks opted to lease, rather than to sell, the land.

## 50 Years Ago 1960

### James Ward Russell, Jr., President

A ground breaking ceremony was held at the Diamond Head site of the future Outrigger Canoe Club. President Ward Russell performed the ceremonial rite of shoveling dirt and Kahu Edward Keahi Kapoo blessed the land while Board and Club members solemnly observed. Construction of the new facility commenced shortly after.

Two committees were formed: New Building Finance Committee chaired by Tom Singlehurst, and New Site Building Committee, chaired by J. Cline Mann. A contract was signed with Hawaiian Dredging and Construction Company and Vladimir Ossipoff was authorized to proceed with designs for the new clubhouse.

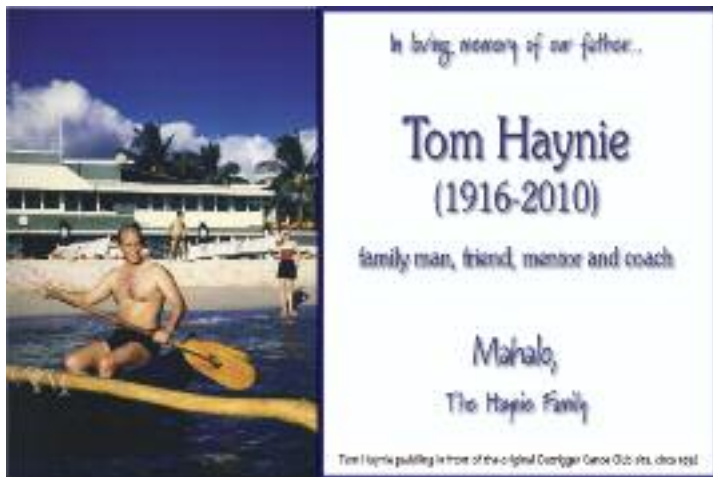

The B & G committee felt that periodic displays of the Club's Olympians in the Lobby display case or trophy case would be more appropriate.

**Trophy Case in Ka Moi Boathouse:** It was suggested by the Historical Committee that trophy cases be constructed in the Ka Moi Boathouse (louvered area) to house the Macfarlane and other trophies. The Building and Grounds Committee recommended rejection of this request which the Board approved. B&G felt that these trophies can be displayed periodically in the Lobby trophy case. The committee also felt that building a trophy case in the Ka Moi Boathouse would interfere with air circulation and would alter the design of the building.

**Finance Committee:** This committee reviewed the Club's insurance renewal proposals and D&O, Fiduciary and ERISA Bond policies and recommended that the Board approve both renewals and the new policies. The Board approved the recommendation.

**Exclusive Buy-Out of Koa Lanai:** In 2009, the Board authorized the KL to be reserved for private events when certain dollar minimums were met. The parameters by which this occurs are defined in the General Information and Catering Policies document which was approved by the House Committee in March 2010. Recently, a complaint was received by a member who wanted to have dinner in the Koa Lanai on an evening it was booked for an event. The Board revisited and re-affirmed the parameters

established as it relates to the exclusive use of the Koa Lanai as set forth in the existing General Information and Catering Policies document.

**ODKF:** On August 24, the first Annual Waterman's Hall of Fame will induct 10 inaugural members.


**Financial Statement:** There was Net Income from Clubhouse Operations of \$4,567 which is \$7,067 worse than budget, and year to date, net income of \$3,670 which is \$60,370 better than budget. Year to date, \$342,900 in initiation fees were collected and deposited in the Capital Improvement Fund. There was a combined Food & Beverage net income (with the mini-charge) of \$5,990 which is \$4,910 below budget.

**Projects in Progress:** Phase 2 of our Sewer Rehabilitation work is in the permitting phase. Spall repairs in the garage are underway. Lowell Barnhart & Brian Shuckburgh have completed the lighting project around the clubhouse.

**Athletics:** The Junior VB program is charging participants coaching fees and managing the disbursement of these fees through the member's personal banking accounts. The management of these funds is required to be handled through OCC's Business Office (Athletics-Volleyball), as is required for any OCC athletic team.

**Ala Wai Canal:** Parents are still concerned about their children practicing in the Ala Wai Canal. The Club needs to explore other options (alternate locations, launching from the Club's beach) for the youth crews to practice. To that end, the Building & Grounds Committee will be asked to look at the area (where coconut trees are located on the beach adjacent to Colony Surf) to devise a way that the racing canoes can be stored and launched from that area.

**Public Relations:** Athletic teams need to send any details/results to the magazine editor and the Executive Office so it can be published in the magazine and posted on the Club's website.
