

President's Message

We have just completed the first half of this calendar year at the Outrigger Canoe Club and I am pleased to report that your hardworking and devoted Board members and committees, along with the Manager and his staff, have accomplished new and exciting innovations for the coming months ahead.

1. Before long you will see remodeling taking place in the accounting office and lobby, which is being done to accommodate the new computer and components due for installation in August. The computerization of our bookkeeping system will result in a more efficient and effective method of accounting, benefitting both the membership and staff, as our accounts receivable will be on a timely and current basis.

Comptroller Barbara Annis will occupy the Manager's present office. General Manager Raymond Ludwig, his assistant Barbara Johnson, and our Junior Secretary Michelle Johnstone will move into the newly created executive suite, which is now the women's room off the lobby.

The telephone booth in the lobby will be eliminated to create more space in the Manager's office and a counter is to be constructed in the lobby to accommodate two new telephone outlets for your convenience.

2. Because of the extreme and rapidlyincreasing utility expenses, installation of a heat exchanger is presently underway and is expected to reduce our waterheating cost by 50 percent and pay for itself in less than two years' time.

3. The Board has given approval for working drawings to commence on the much needed kitchen expansion and renovation of the lower level purchasing/receiving/storage area. Work is expected to begin in the fall.

4. The new lockers you have been inwaiting for are here! 98 have been installed in the women's locker room and 186 in the men's. This should alleviate problems we have had in these areas.

5. The Junior Athletic Summer Pro-

gram (JASP) is flourishing under the able guidance of Jonathan Bintliff and his assistants. This popular program should prove to be a healthful and educational experience for all participants.

6. For interested members of all ages, we have instituted a FREE physical fitness course under the direction of Tawny Dennis. These sessions will begin the week of July 7 and continue for two months or longer, depending upon members' response and acceptance. Aerobics, isotonic or floor-work exercises, cool-down or yoga relaxation and body-fat testing before and after each session for each person will be available. Sign up NOW and get with it, if you haven't already done so.

7. All of our various athletic programs are underway and in full swing. The volleyball team participated in one tournament on the mainland and our canoe paddling team has established itself as the team to beat in the Oahu and State Championships on August 9 and 10 under new coach Walter Guild.

8. Our first social event of the year, the *Cinquo De Mayo* party, proved to be a huge success and a sell-out. It should set the pattern for all our socials thruout

Canoe Racing Arrives

If you haven't noticed from the canoes stacked on the beach and the activities of the paddling crews, it's Paddling Season!

The part of paddling that is visible to all of us is the activities of the crews training. You can find crews in training from 6:00 a.m. until the sun goes down. However, there is more to the OCC paddling program than the activities taking place daily on the beach.

This year's Canoe Committee members are Stu Brisette, Kimo Austin, Walt Guild, Hank Lass, Paula Carbone, Mike Mason, Bruce Ames, Bob Fisher, and Tom Connor.

On race day, members of the racing committee are at the Club before dawn, loading boats and other equipment required to put OCC paddlers in the water. The job is fun, but a lot of work.

In addition to the normal maintenance activities, the Club is continually experimenting with new methods to increase the performance of our boats, and to find new ways to preserve our irreplaceable Koa canoes.

When Wayne Faulkner constructed the OCC's new racing fiberglass canoe, the Iwa Lani, he included a bracing system that has proved so effective that it is being added to our Koa Fleet.

If you're not a paddling fan, it's because you haven't been going to the Regattas. It's difficult to try to relate the feel of a Regatta scene to those of you who haven't been to one. A Regatta consists of 27 events, which run from 9:00 in the morning until completed, usually at 3 or 4 in the afternoon. Each event will include from four to fourteen boats, depending on the interest that each club has devoted to the various events.

The enthusiasm which the younger paddlers enjoy for the sport has, in many cases, spilled over into the rest of the family, who will come out and make it a family event.

The 1979 canoe season was one of stiff competition between OCC and Hui Nalu Canoe Club for the State Championship. As you can see from the results of the first 5 regattas, things have not changed much. This year's action has been fast and furious, with stellar performances from all participants. The season started with a bang on June 8th at Kailua Beach Park, when OCC outdistanced all other participants in the Kamehameha Day Regatta with a total score of 77 points. OCC's closest rival was Hui Nalu with a score of 51.

The OCC paddlers showed balanced strength with the following crews winning their events: Boys 12A, Girls 13 Under, Boys 13 Under, Boys 14 Under, Women Novice A, Men 18 Under, Freshmen Men, Junior Men, Open Four, Senior Men.

The Freshmen Men were very impressive and showed to all that they will be a crew to be reckoned with this season.

The Junior Men came through as expected. This crew has a lot of pressure on it, as Head Coach Walt Guild counts on them as a sure win each week.

The Open Four is truly a crew to behold. At first glance, you think you are looking at the Senior Men's crew, less two, and in fact five of the six members who rotate in and out of the boat are previous Senior paddlers. If Kailua is any indication, we'll see a lot of gold out of this Crew this season.

As always, the premier race of any regatta is the Senior Men's race. At Kailua, OCC's Senior crew swept the field and served notice to all that they are the premier crew.

The second regatta was the Leeward Kai Regatta, held at the Nanakuli Beach Park on June 16th. OCC continued their winning ways, scoring 83 points. Hui Nalu was second again with 55 points.

The winning crews at Nanakuli were: Boys 12A, Girls 17 Under, Women Novice A, Freshmen Men, Junior Women, Junior Men.

The third regatta of the year was the George K. "Pop" Waialealea Regatta, held at the Waimanalo Beach Park on June 22nd.

The ocean cooperated by providing some of the best conditions that paddlers have encountered there in several years. I'm sure the people who were caught in the two-hour traffic jam didn't appreciate it, but it was a great day. Particularly great for OCC, as they won the regatta, scoring 67 points to Hui Nalu's 63 points for second place.

OCC's winning crews were: Girls 13 Under, Boys 14 Under, Women Novice A, Freshmen Men, Senior Men, Women's Masters.

As you can see from the results of the first three regattas. Hui Nalu appears to be creeping up. Normally this wouldn't bother a stout-hearted OCC paddler, however the next two regattas were scheduled at Waikiki Beach. Fred Hemmings and company are noted for their performance in the surf at Waikiki.

For those of you who have not witnessed a surf race, the draw of the lanes can be all important, depending on surf conditions. The course is laid out perpendicular to the beach with canoes starting from the beach area, out through the surf to a set of flags a quarter and a half mile out. Depending on the length of the race, the canoes will turn on the appropriate flag and race back to the beach.

However, if the surf is too big and unpredictable, as it was this year on July 4th, it's not so much the luck of the lane draw, but the luck of that lane's conditions during the race.

The first of the surf races, the John D. Kaupiko Regatta, sponsored by Hui Nalu Canoe Club, was held on June 29th. Hui Nalu had an incredible day.

At the end of the regatta, they had amassed 95 points. Hui Nalu's closest rival was OCC, which was second with 45 points. OCC's winning crews were: Girls 15 Under, Women Novice A.

The water was relatively flat and Hui Nalu had predominately the first three lanes. However, this doesn't explain away Hui Nalu's 95 points. Hui Nalu had a great day. For our paddlers, it was one of those days when we didn't do anything really bad, but nothing seemed to work right.

The Walter J. MacFarland Regatta was held on July 4th at Waikiki Beach.

As you all know, the Walter J Mac-Farland Regatta is sponsored by OCC, and as the sponsoring club, due to the high surf conditions, OCC, with the approval of the OHCRCA officials, opted to allow any club which so desired to use fiberglass canoes instead of taking a chance on destroying any of the irreplaceable Koa canoes.

Waikiki Surf Club, the only club that opted to use its Koa Canoe, had to withdraw in the later stages of the regatta, when the canoe was split as it swamped on a wave.

Unfortunately for OCC, Hui Nalu's crews had most of the fun. Hui Nalu won the regatta with 86 points to 62 for OCC's second place finish. OCC's winning crews were: Boys 13 Under, Girls 15 Under, Women 17 Under, Men 18 Under Freshmen Men, Sophomore Men, Junior Men, Women's Masters.

If you only had the results of the first 5 regattas to go by, it would appear that OCC is on the ropes and that Hui Nalu has received a shipment of strength and is approaching invincibility.

This was evident at the Makaha Regatta where Hui Nalu outpaced OCC by only one point under good water conditions, and finally in the Oahu Championships where Hui Nalu assembled their best effort by blitzing all Clubs by scoring over 90 points and holding OCC to Second Place.

At this point Coach Guild has seen everything go wrong that could go wrong and is currently mounting a tremendous offensive effort to bring home the State Championships to OCC.

Manager's Message

Due to violations of the following sections of the bylaws concerning illegal use of the club, I must remind you:

Excerpt from Section 31, Guests and Restrictions Thereon:

"No guest shall visit the club more than two days in any one month without written approval of the general manager provided, however, that this limitation shall not apply to spouses of members or ladies and gentlemen of single men and women members, respectively. All guests shall be registered upon entering the club premises and, except for spouses of members holding valid "Special Guest Cards," shall be accompanied by their hosts and shall not incur any indebtedness to the club."

Section 52, Payment of Indebtedness: Dues, assessments and other debts shall be due and payable upon the first day of each month at the office of the club and shall become delinquent if unpaid by the fifteenth of the following month. If unpaid by that date the delinquent amount shall be posted with the name of the member owing same on club bulletin board and no further credit shall be extended to such delinquent member.

Section 52, Penalty for Delinquency and Credit Limit:

Any delinquent indebtedness at the end of each month shall be increased by a penalty of 5 percent and shall cause an automatic suspension of all club privileges of the member owing same. The board may establish terms for repayment and may limit the credit of any member.

To your Health by Sharon J. Bintliff, M.D.

Surveys affirm that which all of us acknowledge, that our family is the most important element of our life. I have just returned from an exciting and enlightening experience as one of twelve Hawaii delegates to the White House Conference on Families, and I would like to share it with my Outrigger family.

The White House Conference on Families was called by President Carter to "examine the strengths of American families, the difficulties they face, and the ways in which family life is affected by public policies." The Conference was held regionally with a meeting of Eastern States in Baltimore on June 5-7; a second meeting for the Midwest at Minneapolis June 19-21, and a Western-Pacific regional meeting in Los Angeles July 10-12.

The history of such White House Conferences date back to the First White House Conference on Children and Youth called by President Teddy Roosevelt in 1910. From this, and follow-up conferences every 10 years, have come some astounding accomplishments, landmark legislation and practices for our children and youth. Now that we've completed a similar conference for the '80s, what will come of this \$3 million affair (that's right, \$3 million of our hard earned tax dollars). By design the conference cannot solve or decide anything, but it can and did identify areas of concern, and in that sense the conference will help the President. Congress and others to set our national agenda with respect to families

Interestingly, the conference refused to define the family. Oh, there were some conservatives there who pushed for a very concrete definition; to define the family as "two or more persons related by blood, heterosexual marriage, adoption, or extended family." The term traditional family continued to be banted about, but faded in the wake of a recent statistic: that the traditional American family of a father working, a mother at home and 2.5

children represents only 8% of current USA families. No wonder many experts are voicing concern that the American family is disintegrating. This kind of concern was instrumental in changing the focus of White House Conferences from Children and Youth to the Family. The most acknowledged fact in Los Angeles was that the family is not disintegrating but is definitely changing; and it's the systems, public and private, that do or don't support it that are disintegrating. And in response to this fact came the following recommendations from the Los Angeles conference:

• Increase parental involvement in educational planning.

· Adequately fund those programs and laws already on the books for improved services for the disability community.

· Change laws to eliminate the existing "marriage penalty" tax that makes it more expensive for a couple to be married than to live together unmarried.

• Establishment of work policies in business and government that would allow for flexible leave, job-sharing and other policies to encourage family unity.

 Tax deductions for families who care for their elderly or infirm rather than institutionalize them.

 Drug and alcohol abuse education and prevention programs and the media responsibility to cease from glamorizing these practices.

I know you are dying to know what came of ERA and the abortion issue. They remained very controversial, occupied much time and energy from the delegates, and were the breeding ground for a couple of walkouts staged to get media attention. And although neither was in the top 15 recommendations, both resolutions were approved by the conference with a 60% or better majority.

Now, what is the punchline of all this rhetoric? It appears to me that the family is working overtime to survive; and it has to, because it has little support from its institutions, those of the gov-

ernment, church and business. I care less how "they" define family as long as its function is understood. The family continues to be the single most important influence, with the absolute vital task of shaping the next generation. The family most powerfully maximizes development of the children and shapes their values. At the same time, it is the family that is the critical unit of action in enhancing the quality of life for all its members.

My last column was about foodthis one is about food for thought!
