# A Message from the President

I realize this first message to you as your President is long overdue. Nevertheless, I am happy to report that your Board of Directors has been functioning and performing in splendid fashion. Chairpersons and members of the various committees have also been hard at it, as can be attested to by the results of all of our activities so far this year.

1976 began with interest in an offsite tennis and athletic complex of 90,000 square feet on the ocean at Wailupe. After much deliberation on the location and considering the negative results of a poll of the voting membership, we did not pursue the matter any further. Interest immediately turned to another site located on Kailua beach, covering approximately 41/2 acres of improved property. At this point, we decided that the possibility of purchasing our present Club site should be determined first and foremost before looking elsewhere for additional facilities. Accordingly, a professional MAI appraisal was ordered on our present site, and we are currently in the process of communicating with the Elks Lodge next door. I am mindful that should our efforts prove fruitful, any proposal would be subject to presentation to the full membership and approval by a majority of our voting members. In this regard, a "State of the Club" message will be forthcoming to you under separate cover which will explain our thoughts in greater detail.

Special ad hoc committees composed of various Directors have been involved in such matters as workmen's compensation insurance, Directors' liability insurance, bylaws changes, employee retirement policy, Diamond Head Master Plan, accounting system, and the like. Needless to say, all require a great deal of time and effort on the part of the individuals concerned.

A review was made of the records of members classified as inactive, a total of 573 at the beginning of the year. Those not qualifying for inactive status as mainland full-time students, financial hardship cases or

the ill were advised that two alternatives were available: either to transfer to non-resident membership or resign if use of the Club was no longer contemplated. Our total number of inactives now stands at about 290, and we have not yet completed our undertaking.

A few projects currently underway or completed include re-roofing the entire Club, replacement of the beach stand, shoring up support columns in the garage area, and repair of the old Wichman clock. Most of you oldtimers will remember the clock at the old Club in its stately location in front of the Hau Terrace near the sunbathing area. A few of vou real oldtimers will remember the clock at the old, old Club where it stood near the end of the wooden boardwalk on the beach. We plan to install it in a similar suitable location on the Club premises. Shades of vestervear!

I would remind all of you that monthly statements of the Club's financial position, including all expenditure data, are available in the business office for your review. You are invited to examine our monthly or year-to-date expenses or any other financial transactions. Should you have any questions, I would be happy to answer you personally.

They are to be commended for their excellence in the sport for which the Club was founded.

At the September Board meeting your Directors approved the annual Employees Christmas Fund. Our employees deserve much more than you may realize. Their sincere dedication and loyalty has made this Club one of the finest in the world. I, therefore, urge you to be generous in keeping with the Christmas spirit.

# Three Place in Surfboard Race

One of Hawaii's most revered and demanding forms of water sport has a new and very challenging event. Saturday, October 23rd, saw the first running of a new paddle and surfboard race from Kailua Beach Park around Makapuu Point to Hawaii Kai's Koko Marina Pier, a distance of approximately 15 miles.

Outrigger, long an active participant in the sport and recent sponsor of the Christmas Day classic from our beach around Diamond Head Buoy and back, was well represented in this opener.

Paddling the course, which covers about every conceivable water con-

dition Hawaii can come up with, from the chop off Waimanalo, the currents and backwash of the Makapuu/Sandy Beach stretch to relatively calm waters off Portlock, were Bret Goodfriend and Dale Hope on paddle boards and Pua Rochlen, Pau Scully and Paul Manaut on regular surfboards. Bret was in second (3 hours, 12 minutes, 12 seconds) and Dale in third (3 hours, 22 minutes, 31 seconds) on the paddle boards, following winner Kiki Spangler (3 hours, 6 minutes, 31 seconds). Winner of the surfboard division was Pua Rochlen (3 hours, 45 minutes, 53 seconds).

# It's A Hobie World

A special luster, an international ambience enveloped our Club during the first Hobie 16 World Championship Regatta early last month to enhance OCC's image as a world center of water sports.

And the event was a smashing success.

As host Club for races which attracted more than 100 aspirants—representing 17 foreign countries, several Mainland states as well as Hawaii—we offered the warm hospitality of staff and members, attentive cooperation and assistance and near-perfect physical facilities for the six-day event. Counting families, friends and just interested spectators there were more than 400 visitors during race week.

The weather cooperated too, providing the full range of sailing conditions.

And Hawaii skippers sailed off with six of the top ten honors in the big, first world regatta. Our Club standard-bearer was commodore and sailing committee chairman, Hal Hutchings. He took third place in the winners circle.

"The competition was intense, the conditions totally unforgiving and the laurels well-earned," wrote Beth Parker, Hobie Cat Association publicist and editor, in her final release. "The challenge is on. The first champions won in their own territory and will have to fight to keep the title in all conditions across the sailing world. But for now, it's pau and as one of the winners said, 'when the world comes to your neighborhood you can't let them steal the pie from your own backyard.'"

For the record, here are the statistics: There were 52 skippers and crews for the two-man boats prequalified for the event from previous regatta competitions. An additional 77 entered the first two days of pre-

qualifying races; of these, 32 were selected for a final total of 84 officially entered in competition. These sailed six races each over three days, alternating races and changing boats; there were four races daily. Finally, the top half—42—raced the final two races, Sat., Nov. 6. Winning positions were then computed on the basis of seven of the eight official races each skipper and crew had sailed.

The top ten were: Dean Froome & John Driscoll, Kailua and Lanikai; Jeff Canepa & Richard Loufek, Capitola and Newport Beach, Calif.; Harold Hutchings & Howard Lynn, Honolulu; Jerry King & Pat Love, Newport Beach and Honolulu; Rick Naish & Jeff Faulkner, Kailua and Kahaluu; Keith Baxter & Mike Malek, Kaneohe: Danny Gale & Doug Polsey, Honolulu; Herb Andresen & Albin Lemquist, Kailua and Kaneohe; Geoff Horsley & Bob Forbes, Sydney, Australia; and Bill Sykes & Lyn Kreibig, Sydney and Canberra, Australia.

Sponsors were the Irvine, Calif.based National Hobie Class Association and the Hawaii HCA.

Milling about on the Hau Terrace were Hobie Alter (creator of the craft) and his two sons (all were competitors); Doug Campbell, president of Coast Catamaran, manufacturers of the craft; Sandy Banks, overall chairman; and Bob Brown, Coast Cat's public relations director. Club manager Norm Reide was wreathed in smiles; the Club was busy. Sailing committeeman and event chairman for the Club, Dave Hoffman, helped keep everything smoothly coordinated among the various official participating organizations.

Commodore Hutchings was especially pleased over the stimulation and excitement offered non-sailing and sailing members, especially the youngsters—P.J. Wheelon, Todd Bradley and Don Machado, for example—some of whom got a chance to participate.

Beach captain Wayne Faulkner and his staff, Kip Kennedy and Fred Frizzell, did yeoman service during the week. Visitors, official and otherwise, were generous with their appreciation and compliments.

Bob Brown put it straight: "Nowhere else in the world," he said, "have we ever held an international, national or regional Hobie regatta in a better location. This is beautiful."

# **Boats Off The Beach**

Effective January 1, 1977, Club members who park their sailboats on the OCC beach or leave their power boats anchored in the OCC swimming lagoon overnight will be fined \$5.00 per day, unless they receive permission from the Manager. This action was taken by the Board of Directors in response to the many serious problems caused by boats on the beach. Among these are the loss of beach space by the general membership and by those who live in the area, hazards to children, and violation of an agreement with the State Harbors Division.

The Board is concerned that most of the membership opposes sailboat storage on the beach because it takes up valuable beach space and feels its action is in the interests of the great majority. In addition, the OCC and the State Harbors Division have an agreement that only sailboats will be moored in the lagoon. The one exception to this rule is the

Club rescue boat. Violations of our agreement with the State will jeopardize our continued use of the lagoon for mooring small sailing craft. Furthermore, the State Harbors Division and Land and Natural Resources Departments object to boats being stored on a public beach.

Under the new rule, boats may still be brought from the lagoon mooring to be rigged on the beach, and members are still allowed to come into the lagoon during the day with their power boats to moor and have lunch. Storage is the primary problem and the fine applies when craft are left overnight. Stainless steel mooring clips are available from the Manager for boat owners who have none.

Other rules and regulations regarding boats are available for boat owners and for all Club members to read. They are incorporated in the "Rules and Regulations" for the Club posted on the Bulletin Board in the lobby. Additional copies can be obtained from the Manager.


# From the Building and Grounds Committee
