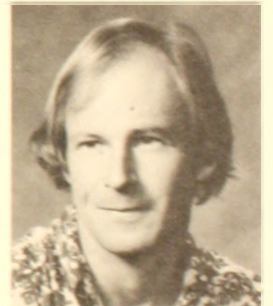

The 1975 Annual Membership Meeting

On Monday, February twenty-fourth, our Club moved into its sixty-eighth year of active life with a well-attended Annual Membership Meeting held at our Diamond Head clubhouse.

Following the opening formalities, Chairman Joseph B. Stickney of the Judges of Election Committee reported

that a total of 880 valid votes for Club Directors had been cast; 150 more than at last year's election and 31 more than the previous all-time high of 849 cast in 1972.

He then announced that the seven Candidates elected or re-elected to serve our Club as Directors for the next two years are: Stanley J. Beard-

more; William C. Capp; Robert Alexander Anderson; William J. Eggers III; Roy C. Kesner, Jr., Frederick M. Hemmings, Jr., and Ronald G. Sorrell.

Reports of Officers and Committee Chairmen

The President's Report

Another year has passed, and many things have happened at the Outrigger Canoe Club. Not all of them have been considered good, but I would like to leave this office believing that there have been more good things than bad.

Already in the records are the reports from your Secretary, your Treasurer, and the various committee chairmen; and you should be fully aware of the tremendous amount of time spent by these committees helping to

plan and organize all of your Club's memberships, facilities, operations, and activities. I would like to express my thanks and appreciation to the committee chairmen and to all of the members of their committees.

From the Treasurer's report it is evident that your Club is in a healthy financial position, and the budget for this year appears realistic. Because of the increased cost of food and services, we have had modest increases in our food and beverage prices; but, so far, it has not been necessary to raise dues.

During 1974—as was reported in the Building and Grounds Committee report—we completed a few major improvements to our Club. Of prime interest was the replacement of our bar, which was necessitated because of the tremendous termite damage to the original bar. After careful analysis by the architect, the Building and Grounds Committee, the management, and the Board of Directors, it was determined that the original location of the bar itself was still the most functional location from which to provide the best service to all areas of the Club.

Nineteen-seventy-four was another outstanding year for the Outrigger Canoe Club in our athletic programs. There were many outstanding achievements, membership participation was excellent, and Club athletes brought increased favorable recognition to our Club. The Annual Awards Banquet earlier this month was well attended and was a tremendous success.

At this time, I would like to express my sincere thanks and appreciation to our General Manager, Norm Riede, for his dedicated efforts at all times. I would also like to congratulate him on being elected President of the local chapter of THE CLUB MANAGERS ASSOCIATION OF AMERICA. Also, many thanks to Age, Ray, Vickie, Charlie, Teri, Anzai, Eddie, Wayne, and all of the other fine employees who help make the Outrigger Canoe Club one of the finest private clubs in the world.

In closing, I wish to express my deepest appreciation to the members of the Board for their cooperation and help during this past year. It has been a tremendous honor to be the President of the Outrigger Canoe Club, and I want to thank all of you for this opportunity to serve.

Secretary's Report

William J. Eggers III, Secretary

Immediately following the 1974 annual membership meeting, the Board of Directors met in the Board room and elected Officers and appointed coordinating Directors to the standing committees.

The Board held 12 regular meetings and one additional budget session. The Executive Committee met regularly 12 times during the year. A quorum was present at each of these meetings.

Several ad hoc committees were appointed: Mooring Insurance, Investment, Membership Handbook. The ad hoc committees regularly reported their recommendations to the Board, which took appropriate action.

During the course of the year, your Secretary has also engaged in extensive correspondence as directed by the Board and the dictates of necessity.

Your Secretary's attention this year was devoted to membership delinquencies. The system of suspensions and terminations because of nonpayment of bills was improved upon. Letters were sent to a number of members suspending or terminating their memberships. The Board instituted a firm but fair policy regarding outstanding debts so as to insure the Club's monthly fiscal integrity. The present cost of goods and labor combined with present day inflation requires that the Club maintain a stable monthly cash flow.

Treasurer's Report

The year 1974 was one of severe economic pressures, as most of you are well aware. The Club too was plagued with ever rising costs of utilities, food, wages, and just about everything involved with doing business. Despite all of these negative factors, however, we managed, as usual, to come out of all this in splendid fashion.

The food and beverage operation which is extremely sensitive to rising costs showed an overall profit of \$54,200, down only \$8,000 from the previous year. The Club's total income, consisting mostly of dues, food and beverage sales and initiation fees, amounted to a staggering \$1,904,500, up a remarkable \$193,000 over last year; and again, the largest volume ever generated in the Club's history. Last year I predicted that we would reach the 2 million mark in 1975. I am still confident that we will.

What effect does this amount of revenue have on a club like ours? Advantageously, through sound management, it ensures profitability from operations, which may be used to defray our general and administrative expenses or be set aside for major capital improvements. Adversely, however, it places an extremely heavy burden on our office accounting and clerical personnel. We have a mechanized billing system, that is true. However, there is a manual intervention between all of our revenue chits and our computer application. I can tell you from first hand experience that despite the ever increasing volume, our Office Manager, Mr. Charles Hee and the office staff have been performing in a truly outstanding and faithful manner. We should all be grateful for their dedication.

Let me turn to the Club's net income and cash generated for the year 1974. We produced a net income of \$99,200 after depreciation expense of \$55,200 or a total funds generated of \$154,400. The major contributors to this amount are as follows:

In analyzing the \$154,400, everything is in proper order. The initiation fees remained intact and available for future club expansion or other major capital improvements; food and beverage net income indicated a profitable operation despite the ever rising costs of last year; and dues and miscellaneous income from operations were on the plus side.

During the past year we increased our invested cash to \$311,300 and placed it to the highest and best use. As a result of the Financial Committee's efforts, our investments earned \$31,109 during the past year, or an outstanding average yield of 10 percent.

Additional statistics which may be of interest to you are as follows:

- (1) Members equity or the net worth of the Club totalled an all time high of \$1,489,000, or an increase of \$99,000 over last year. Our assets also hit an all time high of \$1,811,170, while

our liabilities were only \$322,000, reflecting an exceptional 5.6 to 1 ratio.

(2) It is of note that during the year we reduced the mortgage on our physical plant by \$39,000. The balance now stands at \$181,700 and will be completely paid off in 1977.

In conclusion let me say that the excellent financial results of operations for the year 1974 are again attributable to our Club Manager, Mr. Norman Riede, and the devoted staff who assist him. We are extremely fortunate to have a man with his expertise as our General Manager.

Admissions and Membership Committee

The Admissions and Membership Committee held twenty-six regular meetings during calendar year 1974. We reviewed the qualifications of prospective members, with both sponsor and candidate interviews.

The Admissions Committee recommended for membership (or changes in classification) in each major category the following additions:

Considering deaths, resignations and other deductions, we netted an addition this year of 67 members in all categories.

Various recommendations made by last year's committee to the Board of Directors were submitted to the membership and approved at the last annual meeting. These governed our activities during 1974.

Additionally, this year's committee made recommendations to the Board concerning such matters as initiation fees, which were duly approved by the Board.

The Committee this year was composed of Marian Wyman, Guy Harrison, John Beaumont, Jay Pease, Jon Sutherland and myself. Our coordinating director was Pat O'Connor.

Building and Grounds Committee

Archibald A. Carswell, Chairman

This year for the Building and Grounds Committee has been challenging and rewarding in many ways and I feel much progress was made. However, it has also been a particularly difficult period in which to accomplish our projects within reasonable budgets, due to the inflation of all materials and labor costs. We believe we have done the best job possible within the limits of our budget to beautify and maintain the premises and satisfy the majority of our membership.

The following projects were completed under the auspices of the Building and Grounds Committee during 1974:

- Renovation of entrance to dining room with new service area.
- New Hau Terrace Stand.
- New bar in same location as old one.
- Refurbishing of the women's room off the lobby.
- Repair of sidewalks in front of our property on Kalakaua Avenue. (The Public Works Dept. of the City did this work.)

Time and effort were expended on design and plans for an addition to the parking garage, but when proposals from contractors were received they were so much over our budget that this project was postponed indefinitely.

Since parking space is at such a premium for our Club, the Committee has been considering all possible ways of alleviating this situation. Studies are continuing on the possibility of locating a suitable off-site building for a storage and maintenance work area. This would free space for more parking at the Club.

Estimates were obtained for water proofing garage slabs.

Ground nesting termites continue to be a major problem in the Club. Work is now proceeding for treating the entire Club, including all planting areas.

A continuing program of painting throughout the building, additional landscaping, and replacing of plants and foliage are all necessary to main-

tain the Club in first class condition.

For their cooperation and help during this busy year I wish to thank Norm Riede, Manager, Robert W. Guild, Coordinating Director, and the Engineering Sub-committee, Ted Bean, Vic Larsen, Richard Libbey, and Keith Wallace.

My thanks and appreciation are also extended to our committee members: George Brangier, John Farmer, Jay Harden, Charles Heitzman, Paul McLaughlin, Roswell Towill and Robert Vierra. Their loyal and constant help throughout the year was invaluable to me.

House Committee

William C. Capp, Chairman

During the calendar year 1974, your House Committee, with the cooperation of the General Manager, analyzed areas requiring particular attention.

Our prime concern was directed to the spiraling increase in wages, food, beverages, and practically all items necessary to keep the Club operating.

Every effort was made to maintain the desired quality in food and service at a high level with a minimal price increase to the membership.

Emphasis was also directed to the following subjects:

1. Improvement in food and beverage service on the Hau Terrace.
2. Amendments to the House Rules.
3. Increased utilization of parking areas.
4. New parking decals for 1975.
5. Monitoring of menus, along with food and beverage controls.
6. Long range planning projects.
7. Surveillance of our guest policy and procedures.

The duties and responsibilities of the House and the Buildings and Grounds Committees parallel each other in many ways. It has accordingly been the practice for the chairmen of these committees to attend each other's meetings. Thus duplication of time and effort is minimized and proper coordination attained.

Club Captain's Report

The 1974 Club-sponsored Athletic Program consisted of ten general categories and included a wide range of membership participation. This year marked many outstanding performances by the Club teams. Also noted was the increasing interest shown by our Lady members. Following is a brief summary of the activities.

The Club canoe paddlers were strong contenders in all the major regattas. One of this year's highlights was winning the Walter Macfarlane races which are held in the surf in front of the old Club. The Outrigger finished second in both the Oahu and State Championships. Five crews won State championships: the girls 15 and 17; the boys 18, and the Junior and Senior Men. In the distance races, the men won the Duke Kahanamoku race, while the women paddled to victory in the inaugural Dad Center event. The Outrigger paddlers did an outstanding job in the Molokai to Oahu Race, finishing 2nd in their class and 3rd overall.

The Junior Athletic Sports program was presented with a little different format, which concentrated on teaching advance skills in volleyball.

The Outrigger was represented in the Hobie Cat Nationals and the Hobie Cat World Regatta held in Tahiti. The Club crowned champions in the Hobie Cat class and also in the Scorpion divisions. In addition to the Club events, two successful invitational regattas were held in front of the Club premises.

Surfing experienced a very active year, primarily on an intra-club basis. In addition to the regular surfing events, a paddle board race and a canoe surfing event were held. Club championships were awarded in six divisions: Keiki, Boys, Junior Men, Senior Men, Makule, Women, and Tandem. Outrigger entries captured the open stock and Malibu divisions in the Diamond Head paddle board races.

Club teams again dominated the State Volleyball picture this year, winning all the major doubles and six-man tournaments, both indoors and in the sand. The Outrigger Open

Team won the Haile Tournament for the sixteenth consecutive year. A variety of Club tournaments were played during the summer months, including the following Club championships: Junior, Junior-Senior, Women, Senior, and Kane-Wahine. The Outrigger was represented by the Open Six Man and Master's team in the AAU and USVBA Championships. Both of these teams placed 3rd in their respective divisions of the Volleyball Nationals.

One of the newer activities gaining interest among both female and male members is running. Many 1,000-mile certificates were awarded this year. The Club Running Team recaptured their title in the 1974 Olympic Club Marathon.

The Outrigger Mountainball Team added another championship by winning the Surveyors Mountainball League. Interest in the Women's Softball Team continues to increase. Two golf tournaments for members were enjoyed by those who participated. Tennis continued as a popular activity, but no championships were held due to the lack of playing facilities.
