Outrigger wins Five Firsts in Macfarlane Regatta, loses Meet to Healani on Points

Outrigger paddlers covered themselves with glory in the tradition-hallowed July Fourth Regatta at Waikiki Beach, winning the blue ribbon Senior Men's 2½-mile event; the Boys—12 "A"; Men's Novice, "B"; Boys—14, and Women's Junior, besides taking two second places and three thirds. The strong Healani Club, however, also scored five firsts and enough additional points in second and third places to outscore Outrigger, 56 to 44.

The Regatta, Blow by Blow by Jerry Ober

The meet started with what looked like a win for Outrigger's Boys — 12 "B" crew, but the race was called back on some technicality and on the later re-run, our crew had to settle for a strong second. Our Boys — 12 "A" crew came through in style, however, winning their event easily for Outrigger's initial first in the meet.

Our Men Novice "B" crew scored Outrigger's second win of the day. Then came a commanding first place by the Boys — 14 crew. followed by the Junior Women's crew, winners of their event.

The really big event of the regatta, for our Club at least, came when our Senior Men took a commanding lead in the first half mile of their 2½-mile grind and never relinquished it. Fittingly, champagne was quaffed from the Matson Trophy Cup to celebrate its return "home" to the Outrigger.

The Canoeing Season

In the first race meet of the season, held in the waters off Kailua Beach Park in June, Outrigger crews performed well but with the exception of the strong Boys — 12 "A" crew, which scored a win, had to settle for seconds, thirds and also-rans to finish well behind the Healani powerhouse on points.

An interesting sidelight on the season to date has been the emergence of several friendly father-and-son rivalries. There's the case of Henry Ayau and his son, Patrick, for example. Patrick is a member of the so-far twice victorious Boys — 12 "A" crew, while Henry paddles on theto-date-less successful Junior Men's crew. Then there's Ted Crane and Howard Bugbee, both of whom paddle on the Men Novice "B" crew while their sons paddle on the Boys — 12 "A" crew. In the Kailua Beach regatta, the Junior Men lost while the boys won, but in the more important Macfarlane regatta, both crews won. There are a few other similar situations, all of them holding out real promise for the future of canoe racing by Outrigger crews.

One group of Clubmen who are deserving of honorable mention is the full-time canoe paddling coaching staff. Included in this group are Bill Burso, who trains the younger boys' crews; Brant Ackerman, who handles both Novice Men and Freshmen crews; Al Lemes, coaching the

Juniors and Seniors, and Mike Holmes, who has the enviable task of coaching the wahine crews. Finally, there is Bill Cook who has come up with an efficiently organized regatta food and beverage program. Mahalo and "well done" to all!

1973 Volleyball wrap-up

Late in June the Club's volleyball team headed east to compete in the AAU National Championships in St. Paul, Minnesota and the U.S.V.B.A. National Championships in Duluth, Minnesota.

Only 16 teams were entered in the single-elimination A.A.U. tournament, and our team, after advancing to the semi-finals, lost to the Kenneth Allan team of Chicago by scores of 10-15 and 14-16. This meant that OCC had to defeat the Columbus Caps for third place in the meet, which they did handily by scores of 15-10 and 15-9.

At Duluth, 40 teams were entered in the U.S.V.B.A. National Championships. Against this formidable competition, our Club team advanced to the semi-finals by defeating the Minnesota Athletic Club, San Diego State College, and the Olympic Club of San Francisco. In the semi-finals, the team was pitted against Chuck's Steak House, which is basically the College All-Stars of Southern California. This power-house proved a bit too much for our lads who lost two well-played games, 9-11 and 5-15. This loss put OCC in the losers' bracket with Kenneth Allen of Chicago, who were victorious at St. Paul. This time, Outrigger turned the tables. winning two games, 15-9 and 15-4. Since the National Championships are a double-elimination affair, Outrigger was then in the semi-finals of the losers' bracket, with four teams to play in the tournament windup. Playing against the strong Ski-Mart team of Long Beach, Outrigger put up a good fight but finally lost out, two games to one. This left Outrigger in fourth overall position in the National Championships for 1973, the highest finish for our Club in open national play since 1968, when an Outrigger team placed second. Disappointing to some, but all-in-all, a good show.

The Outrigger Masters meanwhile overpowered all competition except Balboa Bay Club of Southern California, which took the championship for the second year in a row. Although our team played some very close games in both finals against Balboa, that team's overall strength proved too much for OCC. This second place finish is identical with the Masters' record over the last seven years of play.

Tom Haine and Pete Velasco made First Team All-American for Masters, while Fred Hiapo made second team All-American and Billy Heilbron made Honorable Mention. In the Open Division, Don Maze and Randy Shaw made Honorable Mention All-American, Randy being selected to train with the U.S. National team in Los Angeles.

In sand court action, Andy Holman and Randy Shaw edged out Dennis Berg and Dave Shoti in the first open doubles sand court tournament.

- 1. Sponsor selects suitable candidate. (candidate must be sponsored by two voting members who have known him for at least one year. and who themselves have been members at least one year. There is also a one-year residency requirement for all applicants except Nonresident and Service
- 2. Sponsor picks up Membership Application and Confidential Reference Forms at Club office.

- 3. Sponsor completes forms. Applicant and both sponsors sign application and return to Club office with photograph of applicant. (incomplete applications will not be processed)
- 4. Application is checked and, if in order, approved by the Committee for posting. (credit check is initiated)
- 5. Candidate's name posted for thirty days and circulated to membership for comments, pro
 - (posting list is mailed with monthly statement)

- 6. After posting period is completed. sponsor or co-sponsor meets with Admissions Committee to review candidate's qualifications (Juniors exempt).
- 7. Sponsor accompanies applicant (and spouse, if any) to a personal interview with the Committee.
- 8. Committee recommendations reviewed by Board of Directors, and General Manager is notified of applicant's acceptance or disapproval.
- 9. Manager notifies successful applicants of acceptance, and business office mails statement for initiation fee, first month's dues, and OCC history book. (book charged to voting mem-
- 10. Secretary notifies sponsor if his candidate has been disapproved or deferred.

- 12. If applicable, new member may then apply for a Special Guest Card for spouse, and parking decal.
