Coach Dennis Berg reports that there have been two more "B" Tournaments, the first Women's "B" Tournament and the first "A" Tournament since the opener at Waimanalo reported in the last **Outrigger**. The season starts in January and runs through to the Nationals and AAU Tournaments held on the mainland in late spring. Serious practice consisting of two sessions a week commenced for the Outrigger teams in January.

The three women's teams are all "B" teams with the strong possibility of a 4th team to be made up because of the exceptionally large and enthusiastic turnout. Two teams finished 3rd and 4th in the first Women's Tournament out of ten competing teams at Waipahu and Wahiawa.

The Men's "A" and the Masters Teams finished 2nd and 3rd respectively in the first tournament at Waialua. The Masters Team led by Tom Haine seems to be headed in the right direction to win at the National Championships.

The "A" Team led by Buster Chapman, Chuck Haneberg and Mike Holmes will combine with the "AA" players Tony and Chris Crabb and Jenkins to go after an open National Title.

Two trips are planned for the "AA" players. These are set for February 3rd to 7th and March 24th to 30th and are intended to prepare our teams for the ultimate competition at the Nationals. Most of the games on the mainland will be exhibition games for which admission is charged. The Club will help defray the cost of these trips with their share of the receipts from the exhibition games.

From the President's Desk

Dear Fellow Member:

Your Board of Directors has found it necessary in the interests of responsible financial administration of the Club to increase dues charges. This action is taken reluctantly and only after an exhaustive study of alternatives.

Costs of your Club's operations have increased commensurate with the rising costs of wages and supplies, despite successful past moves to improve operating efficiency and control costs.

Dues were last increased nearly four years ago. Since that time general living costs have increased approximately 20 percent! The dues increases required to offset these added costs have been allocated equally to all Voting, Service, Island and Nonresident members, and at reduced rates to Associate and some classes of Junior members.

As a result of this increase, members can expect to receive continued quality, service and food and will be assured that their Club's facilities will be properly maintained and improved, and that its fiscal affairs will continue to be conducted on a sound basis.
