The club will be in direct contact with Wally Young in Detroit and the results will be posted on the club bulletin board as soon as they are received. Remember, last year we took second place and this is our year!

The Annual Volleyball Tournament sponsored by Outrigger was held at the Mid-Pacific School Gym on Saturday, April 15th. Eight teams competed in this the last tournament of the season. Outrigger own first place with the Red team and surprised many with its winning of the second place spot by the Green team. (Outrigger teams are given color designations rather than numbers or letters.)

Outrigger's volleyball coach **John Lowell**, who is currently grooming our champion volleyball team into top shape for the National Volleyball Championships in Detroit, is a man with a background of constant action. John was born in Webster City, Iowa, joined the Army in 1942 and retired from that service in 1962. John had a varied career in the Army which carried him to many parts of the world and particularly the Far East. After John retired he became a student at Brigham Young University and received both Bachelor of Arts and Master of Science degrees in 1965. John then worked with Brigham Young University as Director of the Service Program for the Men's Physical Education Department. John holds many impressive athletic honors in volleyball both in the military service and in his civilian life. To name but a few, All-Army selection in Track and Volleyball, All-Air Force and Interservice Volleyball in 1961, coached Brigham Young's volleyball team to take third place in the Nationals with no support from the school. All-American selection in Volleyball, 1958, selected as State Department representative to travel to Poland and study volleyball during summer of 1966, selected to act as Assistant Coach for the U. S. National Team at the World Volleyball Championships held in Prague in 1966.

John is currently Director of Athletics at Church College in Laie, Hawaii, and is presently adding Outrigger Canoe Club to his long list of successes. We wish John and his team the best of luck at the Nationals.

5. Boys (6) 16 and under..... $\frac{1}{2}$  mile
6. Women Freshmen (6) ..... $\frac{1}{2}$  mile
7. Women Junior (6)..... $\frac{1}{2}$  mile
8. Junior Men (6)..... $1\frac{1}{2}$  miles
9. Women Seniors (6) .....1 mile
10. Men Senior (6) .....2 miles
11. Men (6) 18 and under.....1 mile
12. Freshmen (6) .....1 mile

## ATHLETIC SPONSORS COMMITTEE

Billy Brooks has been named to head up this new committee. Billy in this outline describes the scope and intentions of this group:

Generally speaking, the functions and purpose of the Athletic Sponsors Committee are synonymous with, and intended to project, the first purpose for the existence of the club itself, as set forth in the opening words of Section 2 of the Outrigger Canoe Club bylaws which read as follows:

"The purposes of the club shall be the promotion of athletic sports and activities in all their forms and branches, etc."

Specifically speaking, this committee officially concerns itself with activities of the nature of the following:

1. Organizing and sponsoring various inter-club functions related to raising special funds for the promotion of athletic activities;
2. Sponsoring athletic memberships;
3. Sponsoring and assisting all new sports, where adequate interest is indicated by club members, until such sports win board approval and can be provided for in the budget as an official team;

4. Organizing and administering an annual awards banquet to give recognition to club teams and their members;
5. Choosing the recipients of, and making the awards to members of the club who are to be honored by receiving the Athletic Sponsors Committee's winged "O" award;
6. Controlling under board approval the nature of all the club's athletic awards;
7. Actively promoting and engaging in various programs aimed at magnifying and enhancing the club's athletic image as well as encouraging the general membership to participate to some extent in its athletic activities either as competitors or boosters;
8. Actively assisting and aiding the club captain and his committee to implement their program whenever needed.

In years past Outrigger Canoe Club teams participated in a wide variety of sporting events. The OCC spirit and "O and paddle" emblem were clearly apparent at almost every important athletic contest on this island. It is the goal and fond hope of the Athletic Sponsors Committee that a resurgence of this old OCC spirit will be experienced by the general membership and that once again our teams will know the wholehearted support which can only come with that kind of enthusiasm.

# Surfing

The action has been at Chun's Reef where the Hawaiian Surfing Association has held two meets. In the first meet held in late March Doug Beckert made the finals by qualifying in his heat.

Kimo McVay gave the surfing enthusiasts of the club a great treat several weeks ago when he provided a color TV for the members to watch a showing of the Duke Invitational meet on CBS sports spectaculars. The Duke himself was there along with Hawaii's surfing elite to enjoy a superb presentation of the Invitational.

Globe-trotting Fred Hemmings, Jr., is back from Peru where he competed in the Peruvian Surfing Championships. Accompanying Fred was fellow local surfer Jock Sutherland.

High placing in the February Duke Kahanamoku Championships earned both surfers the invitation to travel expense-free to Lima.

Hemmings nabbed a fourth place in the big-wave division, and coupled with Sutherland's third place finish and his win in the small-wave classification, helped bring the unofficial team title back to Hawaii. Quite a feat for a two-man team.

"As always," said Hemmings, "the hospitality was tops. It's a pleasure to compete in such a favorable climate of friendliness and sportsmanship."

Ron Haworth, our member who writes the popular *Surfspray* column for the *Star-Bulletin*, recently featured an interview with Phil Edwards and his impressions of surfing in Peru. Felipe Pomar, much quoted in the article, has this to say about the Outrigger athletic spirit. Referring to the Club Waikiki in Peru, Pomar said, "It has the architecture of the present Outrigger Canoe Club and the athletic creed of the Outrigger of bygone summers." That is one man's point and not one of a member at that. Felipe may have a point, it's a good idea to take a look at ourselves. Do we present a social image or do we function as an athletic club? The primary purpose of those who founded the club was to perpetuate Hawaiian water sports. As one looks about, one often has cause for concern.



# Sailing



The action increases in this department with more races, prospects of more and finer boats and more and more participation on behalf of the membership.

New rules are listed here. Sailing can be a lot of fun, it is a lot of fun, but there must be procedures where the use of the club equipment is so heavy in demand. These rules should not be thought of as restrictions, but guides to the better use and enjoyment of the equipment.

## Sunfish Qualification Procedure

All persons wishing to use Club Sunfish must demonstrate knowledge of the following qualification standards to the Qualification Sub-Committee of the Sailing Committee:

- I. Know the difference between Port and Starboard.
- II. Be able to rig a Sunfish from scratch, demonstrating knowledge of the following points:
  - a. Knowledge of how to install the Sunfish rudder.
  - b. Knowledge of how to rig the Sunfish sail.
  - c. Knowledge of how to rig all lines on a Sunfish.
  - d. Knowledge of the following knots and their use: Bowline, Clove Hitch, Figure Eight, Square Knot, Half Hitch.
  - e. The position of the Sunfish sail with respect to the mast and hull is very important. In this respect, the person qualifying for use of the Club Sunfish must understand the relationship of the location of the halyard knot on the upper spar and the location of the bronze collar on the lower spar which connect the sail to the mast.
- III. Sail the following legs based on fixed points:
  - a. Windward leg
  - b. Leeward leg
  - c. Reaching leg
- IV. Demonstrate knowledge of the following basic rules of the road for operating a sailboat:
  - a. A sailboat on the starboard tack has the right of way over a sailboat on a port tack.
  - b. A windward sailboat stays clear of the leeward sailboat.
  - c. Overtaking boats stay clear of overtaken boats.
- V. Areas of special knowledge:
  - a. Demonstrate the ability to right an overturned Sunfish from the mast down position.
  - b. Demonstrate knowledge on how to secure a Sunfish on a buoy and in the Outrigger Club garage.
  - c. Knowledge of areas near the Outrigger Club where surf can be dangerous to Sunfish operation.
  - d. Demonstrate knowledge of the location of reefs in the vicinity of the Outrigger Club.
  - e. Demonstrate ability to get Sunfish out of "irons." Be able to back down and fall off on a tack specified by the instructor.
  - f. Know how to effect a self rescue should a failure of the sail, rudder or other component of the Sunfish cause an emergency situation to occur. If such a failure should occur, the Sunfish should be sailed to the nearest point of land, or if sailing is no longer possible, the boat should be paddled to shore by hand, paddling from the bow.
  - g. Must demonstrate ability to swim.
- VI. Members using the Club Sunfish must have a complete knowledge of boat checkout procedures.



Members of the first class of sailing instruction held their first races on Saturday, the 8th. There were three races held that day around a course set outside the club entrance and toward Waikiki. The first of the series was won by Dick McClellan and crew; 2d, Doug Jocelyn and Hamilton; 3d, Don Avery and Hogan; 4th, Jim Byrer and Buster Chapman; 5th, Capt. Madden and Sanford. The second and major race of the day was won by Jody D'Enbeau and Jerry Ober, with Tom Reiner and Jill Maguire in second place. The third race was won by the last to finish, Doug Jocelyn, as everyone else was disqualified.



The Annual Pearl Harbor Yacht Club race run in gusting winds up to 45 miles per hour was won in the P-Cat division by Dan Wallace and Jody D'Enbeau on the first day of the series and by Dan and George McPheeters on the second day. Five boats were reported demasted by the winds the first day of the race.

The first home and home race between Outrigger Canoe Club and the Kauai Yacht Club will be held on Kauai on the 3d and 4th of June. For details see Jere Smith.

The next sailing class for beginners will commence on Saturday, April 22d, and continue for six weeks. By the time you read this it will have been under way for two weeks but join in as soon as you can.

A large orange airport wind sock is being ordered and will be placed at the entrance to the club channel which will clearly mark the entrance and provide a guide to the wind direction and velocity.

The status of the proposal to buy Olympic class Finn boats has received very enthusiastic reception by the Executive Board of the club. Dan Wallace will make a final report recommending the purchase to the next meeting of the Board of Directors. Their approval is expected.

Cline Mann reports that the club is now an official member of the North American Yacht Racing Union. This will allow us to enter in regattas held under the auspices of the Hawaii Yacht Racing Association.

There is a proper procedure for checking out and using one of the Club's Sunfish. Your name, once you have been qualified, is placed on a list and that list is managed by Jim Nanioli. Jim has the center boards to the boats and will only issue them to people who are qualified. If your name is not on the list do not ask Jim to issue you a center board, go to one of the sailing committee members. For the benefit of club members, the sailing committee has adopted the policy of NOT allowing guests to use the Sunfish boats on weekends.

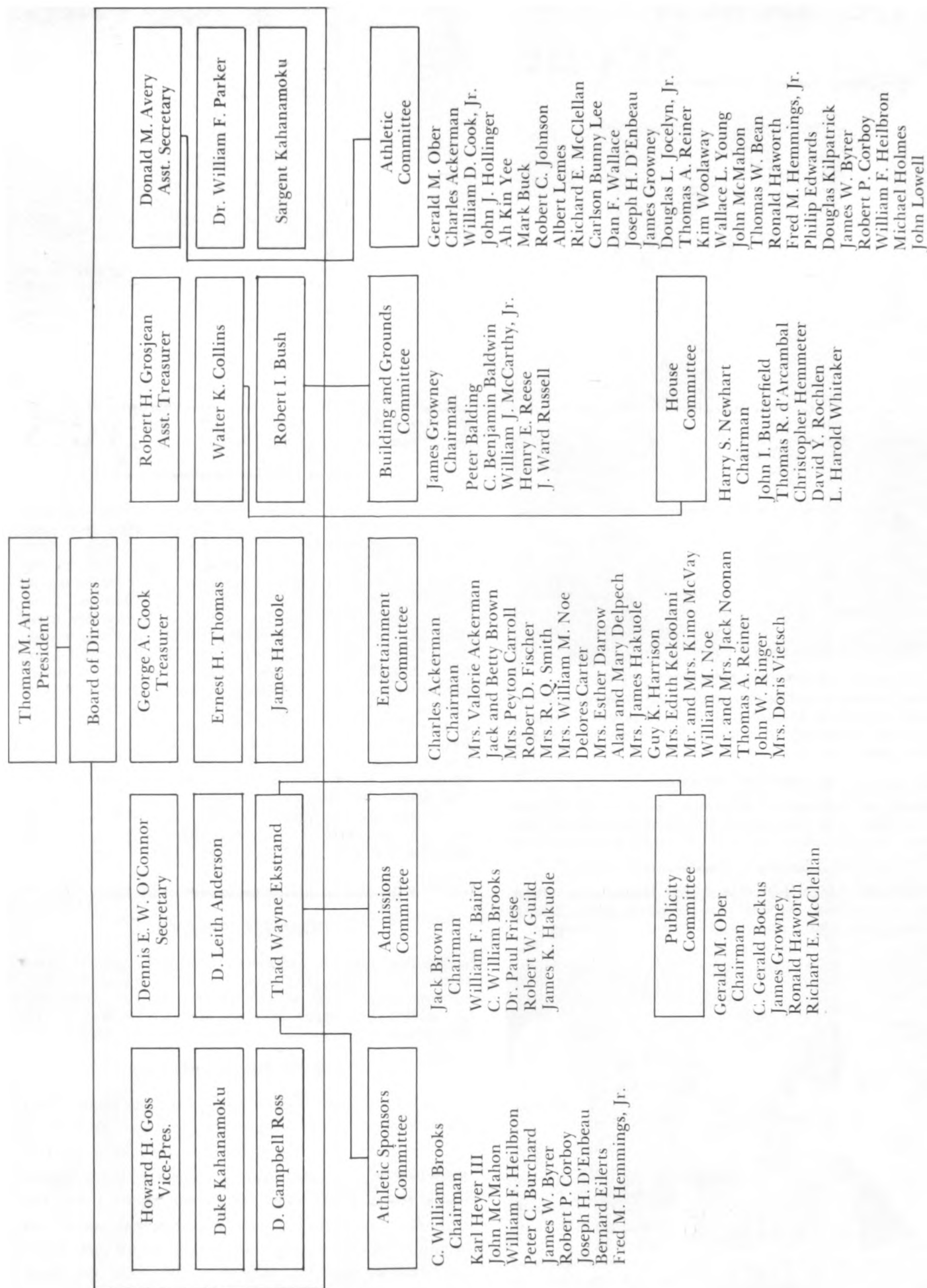
## Outrigger Flyers
