## OUTRIGGER CANOE CLUB ATHLETIC SPONSORS

A new and vitally important committee, the Outrigger Canoe Club Athletic Sponsors, has been formed. It is composed of members, formerly sportsmen and now prominent in the business community, who are dedicated to the preservation of the OCC image as an institution devoted to the development of youth through healthful athletic activities and to the perpetuation of the sports of old and new Hawaii.

Among the purposes of the committee will be the raising of funds to defray the expense of the Club's athletic teams in local, national and international competition.

One of the first projects is to raise funds to send the OCC Volleyball Team, which is undefeated in local tournament play this year, to the nationals in Omaha in early May.

## MANAGER'S REPORT

Here are some recent innovations at the club:

Closing time for the dining room has been extended from 9 to 9:30 p.m.

The charge for overnight parking is now \$12.00 per month instead of \$20.00. Ground rules for overnight parking are: the automobile being parked must belong to the authorized member. This type of parking is on a monthly basis but parking commenced after the 15th of the month will be charged for at one-half the monthly rate, if started prior to the 15th will be charged for the full month. It is asked that autos which are not going to be moved for a day or two be parked on the lowest level so that the more accessible areas may remain open for regular traffic.

This parking service is intended as a convenience for members having difficulty finding parking elsewhere but is not designed as dead storage for autos which will not be used for long periods while members are away on extended stays.

Members are asked not to take towels from the locker rooms to the beach and elsewhere to curtail the present high rate of towel loss.

It is most gratifying to see so many members using the club's beautiful facilities.

## VOLLEYBALL SEASON OPENS!

VOLLEY BALL SEASON — 1965 is here.

The 1964 team, with an impressive 7th place finish in the National Championships, is hard at work on the road to the National Championships to be held in May.

The team looks stronger with the addition of new team members. Heading the list is Hawaii's representative on the United States team in Tokyo, Pedro Velasco. Pedro returned home with the honor of having his team mates elect him captain of the Olympic volleyball team. Also back from a tour in the service is Paul MacLaughlin, collegiate All-American and long-time club member. Rounding out the new-comers is another All-American Thomas Haine, who represented the United States as well as Hawaii in the Pan American Game in Brazil.

The returning team is headed by player-coach and 1964 All-American Robert Hogan and is back with players James Haynes, Robert Daniels, William Baird, Michael Holmes, Ronald Sorrell, Fred Noa, Nathan Norfleet, Franklin Brown, Steven Moder, Drew Flanders, Carlson Lee, Albert Lemes and Mark Buck.

The season opened with the University of Hawaii invitational, with the club splitting the team evenly, enabling the coaches to get a look at all the players. Both the "A" and "B" teams finished in a battle down to the final nite with the B team finishing on top. Paul MacLaughlin and Thomas Haine led the "Bee's" in turning back Outrigger A and the Central Y, last year's state champions.

The Waialua tournament, March 27 and 28, Outrigger A won, led by tournament All-Stars Robert Hogan and Thomas Haine. The B team, Outrigger's 2nd, finished a strong 3rd.

This was followed by another victory in the Laie Church College tournament in which the A team, led this time by player-coach Velasco, easily proved to be the best. Again the B team was edged out by the Central Y team.

## CANOEING

This year the Canoe Committee is endeavoring to compile an up-to-date list of all "qualified" steersmen, senior and junior members, for big and small canoes. This list will become effective on May 1. All members are urged to enter their names on the list posted on the bulletin board. If your name is not entered on the list, you will not be able to take a canoe out after May 1.

For those who cannot steer a canoe, but who desire to learn the fundamentals of paddling and steering, courses will be conducted commencing June 1. Further information is available from Bud Ackerman, Canoe Committee chairman, at the club or at home, 574-725.

Here are the rules and regulations governing the use of outrigger canoes:

1—Must be a bona fide member of the Outrigger Canoe Club and "qualified" to use that type of canoe. All steersmen to be approved by the Canoe Committee.

2—Whoever takes a canoe out must sign his name in the beach attendant's Canoe Book, stating the name of the canoe, number of paddles and buckets used, time "out" and time "in."

3—All steersmen will be responsible for equipment. Any damage done to a canoe or any equipment lost or unaccounted for will be charged to your account.

4—When checking "in" it is the steersman's responsibility to return the canoe to its proper cradle.

5—All paddles, buckets and rollers are to be returned to the canoe storage locker.

6—On Saturdays, Sundays and holidays, the time of use shall be restricted to one hour only. Upon return if no one has signed up for the canoe, you may sign up for another hour.

7—A surfing area chart for beginners, posted on the bulletin board, will be strictly adhered to.

8—Anyone disregarding the above rules will be denied use of the canoes for a term to be determined by the Canoe Committee depending upon the type of offense.

## BY-LAW AMENDMENTS

The following amendments to the By-laws are those referred to in the call of the annual meeting of the members of the Outrigger Canoe Club which was held at 5:00 p.m. on Friday, February 26, 1965.

In parentheses following each amendment is the purpose thereof. Reference is made to the 1964 reprint of the By-laws, copies of which were mailed to all members in December 1964.

### SECTION 8

*Nominations for Directors.* In the first sentence of this section strike the words "of not less than three members." (To remove the present conflict with Section 24 which provides for a Nominating Committee of at least five members.)

### SECTION 9

*Election.* In the ninth line change the word "seven" to "ten." (To make this section consistent with Section 53, *Notice of Club Meetings.*)

### SECTION 20

*Committee on Admissions.* Strike the words "term" and "or associate" and the phrase "two of whom shall be ladies." (To qualify only voting members as members of the committee and remove the mandate of two women thereon, compliance with the present provision being extremely difficult because of the marked decrease of women members.)

### SECTION 25

*Classes of Members.* Insert the word "intermediate" between the words "regular" and "associate."

Add the following sub-section between the sub-sections "Regular" and "Associate":

*Intermediate.* Intermediate members shall consist of single or unmarried women or persons between the ages of 18 and 30 years inclusive. (To establish a class of membership to replace the sub-category in the Special class created by the Board of Directors at a special meeting on June 30, 1964 when the new schedule of dues and assessments was adopted, effective October 1, 1964.)

### SECTION 26

Amend the following sub-sections to read:

*Temporary.* Temporary members shall be admitted to membership by the Admissions Committee following written application for any period at the discretion of said committee but not to exceed a period of 90 days. (To transfer the authority of granting Temporary memberships from the General Manager to the Admissions Committee and place a time limit on such memberships.)

*Guest.* Guest members may be admitted to membership for periods not to exceed a total of two weeks per year by the issuance of a guest membership card by the general manager either on application by members in good standing (except minors) in the life, regular, intermediate, associate, island and service classes or on presentation of a card or letter of introduction from the management of a club with which the Outrigger Canoe Club has a reciprocal privileges agreement. (To restore to most membership classes the privilege of sponsoring guest members and to qualify for guest membership those persons who are members of clubs with whom the Outrigger Canoe Club has reciprocal privileges, and hence make the By-laws consistent with long standing policy.)

### SECTION 29

*Guests and Restrictions Thereon.* Any member in good standing, except a guest member, may bring guests to the club, provided that no such guest has had his membership terminated for cause or otherwise been expelled from the club. No such guest shall visit the club more than two days in any one month without written approval of the General Manager, provided however, that this limitation shall not apply to spouses of members or ladies and gentlemen of single men and women members, respectively. All guests shall register upon entering the club premises and, except for spouses of members, shall be accompanied by their hosts and shall not incur any indebtedness to the club. (To deny to guest members the privilege of bringing guests, a long standing policy; to limit to reasonable frequency the visiting privileges extended to any one guest; and to provide for special guest treatment of members' spouses and escorts of single members, also a long standing policy.)
