## Former Bishop Trust President Dies At 64

Gerald W. Fisher, 64, for-mer president of Bishop Trust Co., died yesterday at Queen's Medical Center.

Funeral services will be at the Lihue Cemetery, Kauai, at 4 p.m. tomorrow.

Mr. Fisher was born in Cambridge, Mass., the son of Galen M. Fisher, founder of the YMCA in Japan, and Ella W. Fisher of the Abner Wilcox missionary family of Kauai.

HE WAS EDUCATED at the Tokyo Foreign School and Princeton University. In 1927 he came to the Islands to work as an agriculturist with the Hawaiian Sugar Planters Association Experiment Station.

In 1928 he became head foreman at Kahuku Plantation, and assistant manager there the following year.

Mr. Fisher started his career with Bishop Trust Co., in 1935 as assistant secretary, and advanced through various offices to executive vice president in 1953, and president in 1955.

BISHOP TRUST Co. expanded not only in trust and estate areas during his presidency, but in insurance, stocks and bonds, real estate and mortgage loans, and acquired Honolulu Mortgage Co., Ltd.

Mr. Fisher requested an early retirement in 1964 to devote time to his many directorships in local business corporations and to extensive community service.

Among local companies in which he was a director are Bishop Trust, C. Brewer & Co., Amfac, Hawaiian Telephone Co., First National Bank, Hawaiian Eelctric Co., Dillingham Corp., and Grove Farm Co.

HE WAS a Punahou School trustee and financial vice president for 28 years; a trustee and treasurer for Kauikeolani Children's Hospital for 25 years; was a director of the Oahu Development Conference, the Chamber of Commerce, the Child and Family Service, and the Downtown Improvement Association, and was chairman of the McInerny Foundation Distribution committee.
